INTRODUCTION




Figure 1: Plan showing the general locations of the two gates.

Under the terms of its PIC contract with Historic Scotland, Kirkdale Archaeology was asked to carry out an archaeological watching brief during the removal of two old gates, and the installation of two replacement ones at Iona Abbey, Iona (Fig. 1).

Excavation was undertaken by hand, by Historic Scotland staff under archaeological supervision, and the work took place on 1st September, 2015.

DESCRIPTION

Gate 1

Gate 1 was located to the north-west of the site, and consisted of a single swing gate supported on a hinge-post at one side, and a locking-post at the other. The gate was removed from the hinge-post, and the concrete settings for the posts were broken up, and both posts removed.

Trench 1

This was located on the southern side of the path. Beneath the 7.5cm thick layer of turf and topsoil, **100**, a layer of concrete, **101**, extended to a depth of 0.32m. Beneath this, a silty mid-brown deposit **102**, 0.12m thick, containing concrete fragments and small rounded stones was visible. Nothing of archaeological interest was revealed, and the finished trench measured 0.64m N/S x 0.66m E/W x 0.44m deep.


Trench 2

This was located on the northern side of the path. Beneath the 7.5cm thick layer of turf and topsoil, **200**, a layer of concrete, **201**, extended to a depth of 0.28m. Below this was context **202**, some 0.2m thick, containing an assorted array of rubble containing brick fragments, large angular stones, occasional pieces of modern wire and fragments of broken ceramic pipe. An old, broken ceramic pipe **204**, 0.11m in diameter, was visible in the E-facing section. Below this was the natural gravel, **203**, a thickness of 0.05m of which was excavated before the required trench depth was reached. Nothing of archaeological interest was revealed, and the irregularly sized finished trench measured a maximum of 0.4m N/S x 0.4m E/W x 0.53m deep.




Figure 2: Post-excavation plan of trenches 1 and 2.

Gate 2

Gate 2 was located to the south-east of the site, and consisted of a single swing gate supported on a hinge-post at one side, and a locking-post at the other. The gate was removed from the hinge-post, and the accompanying wooden framework dismantled.

Trench 3

This was located to the north. Following the removal of the 5cm thick turf and topsoil **300**, the hingepost was revealed to be sitting atop a layer of regularly arranged red bricks, **301**, one course thick (0.1m). Beneath this was **302**, a 0.18m thick layer of dark, stone-free material containing mortar fragments. This in turn lay over **303**, a 0.13m thick layer of loosely packed mortar fragments. The finished trench measured 0.43m N/S x 0.43m E/W x 0.46m deep.


Trench 4

This was located to the south. Following the removal of the 6cm thick turf and topsoil **400**, the locking-post was revealed to be sitting within **401**, a 0.35m thick deposit similar in nature to **302** - i.e. a layer of dark, stone-free material containing mortar fragments. Within **401**, was a 5cm (on average) thick lens of clean sand, **402**. Nothing of archaeological interest was revealed, and the finished trench measured 0.43m N/S x 0.43m E/W x 0.41m deep.





Plates 3 and 4: Trench 3, post-excavation photo (left), and Trench 4, post-excavation photo.






Figure 3: Post-excavation plan of trenches 3 and 4.

CONCLUSIONS

Other than the layer of red bricks (301) encountered in Trench 3 (possibly part of a larger arrangement), little of archaeological interest was revealed. Within trenches 3 and 4, the deposits probably indicate an episode of levelling, possibly during the 1930s restoration works.

Clearly the site remains of high archaeological potential and similar ground-breaking works should be accompanied by an archaeological watching brief.




Figure 4: Clockwise, from top-left: Trench 1, S-facing section; Trench 2, E-facing section; Trench 3, S-facing section, and Trench 4, E-facing section.
