#### Abstract

A programme of archaeological observation, investigation and recording was undertaken by Northamptonshire Archaeology(now operating as MOLA), on behalf of Galliford Try between February and November 2013 during groundworks connected with the construction of a new, two-storey teaching block and temporary haul road on land at Standens Barn Primary School, Flaxwell Court, Northampton. A truncated natural substratum was recorded throughout the investigation area. No archaeological features or artefacts were present.

#### 1 INTRODUCTION

A programme of archaeological observation, investigation and recording was undertaken by MOLA (formerly Northamptonshire Archaeology) between February and November 2013 during groundworks connected with the construction of a new two-storey teaching block on land at Standens Barn Primary School, Flaxwell Court, Northampton (NGR SP 7990 6188; Figs 1, 2 and 3). The work was undertaken on behalf of Galliford Try and was carried out following a request for a programme of archaeological observation, investigation and recording by the County Archaeological Advisor, Northamptonshire County Council in a brief issued on the 14 December 2011 (Mather 2011).

It adhered to the National Planning Policy Framework (DCLG 2012) and followed a Written Scheme of Investigation produced by Northamptonshire Archaeology (Leigh 2012) and the procedural document MoRPHE issued by English Heritage (EH 2006) along with the appropriate national standards and guidelines, as recommended by the Institute for Archaeologists (IfA 2008).

#### 2 BACKGROUND


# 2.1 Location and topography

Standens Barn Primary School is located within a residential area on the south-eastern side of Northampton. The investigation area lies on ground sloping gently down to the south-east at an approximate height of 65-60m aOD.


The underlying geology has been mapped by the British Geological Survey as comprising Upper Lias Clay (BGS Geoindex: <a href="http://www.bgs.ac.uk/geoindex">http://www.bgs.ac.uk/geoindex</a>).

2.2 Historical background

The site lies within an area of undetermined archaeological interest. To the east of the site a number of Roman pottery sherds are recorded as having been recovered in the area.

No previous archaeological work is recorded as having been carried out within the site. Up to the present application the site has comprised an area of hard-standing and grass within the school grounds.

#### 3 OBJECTIVES AND METHODOLOGY

The aims of the archaeological investigation were to:

- Observe the groundworks for the new teaching block and temporary haul road and to record all archaeological deposits uncovered;
- Determine the date, character, state of preservation and depth of any archaeological deposits observed and to retrieve all datable artefacts;
- ♦ Create a permanent archive and record of the archaeological information collected during the course of the fieldwork and analysis.

A photographic record in both black and white negative and colour slide was kept, with supplementary photographs in digital format. The written record used Northamptonshire Archaeology pro-forma sheets, (NA 2011). The watching brief was carried out in accordance with the *Standard and guidance for an archaeological watching brief* (IfA 2008).

The fieldwork was undertaken between February and November 2013 during soil stripping for the temporary haul road (Fig 4) and groundworks for the new teaching block. The groundworks were carried out using a 360° mechanical excavator fitted with a combination of toothed and toothless buckets. The works comprised the removal of topsoil across the area of the new haul road and teaching block.

## 4 THE RECORDED EVIDENCE

A consistent stratigraphic sequence was recorded throughout the investigation area (Fig 5). This comprised pale grey-brown clay encountered approximately 0.20m below present ground level. Overlying this was grey-brown sandy loam topsoil, up to 0.20m thick, containing numerous small fragments of modern ceramic building material and degraded fragments of modern plastic along with very occasional irregular stones.

No archaeological features or artefacts were present.

# 6 CONCLUSIONS

A truncated natural substratum was recorded throughout the investigation area. No archaeological features or artefacts were present. The absence of any artefactual evidence, would suggest, but not preclude, that no significant archaeological deposits are present in the immediate vicinity of the investigation area.

The archaeological investigation was carried out in favourable circumstances and the results are considered to be reliable.
