The Capability Brown Festival

The Capability Brown Festival was hosted by the Landscape Institute on behalf of a partnership comprising Historic Houses (formerly the Historic Houses Association), the National Trust, English Heritage, Historic England, Natural England, The Gardens Trust (with the County Gardens Trusts), Parks & Gardens UK, Kolab,

the Embroiderers' Guild, The Arts Society (formerly NADFAS), the National Garden Scheme, the Royal Horticultural Society, VisitBritain, VisitEngland, Historic Royal Palaces, Bridgeman Images, Blenheim Palace and the Georgian Group. The Capability Brown Festival was funded by the Heritage Lottery Fund. Nearly 500 events took place across England and Wales, including 38 strategic commissions, fulfilling the Capability Brown Festival's two key aims of developing new audiences and interpreting Brown for the needs of the widest possible range of participants. The Festival produced 24 downloadable leaflet maps for Brown sites and 160 Brown sites on the interactive map now have researched and illustrated entries covering both historic and biodiversity information. The Festival attracted at least 1,571 pieces of media coverage and thanks to the internet, is estimated to have reached a potential audience of 4.2 US billion.

SUMMARY

This Historic England research report presents an evolving reference catalogue of existing survey and design plans from the office of the landscape designer Lancelot 'Capability' Brown (1716–83). It forms part of the Capability Brown Festival legacy. As well as setting out the place name, and location of the original, where known, it provides information on published reproductions that are relatively easily available, including in monographs and scholarly journals such as *Garden History*.

1 PURPOSE OF THE CATALOGUE

The 2016 Capability Brown Festival prompted new research and, in turn, highlighted plans and documentation for Brown's landscape designs. The Festival generated a major re-evaluation of Brown's work and related resources since Dorothy Stroud's seminal work over 50 years ago. As a result, more plans and drawings have been rediscovered and more materials are available online, but a reference list – like the catalogues for artworks of the other 18th-century giants such as Constable and Turner – has been missing.

To address this, the following reference catalogue of surviving plans from the office of Lancelot Brown is aimed at historians and conservation professionals. It does not claim to be complete but is a <u>work in progress</u>, a position statement that can be amended in the light of significant new information received. As well as itemising the various plans using modern site names, the catalogue provides an indication of location and ownership, the purpose of the plan, and where reproductions are to be found in relatively widely available secondary sources. This document covers only design plans and surveys from Brown's office. Although a number of perspective drawings and elevations from his office survive, these have not been included.

Historic England was a partner in the Capability Brown Festival and advised on the research agenda including commissioning and publishing a research report from the University of East Anglia in 2013. As part of this, an interactive map was published online as a research tool, presenting the aerial photograph collection for Brown landscapes. Historic England drew on the new research finds to update and review Register entries for Brown landscapes and published John Phibbs' text book on Capability Brown in 2017 (*Place-Making: The Art of Capability Brown*) which includes many Brown plans and drawings.

The catalogue contributes to the Capability Brown Festival legacy, as a resource for 18th-century landscape studies. It responds to recommendations in Historic England's published research report *Lancelot 'Capability' Brown: A Research Report Impact Review by the Landscape Group*, University of East Anglia (UEA). In particular the catalogue is a stepping-stone towards the recommendation to collate high-resolution digital images of all the Brown plans for research and study, and to ensure this important record is safeguarded.

It is hoped that publication of this reference catalogue may spur on other discoveries of Brown plans. There are clues suggesting there might be other plans which survive; there may be plans by members of Brown's staff perhaps not recognised as part of the Brown landscaping; there are almost certainly earlier estate plans where Brown or one of his staff has overdrawn with his landscape proposals; and others' plans which have been endorsed by Brown or his staff. The catalogue could be systematically expanded to include these if resources allowed.

As with all historic parks and gardens, sites which are particularly well recorded through historical documentation may be of particular interest for these reasons alone, and the survival of good historical records can enhance the interest and therefore the significance of a site. Particularly where the condition of the site is poor, documents and other sources may show a site to be of considerably more interest and have more historic features surviving, than an initial site investigation may indicate. New archival information concerning the historic development of a park or garden might also result in that site being re-evaluated.

This also applies to designation and the Register of Parks and Gardens and grades. As stated in Historic England's *Register of Parks and Gardens Selection Guide: Rural Landscapes*, "Whatever its date and type, where a landscape's creation or development is particularly well documented it will almost always add to its interest, and can merit designation at a higher grade."

It should also be noted that the existence of a plan is not proof that the alterations shown were undertaken or that the suggested works were altered during the implementation process.

The list is aimed at a wide range of users. These include:

- Historic England and the other Capability Brown Festival Partners
- The National Heritage List for England (NHLE) Enrich the List facility
- Art historians and landscape researchers interested in the 18th century
- The Gardens Trust and county gardens trusts
- Landscape consultants working on 18th-century landscapes
- Repositories and collections including public archives and private collections

2 SCOPE OF THE CATALOGUE

The list of 82 documents includes surviving surveys and design proposals firmly attributed to Brown's office, or those where a strong link is identified such as an existing plan annotated by Brown or one of his staff. The list may well not be complete and can be updated as required. The format is flexible and in future editions other information could be added such as primary references in other documents, cost, and so on.

The catalogue does <u>not</u> currently include drawings or architectural plans for houses, bridges, and other buildings and structures. An example of one of Brown's drawings is included in the entry for Rothley Lakes for interest. These are important resources for understanding the landscape designs.

2.1 Using the Catalogue

The catalogue draws on Capability Brown Festival resources owned by the Festival partnership, and desktop research for reference materials. Reference material of particular help with current attributions of sites and the level of certainty of attribution is John Phibbs' *List of Lancelot Brown Site Attributions* (Dec. 2016, 5th ed). Information for each site includes:

- NHLE entry number: National Heritage List for England entry number included if the landscape is included in the Register of Parks and Gardens. (Listed buildings and other designations are not included; however, individual register entries do highlight listed buildings).
- Current site name
- Address
- Existence: level of certainty that a plan exists, generally yes, no, or unclear, but also included is one example where the original has gone but copies survive (Uppark)
- Date: or approximate date, of creation
- Provenance: level of certainty of provenance being from Brown's office
- Purpose of plan: whether design, survey or other
- Author: likely hand of author (if evident); whether by Brown or one of his staff
- Current owner
- Location of original: repository and catalogue reference with weblink if available
- Reproductions: whether published in commonly available sources, if any, including books, journals and websites. The sources are given in full in Section 5: References.
- Notes: additional information where available, such as original name of site, plan title, area covered, attribution queries, and so on.

Gaps may not mean the information is not extant, merely that it was not available within the scope of this project.

3 RECOMMENDATIONS FOR FURTHER WORK AND INITIATIVES

3.1 Curation and Cataloguing

- To review and revise this list periodically to complete it as far as possible by adding further information, particularly about the existence of plans from Brown's office, either relating to additional plans or the information presented above, and other details like folio types, and types of plans such as plans pricked through from surveys.
- To build on Phibb's *List of Lancelot Brown Site Attributions* which identifies some signed plans and drawings, and draw up a list of all sites for which Brown is known to have prepared a design plan so that the survivors can be placed into context. Map all sites for which he prepared design plans and identify those for which they are extant.
- To use this list to promote and inform the production of a digital archive of all the plans, reproducing them at high resolution.
- To use this list to promote and inform the production of a publication of all the plans itemised, reproducing them at high resolution.
- To identify the extent of implementation of the design plans on site.

3.2 Further Research and Analysis Projects

- To compare all the surveys and design plans to identify the development of Brown's artistic and landscaping styles and of technical techniques with water, soils, planting styles.
- To forensically compare all plans signed and initialled L.B. to confirm whether drawn by Brown personally.
- To carry out a similar research exercise to identify surviving sketches and architectural drawings including architectural and landscape scenes from Brown's office.
- Using the existing plans, to carry out further research into Brown's office staff including Spyers, Lapidge, Milliken, White and others to identify them and the various artistic hands, leading to a published guide.
- To research in detail how Brown recruited staff and his network of contacts, workmen, suppliers, and so on.

3.3 Other Initiatives

- Use the catalogue to add more information to the National Heritage List for England via the Enrich the List facility.
- Review the National Heritage List for England to ensure that Brown's surviving
 work is appropriately reflected, including the extent of his significant work
 within each site. If plans are rediscovered, review the designation status of
 the landscape.
- The catalogue offers a model for other landscape-related collections such as the research being undertaken for the Humphry Repton bicentenary in 2018.
- Where plans are rediscovered, review the National Heritage List for England designation status for the site.

4 CONCLUSIONS

The plans are widely scattered and diverse. Around 34 publicly accessible archives or collections hold the majority of plans. Of these, local authority archives are important repositories, with around 17 holding Brown plans. Many of the largest country estates still own and store their own plans. A few plans are abroad – the USA, Canada and Vienna; three universities hold plans; plus the Royal Institute of British Architects, the National Trust, English Heritage, the Royal Collection, the National Records of Scotland, and The National Archives, Kew.

Several types of plan exist, including preliminary site surveys, design plans, and, more rarely, plans by other surveyors and designers where Brown or his surveyors added to them (Clandon Park, for example).

Further work is required to fill all the information fields in the list as far as possible:

- The plans are in several different hands but the authors of relatively few have been identified.
- Detailed planting plans identifying positioning of species are absent.
- There are undoubtedly more plans from Brown's office to be found.










