SUMMARY

An archaeological desk-based assessment was carried out in June 2009 on Cobbs Lane, Guilden Morden, Cambridgeshire (centred on NGR TL 284 453). The work was commissioned by Cambridge Water PLC, prior to the replacement of a water pipe alongside Cobbs Lane. The study area is located on the parish boundary between Guilden Morden and Steeple Morden, to the southwest of Cambridge.

A search was made of all relevant and readily available published and non-published documentary sources held by the Cambridgeshire Historic Environment Record (CHER), and Cambridgeshire Archives. A map regression exercise for the site was also undertaken, including reference to all available historical mapping.

The map regression and HER assessment showed that from the medieval period up until the present day Cobbs Lane has probably acted as the boundary between the two parishes of Guilden Morden and Steeple Morden. The land adjacent to Cobbs Lane has remained as agricultural fields. The presence of archaeological remains dating from the Prehistoric to medieval periods within the wider study area indicate that there is potential for archaeological remains surviving in the easement of the pipeline. In particular a possible ditch visible on the air photos may date to the medieval or post-medieval period and will be directly affected by the proposed pipeline.

1 INTRODUCTION

- 1.1 In June 2009, Birmingham Archaeology carried out archaeological desk-based assessment (map regression and HER assessment) at Cobbs Lane, Guilden Morden, Cambridgeshire. The work was commissioned by Cambridge Water Company, in advance of proposed groundworks for a replacement water pipeline. This assessment is the first stage in a process including an archaeological evaluation of the site, which will allow an appropriate mitigation strategy to be devised.
- 1.2 This report outlines the results of the assessment, which was carried out in June 2009, and prepared in accordance with a brief issued by CAPCA (Cambridgeshire Archaeology Planning and Countryside Advice, 2009) and the Institute for Archaeologists' Standard and Guidance for Archaeological Desk-Based Assessment (IfA 2008).

2 LOCATION AND GEOLOGY

- 2.1 The site consists of a 12m wide strip of land forming the easement of the proposed pipeline, which is to be stripped of topsoil, with an approximate length of 1.9 km. It is located along the line of Cobbs Lane from Flecks Lane to approximately 40m north of Tadlow Bridge. Cobbs Lane is located on the parish boundary between Guilden Morden and Steeple Morden, to the southwest of Cambridge. The site is centred on NGR TL 284 457 (Fig. 1).
- 2.2 The underlying geology of the area is superficial deposits of alluvium and sand and gravel, overlying solid geology of the Gault formation (British Geological Survey 2006).
- 2.3 The present character of the site is a track bounded by trees, in places, (Plate 5) and surrounded by mainly arable fields, currently under a crops of rape and wheat, apart form a small pasture field at the south end of the proposed pipeline. The site is located at a height of between 26 and 30m AOD.
- 2.4 The study area consists of a 2.5 km radius of land surrounding the site.

3 AIMS AND OBJECTIVES

3.1 The principal aim of the project is to assess the survival and potential significance of any archaeological remains within the site which may be affected by the proposed pipeline groundworks. This information may inform the location of trial-trenches as part of the archaeological evaluation of the site which would enable an appropriate archaeological mitigation strategy to be devised.

4 METHODOLOGY

4.1 A search of all relevant and readily available published and non-published documentary sources, including historic maps, was carried out at the Cambridgeshire Historic Environment Record (CHER) offices and Cambridgeshire Archives.

5 **HER ASSESSMENT** (Fig. 2)

5.1 **Prehistoric**

A burnt flint scatter with associated flint flakes and animal bone (CHER 09850) was located to the west of Cobbs Lane at Green Knoll Farm. To the east of the site, Late Bronze Age artefacts (CHER 03320b), including an awl, dagger and socketed axehead, possibly representing a hoard, have been found. In the same location, an Iron Age settlement (CHER 03320a) is known from an earthwork and associated finds including a brooch, pin, spindle whorl and combs.

5.2 **Roman**

A Roman settlement, including an inhumation (CHER 03320) was identified to the east of the site in the same area as the Iron Age settlement (see above), during coprolite digging between 1879 and 1884.

Two findspots recording finds dating to the Roman period are also within the study area. Roman pottery (CHER MCB16170) was uncovered during fieldwalking in 1986 to the west of the site, and two Roman coins (Pius 138 – 161 AD and Verus 161 – 169 AD) (CHER 02279) were found during ploughing to the north of the site in 1907.

5.3 Anglo-Saxon

Excavations in 1997 uncovered two Anglo-Saxon graves (CHER CB14603) in Guilden Morden to the west of the site. To the north of the site there is a possible burial mound (CHER 02276a), suggested as the burial site of Tadda, from which Tadlow village probably gets its name.

Two findspots of Anglo-Saxon pottery have also been identified within the study area to the east (CHER 03320c) and west (CHER 02285) of the site.

5.4 Medieval

The majority of sites identified within the study area, date to the medieval period. Five distinct areas of ridge and furrow (CHER 02280, CHER 09910, CHER 09870, CHER 11404, and CHER 02282), have been located to the north, northeast, east and west of the site, highlighting the importance of agriculture in the area.

A total of five moated manors were located within the study area. One in Tadlow (Moat House, CHER 01207) to the north of the site, one in Guilden Morden (Morden Hall, CHER 01210) to the west, one in Steeple Morden (CHER 01212) and two in Abingdon Piggot (Manor Farm, CHER 01232 and Moyne's Manor, CHER 01214 (SM 33598)) to the east. In addition to these, a further five moats were located within the study area. Three of these were located in Steeple Morden (CHER 01211, CHER 01209, and CHER 01213) to the south of the site, while the remaining two were located in Croyden (CHER 01215) and Tadlow (CHER 01208) to the northeast and north respectively.

A number of ditched enclosures are visible within Tadlow to the north of the site (CHER 02288 B/D/E). The functions of these enclosures are unknown. However, the large

number of moats and moated manors in the area may suggest that these enclosures were moats.

During the medieval period a number of villages were established in the area, such as Tadlow DMV (CHER 02288) to the north, Wendy (CHER 08147) to the northeast, and Glitton (CHER 00183) to the south. These villages became depopulated and eventually deserted during the later medieval period.

Cobbs Lane which runs along the edge of the site, was originally the medieval road from Guilden Morden to Tadlow, and marked part of the boundary between the parishes of Guilden Morden and Steeple Morden.

6 **LISTED BUILDINGS** (Fig. 3)

There are a total of 27 Grade II listed buildings (LBS: 52552, 52508, 52507, 52506, 52524, 52525, 52505, 52504, 52512, 52510, 52550, 52503, 52500, 52497, 52498, 52509, 52502, 52499, 52511, 52542, 52543, 52544, 52555, 52545, 52547, 52546, 52548, and 52549) located within Guilden Morden to the southwest of the site. These buildings include a well, dovecotes, cottages, a barn, and a water mill and house.

The Church of St Mary in Guilden Morden (LBS 52501) is the only Grade I listed building within the study area, and was built in the 12th century.

The remaining Grade II listed buildings located within the study area are a house (LBS 52617), two farmhouses (LBS 52618 and LBS 52633), and two cottages (LBS 52634 and LBS 52635) located in Steeple Morden (LBS 52618), and the Church of St Giles in Tadlow (LBS 52794).

None of these buildings will be affected by the proposed pipeline.

7 CARTOGRAPHIC EVIDENCE

The 1804 Guilden Morden Tithe map (Plate 1) shows the west side of the site. A road is located along the southern part of the present Cobbs Lane, however no name is given for this road. The ground to the west of the site is mostly divided up into individual landholdings, with a large field, named as Tadlow Bridge Field towards the northern end. It is unknown what the land was used for, although most likely it was used as agricultural or grazing land.

The east side of the site is shown on the 1817 Steeple Morden map (Plate 2). Again a road is located along the line of the present Cobbs Lane, however it is named as Tadlow Road on this map. A cottage is located at the southern end of Tadlow Road, while the remaining land is mostly owned by New College and appears to be undeveloped.

The 1840 Tadlow parish map (Plate 3) shows the northern end of the site within, and surrounded by, fields owned by New College. Tadlow Bridge Farm is also visible directly to the northeast.

The Ordnance Survey First Edition of 1886 (Plate 4) is the first map to name Cobbs Lane. The majority of the fields around the site appear to be agricultural, with only two small areas of woodland towards the southern end.

The 1950 Ordnance Survey map of Cambridgeshire and Isle of Ely shows no changes to the site or the land adjacent to it.

8 AERIAL PHOTOGRAPH EVIDENCE

An aerial photograph survey was carried out, covering a 200m wide study area, centred on the route of the proposed pipeline (Deegan 2009). The results of the survey are summarised here.

- A possible medieval or post medieval hollow way and ditches are visible at the northern end of the study area and part of this may be affected by the pipeline.
- Medieval or post medieval levelled ridge and furrow and a plough headland are visible running along the eastern edge of the site and may be affected.
- Probable post medieval field boundaries and some possible undated ditches are visible to the east of the site and may be affected.
- The ridge and furrow visible to the east and west of the site may conceal or mask underlying features.

9 IMPLICATIONS

The site appears to have been used as the main road to Tadlow from Guilden Morden for a considerable time, and probably since the medieval period. During the mid to late 19th century it appears that the Tadlow Road may have been less frequently used and eventually renamed Cobbs Lane. The land adjacent to Cobbs Lane appears to have been used purely for agricultural or grazing purposes throughout this time.

The presence of archaeological remains dating from the prehistoric to the medieval period within the study area suggests that there is good potential for archaeological remains to be found within the site. In particular a possible ditch visible on air photos may date to the medieval or post-medieval period and will be directly affected by the proposed pipeline.








Route of Pipeline




PN: 1949 Cobbs Lane, Guilden Morden Plate 1 : 1804 Tithe map of Guilden Morden by Tinkler





Full description

R2, Moated site (Class A 1 (b) TL 283-/476-) on flat gault clay at the foot of a gentle slope to the S. It is that of the manor house of Tadlow or Hobbledods. In 1840 the field to the S was known as Batterborough (tithe map). The ditches are overgrown and part of the interior is planted with trees. A trapezoidal area 330ft NW by 205ft NE by 340ft SE by 130ft SW is enclosed by a wet ditch 25ft to 33ft wide, 3ft to 5.ft deep, and12ft to 15ft wide across the bottom; It is filled by a stream entering at the N angle and flowing out at the S angle. The entrance seems to have been in the NW side. On the 1750 maps (in Downing College) a lane ran NE from the present village street, ending near the NW side, and its line, a continuation of the hollow-way described under Monument (6(a)), is represented by a hollow-way 32ft wide and 1,5ft - 2ft deep which now runs into the Wangle of the moat. Originally the lane ran between the NW side and a length of ditch 160ft long 25ft wide and 2ft deep, parallel to the moat ditch at a distance of 30ft; this ditch has an arm projecting NW for 50ft at the SW end, probably an inlet channel. There is a staggered entrance now 50ft wide in the NW side of the moat, 100ft from the N angle, and on either side the ditch has cupped ends with the SW length set back 30ft from the line of the NE length. Inside the moat there is a roughly rectangular depression 6ins to 1ft deep to the SE of the entrance with disturbances on the SE where a building stood in 1901. In the E corner there is a circular mound20ft across and 2ft high, and in the S corner there is a raised area100ft across and 1ft to 1,5ft high. Outside the SW side of the moat is a platform 120ft long and 80ft wide at the N end, bounded on the SW by a curving scarp 4ft high; this scarp was probably made during the construction of the present road in 1826. The ditched enclosure S of the road, see Monument (6(b)), does not seem to be connected with the moat.R3, Moat, close to the N side of the main road, a quarter of a mile E of Tadlow Church. A rectangular area measuring 350ft by 175ft surrounded by a wet moat. The inclosed area is level and is for the most part under grass, though the former existence of a small house at the northern end has caused some disturbance here, and probably accounts for the filling up of some 100ft of the moat on the NW by the N corner. The moat averages 10ft in width and 3ft in depth, and NW side is prolonged SW for 400ft, being crossed by a modern road; the prolongation averages 10ft in width and is shallow and dry.

Slight remains of moats in the field beyond the road complete the general plan of an elongated Inclosure appendant to the main site on the SW side, with a further small site about 50ftsquare at the far end, but the relation of this appendage to the main site hardly constitutes a double moat, of the kind not uncommon in the county. On the 1750 Downing College map this site is called Batterborough. It was occupied by a farmstead and did not differ from its present form, except that the road did not exist.

O2, A dry homestead moat, 120 m by 70 m transversely, the arms 8 m wide and 1.5 deep. All traces of buildings have now been destroyed within the work and it is heavily overgrown with scrub. The NW arm is broken and was probably the site of the original entrance. A dry pond at TL/2833/4756 could be the remains of a well. The name 'Tadlow Manor House' not known locally. Published survey (25") revised.

R4, Shown as broken on both NW and SE sides. Immediately to NW of main enclosure is an L shaped wet ditch, of same width as moat, the foot of the L parallel with NW arm of moat and c 120ft long. Other arm of ditch c 200ft long. Two buildings within moat described as farm buildings.

O3, Recently channelled out and landscaped. R1. The chancel and nave are C13 by their lancet windows. The W tower must be perpendicular, also the W doorway, W window, and arch towards the nave. The church was restored by Butterfield in C19 (1860), the S and E windows of the chancel and the S porch date from this time. See Conservation Section. See also RN 02276a -? AS burial mound.

R2. Bell 3 of 3 - 15th century, founder H Jordan (London).

R3. The church stands on a spur of a chalk ridge at the N. end of the village. The fabric, consisting of chancel, aisleless nave, and W. tower, is of fieldstones and clunch witg dressings of freestone and clunch; the roofs are tiled. The chancel and nave are of the mid C13. A tower was added c.1400 to a partly corrected orientation, and sebsequently the S. side of the nave was refenestrated. At some unknown date prior to 1748 the chancel was shortened. There was a restoration in supervised by W. butterfield in 1860.

Fittings:

Bells: 3rd of three inscribed in black-letter 'Sancte Andrie Ora Pro Nobis', late medieval. Churchyard cross: Plain base only, limestone, 1 ft. 8 inchs square with square socket for shaft, medieval; said to have come from Church Farm, where it had been built into the farmhouse. of overlapping Door: То tower stair, planks, nail-studded, C16 or C17. Glass: A few late medieval fragments in tracery lights of second window on S. side of nave. Floor slab: In nave, white limestone much worn, which remains of incised female figure and marginal inscription, traces of bituman filling; it is that of Margaret, wife of William Brogriffe, 1493.

Plate: Includes and inscribed cup by Thomas Buttrell, c.1570; and paten with London marks for 1844.

Scratchings: Include, on N. respond of chancel arch 'i h c' and on S. respond 'i h c' twice and a cross upside down; on N. jamb of W. door 'Anno dni mcccccxvij' and beneath it, a nme, not readable.

Misc: A quantity of stonework loose in the churchyard, immediately W. of the approach path from the S., includes fragments with sub-classical mouldings, C16/C17; these were brought here in 1906 from a house at Clopton demolished in the 1905.

R1, Tadlow Towers consisted of a C18 prospect tower in red brick of 4 storeys, an internalchimney dwelling of the C17 or C18, and a C16 granary of plank-and-muntin construction with hipped tiled roof divided into 3 bays by tie-beam trusses. All were derelict and have recently been demolished.

R2. When the Tadlow Granary was dismantled, moved to Wandlebury, and repaired in 1971, dendrochronological samples were taken from the wood. The oak trees for the granary were probably felled c. 1415-25. The construction of the granary is probable to fall in or close to this period.

1. Cultivation remains (not on OS). Ridge and furrow with ridges 60yds to 170yds long, 7yds to 9yds wide and 9ins to1ft high, with headlands of 5yds to 8yds, remains around the village... At about TL/277-/475- a large field, called 'Great Cow Pasture' in 1750, has been cut by the later road and split into smaller fields; 27 straight ridges remain in the middle of the former large field. The remains in the S of the village aroundTL/282-/469- were formerly divided into 5 closes by ditches 10ftwide and 9ins deep. The traces of ridge and furrow visible on APs over most of the N of the parish are straight or slightly curved, and fit the existing field boundaries except along the stream. This parish apparently had 2 open fields in 1220 and these appear to have survived until the mid C17 (MA Postgate, 'The Open Fields of Cambs', unpublished thesis, Cambridge, 1964, 17 and 269), but the extents of these cannot now be established. By 1750 the entire parish was enclosed.

The walling again required extensive repairs in the 1960s, and in 1972 the spire, which was unstable, was dismantled and re-erected. The churchyard as closed c.1897, and a new cemetery was established N. of the road to Great Green.

There is an external bank along the E arm of the moat, cast 75cm up, and possibly dating to the same works noted in O1. In the S enclosure there is abraded building debris and pottery (including Medieval); in the field to the E is tile.

O4, Visited the site after completion of the extension to the stable. Building works extended some 0,70m only and affected the already altered profile of the moat's western arm. Minimal damage caused despite 2m deep foundations to building. Works unwatched so no archaeological report possible.
