ALTERATIONS TO RULES

At the Annual General Meeting held on 9 April 1983 the following alteration to the Rules of the Society was approved:

RULE 16 – Names of candidates for membership should be approved by Council who shall submit all approved applications to the members at the next General Meeting. No election shall be deemed complete until the candidate has paid his first year's subscription or compounded for life membership. If such payment has not been made within one calendar month after notice of election has been sent, the election may at the discretion of the Council be declared null and void.
