

## **Publications on Cumbrian History and Archaeology, 2015-16**

**T**HIS year we have decided to extend the range and number of publications listed and to include a supplement to the previous year's entries. We have also included articles published in *Transactions* in order to provide a comprehensive coverage.

The bibliography is arranged in four sections:

### **1. Books**

### **2. Chapters in books**

There should be sufficient information to be able to order these through good bookshops or online retailers. The publishers also have full listings on their websites. Some books should be in Cumbrian libraries or possibly available through inter-library loan.

### **3. Theses**

Recent theses are invariably being made available in digital form. These can be downloaded for free from the relevant university's eprint facility or through the British Library's EThOS: UK E-Theses Online Service <http://ethos.bl.uk/SearchResults.do>. You need to register with EThOS but there is no charge if the thesis is freely available (there is a charge for older theses, if not digitised). In some cases, access has been restricted until a specified date.

### **4. Journal articles**

Most of these are now available digitally through publishers' websites, for example Oxford University Press, Cambridge University Press and particularly Taylor and Francis. If you are registered with a higher education establishment, you should be able to access them for free. Otherwise, publishers offer either to sell individual articles or to provide a time-limited period of access (e.g. 24/48 hours; one month) during which you can download any articles of interest from current and back issues, so it is worth drawing up a full list of what you want before paying. A few are free.

To find the relevant publisher, type the article title into Google search engine in double inverted commas and it should provide a link to the relevant page on their website. You can then search that journal or the publisher's entire output.

For non-commercial organisations, such as ours, it will be necessary to go to their website or journal directly, e.g. *Local Historian* (published by the British Association for Local History, digitised with three year restriction); *Historic Society of Lancashire and Cheshire* (HSLC); *Garden History* (Gardens Trust). In some cases, individual issues of a journal can be bought for a reasonable price.

### Abbreviations

Titles of books and journals are given in full except for *Transactions of the Cumberland and Westmorland Antiquarian and Archaeological Society* which has been abbreviated to *CW3* followed by the relevant volume number and year, e.g. *CW3*, 16 (2016).
