

SUPPLEMENTARY DERBYSHIRE CLERGY LIST.

IN his well-known work the *Churches of Derbyshire*, 4 vols., 1875-9, the Rev. Dr. J. C. Cox gave lists of incumbents which for various reasons are incomplete. Mr. W. E. Godfrey (*D.A.J.*, Vols. LIII and LVI) published lists which supply some of these omissions and correct some mistakes in others. In perusing many papers in the *D.A.J.* and other published works and MSS. not then available to Dr. Cox, I have been able to compile the list that follows which gives many new names, corrects some errors and in many cases gives additional dates. The Every MSS. were kindly placed at my disposal by Sir Edward Every, Bart.

Dr. Cox drew many of his names from the Lichfield Episcopal Registers which since his day have been carefully transcribed and published by the Salt Society. I have worked through these volumes and also the *Magnum Registrum Album* (Salt Soc.) and it will be noticed that he missed many names and made errors in transcribing others. I am grateful to Mr. F. Williamson for drawing my attention to a clergy list for Derbyshire dated 1602-3 found by Dr. Cox among the County Council Muniments and published by him in his *Three Centuries of Derbyshire Annals*, 2 vols., 1890. This list fills many gaps in his *Churches* and corrects some errors. Almost all the Derbyshire parishes are included but Bakewell is an important omission, and

two parishes, Stanton-by-Dale and St. Michael's, Derby, are stated to be "void," whilst several others are noted as being served by curates although many of these curates were in reality vicars or rectors. Curates serving chapelries have not been included in the following list.

It is, of course, obvious that the following list does not fill all the gaps in Cox's *Churches*, but it is at least a step towards that end. There must be many unrecorded names scattered among the literature and MSS. of the county, and I shall be pleased to hear of any with a view to publication at some future date.

In D.A.J. LIII 31, Mr. W. E. Godfrey gives Ralf s. of Walter, priest, whereas the cartulary has 'Ranulphus filius Walteri presbiteri de Wirk'.

1276. Nicholas de Oxton, perpetual vicar (Darl.). He was party to an agreement with the canons of Darley Abbey regarding the tithes of Wigwell in the parish of Wirksworth where the canons had a grange, dated 12 Mar. 1276.

1359. Robert of Ireton, vicar (Darl.). He confirmed above agreement, 13 May 1359. Resigned 1362 when Robert de Spondon was appointed (Lich.).

1379. Thomas Castleton, perpetual vicar, granted leave of absence for one year, Sept. 1379 (Lich.).

1602-3. Michael Harrison, vicar, D.D. (Db.A. I, 251).

He held the living 1577-1608 (Cox IV, 521).

1660. Warrant for the presentation of John Burton, M.A., to the vicarage of Wirksworth dated 8 Sept. 1660 (S.P.D.). Burton, writing from Clowne on 13 Nov. 1660, to the secretary of the Secretary of State, Sir Ed. Nicholas, states that he has been deprived of the livings of Wigan and Wirksworth, and begs aid to recover one of them (S.P.D.).

It would not appear certain that he ever officiated as vicar of Wirksworth.

Cox III, 9, spells his name Sprysoe, but Bristowe is correct.

1365-6. William Prat', instituted Mar. 1365-6 in the person of his proxy William Rymour, vicar of Ashbourne, on the death of Robert le Glen (? Glover) (Lich.).

Cox III, 28, refers to Wm. Poymor and Robt. le Clere (? alias le Stone).

Mr. W. E. Godfrey, D.A.J. LIII, 31, quotes Jeayes 1347 shewing Roger de Brompton as rector in 1390. Roger de B. was instituted to the living of Bradley, Staffs, in 1380, at the presentation of Hugh, earl of Stafford (Lich.), whereas the presentation to Bradley, Derbyshire, was always in the hands of the deans of Lincoln. Thus this entry in all probability does not refer to Bradley, Derbyshire.

1383. John, son of Nicholas de Wymyngton, exchanged living of Dodleston with R. de S. Mar. 1383 (Lich.).
