### **1. INTRODUCTION**

#### 1.1 General

- 1.1.1 Heritage and Archaeological Research Practice Limited (HARP) were commissioned by Forth Property Management to carry out a programme of archaeological works at the location of a proposed extension to the rear of 2 Old Mill Lane, Edinburgh in order to fulfill an archaeological condition as part of planning consent (Centred 327325 670719). The works consisted of an archaeological watching brief to monitor ground breaking associated with the development. This report presents the findings of the watching brief.




Fig.1 Site Location Map

- 1.1.2 The development area is located in the garden to the rear of 2 Old Mill Lane in the Cameron Toll/Liberton area of Edinburgh (see Fig. 1). The site consisted of mainly concrete paving, a low garden wall and a small washhouse that was demolished prior to the construction of the extension.
- 1.1.3 Work was carried out between Wednesday 25<sup>th</sup> and Thursday 26<sup>th</sup> May 2012. The weather was fairly mixed and inclement.

#### 1.2 Background

- 1.2.1 There is potential for buried archaeological remains in the area due to the location of the site within the bounds of the historic settlement of Neither Liberton. The site lies within the historic limits of Neither Liberton, which has been recorded as far back as 1369.
- 1.2.2 Much of the post-medieval layout of the village still survives, centred upon the 18<sup>th</sup> century Neither Liberton House and Neither Liberton Mill (to the west & east of this site) and this layout can clearly be seen on both the 1853 1<sup>st</sup> Edition OS map and the earlier eighteenth century (c.1750) Military Survey by General Roy.

1.2.3 Whilst the scale of the development is small there is clearly a potential for buried archaeological remains within the development area.

#### 2. METHODOLOGY

#### 2.1 General

2.1.1 All work undertaken by HARP was conducted with regard to the Institute of Field Archaeologists' (IFA) *Standard and Guidance for an Archaeological Watching Brief* and *Code of Conduct*.

#### 2.2 Watching Brief Strategy

- 2.2.1 The Watching Brief was carried out under strict archaeological monitoring during the ground-breaking works associated with the foundations for the proposed extension in order to identify any potential buried archaeological remains. Foundation trenches were excavated to the rear of 2 Old Mill Lane and were 0.8m wide and up to 0.83m deep (see Figure 2 for trench locations). All ground-breaking that was carried out by aid of machine excavators was done so with a smooth-bladed ditching bucket to remove modern overburden, under constant archaeological supervision.
- 2.2.2 Any archaeological features such as linear features or pits uncovered were excavated by hand and recorded. Structural remains such as walls were cleaned and recorded by drawing and photography.
- 2.2.3 Bulk samples of any features of archaeological interest were taken in order to establish their likely date, nature, extent and condition. All such sample excavation was conducted by hand. Bulk samples consisted of a minimum of 10 litres, unless the feature was smaller than this, in which case a minimum of 50% of the feature was sampled.

2.2.4 All excavation and on-site recording was carried out according to standard HARP procedures, principally by drawing, by photography and by completing standard HARP record forms.

### **3. ARCHAEOLOGICAL RESULTS**

#### 3.1 General

- 3.1.1 A list of all archaeological contexts including descriptions can be found in Appendix 1. All Appendices are to be found in section 5.
- 3.1.2 All numbers in bold and parentheses in the following sections correspond to context numbers listed in the Appendices. Context numbers in rounded parentheses refer to deposits, whilst those in square parentheses refer to cuts for features.




Fig.3 - SE Facing Section Showing Transition from Garden Soil (005) to Rubble Deposit (002)

- 3.1.3 Excavation revealed two distinct deposit types within the garden, split into the north east and south west halves of the foundation trenches (Figure 2). The north eastern half consisted of a rich grey-brown garden soil (005) that contained occasional modern debris and pipes associated with the wash house that had been previously demolished. This generally continued to a depth of 0.4m deep. It overlay a dark brown silty clay subsoil layer (003) that continued to a depth of 0.3m. (003) overlay a mid orange-brown clayey sand natural (006) (see Figure 3).
- 3.1.4 The south western half of the foundation trench consisted of modern concrete paving (001) overlying a rubble bedding deposit (002) for the paving, whic consisted of small and medium stones with occasional bricks and mortar fragments. This deposit continued to a depth of 0.3m and overlay the garden soil (005) noted in the north eastern half of the foundation trench (see Figure 3).
- 3.1.5 The only feature of note uncovered during excavations was the foundations for a mortar bonded stone built wall (004) running north west to south east. The wall remains were 0.5m thick, 0.37m and three courses high and a length of 0.8m (see Plate 1), the remains continued beyond the edges of the

trench. The remains however were part of the foundations of the washhouse that had been demolished previously.

### 4. DISCUSSION AND CONCLUSIONS

#### 4.1 General

- 4.1.1 No archaeologically significant remains were uncovered during excavations at 2 Old Mill Lane. Deposits that were revealed consisted of garden soil and modern building remains. The only feature revealed were parts of the foundations of the modern washhouse that had been previously demolished.
- 4.1.2 No remains relating to the post-Medieval village of Neither Liberton were revealed, however it must be noted that the nature of the excavations were small scale and localised.






Fig.4 - SW Elevation of Wash House Foundations (004)
