1 INTRODUCTION

- 1.1 This report, prepared by RSK Environment Ltd (RSK) on behalf of Mr P. Walton, is a Level 2 historic building record, for a 'combination barn' at 2 Lodge Lane, Cronton, Merseyside, postcode WA8 4QA (hereafter 'the site'/'the barn'); National Grid Reference (NGR 348870, 388078), see Figure 1.
- 1.2 Planning consent **16**/**00563**/**PDC** was granted by Knowsley Borough Council for the 'Change of use of an agricultural barn to form 1(No.) four bed dwelling and associated development'. Condition 6 placed on the permission required the implementation of the programme of recording, stating:

The site is identified as a site of archaeological interest; the proposal does not identify any enabling works in connection with the proposal permitted which would lead to any disturbance or removal of deposits at or below ground level which are likely to damage archaeological remains.

Notwithstanding the details of the proposal no below ground works shall take place until the implementation of a programme of archaeological work in accordance with a written scheme of investigation submitted to and approved by the Local Planning Authority has been secured.

The development shall only take place in accordance with the detailed scheme so approved. Any archaeological works shall be carried out by a suitably qualified investigating body approved in writing by the Local Planning Authority.

- 1.3 Consultation undertaken with the Merseyside Environmental Advisory Service (MEAS) Planning Archaeologist has confirmed that a Historic England Level 2 Building Record¹ is deemed necessary, as the building is recorded as a stable [sic] on the Merseyside Historic Environment Record as a non-designated heritage asset (MME 7112). (See Part 2).
- 1.4 A written scheme of investigation for the recording (RSK, February 2018) was submitted to and approved by MEAS. The recording was undertaken in accordance with the WSI by RSK in March 2018.
- 1.5 RSK is a Registered Organisation with the Chartered Institute for Archaeologists (ClfA). RSK's work is undertaken to the highest professional standards: This document has been prepared with reference to *Understanding Historic Buildings, A Guide to Good Recording Practice* (Historic England, 2016), *Photographing Historic Buildings* (Cole, 2017), *Digital Image Capture and Storage: Guidelines for Best Practice* (Historic England, 2015) and ClfA's *Standards and Guidance for Archaeological Investigation and Recording of Standing Buildings or Structures* (2014) and *Code of Conduct* (2014).

2 SITE LOCATION AND DESCRIPTION

- 2.1 The site is located at 2 Lodge Lane, Cronton, Merseyside, postcode WA8 4QA; National Grid Reference (NGR 348870, 388078), see Figure 1.
- 2.2 Lodge Lane is named for Caxton Lodge, to which the barn belongs. Caxton Lodge is located 30 m to the north west of the barn. The barn is orientated NE-SW with Lodge Lane, which runs directly adjacent to the south. Lodge Lane runs between Cronton Road (A5080) and Stockwell Road / Northern Lane.




Figure 2: Location of existing buildings within and immediately beyond the planning application boundary

- 2.3 The plot comprises the lodge (converted to a farmhouse) and barn (the subject of this report), outbuildings (remnants of a larger range) in the yard, and a shed located to the north east of the lodge. Within the planning site boundary comprises the barn and the outbuilding remnants only, along with a cobbled forecourt in between (to the north west of the barn) (Figure 2).
- 2.4 Easterly along Lodge Lane are two large new agricultural buildings but otherwise the lodge is surrounded by open arable fields.

- 2.5 The general site area site is identified by MEAS as a site of archaeological interest as it contains two built non-designated assets which are listed on the Merseyside Historic Environment Record (HER).
 - Caxton Lodge (MME7110)
- 2.6 Cement rendered with ornamental quoins. Caxton Lodge is now used as a farmhouse. There are altogether about 24 rooms in the house. Interpreted as a probable 19th century replacement of an 18th century house.
- 2.7 E. Baines' *History of Lancashire* (1836, 719) states that the house was built by Fisher but doesn't give a date; however, given that Fisher was Baines' publisher, this is likely to be correct.
 - Shippon at Caxton Lodge (MME7112)
- 2.8 Interpreted as a cattle shed, the barn is described as a brick range with a cart shed integrated into northern end and a cobbled forecourt to northwest.



3 AIMS, OBJECTIVES AND METHODOLOGY

- 3.1 The aim of the programme of historic building recording was to create a record of the barn prior to alteration, in fulfilment of Condition 6 placed on permission for redevelopment of the site.
- 3.2 In order to achieve this aim, the specific objective was to produce a Level 2 historic building record of the structure, to the satisfaction of the local planning authority.
- 3.3 A historic building record ensures long-term preservation by record of a standing structure, and is carried out to inform a management strategy or heritage statement, or by way of mitigation to offset a development impact.
- 3.4 A Level 2 historic building record is defined by Historic England as:

"a **descriptive** record, made in similar circumstances to Level 1 but when more information is needed. It may be made of a building which is judged not to require a more detailed record, or it may serve to gather data for a wider project. Both the exterior and interior of the building will be seen, described and photographed. The examination of the building will produce an analysis of its development and use and the record will include the conclusions reached, but it will not discuss in detail the evidence on which this analysis is based. A plan and sometimes other drawings may be made but the drawn record will normally not be comprehensive and may be tailored to the scope of a wider project."²

- 3.5 The objectives of the works were therefore as follows:
 - To present annotated drawings using existing elevations and plans submitted as part of the planning application, with any phasing depicted in differential shading;
 - To view, describe and photograph the building materials and construction information for both the interior and exterior of the buildings, including any structural detail, architectural decorations or small-scale functional detail; and
 - To present conclusions regarding the buildings' development and use, including any interaction between groups of buildings.
- 3.6 The historic building recording was undertaken in accordance with the methodology described in the approved Written Scheme of Investigation (RSK 2017; not reproduced). There were no deviations from the specification.
- 3.7 The camera used for the survey was a Nikon DSLR; files were collected as 24 MegaPixel JPEG and Nikon RAW. A Go Pro Hero 5 mounted on a telescopic pole was utilised for elevated shots of areas of the barn that would not otherwise have been accessed. Go Pro shots are 10 MegaPixel JPEG (no RAW format available).
- 3.8 The site recording was undertaken on 9th March 2018.
- 3.9 The archives consulted as part of this survey/report were Liverpool Archives, Liverpool Central Library; Lancashire Archives, Preston and Kirkby ARK.

4 HISTORICAL BACKGROUND

- 4.1 The archives consulted to compile this section comprised Liverpool Archives, Liverpool Central Library; Lancashire Archives, Preston and Kirkby ARK.
- 4.2 The site lies on the western fringe of the hamlet of Cronton Smithies, one of two nucleated centres in the township of Cronton which is considered likely to have begun in the later post-medieval period as a subsidiary to the main settlement at Cronton Town End to the North (Cowell 2002, 137).
- 4.3 Although the placename is of Anglo-Saxon origin, Cronton is not mentioned in the Domesday Survey (ibid, 126).
- 4.4 The following sections reference Farrer and Brownbill (1906):
- 4.5 In the 12th and 13th centuries Cronton formed part of the Widnes barony, but in about 1250 the township was given by Edmund de Lacy to Stanlaw Abbey, with all his land and rights there, including a mill on Pex Hill.
- 4.6 The abbot of Stanlaw proceeded to make improvements of the waste but otherwise little is known of the internal management of the township. Towards the middle of the fourteenth century the abbot was involved in various boundary disputes with his neighbours in Rainhill, and Upton in Widnes, though the present site is unlikely to be mentioned or identifiable in these.
- 4.7 After the suppression of Stanlaw Abbey Cronton was, with other monastic manors, sold to Thomas Holt of Gristlehurst and the manor is mentioned in a family settlement of 1578 as part of the property of Francis Holt. Holt sold on the manor in 1587 to Thomas Brooke who shortly afterwards re-sold to it to Thomas Ireland, from whom it passed in 1598 to James Pemberton of Halsnead in Whiston. There were 20 messuages in the manor in 1587.
- During the 16th and 17th centuries a number of freeholders (names include Hawarden, Parr, Gleast, Burgess, Gresse, Wright, Lawton, Parte, Norman, Deane, Orme, Whike, Linacre, Windle and Stock) in Cronton held land by knight's service, their tenure probably arising from purchases from the Holt and Pemberton families. John Atherton was the principal contributor to the land tax in 1785. The Wright family '...are said to have possessed the hall of Cronton for generations...', but in 1821 they sold it to Bartholomew Bretherton of Rainhill and the family continued to own the house until well into the 20th century, though no manorial rights were attached.
- 4.9 Henry Fisher set-up Caxton press in 1818 so the name on the Greenwood map is unlikely to be any earlier³. Fisher died in 1838 when tenant took over the house.

Historic Mapping

4.10 The property is shown on Yates' map of 1786, although the lodge and barn are not differentiated so it is unclear whether the barn was constructed by this date (Figure 3).

4.11 By the time of the survey for Greenwood's map of 1818 the site was labelled as 'Saxton Lodge', and the two separate buildings are indicated at the site (Figure 4). The dimensions and layout are such that one of the buildings potentially represents the barn

4.12 Hennet's map of 1829 shows the same information as Greenwood's map, with slightly more detail in the surrounding area (Figure 5). The site was named 'Caxton Lodge' by this date.




Figure 6. Cronton Tithe map (1843)

4.13 The lodge and barn are each clearly indicated on the Cronton Tithe map of 1843 (Figure 6) and according to its apportionment, the 'House and Garden' at Plot No. 219 was owned by Jonas Dixon and occupied by Joseph Holland.




Figure 7. 1893 1:2500 Ordnance Survey




Figure 8. 1927 1:2500 Ordnance Survey






Figure 9. 1990 1:10,000 Ordnance Survey

- 4.14 The historic Ordnance Survey (OS) sequence illustrates the development of the site throughout the later historic and modern period.
- 4.15 The 1893 1:2500 OS (Figure 7) shows that the range of outbuildings facing the barn across from the cobbled yard were constructed in the later 19th century, and comprised nine units/spaces. Only two of these remain.
- 4.16 The 1927 1:2500 OS (Figure 8) illustrates that by this date two large buildings were constructed to the east end of the yard, one of which abutted the eastern gable of the barn. The 1959 1:2500 OS (not reproduced) suggests that both of these buildings were open-sided barns.
- 4.17 The 1990 1:10,000 OS (Figure 9) illustrates that by this date the open sided barns had been removed, along with the eastern outbuildings.

Historical Photographs

4.18 The Merseyside HER hold 3(No.) historic images of the barn. These are black and white but not believed to be of great antiquity. They have been reviewed as part of this assessment but do not show any detail that is not evident by modern inspection, other than that guttering and downpipes (now UPVC) were apparently originally cast iron. The photographs have not been reproduced here due to copyright.



Census Data

- 4.19 **1841** Caxton Lodge occupied by Joseph Whitfield, Farmer aged 60. Other occupants were Samuel (20), John (20), Elizabeth (15), Sarah (15) and Agnes (10) Whitfield, presumably his children.
- 4.20 **1861** Caxton Lodge occupied by George Lunt, Farmer (61), Amy (?) Lunt, Wife (61), Martha Lunt (20/6) Ann Hartley (21), maid of all work(?), Thomas Atheston(?), carter (20), Richard Littlehouse(?), carter (21).
- 4.21 **1871** Caxton (mis-spelled on DB as Carton) Lodge, Stock Lane James Cook, Farmer 29, Margret Cook, Wife (27) Sarah Rimmer, servant 76? Thomas Gibson(?), farm servant (24).
- 4.22 **1881** Caxton Lodge James Cook Farmer (38) Mary Cook, Wife (28), James (15) months, Robert Glover cousin Farm Servant (14), Jane Nocturn(?) (18) General Servant, Illegible (50) Farm Servant.
- 4.23 **1911** Caxton (mis-spelled on DB as Carton) Lodge occupied by Mary Cook, Widow Farmer (59), James (31), Ellen (29), Thomas (27), George (24), Arthur (22), Jessie (18), John Glover, Brother (54) worker George Brimilow, nephew (30) worker.

Leases

4.24 Several post medieval leases relating to properties in Cronton have been traced, though none could be related to the site, most seem to be in relation to the Wright family and Cronton Hall.










Figure 10: Plans with shaded phasing TOP – first floor BOTTOM – ground floor




Figure 11: Elevations with brick/sandstone detailing outlined. ID blocked doors and windows discussed in text TOP LEFT – North East Elevation

6 SURVEY

Plans and elevations of the building are included in Section 5 (Figures 10 and 11). All photos referred to in the text are included in Appendix 1.

Context

- 6.2 Caxton Lodge and the barn which is the subject of this report are located on the west side of Lodge Lane at its northern end (photos 01 & 02).
- 6.3 The barn is presently separated from the grounds of the house by a wooden fence and a single storey brick outbuilding which is superficially the same date as the barn. The line now taken by the fence was once occupied by a now demolished range of small sheds in the mid-19th century for which the only evidence is now the stub of a wall projecting from the south elevation of the outhouse (Photos 03 & 04) (see also Figures 7 & 8). Two of nine former outbuildings remain. It is likely that the barn, outbuilding and sheds were constructed together and that whilst they were part of the grounds of Caxton Lodge, they were always intended as a discrete entity from the house.
- 6.4 The barn fronts directly on to Lodge Lane to the east. Generally, the site has a very open aspect to the north, east and south, though the barn is sheltered from the west by the grounds of Caxton Lodge.

Description and Phasing

- 6.5 The barn is of a single phase of construction but has been extensively modified throughout its use. Openings have been blocked, or historically modified before being blocked; these are labelled on Figure 10 and discussed below.
- 6.6 The barn is a single bay building constructed in unfrogged(?) hand-made brick using a bond of four courses of stretchers between header courses (American or Common Bond) on all elevations. The brickwork is bonded with pale cream lime mortar, though there is extensive 20th century repointing in Portland Cement on all elevations.
- The roof is clad in corrugated asbestos sheeting with asbestos barge boards which is a 20th century replacement of the original (probably Welsh slate) roofing material. The roof rests (rather than is tied in) to the original gable walls, the tops of which are partially collapsed and in poor condition (Photo 017).
- 6.8 The floors in Rooms 1 and 2 are 20th century concrete, which may overlay an earlier floor. Flooring to Rooms 3 and 4 is stone slab/cobbles (Photo 024).
- 6.9 Roof trusses (T1 & T2) in Room 1 and Room 2 have been severely charred by fire obscuring all detail (Photo 012) and are composed of a tie beam with king post and struts. The roof timbers are supported with timbers built into the internal brickwork (Photo 018).
- 6.10 All guttering and downpipes are UPVC replacements of the originals which would have been in cast iron.



Exterior

- 6.11 The brickwork rests upon a red sandstone ashlar plinth which is visible on the southern, western and eastern elevations. The plinth cannot be seen on the northern elevation; this may be because the ground level slopes down to the south and the foundations may have been cut more deeply, or else it is obscured by later build-up of ground surfaces in that area. The eastern and western elevations are capped by a course of dressed red sandstone.
- The northern and southern corners are chamfered, with stops at first floor level created with north western and sandstone corbels (Photo 06).

North East Elevation

- 6.13 The north east elevation is the simplest, the only openings being a series of 5(No.) evenly-spaced and distributed breathers formed by omitting alternate headers in a diamond pattern (3 over 2 over 1) at first floor level only.
- 6.14 A vertical series of missing bricks down the NW corner edge (Photo 005) indicates a demolished wall of the open-sided barn depicted on the 1927 OS mapping (removed by 1990).

South East Elevation

- The south east elevation fronts onto Lodge Lane and has been extensively modified by the blocking and alteration of openings (Photo 07). Three diamond pattern breathers are situated at first floor level, which unlike at the north east gable are inserted more randomly, where there is space between openings.
- 6.16 D1 is located at the northern end of the building and is blocked with corrugated steel sheeting. It is capped by 20th century RSJ in replacement of the original segmental arch which would have mirrored that on D6 on the north western elevation. The brickwork above D1 has been replaced in 20th century brick; the whole wall above this opening evidently collapsed to eaves level at some time.
- 6.17 Doors D2 and D4 and window W3 are blocked in 20th brick/concrete block but retains their red sandstone lintel in each case; door D3 has been similarly blocked and its lintel removed, the outline of the lintel being visible as a change in the brickwork.
- 6.18 Window W5 is a small opening capped by a timber lintel with a concrete sill and is probably a later insertion.
- 6.19 The sequence of blocking around door D5 is more complex (Photo 019), a gap in the sandstone plinth course shows that this was originally a wide door, similar to D1, 3.3 m wide and 2.5 m high, capped by a timber lintel. It would have been for a vehicle rather than pedestrian. This was subsequently modified by clocking to create pedestrian door D5 and window W6, the form of the brickwork suggests that this occurred in the mid-20th century. W6 re-used a red sandstone sill, possibly removed from and other part of the building. W6 and D5 were themselves blocked in the later 20th century with modern brick/concrete block.
- 6.20 Windows W1, W2 and W4 are all at first floor level, though only W1 retains its sandstone lintel. Windows W2 and W4 had had their lintels removed. W4's has been



- replaced with a wooden beam, though their outline can still be seen in the brickwork blocking these openings.
- 6.21 A blind segmental arch at first floor level of the southern end of this elevation does not appear to relate to an opening and is probably a relieving arch (Photo 019).

South Western Elevation

- The south western elevation (Photo 008) has evidence of two openings. Door D11 was 2.43 m wide and 3.1 m high and was originally capped by a segmental brick arch. This coincides with a gap in plinth course, indicating it was an original opening. It would have been for a vehicle rather than pedestrian. It has at least two phases of late 20th century blocking in brick and concrete block, topped with a replacement wooden beam.
- 6.23 Blocked window W13 at first floor level has lost both its lintel and sill, its outline being visible as a change in the brickwork.
- 6.24 The wall incorporates two through-drains, apparently ceramic land drains inserted through the wall from the base of the first floor level, probably to allow leaking rainwater from the interior to drain from the hay loft naturally.

North Western Elevation

- 6.25 The north western elevation (Photo 009) faces towards the grounds of Caxton Lodge.
- 6.26 Three breathers (diamond pattern, 3 over 2 over 1) are situated at first floor level, inserted randomly between existing openings (although they are mirrored on the south eastern elevation).
- 6.27 Door D6 at the northern end mirrors D1 in the eastern elevation and retains its original segmental brick arch (Photo 020). It is blocked in concrete block.
- Door D7 remains open and has a modern UPVC door and frame below a red sandstone lintel. Within this is a two part timber door. Doors D8 and D9 have been blocked with late 20th century brickwork/concrete block and the original lintel above D8 removed. All of these doors have worn red sandstones steps at their base (Photo 021).
- 6.29 Window W10 is blocked with 20th century brickwork but retains its sandstone lintel which is in a different form to the others and there is no sill, so this may be a later insertion. Window W11 is identical in form to W5 on the eastern elevation and may also be a later insert. Window W12 is a small blocked opening capped by a segmental arch.
- 6.30 Windows W7 and W8 remain open and have replacement concrete lintels and sill and UPVC frames. W9 is blocked and has red sandstone lintels and sills.
- 6.31 Door D10 is at first floor level at the southern end and would have provided external access directly to the internal 1st floor loft ('Room 5') for loading. The original sandstone lintel has been replaced in timber and it is blocked in concrete block (Photo 022).

Interior

6.32 The interior is composed of five spaces: two large full-height spaces at ground/first floor levels, two smaller spaces at the southern end of the ground floor with one corresponding smaller space at first floor directly above.



Ground Floor

- Room 1 at the northern end of the building is open to the full height of the building. Room 1 is the 'integrated cart shed' reported in the HER Entry, accessed by full height/width vehicle openings in either end (doors D1 and D6). It is separated from Room 2 by a partition wall. The only original feature is a badly charred wooden fixture built directly into this wall (Photo 023). The doorway is 3.60 m wide and c. 4 m high and capped by a 20th century RSJ. This is clearly a modification of the original because it truncates an earlier, smaller opening (Photo 010).
- 6.34 Room 2 occupies the central section of the building and is also open to full height. There is a small wall stub (which appears to have been cut), and a corresponding gap in the concrete floor suggests Room 2 was previously divided into two smaller rooms (Photo 018). For the HER entry to identify an integrated cart shed to the north suggests that this was the only full height room at the time of survey, and as such the wall may have been cut to create a full height Room 2 since 1977.
- 6.35 The western and eastern walls retain evidence for the floor joists to the former loft (Photo 011). The height of the wall stub suggests this was a ground floor only and the former 1st floor above Room 2 would have been a single large (ventilated hay) loft. If there was ever an internal access point to the first floor Room 2 loft, the method/location has been lost. This could have been via the opening preserved above the RSJ beam from the Room 1 cart shed, via a hole in the floor in Room 2.
- 6.36 Rooms 3 and 4 at ground floor level were accessed by separate doors from Room 2 (Photo 017). There is no direct access between Rooms 3 and 4.
- Room 3 is situated in the south-western corner of the ground floor, although now open to roof level, door D10 shows that originally it would have been capped by a ceiling with a further room above ('Room 5'). The floor surface has collapsed but would have been wooden. An internal chimney is located in the north western corner (Photo 013); this survives to the full height of the elevation but has been sealed over by the modern replacement roof. There is no associated fireplace and the chimney may have served a stove.
- 6.38 Room 4 is to the east and has white washed walls (Photo 025). The roof beams (Baltic Pine or similar) exhibit tooling and peg scars and may have been reused (Photo 014).

First Floor (Loft)

6.39 Safe access could not be gained to Room 5 though remote investigation by camera suggests that no significant features are present (Photo 016). Room 5 would have been accessed internally from the former first floor of Room 2 (Photo 017) or via an internal ladder (not surviving). The remaining part of the floor in Room 5 is wooden and likely original.



7 DISCUSSION

Date of Construction

- 7.1 Caxton Lodge is interpreted as a 19th century replacement of an 18th century house as it is indicated on 18th century mapping (see Figure 3), but the architecture is 19th century. The mapping cannot be used to infer the reconstruction date. The owner at the time of the HER survey (c. 1977 2011) suggested a construction date for Caxton Lodge of c. 1805, whereas the HER suggests a mid late 19th century construction date.
- 7.2 The barn is shown as a separate building to the lodge on mapping dating from 1818, however the earlier 18th century mapping is not clear, possibly representing the farm (lodge and barn) as a whole. Based on style, therefore, the barn is most likely contemporary with the reconstruction of Caxton Lodge. The reconstruction of Caxton Lodge therefore suggests that the barn may have been reconstructed on earlier foundations also. There is certainly evidence for the reuse of materials in the barn. The suggested date of construction in the HER for the barn is early 19th century. There is no evidence in the observed fabric of the barn to conclusively prove the date of construction.

Function

- 7.3 Interpreted as a shippon (cattle shed) by the Merseyside HER, and a stable range by the Archaeology Data Service⁴, the building is in fact a conventional Lancashire combination barn⁵. There is no evidence for the internal layout of stalls, so stable may not be correct. The size of the openings is consistent with allowing cattle into the building, so it was likely used as a shippon.
- 7.4 The building definitely had a first floor which would have been used for storage of hay, there are joist holes internally and the diamond pattern breathers are all at loft level.
- 7.5 Doors D1 and D6 would have provided access for carts bringing crops and or fodder for processing and storage, probably in a first floor loft which has been removed from the area above Room 2.
- 7.6 The current owner has suggested that historically one of the small rooms at the back of the barn was traditionally lived by Irish agricultural labourers, so could even be classified as a dwelling during this period in the barn's history. Whilst this is not reflected in any archive/census sources, this survey has identified the presence of a chimney probably serving a stove in 'Room 3' and therefore supports this theory.
- 7.7 Over its use-life the barn may have operated under numerous functions but was probably primarily used as a cow house with fodder/crop processing and storage areas, therefore combination barn is an appropriate descriptor.

8 CONCLUSIONS

Significance

- 8.1 The barn, generally in poor condition, has been extensively modified in the 20th century and retains few original fixtures.
- 8.2 The barn is considered to be of local significance.

Conclusion

- 8.3 This report describes the results of a level 2 historic building record. The survey was successfully undertaken in accordance with the approved written scheme of investigation, in fulfilment of the requirements of planning condition 6 placed on permission for redevelopment of the building.
- 8.4 The farm is typical of smallholdings in the southern Lancashire plain and the barn is a typical example of an early 19th century combination barn, used as a shippon and for the storage and processing of crops, found in the area from the late 18th century onwards.
- 8.5 The date at which the barn was constructed could not be determined, though 1800-1830 is a likely range. Map evidence suggests that it may have been constructed on the site of an earlier structure.





Figure 12. Photo Location Plan 1








