

Non-technical summary

Archaeology Wales Ltd carried out a desk based assessment, visual impact assessment and geophysical survey in October 2016 on land at Rocks Green, Ludlow, Shropshire, prior to the proposed construction of a new residential development with parking, access, landscaping and associated infrastructure. The aim of the work was to identify the presence or absence of archaeological features located within the assessment area.

The assessment area lies to the east of the town of Ludlow in an area of open fields currently in use as grazing land. The desk based assessment demonstrates that its use as agricultural land dates back at least the 19th century and likely into the medieval period. A small area of medieval ridge and furrow cultivation in Field 3 represents the only feature of archaeological significance located by the desk based assessment within the development area. However, the assessment records archaeological features located immediately to the south of Field 4, which were identified by the transcription of Aerial Photographs in 1978.

The visual impact assessment on settings of Designated Heritage Assets concludes that the Scheduled Ancient Monument of St Julian's Well, the Grade II Listed Building at 94 Grave Hill, and the Grade II Registered Hanley Park, are all considered of High Importance. However, the settings of these heritage assets can be considered of **minor** risk of impact due to the lack of mutual visibility between them and the development site, with no further mitigation required.

Most of the non-designated heritage assets within the 0.5km radius from site have similar or inter-related settings. The land plot of the new development site is not currently visible from these settings, but the new dwellings probably will be. Most of the settings of the non-designated heritage assets will be visible from the development site. The setting impacts range from neutral to major.

The Geophysical Survey of Fields 1 and 3 shows a low density of features of indeterminate function. Field 2 has negative results. Field 4 does not show conclusive results, possibly as a result of soil importation undertaken during the construction of the A49 Ludlow bypass. It was, therefore, not possible to say whether the archaeological features identified by the desk-based assessment as lying immediately to the south of the development area, continued into Field 4.

The negative physical impact during the construction phase for the proposed development could be mitigated by a programme of archaeological work. A trenched evaluation is recommended prior to groundworks commencing. Targeted trenching has the potential to help better understand the features identified by the geophysical survey in Fields 1 and 3, and also, possibly, in Field 4, although the depth of possible imported soil here is unknown.

1. Introduction

In October 2016 Archaeology Wales Ltd was commissioned by J. Ross Developments Ltd, to conduct an archaeological desk based assessment and geophysical survey on

land at Rocks Green, Ludlow, Shropshire (NGR SO 52480 75580 Fig. 1) prior to the submission of a planning application for the construction of 200 houses with associated landscaping, access and infrastructure. The aim of the work was to identify the presence or absence of any archaeological features within the assessment area which may be impacted upon by the proposed development.

An archaeological scoping response to the proposed development was prepared by Hugh Hannaford, Shropshire Council – Historic Environment Team (SCC-HET). The scoping was used by Archaeology Wales Ltd (AW) to draw up a specification (Appendix 3) for the required archaeological work which was subsequently approved by SCC-HET.

2. Site Description

2.1 Location, Topography, Geology

The assessment area is located at NGR SO 52480 75580 to the north-east of the A49 and the south-east of the A4117 on land at Rocks Green, approximately 700m to the north-east of the town of Ludlow, Shropshire. The site, currently in use as grazing pasture, comprises four fields and a total of 119,000m² (Fig 2).

The site is gently undulating in surface profile with land falling away gently towards the south east from a height of 130m OD to approximately 115m OD.

A small building complex, Rock Green Terrace and the Nelson Inn, is present adjacent to the north-west of the site boundary.

The underlying solid geology of the assessment area is composed of limestone in the Ludlow series from the Silurian era. The subsoils covering the assessment area are described as freely draining, loamy, floodplain soils with shallow groundwater tables (BGS 2016; Soilscapes 2016).

3. Archaeological Background

3.1 Historical Background

There is little evidence for early occupation on the site of Ludlow. The placename and medieval documentary evidence suggests the existence of a Bronze Age barrow on the site of the church (Gelling, 1990), and there is an important Bronze Age cemetery at Bromfield, a few miles north of the town. A number of flint flakes and a Neolithic stone axe fragments have been recovered from the general area of the town. It has also been suggested that two prehistoric routeways met at Corve Bridge, comprising the east-west "Clun-Clee ridgeway" and a north-south route reflected by the line of Corve Street and Old Street (Lloyd and Klein, 1984). This second routeway is believed to

have been aligned on a ford over the River Teme, and may have been followed by a Roman road.

The town is not mentioned in the Domesday Book of 1086. The construction of Ludlow Castle commenced between 1086 and 1094 and by 1138 the placename 'Lodelow' was in use.

Medieval Ludlow had over 500 burgage plots, which were clustered around the large spaces occupied by the castle and the parish church. The sequence of planning phases responsible for the medieval development of Ludlow, whilst a matter of speculation, clearly includes the burgaging of areas outside of the town walls (Such as along Old Street). In 1377 Ludlow had a tax paying population of 1172 and ranked as the 33rd largest provincial town in England.

The assessment area is located away from the centre of Ludlow within the adjoining parish of Stanton Lacy. During the medieval period, land use within the assessment area is likely to have been largely agricultural. Lloyd (1999) states that "Cultivation took place on 'the open fields of Ludlow' which stretched as far as Prior's Halton in the west, Stanton Lacy in the north, Rock in the east and Overton in the south", thus encompassing the assessment area. Faraday (1991) also makes reference to common pasture at Rock in the later 13th century.

Excavations in 1975, carried out in advance of the construction of the A49 trunk road to the immediate south-west of the assessment area, recovered a small Bronze Age beaker assemblage associated with a hearth as well as a likely Romano-British rectilinear ditched enclosure.

The archaeological and historical background is covered in greater detail within the desk based assessment section of this report.

4. Aims and Objectives

4.1 Desk Based Assessment and Heritage Impact Assessment

The assessment was undertaken to:

- Gain an understanding of the history of land use within the assessment area and locate any readily identifiable archaeological features
- To place the results of their work in their historic context
- Assess the likely visual impact of the proposed development
- To aid and inform any further stages of archaeological work deemed necessary

4.2 Geophysical Survey

The geophysical survey was undertaken to:

- Locate any archaeological features which may be present within the assessment area
- Highlight any archaeological material which may be affected by the proposed scheme with reference to its character, distribution, extent and relative significance.

5. Methodology

5.1 Desk Based Assessment

As part of the desk based assessment, the following repositories were searched for readily available information pertaining to the area of proposed development and its immediate surroundings.

- A search of the regional HER (Shropshire) database for the locations of all known archaeology (Monuments, Events) within a 1km radius of the assessment area boundary
- Aerial photographic coverage held by the Cambridge University Collection of Aerial Photography (CUCAP) and transcriptions within the regional HER (Shropshire).
- The County Archives for all readily available historic mapping covering the assessment area as well as published articles pertaining to the site.

All works were undertaken in accordance with the CIfA's *Standards and Guidance: For an Archaeological Desk Based Assessment* (2014) and current Health and Safety legislation.

A site walkover was also carried out as part of the desk based assessment in order to locate any visibly extant archaeological features apparent within the assessment area. Any visible features were noted, their locations within the assessment area recorded and were photographed using a high resolution (20mp+) digital camera.

The site walkover and desk based assessment were carried out by Chris E Smith MCIfA of AW under the overall management of Kate Pitt ACIfA (AW). The assessment of visual impacts on setting was carried out by Auri Zamora (AW).

5.2 Visual Impact Assessment

The Heritage Impact Assessment included an assessment of the potential impacts on the settings of designated heritage assets within a 1km radius of the site and nondesignated heritage assets within a 0.5km radius of the site. In this case, the radius was from the centre of the site, but did include the Grade II registered park just outside this 1km radius. The work complied with the guidance provided in Historic England's 'Historic Environment Good Practice Advice in Planning Note 3: The Setting of Heritage Assets'. The Heritage Assessment also made recommendations for any proposals to mitigate direct impacts on the archaeological interest of the proposed development site itself.

5.2.1 Visual Impact Analysis

The methodology will consider the Zone of Theoretical Visibility (ZTV) in order to define the area from which the development may potentially be visible by reference to surrounding topography. The scale and severity of impacts upon heritage assets will be assessed in accordance with *The Setting of Heritage Assets* (Historic England, 2015) and the *Design Manual for Roads and Bridges* (DMRB, 2007).

5.2.2 Assessment of the Significance of a Heritage Asset

In order to understand the effect of the proposed scheme upon a heritage asset, these assets have been individually assessed in relation to statutory designations and the regional research agenda. The value of the heritage assets have been defined using the following grades: Very High, High, Medium, Low, Negligible and Unknown. The criteria for defining the importance of an asset are in the following table:

5.2.3 The Significance of the Setting of a Heritage Asset

The setting of a heritage asset relates its immediate surroundings and the extended views of the asset. Setting embraces all of the surroundings from which the heritage asset can be experienced, or that can be experienced from the asset. The setting takes into account views from, towards and through the asset. It should be noted that the

contribution that setting makes to the significance of an asset does not depend on ownership or public access to experience that setting.

The value of setting for a heritage asset has been assessed by considering the importance of that asset, as defined by the criteria set out in Table 1. The degree to which the setting contributes to the understanding or appreciation of the asset has been determined according to the extent that the surroundings complement the location and appearance of an asset. The overall value of the setting of an asset has been assessed as a function of the importance of an asset and the significance of its setting.

5.2.4 Assessment of Impact of the Proposed Development

The impacts considered for the proposed development significantly include the physical impact within the footprint of the site, and the visual impact upon the setting of surrounding monuments or the change in view from those assets.

In order to assess the visual impact of the scheme, all heritage assets have been considered within the Zone of Theoretical Visibility (ZTV) of the development site. The ZTV has been used to define the area from which an asset may be totally or partially visible by reference to surrounding topography. According to specification drawn by SCC-Historic Environment Archaeology Service, a Visual Impact Assessment was undertaken for all the Setting of Designated Heritage Asset within 1km radius of the site, and all the Setting of Non-designated Heritage Asset within 0.5km radius of the site. This element should comply with the guidance provided in the guideline 'Historic Environment Good Practice Advice in Planning Note 3: The Setting of Heritage Assets' (Historic England 2015).

5.3 Geophysical Survey

A Bartington Grad601 gradiometer was used to undertake the survey. Previous research has shown that fired, or cut and backfilled archaeological features such as kilns and hearths, ditches and pits often have an anomalously higher magnetic susceptibility than the surrounding subsoil due to burning and biological processes. Differences in magnetic susceptibility within the subsoil and archaeological features can be detected as changing magnetic flux by an instrument such as a gradiometer. Data from this may be mapped at closely spaced regular intervals, to produce an image that may be interpreted to locate buried archaeological features (Clark 1997; Aspinall et al 2011).

Detailed survey was carried out in grids of 30m x 30m along parallel traverses spaced at 1m intervals, recording data points spaced at 0.25m intervals to a maximum instrument sensitivity of 0.1nT in accordance with English Heritage Guidelines. The survey mode was set to bi-directional (traverses walked alternately south-north/north-south). At regular intervals the data was downloaded in the field onto a laptop computer for storage and assessment. The location of the survey area was then surveyed using a Topcon GTS 725 total station.

Data Processing and Presentation

Following the completion of the detailed survey, processing and analysis took place using the Geoplot software package. After downloading, the results were plotted. The most typical method of visualising the data is as a greyscale image. In a greyscale, each data point is represented as a shade of grey, from black to white at either extreme of the data range.

A number of standard operations (including destriping and despiking) were carried out to process the data. The mean level of each traverse of data was reduced to zero and all grids matched so that there were no differences between background levels. The data was then analysed using a variety of parameters and styles and the most useful of these were saved as JPEG images and displayed using Adobe Illustrator software. The results of the survey were then overlaid onto a digital map of the study area. This was then used to produce interpretation figures.

All works were undertaken in accordance with the CIfA's Standards and Guidance for a geophysical survey (2014) and current Health and Safety legislation.

The on-site work was undertaken by Hywel Keen & Irma Bernardus and data processing by Hywel Keen (ACIfA).

6. Desk Based Assessment Results

6.1 HER Data - Monuments

A search of the regional HER revealed a total of only 38 known and recorded archaeological sites within a 1km radius of the assessment area (Fig 3). The sites are listed by SMR number and a brief description of each is given below. The full HER database for the assigned 1km search area is contained within Appendix 4.

An assessment was undertaken to accompany a planning application for demolition of existing redundant farm buildings and the construction of a new food store and fuel station, together with associated access and parking, at Dun Cow Farm, Rocks Green, near Ludlow, Shropshire. 6.4 HER Data Summary

The data received from the HER shows a total of 38 monuments and 8 archaeological events located within a 1km radius of the assessment area boundary (Fig 3).

Within the 38 monuments are 2 listed buildings and one scheduled ancient monument.

With the exception of monument polygon MSA2910, an area of medieval ridge and furrow earthworks, none of the HER data is located within the assessment area itself.

Those HER monuments of most relevance to the development proposals are SMR numbers 03096 to 03099, Rockgreen enclosures 1 to 4. These HER entries represent a series of enclosures adjacent to the southern edge of the assessment area of likely Romano-British date. Excavations in 1975 on the route of the A49 by-pass to the immediate south-west of the assessment area also located Bronze Age materials including Beaker pottery and an associated hearth (ESA2850).

Whilst the HER data shows these sites to be located immediately outside of the assessment area, it is possible, given their extreme proximity, that similar archaeological features also exist within the site itself.

6.5 Impact Assessment

As all but one of the sites contained within the HER data are located outside of the assessment area no physical impact will arise as a consequence of the development proposals on the known archaeological features.

MSA2910, the single HER data entry within the assessment area, is an area of medieval ridge and furrow earthworks extending eastwards from the middle and eastern edge of the assessment area towards Rock Farm. Approximately one third of this monument polygon is contained within the assessment area.

The significance of an impact is devised by cross referencing the importance of the affected feature with the estimated level of impact. This follows the principles set out in the Design Manual for Roads & Bridges, Volume II, Section 3, Part 2, Cultural Heritage (Table 1).

MSA2910, an area of medieval cultivation furrows, can be ascribed a level of low or negligible importance. As the development proposals do not include a proposed site layout at this point, the physical impact of the development on MSA2910 is assumed to be its total removal, a major magnitude of impact. Using Table 1, a major magnitude of impact upon a feature of low to negligible importance results in a moderate/minor impact. This could likely be downgraded to a minor impact as only approximately a third of MSA2910 is located within the assessment area, thus the majority of the feature will remain *in situ*.

Whilst the listed buildings, scheduled ancient monument and designated historic park and garden located within a 1km radius of the assessment area boundary will receive no direct physical impact as a result of the development proposals, there may be indirect impacts upon the setting of these designated monuments.

6.6. Visual Impact upon Settings of Designated and Non-designated Heritage Assets

6.6.1 Views to the Surrounding Landscape (Plates 17-21)

The development site is situated on the northeast edge of the urban townscape of Ludlow, and overlooks the Henley Road and Rocks to the southwest, and the natural landscape of Clee Hill to the northeast. The urban pattern is defined by hamlets and smaller villages and a medium to high density dispersal of farmsteads. There are clusters of wayside cottages and smallholdings resulting from encroachments on common land between the sixteenth and early nineteenth century.

Aside from the designed parkland, this landscape type lacks significant woodland; characteristically, tree cover comprises scattered hedgerow and field trees, mainly oak

and ash. In the medieval period many of the villages in this landscape were surrounded by open fields. These fields were enclosed on an informal basis from the sixteenth century onwards. Farms developed away from villages by the nineteenth century, associated with piecemeal, reorganised enclosure, creating a pattern of sub-regular hedged fields. The land use is primarily mixed farming. The farmsteads are characterised by medium-scale estate farms such as Rock Farm. The traditional building type is of timber-frame and local limestone construction, with brick used from the mid-1800s.

6.6.2 Scheduled Ancient Monument, Listed Buildings and Registered Park

There are 3 designated sites listed on the Shropshire Historic Environment Record (HER) within 1km of the development site; these include a duplicate record for St Julian's Well, which is a Scheduled Ancient Monument and Listed Building. The sites are briefly described below:

St. Julian's Well; SAM 1020656 and Grade II Listed Building 1202883 (Plates 21-26)

The monument includes the standing structural and buried remains of St Julian's Well, a holy well, situated in the middle of Livesey Road, in the north eastern outskirts of Ludlow. The well was originally within the precincts of the Augustinian friary, which was established in the mid-13th century and is located to the east of the medieval town. St Julian's Well was used as a source of water for the White Conduit, which is thought to have served as the town's first public water supply.

There are documentary references to the White Conduit during the reign of Edward IV (1461-83), and this is probably the water supply mentioned in a document of 1308. The well and the conduit's course are both shown on a map of 1862. The well house, constructed over the cistern, is built of rubble with dressed quoins and coping stones. The nature of its construction suggests that it has been extensively repaired in the post-medieval period. It is roughly rectangular in plan and of pediment shape. It measures approximately 2.6m by 3m and stands to a height of 1.07m. In 1994, as part of a programme to consolidate the well house, a limited investigation was undertaken. This revealed an entrance at the south western end, which had been blocked by two stone slabs. Inside, steps led down into the cistern, the sides of which were lined with ashlar. The cistern was found to contain a thick deposit of organic matter. This investigation has shown that the structure as a whole survives in good condition. The well is a Listed Building Grade II. The road surface and kerbs, the lamp standard and sign are all excluded from the scheduling, although the ground beneath all these features is included.

94 Gravel Hill; Grade II Listed Building 1202916 (Plates 27-31)

This monument comprises a mid-18th century cottage with 19th century alterations. It is a two storey building of red brick, with plain tile roof, two ranges of sash windows. The par-glazed door from 19th century within two-light casement. Finished on cream

colour rendering. It comprises also a single- storey wing with corrugated iron roof to the right. The thickness of the front wall suggests an additional brickwork from possibly 19th century. This is a building that preserves a combination of typical late-Victorian and Edwardian architectonic styles. It is located in one of the main access from Ludlow Gravel Hill, which contains a number of Local Heritage features, and another Grade II Listed Building: Gravel Hill House (LB 1281929), although it is not included within the 1km radius from site.

Henley Hall and Parkland; Grade II Registered Park 1001124 (Plates 32-36)

Historic England holds a Register of Historic Parks and Gardens of Special Historic Interest. These Registered landscapes are graded I, II* or II, and include private gardens, public parks and other green spaces. Registration is a material consideration in planning terms, meaning that planning authorities must consider the impact of any proposed development on the special character of the landscape.

There are no registered parks and gardens within the 1km study area. However, the parkland at Henley lies approximately 4km to the northeast of the centre of Ludlow, and approximately 2km to the northeast of the development site. The park comprises a roughly triangular tract of land of approximately 60 ha, which is registered at Grade II. At its north end, on the A4117, is an early 18th century wrought-iron screen and gates (listed grade II*), probably by Robert Bakewell of Derby, brought to Henley in the early 20th century from Wirksworth (Derbys).

Henley Hall (listed grade II) is a large and long red-brick building, ranged east/west, of various dates from the 16th century. It was rebuilt and extended in brick about 1700, and again in 1772 by Thomas Knight. Further substantial alterations and additions were made in 1875 and 1907.

Visual Impact Assessment on Settings of Designated Heritage Assets

The Scheduled Ancient Monument of St Julian's Well, the Grade II Listed Building at 94 Grave Hill, and the Grade II Registered Hanley Park, are all considered of High Importance according to Table 1. However, the settings of these heritage assets can be considered under a minor risk of impact due to the lack of mutual visibility between these and the development site. Consequently, the Visual Impact Assessment for these settings of heritage asset fall into the category of Minor Impact. This requires no further mitigation relating to these assets.

6.6.3 Non-Designated Heritage Assets

There is a total of 18 non-designated heritage assets listed on the Shropshire Historic Environment Record (HER) within 500m of the development site, with settings subject to visual impact assessment due to historic or landscape significance, and the proximity to the new proposed development. The settings of these SCC-HER monuments are in most occasions related to each other, as they all are characteristic of the historic-natural

landscape of Shropshire. These heritage assets can be grouped according to the following period-type relation:

Prehistoric to Romano-British (Plates 37-44)

There are 4 prehistoric to Romano-British heritage assets: the Rock Green Cropmark Enclosures 1 to 4 (MSAs 2013, 2014, 2015 and 2016), along with two Ridge and Furrow fields, at NE and W of Rock Farm (MSAs 2909 and 2910).

Cropmark Rockgreen 1 MSA 2013, a sub-circular enclosure of unknown date identified from aerial photography, which preserved the north half of a very faint circle with approximately 50m in diameter. It contained two possible rectangular features set within the circle, one of approximately 32m by 12m and one on the interior E side of c. 12m by 8m, both on a northwest-southeast axis.

Cropmark Rockgreen 2 MSA 2014, a linear feature with a 90 degrees angle at its N end. The N/S section runs for c. 30m and then turns E for c. 10m.

Cropmark Rockgreen 3 MSA 2015, a complex of two probable rectangular enclosures about 6 to 10m apart, aligned roughly north-south and linked by a ditch on the E side.

Single ditched enclosure Rockgreen 4 MSA 2016, a rectangular enclosure with no visible entrance. Maximum dimensions c. 40m by 30m in a north-south axis.

In 1975, a number of excavations at Rockgreen in advance of bypass construction (Event ESA2850) investigated these sites, and in 1979 field observation by the Ordnance Survey (Event ESA2851). The most noteworthy evidence from these excavations was a hearth from the Beaker period, Beaker sherds, a flint flake and a barbed and tanged arrowhead. The ditch was located and excavated at two points: it was about 2m wide and 1m deep from the present ground surface. The eastern run on Rockgreen 3 had been backfilled with clay containing several sherds of red soft pottery thought to have been Romano British. Two further parallel ditch systems where identified in Rockgreen 4. None of the features had strong or clear edges, no animal bone survived and some pottery fabrics had been so affected by corrosion that they lost their structure, particularly a soft pottery which appeared only as a bright red smear. Discussed by Halsted, in the context of the Bronze Age in Shropshire: 'the hearth associated with fragments of Beaker pottery and a flint scatter at Rock Green may represent a transient settlement episode and appears to be consistent with the ephemeral nature of settlement evidence recorded for the Late Neolithic and Early Bronze Age in Britain generally'. Halsted reiterates the evidence for transient occupation at Rock Green. He remarks on the distance from a water course, possibly indicating 'transient occupation episodes associated with hunting, ceremonial events and transhumance practices' (Halsted 2007). The range of dates attributed to these sites go from Bronze Age (1600 BC) to Romano-British (AD 410). The sites lay within arable fields by the time of the archaeological investigation, but have been severely disrupted by the embankments and road of the Ludlow Bypass, especially Rockgreen 1 and 3. The northwest, west and south margins are now overlaid by new dwellings, and in consequence, none of the archaeological features are actually visible.

Due to MSA 2013, 2015 and 2016 being now heavily developed, they can be ascribed a level of negligible importance. The impact of the development on the setting of them is assumed to be major. Using Table 1, a major magnitude of impact upon a feature of negligible importance results in a minor impact.

MSA 2014 survives in open fields adjacent to the assessment area, and is ascribed a level of medium importance. The impact of the development on the setting of MSA 2014 is assumed to be major. Using Table 1, a major magnitude of impact upon a feature of medium importance results in a major impact.

Medieval (Plates 45-50)

The Ridge and Furrow at NE of Rock Farm MSA 2909, and the Ridge and Furrow at W of Rock Farm MSA 2910, are earthworks observed and photographed from the air in April 1990. MSA 2909 is a small to medium area of ridge and furrow adjacent to the road, with a square depression and a possible platform near the western edge of the field. MSA 2910 comprise of the same type of ridge and furrow, but at the northern side of the Ludlow Road (A4117). The range of dates attributed to these sites are between AD 1066 and 1540. The sites lie within arable fields crossed by the Ludlow Road. To the southern side, the ridge and furrow MSA 2909, located west of Rock Farm; and to the northern side, the ridge and furrow MSA 29010, located east of Dodmore Cottage, MSA 15780.

MSA 2909 and MSA 2910 can be ascribed a level of low importance. The impact of the development on the setting of MSA 2909 and MSA2910 is assumed to be major. Using Table 1, a major magnitude of impact upon a feature of low importance results in a moderate impact.

Modern

From the post-medieval period, there are twelve buildings categorized as nondesignated heritage assets within the 0.5km radius from site. Eleven out of these twelve have relative inter-visibility, and are mostly located along Rocks Green Road and around Rock Farm:

MSA 15490 (Plates 51-53): Fir Tree Cottage, a 1.5 storey brick built house finished in white rendering; gabled and thin slate roof, with skylight and chimney at two ends. With wooden casements and gabled porch. Pigsty built of brick and stone masonry to the rear.

MSA 15491 (Plates 54-56): Suncrest, a 1.5 storey brick built house, finished in cream rendering; gabled and tiled roof, brick built chimneys in one end. Wooden casements, dormers through eaves, and outshot.

MSA 15492 (Plates 54-55, 57): N° 1 Rock Green Bank, a 1.5 storey brick built house, finished in cream rendering; gabled and old plain tiles in the roof, with brick built chimney at one end. Wooden casements, cat-slide porch, garage and modern extension.

MSA 15780 (Plates 70-72): Dodmore Cottage, East Hamlet, a 1.5 storey house. Timber frame building, gabled with tile roof, dormer at eaves. Brick built chimneys at two ends. Tall windows, lattice frame, and a second unit.

MSA 26542 (Plates 73-77): Dun Cow Farm, a farmstead. The buildings on site comprised the pebble-dashed south-facing farmhouse; fire-damaged red-brick stables are located to the north. There is an L-shaped agricultural range to the west of the house, and two dispersed mid-20th century corrugated sheds on the yard. The farmhouse has been significantly enlarged from the building recorded on an estate map of 1835, on which the farmstead is first depicted.

Rock Farm group (Plates 58-69)

Rock Farm is a group of agricultural buildings in the nearest surrounding landscape of site that comprise characteristic and traditional features of Shropshire agricultural landscape. There are six heritage assets within Rock Farm that can be considered within the same setting:

MSA 15493: a 1.5 storey farm house built of stone and brick, gabled with tile roof; dormers through eaves, brick built chimney at one end, metal casements, cat-slide dormers, planked door, a second unit.

MSA 15494: a 1.5 storey farm house, with outbuildings/stables. Brick built, gabled with tile roof, dormer, brick built chimney, wood casements. One extension.

MSA 15495: a 1.5 storey agricultural building with a second unit, built of stone and brick, tiled roof, pantile and tin sheet roofs, square windows, hoist door.

MSA 15496: further agricultural building, built of stone, randomly coursed, timber frame, weatherboard, pantiles.

MSA 15497: a group of 1, 1.5 and 2.5 storey farmhouse buildings, brick built, with timber frame, modern tiles and tin sheet. Brick built chimneys, wooden casements, gabled. Porch, mounting block, iron goods and attic

MSA 26541: a farmstead dispersed with multiple yards; the detached farmhouse side on to yard; large modern sheds on the site of the historic farmstead: barn, cow stall and

cart storage building (PRN 14988). First identified and classified by the Historic Farmsteads Characterisation Project, 2008 - 2010 (Baxter 2010), largely from the digital version of the c.1900 OS large scale mapping (ESA6427).

These modern assets can be ascribed a level of low importance. The impact of the development on their general setting is moderate. Using Table 1, a moderate magnitude of impact upon features of low importance results in a minor impact.

There is another non-designated heritage asset that is located within the 0.5km radius from site, the Ludlow Cemetery Chapel, **MSA 18515 (Plates 78-80)**. This is a modern chapel that imitates neo-gothic style, located in the central area of Ludlow Cemetery. There is no direct visual relationship however between the development site and this heritage asset, which is ascribed a level of low importance. The impact of the development on the setting is classed as no impact. Using Table 1, a no impact magnitude of impact upon a feature of low importance results in a neutral impact.

6.6.4 Visual Impact Assessment on Settings of Non-designated Heritage Assets

Most of the non-designated heritage assets within the 0.5km radius from site have similar or inter-related settings, as they are all characteristic of the historic landscape of Shropshire, and in close proximity to each other. They are all subject to the visual impact assessment due to their historic or landscape significance, and to the proximity to the new proposed development.

The area is characterised by agricultural land, with traditional agricultural farmsteads and farmhouses, some modern cottages, and an undulating landscape that comprises hills of outstanding beauty (Clee Hill) and registered archaeological assets such as the medieval ridge and furrow.

The land plot of the new development site is not currently visible from these settings, but the new dwellings are likely to be. Most of the settings of the non-designated heritage assets will be visible from the development site. The setting impacts are as follows:

- MSA 2014 has a major impact on setting from the proposed development.
- MSA 2909 and 2910 have a moderate impact on setting from the proposed development.
- MSA 2013, 2015 and 2016 have a minor impact on setting from the proposed development.
- The 12 modern building assets will have a minor or neutral impact on setting from the proposed development.

A range of mitigation recommendations can be precluded as for the new development. Examples of 20th century development in the area, as terraced houses, and other new dwellings in the outskirts of Ludlow, at St Margaret's Road and Parys Road, feature characteristic elements from typical historical-rural landscape of Shropshire, such as

brick built gabled walls, tiled and slate roofs, wooden door encasements or porches (Plates 81-83).

The negative physical impact during the construction phase for the proposed development could be mitigated by a programme of archaeological work. A trenched evaluation is recommended prior to groundworks commencing. This would be followed by any subsequent archaeological investigation required by SCC, such excavation and/or a watching brief.

The 1818-34 map shows the assessment area, though only at a small scale. For the most part no detail is given apart from an old road or trackway bisecting the site extending from Ludlow to Rock. No further detail is shown.

1836 1st Series 2 Inch Ordnance Survey Map (Fig 5).

The 1836 map is largely based on the 1818-34 drafts shown in Figure 4. Consequently no further detail is shown although the whole is represented in greater clarity. No further detail is shown.

1846 Stanton Lacy Parish Tithe Map Transcription (Fig 6).

The 1846 Tithe Map shows the assessment area as being divided up into seven different named fields. These are: Rocks Green, Meadow, Meadows, Copthill, Big Copthill, The Brakes and The Stocking. None of the field names appear to imply any former land use. The road or track previously shown on the 1st Series OS (Fig 5) as extending as far as Rock is shown on the Tithe Map to run between fields Copthill and Big Copthill and terminate at The Stocking. No continuation as far as Rock is depicted. No further detail is shown.

1904 2nd Edition 1:10560 Ordnance Survey Map (Fig 7)

The 1904 2nd Edition OS map shows the assessment area in great detail. It shows no field boundary change to have taken place since the drawing up of the 1846 Tithe Map, the assessment area still consists of seven fields. The road/trackway from Ludlow to Rock is shown on this map as a footpath. A further footpath is also shown crossing the field 'Rocks Green'. A saw pit feature is noted though this is likely to the rear of the Nelson Inn and thus immediately outside the assessment area. The pond feature located within Field 3 on the site walkover is shown on the 1904 map as being present and located on either side of the field boundary between 'Meadow' and 'Big Copthill'. No further detail is shown.

1964 Edition 1:10560 Ordnance Survey Map (Fig 8)

The 1964 OS map shows largely the same amount of detail as that depicted on the earlier 1904 edition. Notable changes within the assessment area include the removal of the field boundary between Copthill and The Brakes. A field boundary has also been added running north-west to south-east, dividing Big Copthill into two smaller fields. A small structure is noted to the south of the field boundary separating Rocks Green from Meadows. The feature is a small unlabelled square. No further detail is shown.

1967 Edition 1:2500 Ordnance Survey Map (Fig 9)

The 1967 1:2500 Edition OS map shows the assessment area in good detail and at a large scale. The field boundary previously noted as dividing Big Copthill into two smaller fields is not depicted on this map. Also, the field boundary between the two fields 'Meadows' and 'Meadow' is shown as having been removed.

The small structure noted on the previous map is still shown as extant and appears divided into three smaller bays. Overhead power lines are depicted running north-west to south-east across the site. No further detail is shown.

1975 1:10000 Edition Ordnance Survey Map (Fig 10)

The 1975 Edition OS map shows largely the same information as that depicted on the earlier 1967 map (Fig 9). No further detail is shown.

6.10 Summary

The map regression analysis has shown that from between 1846 and 1967 there has been some alteration to the field boundary layout within the assessment area. Also, what was originally marked as a road/trackway to Rock on the earlier maps appears to have become a smaller footpath over time. Land use in the assessment area, as evidenced by the historic maps, appears largely unchanged for at least the last 198 years.

6.11 Aerial Photographs

Aerial photographs of the assessment area were held by the regional HER though, for copyright purposes, were not available for reproduction within this report. The most relevant of the aerial photographs within their collection has been transcribed with the results depicted within Figure 11 whilst Figure 12 shows the transcribed locations of the remaining cropmarks.

The aerial photograph transcription shows the locations of cropmarks Rockgreen 1 to 4 (MSA2013 to MSA2016) in relation to the 1975 route of the A49. Rockgreen 2 (MSA2014) and Rockgreen 4 (MSA2016) were unaffected by the works on the A49 and remain *in situ* to the immediate south of the assessment area.

6.12 Site Visit

The site visit was undertaken on the 17th October 2016 in sunny and cold conditions. For ease of description the assessment area was broken down in to its four constituent fields, numbered one to four and shown on Figure 12. A description of the walkover of each field is given below.

Field 1 (Plates 1-5)

Field 1, named 'Rocks Green' on the 1846 Tithe map, is the most northerly within the assessment area, being bound along its northern edge by the route of the A4117 Bridgnorth road.

Undulations in the surface of the field are immediately apparent. These appear largely amorphous though some were clearly linear in shape. The undulations are present throughout Field 1. No further finds or features of archaeological significance were noted within Field 1.

Field 2 (Plates 6-7)

Field 2 represents the western end of a field named as 'The Stocking' on the 1846 Tithe Map. It is bounded along its north-western edge by Field 23 and its southern edge by Field 4.

Slight linear, parallel, undulations were visible within the surface of the field. This is likely to be the remains of medieval ridge and furrow cultivation (MSA2910). No further finds or features of archaeological significance were noted within Field 2.

Field 3 (Plates 8-13)

Field 3 represents the largest of the four fields making up the assessment area. It is made up of two fields named 'meadow' and one named 'Big Copthill' on the 1846 Tithe Map. Its northern edge adjoins Field 1 whilst its south-western edge adjoins Fields 2 and 4.

A linear depression, presumably the line of the now removed field boundary shown on the 1964 OS map, was visible running north-west to south-east within the western end of Field 3. Similar linear depressions were noted in the area of the removed field boundary between 'Meadow' and 'Big Copthill'.

An area of seemingly dumped bricks and concrete was noted within the field boundary between fields 1 and 3. This is likely to be remnants of the small building first shown in this area on the 1964 OS map.

A small, mostly dried up, pond feature is still extant within the south east of Field 3. Similar shaped undulations are present with the vicinity of the pond feature. No further finds or features of archaeological significance were noted within Field 3.

Field 4 (Plates 14-16)

Field 4, the southernmost of the four fields making up the assessment area, is made up of fields named 'Copthill' and 'The Brakes' on the 1846 Tithe Map. The surface of the field appears largely uniform with no apparent topographic undulations relating to potential archaeological features.

No finds or features of archaeological significance were noted within Field 4.

6.13 Site Visit Summary

The site visit has identified a series of topographic undulations within Field 1, Rocks Green, which may be anthropogenic in origin and thus potentially of archaeological interest. The undulations are amorphous and may represent quarrying activity or possible fish ponds.

The presence of ridge and furrow cultivation earthworks within Field 2, The Stocking, was identified and confirms the HER data.

Topographic undulations around the pond feature in Field 3 may represent similar pond features. A linear feature in this area is likely to represent the removed field boundary between 'Meadow' and 'Big Copthill'. A linear depression in the west of Field 3 may represent an earlier, unmapped, field boundary.

No features were noted within Field 4.

The site visit has shown that topographic undulations within the surface of the field are present and are likely to represent archaeological features. Those identified in Field 1 appear to have been previously unrecorded and are not depicted on any of the historic mapping.

6.14 Portable Antiquities Scheme Database

An online search of the Portable Antiquities Scheme Database returned no finds within or immediately adjacent to the assessment area.

6.15 Desk Based Assessment Summary

The historic maps studied as part of the desk based assessment have shown that, from at least the 19th century onwards, the assessment area has been in use as agricultural land. Physical evidence of medieval cultivation furrows (MSA2019) within the assessment area as well as mentions within Lloyd (1999) and Faraday (1991) of medieval cultivation taking place in the area support the idea that the site has been in agricultural use since at least the medieval period.

The series of Romano-British enclosures (Rockgreen 1-4), as well as the Bronze Age features excavated in 1975, located to the immediate south of the site, show continued activity as having taken place in close proximity to the assessment area.

Whilst it is judged likely that only a minor direct physical impact will occur to one known site (MSA2019) as a result of the proposed development, this does not preclude the possibility of previously unknown heritage assets being located within the assessment area.

The Visual Impact Assessment on settings of Designated Heritage Assets concludes that the Scheduled Ancient Monument of St Julian's Well, the Grade II Listed Building at 94 Grave Hill, and the Grade II Registered Hanley Park, are all considered of High Importance. However, the settings of these heritage assets can be considered under a minor risk of impact due to the lack of mutual visibility between these and the development site. Consequently, the Visual Impact Assessment for these settings of heritage asset fall into the category of Minor Impact. This requires no further mitigation relating to these assets.

Most of the non-designated heritage assets within the 0.5km radius from site have similar or inter-related settings, as they are all characteristic of the historic landscape of Shropshire, and in close proximity to each other. The land plot of the new development site is not currently visible from these settings, but the new dwellings will likely be. Most of the settings of the non-designated heritage assets will be visible from the development site.

A range of mitigation recommendations can be precluded as for the new development. Examples of 20th century development in the area, as terraced houses, and other new dwellings in the outskirts of Ludlow, at St Margaret's Road and Parys Road, feature characteristic elements from typical historical-rural landscape of Shropshire, such as brick built gabled walls, tiled and slate roofs, wooden door encasements or porches.

7. Geophysical Survey

7.1 Ground Conditions

The survey was undertaken after a brief dry period. The weather during the survey was largely dry.

7.2 Survey Location and Summary

The assessment area was comprised of four fields. The fences bounding the site contained metallic elements and so a sufficient distance was maintained where possible to avoid impact on the results of the survey data.

7.3 Results of the Survey (Figs 13-17)

The data quality was good. The data has been compressed and then clipped with a resulting range of -3 to 3nT. Figure 13 shows the un-interpreted data while Figures 14-17 shows the interpretation as described below, all overlain onto an OS base map. From the interpretation, archaeological features are marked in red and modern features and marked in purple.

The results of the survey show the remains of the historic landscape dating to a period before the establishment of the present day field boundaries. A number of linear features (red) show the positions of historic field boundaries. The field boundaries delimit area with different land use types. Most commonly the fields show ploughing, particularly ridge and furrow ploughing.

Field 1. In the north-west corner of the field, red lines denote are series of linears which are close to the houses to the west of the site and the road. These are probably wall stubs or foundation trenches. It can be seen that within the red lines there is a darker area which reinforces the suggestion that this is a building as it may be due to rubble or even floors still in situ. The circular red lines outline areas in the field which are large depressions likely to be either ponds or quarries. The purple line marks a large metal pipe that follows the southern boundary of the field.

Field 2. This field has a couple of small single anomalies; one probably due to a small piece of metal, marked in purple. The northern most is a telegraph pole.

Field 3. The red lines mark faint linears which are field boundaries, and a series of regular linears across the northern part of the field that are slightly curved and characteristic of medieval furrows. The strong circular anomaly outlined is a telegraph pole. The purple lines mark a series of linears that are comprised of small anomalies that resemble metal spikes and indicate fairly recently disturbed ground. The purple roughly circular anomaly is close to the present hedge. It is no more than 10m across and possibly a tree bole.

Field 4. The anomalies outlined in purple are due to telegraph poles and metal anomalies. In general there is an irregular scatter of small metal like anomalies across the surveyed area and no other features. This is an unusual survey as on a field the geology would normally show especially as this field is sloping. It is noted that the telegraph poles in this field sit within depression in the ground unlike the others in the other fields. It is possible that modern deposition of soil has taken place on this field that is shielding the results.

7.4 Interpretation and Discussion

The geophysical survey identified features that describe part of the historic landscape prior to the establishment of the modern farming boundaries. The 1846 Tithe map shows detail of a smaller field named Meadow 5 within the Field 3 of the development area. This is recorded in the geophysics results. The OS maps show that its northern boundary is removed by 1967, and western boundary sometime after 1975. Field 3 also shows an earlier field layout, and to the north an area of ridge and furrow.

The results of Field 1 show what is likely to be remains of a building in the north-west corner, and a series of circular features indicting quarries or ponds. A building is shown on the OS 1818 and 1836 maps, removed by 1846. No cartographic sources record any quarry or pond features in this area, which suggests they are earlier than first part of the 19th century.

Fields 2 and 4 do not show any positive results. Field 4 has a very uniform plan which may indicate this field has been built up with imported soil in modern times, especially as the telegraph pole is in a depression. This may mask the geophysics results.

In conclusion, Fields 1 and 3 show a low density of features that could be clarified by evaluation trial trenching. Field 2 does not show any positive results. Field 4 does not show conclusive results and therefore the archaeological potential is unknown.

8. Discussion and Conclusion

The desk based assessment showed that the assessment area's use as agricultural land

dates back at least as far as the 19th century and likely into the medieval period. A small area of medieval ridge and furrow cultivation in Field 3 represents the only feature of archaeological significance located by the desk based assessment within the development area. However, significant archaeological features are located immediately to the south of Field 4 (Figure 11).

The Visual Impact Assessment on settings of Designated Heritage Assets concludes that the Scheduled Ancient Monument of St Julian's Well, the Grade II Listed Building at 94 Grave Hill, and the Grade II Registered Hanley Park, are all considered of High Importance. However, the settings of these heritage assets can be considered under a minor risk of impact due to the lack of mutual visibility between these and the development site, with no further mitigation required.

Most of the non-designated heritage assets within the 0.5km radius from site have similar or inter-related settings. The land plot of the new development site is not currently visible from these settings, but the new dwellings are likely to be. Most of the settings of the non-designated heritage assets will be visible from the development site. The setting impacts are as follows:

- MSA 2014 has a major impact on setting from the proposed development.
- MSA 2909 and 2910 have a moderate impact on setting from the proposed development.
- MSA 2013, 2015 and 2016 have a minor impact on setting from the proposed development.
- The 12 modern building assets will have a minor or neutral impact on setting from the proposed development.

A range of mitigation recommendations can be precluded as for the new development. Examples of 20th century development in the area feature characteristic elements from typical historical-rural landscape of Shropshire, such as brick built gabled walls, tiled and slate roofs, wooden door encasements or porches.

The Geophysical Survey of Fields 1 and 3 shows a low density of features of indeterminate function. Field 2 has negative results. Field 4 does not show conclusive results, possibly as a result of soil importation undertaken during the construction of the A49 Ludlow bypass. It was, therefore, not possible to say whether the archaeological features identified by the desk-based assessment as lying immediately to the south of the development area, continued into Field 4.

The negative physical impact during the construction phase for the proposed development could be mitigated by a programme of archaeological work. A trenched evaluation is recommended prior to groundworks commencing. This would be followed by any subsequent archaeological investigation required by SCC, such as excavation and/or a watching brief.

Targeted trenching has the potential to help better understand the features identified by the geophysical survey in Fields 1 and 3, and also, possibly, in Field 4, although the depth of possible imported soil here is unknown.





Fig 1: Map showing location of assessment area








Fig 4: 1818-34 Ordnance Surveyors 2 Inch Drafts showing assessment area (Reproduced by AW under OS License No. 100055111)




Fig 5: 1836 1st Series Ordnance Survey 2 Inch map showing assessment area (Reproduced by AW under OS License No. 100055111)




Fig 6 : Transcribed 1846 Stanton Lacy Parish Tithe map showing field names




Fig 7: 1904 1:10560 Ordnance Survey map showing assessment area (Reproduced by AW under OS Licence No. 100055111)




Fig 8: 1964 1:10560 Ordnance Survey map showing assessment area (Reproduced by AW under OS Licence No. 100055111)




Fig 9: 1967 3rd Edition 1:2500 Ordnance Survey map showing assessment area (Reproduced by AW under OS License No. 100055111)





Fig 10: 1975 1:10000 Ordnance Survey map showing assessment area (Reproduced by AW under OS Licence No. 100055111)








Figure 12: Assessment area plan showing field numbers from site visit & transcribed cropmark features










Figure 16: Assessment area plan showing the geophysics surveyed areas Fields 2, 3 and part of 4, and their interpretation.







The original interpretation of the southern enclosure as a hall with annexes was subsequently abandoned. A limited investigation in advance of the construction of the Ludlow By-Pass was mounted by WEMRAC in the summer of 1975. The site lay in an area with a thin cover of sandy soil with a high clay content over Old Red Sandstone bedrock. None of the features had strong or clear edges, no animal bone survived and some pottery fabrics had been so affected by corrosion that they lost their structure, particularly a soft pottery which appeared only as a bright red smear.

Only five features were defined with any confidence. F25 and F19 were part of the enclosure ditch which had appeared on the aerial photographs as the more southerly of the two apparently linked cropmark enclosures. The ditch was located and excavated at two points within Trench 2A.It was about 2m wide and 1m deep from the present ground surface. The eastern run, F25 had been backfilled with clay containing several sherds of red soft pottery thought to have been Romano British. Two further parallel ditch systems, F44 and F20/23 were located in Trench 2A, suggesting an internal enclosure about 5m within the cropmark. F37 in Trench 2B was a thin layer of blackened soil and reddened sandstone fragments, dished into a sand-filled hollow. The layer contained 3 sherds of Beaker pottery and a flint flake. The feature is interpreted as a hearth. DISCUSSION: Activity of the Beaker Period is suggested by the Beaker sherds in the putative hearth, F37, and the barbed and tanged arrowhead found 20m away in the subsoil. On the evidence of the soft pottery, the cropmark enclosure on the air photographs belonged to the Romano- British period, and the scatter of Roman material from the ditch features and the topsoil provides some support for this date <8>

Whimster erroneously refers to the excavation of this site in his discussion of Rockgreen 4, PRN 03099. <9>

Evaluated for MPP in 1990-1, as one of less than 10 Romano-British Aggregate Villages. 4 rectangular farms(?) partially destroyed by Ludlow by-pass. <10>

Discussed by Halsted, in the context of the Bronze Age in Shropshire; 'the hearth associated with fragments of Beaker pottery and a flint scatter at Rock Green may represent a transient settlement episode and appears to be consistent with the ephemeral nature of settlement evidence recorded for the Late Neolithic and Early Bronze Age in Britain generally'. <11>

Halsted reiterates the evidence for transient occupation at Rock Green. He remarks on the distance from a water course, possibly indicating 'transient occupation episodes associated with hunting, cermonial events and transhumance practices'. <12>

On 3rd November 1994, SCC dug down the SW side of the well to check the soundness of the structure. The entrance was blocked by two stone slabs, the inner one pierced with a rectangular hole: these were tilted outwards, revealing an iron bar across the entrance. Steps led down into the interior, wher the floor was covered with at least 4 feet or organic refuse. <2>

Scheduled in 2002. Scheduling description: ->

-> The monument includes the standing structural and buried remains of St Julian's Well, a holy well, situated in the middle of Livesey Road, in the north eastern outskirts of Ludlow. The well was originally within the precincts of the Augustinian friary, which was established in the mid-13th century and is located to the east of the medieval town. St Julian's Well was used as a source of water for the White Conduit, which is thought to have served as the town's first public water supply. There are documentary references to the White Conduit during the reign of Edward IV (1461-83), and this is probably the water supply mentioned in a document of 1308. The well and the conduit's course are both shown on a map of 1862. The well house, constructed over the cistern, is built of rubble with dressed quoins and coping stones. The nature of its construction suggests that it has been extensively repaired in the post-medieval period. It is roughly rectangular in plan and of pediment shape. It measures approximately 2.6m by 3m and stands to a height of 1.07m. In 1994, as part of a programme to consolidate the well house, a limited investigation was undertaken. This revealed an entrance at the south western end, which had been blocked by two stone slabs. Inside, steps led down into the cistern, the sides of which were lined with ashlar. The cistern was found to contain a thick deposit of organic matter. This investigation has shown that the structure as a whole survives in good condition. The well is a Listed Building Grade II. The road surface and kerbs, the lamp standard and sign are all excluded from the scheduling, although the ground beneath all these features is included <3>

In 2003 an archaeological and architectural analysis of St Julian's conduit was undertaken. The superstructure of St Julian's conduit was surveyed and photographed to provide a record of the structure prior to any necessary repairs to it. The conduit seems to be of late 18th to early 19th century date, although it is on the site of a much earlier conduit. The roof is plain gabled and the apex is capped by fairly shallow but broad copers with a segmental profile. The copers have been re-laid at some point. Both roof slopes have also been radically rebuilt on more than one occasion. The original design may have been of a much greater quality than the present patched and repaired structure. There is a distinct dip in the apex of the roof, a degree of weathering has occurred with potential frost pockets and voids opening up within the structure, and the north gable has been pushed over slightly by a tree.->

-> On the south gable, immediately below the present ground floor is the entrance under a plain lintel made up of a single stone. In the 1980's the internal structure was accessed and in contrast to the exterior, the interior seemed to have been well made and probably little altered. It was lined with well-worked and quite large blocks of sandstone, regularly coursed and apparently once lime washed. These appear to form the inner skin of the gable ends. The interior was topped by a plain brick vault springing from the tops of the stone side walls. The vaulted profile is segmental, though the apex is slightly flattened, and was made of handmade red bricks, fairly irregular in shape with repairs. There was no sign of the distinct dip in the apex of the roof noticeable on the outside. <4>

CMHTS Report <3>

PORTCULLIS LANE: The original line of Portcullis Lane appears to have been as a classic back lane to the burgages on the east side of Corve Street, though it had kinked round an encroachment by the early 19th century. The centre line of the lane formed the parish boundary between the new C11/12 parish of Ludlow and the earlier parish of Stanton Lacy <4>

CORVE STREET: Upper Corve Street, which was originally cigar-shaped, may have functioned as an additional market street, before or in addition to the medieval market place. The first documentary reference comes in 1186. <5>

CORVE STREET: A watching brief was undertaken on the excavation of 3 small trenches in Corve Street, Ludlow, as part of a sewage feasibility study. In trenches 2 and 3, on the eastern side of Corve Street, a number of well-compacted layers, provisionally dated to the 13th - 14th century sealing earlier sandstone structures in both trenches. These road surfaces lay at a depth of c.0.40m below present ground level. <6>

Description

History : The Roman Catholic congregation in Ludlow formerly met in a modest hall in Julian Road, which was later used as a scout hut. The foundation stone for the present building was laid by the Bishop of Shrewsbury in May 1935 and the church, together with its presbytery, were finished the following year to the designs of Giuseppe Rinvolucri (1894-1963). A parish meeting room, was added later in the C20.

Details: CHURCH: the church is built of rubble-faced stone, with ashlar dressings, all of limestone from the Oreton Quarry at Farlow, Clee Hill. The roof is of concrete covered with a waterproof membrane. The barrel vault, dome and pillars all use reinforced concrete.

PLAN: the nave has three bays and a central, square, crossing space supporting a dome. To either side are transepts with apsidal ends and the chancel also has an apsidal end. Doors at either side of the altar lead to vestries and a meeting room as well as the connecting corridor to the presbytery.

EXTERIOR: the western front has a central portal with arched head, which is approached by a set of stone steps. Above this is a large oculus and to the top of the wall is an open arcade of small arches, which continues around a pair of corner turrets, which have domed caps. A corbel table below the coping continues around the building. The flanks of the nave have triplets of round-arched lancets, set high in the wall, which mark each bay and the transepts and chancel have the same motif. The corners of the square central crossing are chamfered to their upper body. The circular dome has eight triplets of windows to the drum and a plain cap supporting a cross to the apex of the dome. An external spiral staircase of concrete is attached to the southern transept. This leads to the flat roof of the vestries, from which the transept galleries are accessed. INTERIOR: there is a shallow internal porch to the western end with niches to the lateral walls and an organ loft above it. The nave has no aisles, but the transepts have arcades below the galleries and these connect to narrow aisles at either side of the chancel. The altar is set in an apse which has panels of variegated marble to its lower walling. The altar is now set forward from the wall, in line with Vatican II orthodoxy, but was formerly joined to the wall. The green marble steps below the altar also appear to date from the 1970s. Early photographs also show the interior with two pulpits at either side of the chancel, both of which have now been removed. Stained glass was brought from the former Roman Catholic church at Julian Hall. The three arched lights at the eastern end, above the altar are by Hardman of Birmingham and dated 1906. They represent St Peter, St George and Our Lady of Mount Carmel. The circular window at the western end is by Earleys of Dublin and represents the Virgin and Child. The present painting of the dome with gold stars against a blue background, representing the Apostles, was undertaken by Philip Jackson in 1993

THE PRESBYTERY: the church house is of two stories, stuccoed and colour-washed, with a flat roof and concrete coping, and is in a loosely 'Moderne' style.

EXTERIOR: the principal fronts face south, onto the driveway, and west, towards the church. There are horizontal strip windows to both fronts. These were formerly metal casements, but have now been replaced with uPVC units. The south front has three bays, with a semi-circular bow window to the left. The right-hand bay has a square corner at ground floor level and a quadrant curve above it to the first floor. All windows on this front are of five casement lights, except for the right bay which has two four-light windows at either side of the corner and a curved window of six lights to the first floor. The west front also has three lights, with a central doorway which has an arched head with fanlight, flanked by two small lights. Other windows on the front are of four casement lights, but the right bay has windows of five lights. To the left is the arcaded wing which links the presbytery to the church.

INTERIOR: many of the ground floor rooms, including the staircase hall, were panelled in the 1960s. The interior is approached through a replacement, uPVC door. The staircase hall has a cantilevered concrete staircase with open well and balustrade of tubular steel with a wooden handrail. The dining room and study retain their original tiled fire surrounds. Original doors have been covered with panelling in the 1960s. ->

-> Early photographs of the church and presbytery at the time of their completion, show the presbytery with a prominent balustrade of stucco piers and an iron balustrade, which has now been removed from the roof. ->

-> In 2011 an application was made to English Heritage for the building to be listed. After due consideration, English Heritage concluded that alhtough the building had clear local interest. St Peter's Church did not merit listing. <1>

Description

In 2003 an archaeological and architectural analysis of St Julian's conduit was undertaken. The superstructure of St Julian's conduit was surveyed and photographed to provide a record of the structure prior to any necessary repairs to it. An analysis of the fabric was undertaken as well as some documentary research. The interior was inaccessible making a proper assessment difficult. The conduit seemed to be of late 18th to early 19th century date, although it is on the site of a much earlier conduit. The original design of the present structure may have been of a much greater quality than the patched and repaired structure visible today. There is a distinct dip in the apex of the roof, a degree of weathering has occurred with potential frost pockets and voids opening within the structure, and the north gable has been pushed over slightly by a tree.<1>

An assessment was undertaken to accompany a planning application for demolition of existing redundant farm buildings and the construction of a new food store and fuel station, together with associated access and parking, at Dun Cow Farm, Rocks Green, near Ludlow, Shropshire.
