# **EXECUTIVE SUMMARY:**

This DBA considers land at: Startin Tractors Ltd, Main Road, Twycross, Leicestershire, CV9 3PW.

There are no designated heritage assets, Scheduled Ancient Monuments, registered parks. gardens or registered battlefields or listed buildings on the Site. The site lies to the north west of the Twycross Conservation Area.

## 1.0 INTRODUCTION AND SCOPE OF STUDY

- 1.1 This DBA has been researched and prepared by MAS on behalf of Startin Tractors Ltd.




Fig. 2: Location Plan 1:2500

- 1.2 The subject of this DBA (also referred to as the site) is an agricultural plant depot 'Site A' and a field located to the north east of the Main Road A444, 'Site B' Twycross, Leicestershire, CV9 3PW (figs. 1, 2).
- 1.3 In accordance with National and Local Authority guidance, this DBA comprises of an examination of evidence held by HER, and the LA, considers published and unpublished material, internet sources and charts historic land-use through a map regression exercise1.
- 1.4 As a result, the assessment enables relevant parties to consider the significance of any designated and undesignated heritage assets within the study area, to assess the archaeological potential of the site, and to consider the need for design, civil engineering and/or archaeological solutions to any potential identified.

# 2.0 OBJECTIVES AND METHODOLOGY

- 2.1 The purpose of a DBA is to gather information on a site or area to assess the potential for archaeological features and the presence, significance and quality of known archaeological sites. Available resources that can be utilised include local Historic Environment Records (formerly Sites & Monuments Record SMR), local history centre archives, aerial photographs, remote sensing information, historic maps, estate records and other documents. The production of a DBA helps prepare an informed strategy for any further work required, which may include monitoring, targeted evaluation, mitigation or a full programme of works.
- 2.2 The Chartered Institute for Archaeologists (CIfA) defines the standard of a DBA as follows: 'An assessment of the known or potential archaeological resource within a specific area or site on land, inter-tidal or underwater. It consists of a collation of existing written and graphic, photographic and electronic information in order to identify the likely character, extent, quality and worth of the known or potential archaeological resources in a local, regional, national or international context as appropriate'2.

# 3.0 PLANNING BACKGROUND

3.1 This document is to support a planning application (18/10128/PREMAJ): for the erection of a new workshop and ancillary service building on Site A and creation of an agricultural storage area on Site B, on land at Startin Tractors Ltd, Main Road, Twycross, Leicestershire, CV9 3PW, (figs.1-3).

## 4.0 NATIONAL POLICY AND LOCAL GUIDANCE 2018

# 4.1 Proposals affecting heritage assets

- **189.** In determining applications, local planning authorities should require an applicant to describe the significance of any heritage assets affected, including any contribution made by their setting. The level of detail should be proportionate to the assets' importance and no more than is sufficient to understand the potential impact of the proposal on their significance. As a minimum the relevant historic environment record should have been consulted and the heritage assets assessed using appropriate expertise where necessary. Where a site on which development is proposed includes, or has the potential to include, heritage assets with archaeological interest, local planning authorities should require developers to submit an appropriate desk-based assessment and, where necessary, a field evaluation.
- **190.** Local planning authorities should identify and assess the particular significance of any heritage asset that may be affected by a proposal (including by development affecting the setting of a heritage asset) taking account of the available evidence and any necessary expertise. They should take this into account when considering the impact of a proposal on a heritage asset, to avoid or minimise any conflict between the heritage asset's conservation and any aspect of the proposal.
- **193.** When considering the impact of a proposed development on the significance of a designated heritage asset, great weight should be given to the asset's conservation (and the more important the asset, the greater the weight should be). This is irrespective of whether any potential harm amounts to substantial harm, total loss or less than substantial harm to its significance.
- **194.** Any harm to, or loss of, the significance of a designated heritage asset (from its alteration or destruction, or from development within its setting), should require clear and convincing justification. Substantial harm to or loss of:
- (a) grade II listed buildings, or grade II registered parks or gardens, should be exceptional;
- (b) assets of the highest significance, notably scheduled monuments, protected wreck sites, registered battlefields, grade I and II\* listed buildings, grade I and II\* registered parks and gardens, and World Heritage Sites, should be wholly exceptional.

- **195.** Where a proposed development will lead to substantial harm to (or total loss of significance of) a designated heritage asset, local planning authorities should refuse consent, unless it can be demonstrated that the substantial harm or total loss is necessary to achieve substantial public benefits that outweigh that harm or loss, or all of the following apply:
- (a) the nature of the heritage asset prevents all reasonable uses of the site; and
- (b) no viable use of the heritage asset itself can be found in the medium term through appropriate marketing that will enable its conservation; and
- (c) conservation by grant-funding or some form of not for profit, charitable or public ownership is demonstrably not possible; and
- (d) the harm or loss is outweighed by the benefit of bringing the site back into use.
- **196.** Where a development proposal will lead to less than substantial harm to the significance of a designated heritage asset, this harm should be weighed against the public benefits of the proposal including, where appropriate, securing its optimum viable use.

# 5.0 TOPOGRAPHY AND GEOLOGY

- 5.1 Twycross is a village located 29km west of Leicester in the administrative district of Hinckley and Bosworth Borough Council (fig.1).
- 5.2 The site is located along the B4116 with its junction with the A444, where it forms an L shaped parcel of land 2.4ha in extent, in-part occupied by an agricultural machine sales yard and showroom Site A and arable fields to the north east, Site B. The site is centred on SK 433654 305209 at 126m OD, whilst the underlying geology comprises of mudstone with sand and gravel3 (figs. 1-3, Appendix 1).
- 5.3 A walk over survey was conducted on the 15th of February 2019 by the author, at the time weather conditions were dry and sunny (fig. 5, Appendix 1).

# 6.0 HISTORICAL AND ARCHAEOLOGICAL BACKGROUND

- 6.1 The village is certainly old, being first mentioned as *Tvicros* in the Domesday Book. OE twi 'double, two' + OE cros 'cross'. OE cros in place-names usually refers to a carved stone cross. The name probably refers to two crosses, neither of which has survived.
- 6.2 A 1km search radius from the sites central NGR was conducted by the HER, (fig.4, Appendix 2). For the purposes of this report only HER data in the immediate vicinity of the site is discussed below. LiDAR imaging and historic aerial photos were also consulted but found to be inconclusive.
- 6.3 Twycross and its surrounding environs has a diverse archaeological record,

spanning from the prehistoric to post-medieval periods and later. Much of this has been recorded over the years by chance discoveries, research projects, stray finds and during or ahead of development.

6.4 A well preserved medieval moated site is located approximately 200m south east of the site at (MLE3271, SM1012524). This comprises of enclosures and three fish ponds. Trial trenching and monitoring (MLE10079) was undertaken between 2000-03 at (MLE10079) and recorded; ditches, post-holes, gullies, pits and a pond and are believed to be associated with the moated site above (fig.4, Appendix 2).

# 7.0 CARTOGRAPHIC EVIDENCE

- 7.1 A total of six historic maps were studied for this report (figs. 6-9).
- 7.2 The earliest map dates to 1842 and is a draft tithe map of the village. The site is shown as part of two plots, Site A being Plot 26 running parallel with the contemporary B4116 and Site B being occupied in-part by Plot 20. The former plot being owned by Howe the Earl and occupied by Thomas Hare, with the land being used as an orchard, whilst the latter plot is owned by Henry Jones and used as a croft. The later 1852 tithe map shows no change in ownership or occupier. By the time of the 1886, 1903, 1924 and 1959 Ordnance Survey, the site remains the same and arable fields.

## 8.0 CONCLUSIONS AND RECOMMENDATIONS

- 8.1 This archaeological desk-based assessment considers land at: Startin Tractos Ltd, Main Road, Twycross, Leicestershire, CV9 3PW.
- 8.2 In accordance with central government policies, set out in NPPF 2018<sup>4</sup>, and the Leicestershire County Council brief<sup>5</sup>, this desk-based assessment has been undertaken to collect evidence for any archaeological remains on the site and to assess the significance of any heritage assets identified on or near to the site.
- 8.3 There are no Designated/non-Designated Assets, Scheduled Monuments, Registered Parks and Gardens, listed buildings or Registered Battlefields on the site. The site lies 200m north west of a medieval moated site and scheduled monument (1012524)
- 8.4 No buried archaeological remains have been recorded on the site, although archaeology has been recorded 200m south east at (MLE10079).

- 8.5 The evidence of the historic mapping shows that the site appears to have remained mostly undeveloped for approximately 170 years.
- 8.6 The area occupied by the agricultural yard and showroom Site A may have created a degree of truncation across its footprint during its development. The remaining portion of the site, Site B, appears to have remained undeveloped since at least 1842.
- 8.7 The HLCA defines Twycross as Civic and Commercial rates it as having low-medium potential for buried archaeological remains due to previous development.
- 8.8 Taking the above factors into consideration, the potential for buried archaeological remains on the site is low-medium.

## 9.0 POTENTIAL IMPACT

- 9.1 The proposed development would involve the construction of a building in the current hard standing area of the agricultural yard, Site A along with associated service trenches. The remainder of the site Site B will have some perimeter fencing
- 9.2 The construction works in the above area may involve some impact upon subsurface strata/geology, although this could depend upon any foundation base that was laid in this area for the current hardstanding. Site B will have some perimeter fencing added along its boundary, along with some earth bunding.
- 9.3 The visual and perceived settings of any registered parks, gardens, registered battlefields, listed structures or scheduled monuments will not be affected.

# 10.0 MITIGATION

10.1 Some level of evaluation and/or monitoring may be appropriate prior to or during development of the site. Consideration and implementation of such monitoring would be the decision of the Local Planning Authority Archaeological Advisor.

In November 2002, an archaeological watching brief was undertaken by ULAS during topsoil stripping and the excavation of foundation trenches on land off Church Street, Twycross. No archaeological features were observed on the east of the site, where demolition and building rubble appeared to overlie the undisturbed natural subsoil. The western half of the site was also affected by post-medieval or modern disturbance. A group of scheduled medieval earthworks, consisting of a moated site, with enclosures and fishponds are located directly to the north of this area. Pottery dating from the 12th century was recovered from the topsoil and subsoil. A desk-based assessment was carried out in 2013 due to proposals to erect a new dining block, approximately 25m x 12m in size, within the grounds of the school, the full area of which lies within the village's Conservation Area and which is also close to the historic core of the village.

There are four listed buildings in the vicinity (the church and three C18th houses). Archaeological records include a Scheduled moated site, fishponds, a medieval ditch and post-hole features behind 17-19, Church Street, and a sherd of Roman pottery from Flax Lane.

Twycross House has a datestone bearing the date 1703 and the initials WHS. The house, set at the centre of a farmstead, was the home of the Harcourt and Clare families up until the 1870s when it was acquired by the Howe estate and upgraded into a gentleman's residence. At that time the farm buildings and adjacent cottages were removed and terraced lawns and gardens created. In 1978 it was acquired for use as a school.

The proposed development is away from both the house and farm buildings. Although the 1850 tithe map hints at possible medieval burgage plots in the area the site position is well distant from any road frontage. The ground level has also changed and the dining hall site has probably been raised in the 1870s. A watching brief is suggested on the foundation trenches.

A watching brief was carried out on the 31st July and the 1st August 2013, monitoring groundworks associated with the construction of a new dining block, approximately 25m x 12m in size, within the grounds of the school. The topsoil was found to be unusually clean and noticeably devoid of finds. This, and the relatively consistent profile of topsoil (and lack of any distinct subsoil) around the site, indicated that the material had been imported onto a cleaned surface. The suggestion was made in the desk-based assessment that the area south and east of Twycross House (a former farmhouse with a datestone bearing the date 1703), once at the heart of a working farm with outlying cottages, had probably been extensively altered to create a pleasure garden when the house was acquired by the Howe estate in the 1870s. The school grounds close to the dining hall site include two terraces running across the site, bounded at the north by a wide ditch and low stone wall. REASONS FOR DESIGATION:

Around 6,000 moated sites are known in England. They consist of wide ditches, often or seasonally water-filled, partly or completely enclosing one or more islands of dry ground on which stood domestic or religious buildings. In some cases the islands were used for horticulture. The majority of moated sites served as prestigious aristocratic and seigneurial residences with the provision of a moat intended as a status symbol rather than a practical military defence. The peak period during which moated sites were built was between about 1250 and 1350 and by far the greatest concentration lies in central and eastern parts of England. However, moated sites were built throughout the medieval period, are widely scattered throughout England and exhibit a high level of diversity in their forms and sizes. They form a significant class of medieval monument and are important for the understanding of the distribution of wealth and status in the countryside. Many examples provide conditions favourable to the survival of organic remains.

The moat and fishponds at Twycross survive well. The earthworks are well defined and the monument is of high archaeological potential due both to the lack of disturbance and to waterlogging in part of the moat and one of the ponds providing conditions favourable to the preservation of organic remains.

## **DETAILS**:

The monument at Twycross is located on the north side of the village and includes two separate areas: the first containing a moat and fishpond, and the second situated 100m to the north containing two fishponds.

The moated site is rectangular and measures  $55m \times 65m$  overall. The moat ditch is mainly dry with the exception of part of the northern arm. It measures an average of 1m deep and 10m wide but widens out considerably in the south- eastern corner and has an entrance causeway, thought to be original, on the south side. On the north-east side of the moat is a long fishpond, situated on lower ground, measuring  $10m \times 45m$  and up to 2m deep and connected to the moat by a short channel. The two fishponds in the second area lie parallel to a stream on its southern bank and had a connecting channel to the stream, now silted, at the eastern end. The ponds are embanked and measure  $10m \times 30m$  and  $10m \times 35m$  respectively and about 2m deep, the north-eastern pond containing water, with a 5m wide causeway between the two.
