Condition Survey Report

Parcel 1

This parcel was situated on an area of pasture, sloping steeply downhill towards the west. A ravine / stream bed separated this area from Parcel 1A. Access was agreed with the farmer and parking was situated within the courtyard of the farm buildings.

Parcel 1A

Similarly located on pasture, the land in this parcel sloped both steeply down towards the west as well as to the north and south in an undulating fashion. The same access and parking was used as in Parcel 1.

This parcel was situated on an area of rough scrub and grassland, with a grassed mound of spoil running along the western boundary. Parking and access was to the west of the parcel along an access track.

This parcel was located in a small area of pasture containing a sharp slope down to the north halfway along the field. Parking and access was along a tarmac track just to the north of the parcel.

This parcel was situated within an arable field containing a recently planted crop. Some disturbance to the tilled soil was caused during survey, however the young crop appeared to be unaffected by the footfall. Access was agreed with the landowners of the adjacent yard (Laird R) and parking was situated in the entrance to an adjacent field to the south west of the survey area.

Parcel 4A

This parcel has the same ground conditions, access and parking as Parcel 4. The area was separated from Parcel 4 by a narrow drainage ditch.

This area was located in a pasture field containing grazing rams. The eastern half of the parcel was located on level land, which then dropped steeply down to the north-west towards the farm buildings. Access was from the road to the east running alongside the survey area, and parking was in a shallow layby.

This parcel was located in a pasture field containing grazing sheep. The land sloped gently down to the west until near the western boundary it became much steeper. The parcel was accessed from a disused road running along the west of the area, followed by a walk up a steep farm track to the east of this. This track was unsuitable for car access and so the vehicle was parked in a shallow layby on the disused road.

Parcel 6A

Similarly to Parcel 6, this parcel also contained grazing sheep. Access was through a farm gate from Parcel 6. The land in this area was relatively level in the south-eastern part, then sloped steeply down to the west and to the north. Access and parking was the same as for Parcel 6.

This parcel contained a herd of cattle and was therefore unsafe for survey during the first phase of works in April. The parcel was revisited during the second phase in May once the cattle had been relocated, and survey was successfully completed.

This parcel was located in an area of fairly level pasture, with a boggy area and some standing water in the west of the field from a possible ruptured drain / water pipe. The southern and south-western boundary of the parcel was built up slightly and was also in a boggy condition, unsuitable for survey. An area of silage in the north-east of the parcel caused a small obstruction to the survey. Access and parking was in a layby on the road running along the south-western boundary of the parcel.
