To my son John Marten and my daughter Mary Wood each one guinea. To my daughter Anne Marten the sum of 50/- a year till she is 21—at the age of 21 £300. To my son William Marten all my land called New Close together with all my land lying in Keymer and also the tythes belonging to the same—paying to Anne my wife £20 a year for his life. To my son William Marten all my goods and chattels etc. Executor, William Marten. John and Thomas Marten Executors in trust. Witnesses, Michael Marten junior, Ruth Caffin, Thomas Wilson.

His talents were of the most solid and useful order, and his sound and discriminating judgment his engaging affability of manners, his undeviating puncuality and steady perseverance in whatever he undertook, added to his unimpeached uprightness, his known generosity, and the holiness of his life, made him not only a chief pillar and ornament of the Society to which be belonged, but an invaluable member of the community at large, and especially of the many religious and charitable institutions which he was concerned in conducting. As his memory is endeared to numbers, may his example long be remembered and the same spirit and the same faith that guided him in life and supported him in death, influence many to tread in his steps, and thus supplying the loss the public has sustained. His remains were interred yesterday morning in the Friends' burial ground in this town, attended by a numerous and respectable train of relatives and other sincere admirers, and also by about 500 children from the Lewes Subscription School, of which he has been one of the first promoters and most active Directors."
