Context Sheets

Context numbers start at [94] which follows on from the earlier work in the area under XSF10.

Context sheets for [323], [351], [352] and [353] are missing but these contexts are all recorded on the Index of Archaeological Association.

Contexts from the Moorgate Spur Grout Shafts, the Farringdon Road Utilities Diversion, the Tree Root Test Pits and the Charterhouse Square Borehole watching briefs were not included in the post-excavation phasing, and therefore, are not on the Index of Archaeological Association, but they are

recorded on the context register. Context sheet for [1008] is missing but is described in the summary report.

Matrices

The sub-group and group information exists in the Index of Archaeological Association and there are original sub-group/group matrices included except for the groups 47-63 for which the original matrix could not be located.

Plans and Sections

The small scale of the boreholes investigated in the Grout Shaft means that the sections cannot meaningfully be shown on the Site Plan. They are included on the respective site plans for BH1 and BH2 and recorded on the Plan Register.

Finds

The finds from the Community Dig have been boxed separately and the boxes given numbers prefixed with C. There is also a separate finds inventory for these boxes.

There are no Clay Tobacco Pipe recording sheets for contexts from 210-329 although data for these objects is included.
