A WARRANT FOR LEVYING THE VICOUNTAL RENTE.

S^r Thomas Swinburne Knight high Sheriff of the said County to John Swinburne and Francis Frankland and to either of them greeting Theis are to authorise yo^u and likewise by virtue of my Office to comānd yo^u that forthwth vpon receipte hereof yo^u do collect levy & receive att the seūall townnes ⁊ places herevnder written all such sūme and sūmes of monye as are hereafter expressed being the Rent^e of Assize otherwise called the Vicountall Rent^e due to his Ma^{tie} for this p̄sent year 1629, and levyable by the Sheriff for the tyme being. And where they shall refuse to make p̄sent payment thereof, that then imediately yo^u distreyne, ⁊ the distresse soe taken, to sell rendering to the owners the overplus And I do lykewise authorise yo^u to give acquittances for the same if they be demanded they payeing yo^u for the same. And I doe also charge ⁊ command all ⁊ eūy my Bayliff^e to be aydeing ⁊ assisting to yo^u herein. Given vnder my hand ⁊ seale of my Office this twentieth day of September An^o R^{ex} Caroli Anglie ꝑc.
