I.—EXCHEQUER COMMISSIONS AND DEPOSITIONS RELATING TO NORTHUMBERLAND.

Amongst the appendixes to five of the volumes of the reports of the deputy keeper of public records, there are descriptive catalogues of proceedings on the Queen's Remembrancer's or equity side of the Exchequer which consist of *Special Commissions* from Elizabeth to Victoria, and of *Depositions* from Elizabeth to George II. They relate to 'concealed lands,' to the possessions of persons attainted, and of debtors to the Crown; to encroachments and intrusions, to tithes, woods, sea banks, mills, the boundaries of ports, etc.

Mr. Scargill-Bird, in his *Guide to the Public Record Office*, describes them as abounding with legal and topographical information of the highest value and interest; and Mr. Rye, in his *Records and Record Searching*, says that they constitute probably the most useful calendar yet produced by the Record Office.

Unfortunately, this calendar is scattered over five different volumes of reports not easy of access to our members. The calendar is, moreover, merely chronological and not alphabetical, and is unindexed. No doubt much information from it has already filtered into public knowledge, but until a local digest is made there is always danger that some important items may be overlooked.

I have, therefore, thought it advisable to extract such of the entries as relate to Newcastle, Northumberland and the parts of Durham now included in Northumberland, and these extracts I have the pleasure of bringing before the notice of the society.

The compiler of the appendixes appears to have made many mistakes in North country names but it has been found impracticable to correct his errors.
