# V.—SOME ACCOUNT OF ILDERTON AND THE ILDERTONS.

The Genius . . . led me to the highest pinnacle of the rock, and placing me on the top of it, Cast thy eyes eastward, said he, and tell me what thou seest. I see, said I, a huge valley, and a prodigious tide of water rolling through it. The Valley that thou seest, said he, is the Vale of Misery, and the tide of water that thou seest is part of the great Tide of Eternity. . . . . . Examine now, said he, this sea that is bounded with darkness at both ends, and tell me what thou discoverest in it. I see a bridge, said I, standing in the midst of the tide. The bridge thou seest, said he, is Human Life.—'The Visions of Mirza' in the Spectator, No. 159.

In a brilliant and suggestive paper on the 'Names of Persons and Places mentioned in the Early Lives of St. Cuthbert,' the late Mr. C. J. Bates attempted to prove that the home of Kenswith, the foster mother of St. Cuthbert, was at Roddam. This suggestion lends weight to the identification of the adjoining township of Ilderton, as representing the vill whence came Hildemar, king Egfrid's prefect, who, seemingly about the year 680, journeyed to Lindisfarne to supplicate St. Cuthbert, when prior to that house, to go back with him to minister to his afflicted wife, and after her looked-for death, to grant her the privilege of burial in Holy Island.

If the arch thrown across the centuries be too unsubstantial to bear the weight of criticism, or if, like the bridge seen by Mirza in the valley of Bagdad, it be but a splendid vision,

there is documentary evidence to carry back the history of the very ancient house of Ilderton to the period of the Norman Conquest.

In a grant made by Stephen, when at York in 1135, or 1136, to Gospatric II (who was killed at the battle of the Standard, 22nd August, 1138), amongst the manors and lands was the land of Liulf, son of Uctred, to wit, the three Middletons, Roddam, etc. (terram Liulf filii Uctredi videlicet tres Mideltonas, et Roden).<sup>3</sup> In 1201, Gospatric's great grandson, Patrick I, earl of Dunbar, owed ten marks for having a jury of twelve men of Bewick, Eglingham, Middleton, and Roddam, to enquire whether amongst the lands, etc., forfeited to the Crown by his great uncle Edgar were the services of Liulf, son of Liulf, before the first coronation (1154) of Henry II, of the three Middletons and of Roddam.<sup>4</sup> A similar enquiry was made in 1210.<sup>5</sup>

Liulf was succeeded in the three Middletons and Roddam by his son Thomas (*Tomas filius Liulf*),<sup>6</sup> who was dead before 1211, when Thomas, son of Thomas de Hildreton, rendered an account of 100 marks for having his lands Middelton and Roddum (part of earl Patrick's fee), which were in the king's hand.<sup>7</sup>

Thomas de Hildreton was succeeded by Henry de Hildreton, who held the three Middletons about 1235, when the great

medieval feedary known as Testa de Nevill was made,<sup>8</sup> and although the name of his feudal superior only is given in the certificate, as tenant *in capite*, of Ilderton, Rosedon and Wooperton, it seems in every way probable that Henry de Ilderton already held those vills, from William de Ros, as of his barony of Wark-on-Tweed.<sup>9</sup>

The family of Roos, or Ros, who inherited Wark from their collateral ancestor Walter Espec (died 1153)—to whom the manor was granted by Henry I—bore the arms, or, three water bougets sable, derived and differenced from the arms of Roos of Hamlake, gules three water bougets argent, and from them, as their feudal superiors, the Ildertons were permitted to take, and have continued to bear, similar arms, differenced in tincture, argent three water bougets sable. 10

When the priory of Kirkham in Yorkshire was founded in 1121 by Walter Espec in memory, it is said, of his only son, who was killed near that place by a fall from his horse, he endowed it with the Northumbrian churches of Hildretune, Carham-on-Tweed, and Kirknewton, with many manors and estates.<sup>11</sup>

The prior of Kirkham was defendant in a suit brought by Thomas de Hylderton, at the Northumberland assizes in 1256, respecting lands in Hilderton. At the same assizes the latter was defendant in a suit brought by Thomas de Middleton for the manors of Middleton and Wooperton. 12 It was probably as an outcome of the first of these suits that Thomas de Hilderton

granted to the canons of Kirkham and to the church of St. Michael in Ilderton common of pasture in Ilderton for fifteen cows, and one bull, for six mares, six swine and one boar, for eight oxen and four hundred sheep, with wood for fuel. <sup>13</sup> By another charter he gave 4 lbs. of wax to be rendered yearly on the altar of Ilderton on Michaelmas day. <sup>14</sup>

At the Northumberland assizes in 1279 there were suits—difficult to comprehend in their bearings—brought by William, son of William de Ros of Myndrum, as next heir of Henry de Ylderton, against John de Middleton and Alan de Lilleburn, for two parts of two carucates of land in Ylderton, and against Elizabeth, daughter of Richard le Fleming, for the remaining third part of the said two carucates.<sup>15</sup>

In the month of January, 1289-90, it was found that Henry de Hilderton held of Patrick, earl of Dunbar, the three Middletons with Roddam at the rent of 30s. 16

In 1293 Robert de Ros, as lord of the barony of Wark, asserted his right, as against the Crown, to have free warren and other privileges in all his manors, including Ilderton and Rosedon; 17 but on the 6th October, 1307, on the petition of Thomas de Gray, free warren in their demesne lands in Ilderton, Middleton, Roddam, and Rosedon, was granted to Henry de Ilderton and his heirs. 18

By inquisition taken on the Saturday before the feast of St. Gregory the pope (March 12), in the second year of Edward 11 (1308-9), on the death of Patrick, earl of Dunbar, it was found that he died seised, *inter alia*, of the three Middletons and Rodom, which render the farm of St. Cuthbert (that is a rent payable on St. Cuthbert's day), viz., 30s. yearly.<sup>19</sup>

At this period the condition of Northumberland was terrible, wasted by rebellion and ravaged by the Scots, 'no one daring to live in it except under the shadow of a castle or walled town.' <sup>20</sup> The neighbouring family of Roddam of Roddam was amongst the sufferers, and in 1309, a rent charge of six marks out of the moiety of Roddam held of John de Roddam by Henry de Ilderton was conveyed to Richard Embleton of Newcastle, probably by way of mortgage or security. <sup>21</sup>

Henry de Ildreton was one of the attesting witnesses to a grant of land in Beanly moor made by William de Benley to Sir John de Lilleburne, knight, on the 28th May, 1320.<sup>22</sup> Having no son, he sought, and in 1328 obtained, licence<sup>23</sup> to

settle his manor of Ilderton, held as of the manor of Wark-on-Tweed, upon himself for life, and, after his decease, upon Thomas, son of Walter Wetewang and Alice his wife, in tail, and, if they should die without issue, with remainder to his own right heirs.<sup>24</sup> He seems to have been still alive 19th February, 1334-5, when among the possessions forfeited by Patrick, earl of Dunbar, and granted on that date to Henry Percy, there were the homage and service of Henry de Ilderton for his tenements in the towns of Middleton and Roddam.<sup>25</sup>

Lady Margery de Ilderton in Northumberland, who died circa 1338, was buried in the church of the Augustine Friars in London.<sup>26</sup>

Seeing that the settlement made by Henry de Ilderton in 1328 was upon Thomas Wetewang and Alice his wife and their heirs, it is in every way probable that she was daughter, or other near kinswoman, of the settler. Thomas Wetewang was, no doubt, a member of the family of Wetwang of Dunston, whose pedigree-in which Thomas is not placed-is set out in the second volume of the new History of Northumberland. He evidently assumed the territorial name of Ilderton, and, as Thomas de Ilderton, he held, in 1346, the vills of Ildreton,

Weperdon, and Rosden, from Sir John Montague, knight, as of the barony of Ros;<sup>27</sup> and, in 1367, he acquired six marks of land, or rent, in Roddam, from Thomas de Cougate<sup>28</sup> and Agnes his wife.<sup>29</sup>

To a grant of lands made by Alan de Strother, at Kirkharle, July 7th, 1352, Sir Thomas de Ildyrton, knight, was an attesting witness. He was one of the thirteen knights who were present at the great feast made by the abbot of Alnwick to Henry, fifth lord Percy of Alnwick, on the 15th August, 1376, when, besides the 206 who sat down in the refectory, 1020 persons were regaled in the cloisters. He was also an attesting witness to a Strother charter, given at Lanton on the 1st February, 1371-2. As sheriff of Northumberland, at Midsummer, 1376, he went to London to receive a letter of acquittance for 4000 marks paid by Robert, king of Scotland, as the ransom of David II; and on the 20th October of that year payment was ordered to be made to him for his expenses, from York to London and back to York. 33

On the 24th May, 1379, being at Westminster, Sir Thomas de Ilderton and Sir John Heron, knights, entered into covenants to undertake the ward of Berwick-on-Tweed, from Trinity Sunday, for one year, for the payment of 1000 marks per annum, one or other of them to be constantly in the town living or dead. Attached to the indenture are two seals, one of them being evidently Sir John Heron's own seal armorial, a chevron between three herons, the other, apparently borrowed by Sir

Thomas Ilderton, has the legend SIGILLYM WALTERI DE SWYNHOW—three swine two and one, within an engrailed bordure.<sup>34</sup> A similar agreement was made by Ildreton and Heron with John of Gaunt, duke of Lancaster, 17th December, 1381.<sup>35</sup>

In the meanwhile, on the 27th July, 1379, he had been appointed by the duke of Lancaster, to be constable of Bamburgh castle, being by him styled, his 'very dear and well beloved Bachelor Monsieur Thomas de Ildreton.'<sup>36</sup> He received commissions of array in 1377, 1380, and 1381,<sup>37</sup> and a commission of the peace and of over and terminer in 1382.<sup>38</sup> In 1383 he was one of the sixty-seven knights who, with a thousand squires and archers, were retained by the earl of Northumberland for the defence of the Borders.<sup>39</sup>

On the 7th August, 1400, three knights and three squires, of whom Edward Ilderton, esq., was one, were ordered by Henry IV to proceed to Scotland to deliver in person the king's letters to the king and nobles of Scotland to demand their homage, and, this done, to publish them in Edinburgh, Kelso, and other towns in Scotland. Of him little is recorded, but in 1434 the fine estate of Grindon in the parish of Norham belonged to Thomas de Ilderton of Ilderton as son of Edward who was cousin and heir of Robert de Clifford.

The Thomas de Ildirton to whom the tower of Ilderton belonged in 1415<sup>42</sup> must therefore have been son of the above named Edward. He was knight of the shire in 1423-1424, and in 1428

was possessed of some property at North Charlton in the parish of Ellingham, 43 and held the vills of Ilderton, Rosedon, and Wooperton of Ralph Grey, as of his lordship of Wark.44 received a commission of array in 1434, took the oath, but apparently did not act;45 and on the 14th May, 1435, under the description of Thomas Ilderton of Alnwick, esq., he obtained a pardon for not appearing before the justices to answer Ralph Holand, citizen and draper, of London, touching a plea of debt Finally, being present at the battle of of 18l. 13s. 10d.46 Wakefield on the 30th December, 1460, he received knighthood by the hands of the earl of Northumberland: 47 and he probably was the Thomas Hyldertone, knight, whose name, written in a fifteenth century hand, is inscribed in the Liber Vitae, which, before the dissolution of religious houses, lay on the high altar at Durham.48

The Thomas Ilderton, knighted in 1460, may possibly have been father to the Thomas Ilderton 'esquire' who died on the 11th November, 1478, leaving his eldest son about nine or ten years of age.

In the inquisition, on his death, taken at Alnwick on the 12th June, 1480, it was stated that he died seised of the manor of Ilderton, the vill of Rosedon, a moiety of the manor of [North] Charlton, of a tenement in Wooperton, of a tenement and 40 acres of land in Shipley; and, conjointly with Philippa his wife, of a tenement and 100 acres of land in Coupland. His wife Philippa was living, and Thomas Ilderton, his son and heir, was then aged 11 years and upwards.<sup>49</sup>

In Thomas Ilderton, the son, the family possessions were augmented, for he held a moiety of Detchant in Bamburghshire in 1480,<sup>50</sup> a tenement in Rennington in 1498,<sup>51</sup> and on the 17th June, 1503, he took a conveyance of lands in Broxfield from the trustees of Robert Sokpeth or Soopeth.<sup>52</sup>

Sir Thomas Ilderton was dubbed a knight bachelor in Scotland by the earl of Surrey on or about the 30th September, 1497; <sup>53</sup> was sheriff of Northumberland in 1504, and, on the 20th March, 1505/6, as son and heir of Thomas Ilderton, lately deceased, conveyed lands in Coldstrother and Kirkheaton, 'as they all descended to me by hereditary right from my father Thomas Ilderton,' to Thomas Shafto. He appends to the deed 'the seal of office of the mayoralty of Newcastle,' as his own 'seal is unknown to many'; the latter, also affixed, and bearing three water bougets, is earlier in date than 1506 and may possibly have been that of Sir Thomas's grandfather. <sup>54</sup> He seems to have died very soon after. <sup>55</sup>

In an inquisition taken at Newcastle in the 21st year of Henry vii (1505-1506) with regard to an accusation made against his conduct when high sheriff, he is described as 'Thomas Ilderton late of Ilderton, knight, late sheriff of the county'; he was alive 12 July, 1504, when 'without any reasonable cause'—so ran the accusation—at Terreburn [query Tarretburn on the North Tyne] he seized 'by extortion and unjustly by his great power (ex magna sua potencia) the cattle of Andrew Forster, and on the same day he seized the cattle of Joan Forster and Agnes

Forster, widows.' To these charges no doubt sir Thomas would have been able to make good answer had he been alive.<sup>56</sup>

Ralph Ilderton headed the Ilderton contingent of horsemen at the muster taken by Sir Robert Ellerker, knight, on Coldmartin moor, on the 17th April, 1538.<sup>57</sup> As one of the gentlemen in fee with the warden of the middle marches he was paid, circa 1528, 40s. a year.<sup>58</sup> Ralph Ilderton, who evidently received his christian name from his father's neighbour and feudal superior, Sir Ralph Grey of Wark, possessed at Ilderton one of the strongest towers (although in bad repair) in the district; in 1541 it was coupled with Hebburn, near Chillingham, as 'a mete place for a garrison of 50 [foot] men' in time of war.<sup>59</sup> He died soon afterwards, for the earl of Hertford, writing from Alnwick castle, 19th November, 1542, to Sir Thomas Wriothesley, recommends a certain Thomas Carlylle who had done 'good and forward sarvis,' that the king would be pleased to bestow on him the 'pencion of xx nobuls that Rafe Eldertun, late desesid, had.'60

In the Order of the Watches upon the Middle Marches, as set out in the month of October, 1552, it was ordered:—

The passages from Elderton to South Mydleton to be watched with six men, nightly, of the inhabitors of Elderton, Wapperden, and Roston. Setters and searchers, from Rodam to South Myddleton, Anthony Elderton and John Rodam.<sup>61</sup>

It will be observed that the first of the two setters and searchers of the watch bore the same name and was probably the same man who followed his laird at the muster in 1538.

The portion of the feedary's book of 1568 relating to Glendale and the adjacent parts of the county, though obviously imperfect, contains the statement that Thomas Ilderton held Ilderton and Rosedon with other lands at Branton and Shipley<sup>62</sup>

According to the statement made in the return to an inquisition taken at Alnwick on the 28th July, 1579, Thomas Ilderton, described as esquire, died on the 6th April, 1578, but, as his will is dated on the 29th of that month and year, there is evidently a mistake in one or other of the documents. It was found that he held in fee tail the castle and lordship of Ildertoun, and Rossedoun, that he died without issue male, and that Thomas Ilderton of London, gentleman, was his kinsman and heir male: the latter was of full age. 63

Mr. Ilderton's will dated, as has been already mentioned, 29th April, 1578, is printed in the second volume of Wills and Inventories, published by the Surtees Society, and will repay a The testator, after appointing his wife Isabel and Sir Thomas Grey, knight, executors, gives his 'beste horse' to Sir Thomas with all his 'houndes' except two, named 'Waklet' and 'Ruffler,' which he gives to captain Reade. To Mr. Roger Grey he gives his gold chain, his 'velvett bonett, with xxiiij buttons of golde,' and his 'cloke gardyt with velvett.' To his servant, John Ellerker, he gives his larger 'cros-bowe, withe the windowe [windlass] and greate boltes.' To Mr. Thomas Forster of Adderston he gives 'a cros-bowe and a rakke, with a caise of boltes.' He gives his corn on the ground to his wife, to his aunt Sotheron and 'balyf weif of Whickham.' He mentions his tenants at East and West Harbroughe and Blackbroughe, his house at Newcastle and his lands in Felkington. To Edward Ilderton he gives his tenement for ten years on nominal terms,

and gives to Thomas Ilderton of the Langehaughe<sup>64</sup> the reversion of his house at Newcastle, certain cattle, and 'one white fustiane dublett layde withe white silver layse,' etc. The testator neither mentions nor seems to refer to his heir-at-law. The will was proved at Durham on the 16th of March, 1578/9.<sup>65</sup>

The degree of consanguinity which subsisted between the testator and Thomas Ilderton of London, the heir of entail, has not been ascertained. It is possible that the latter never came north to take possession; at all events he did not enjoy his heritage for more than eight years. By an inquisition taken at Morpeth on the 24th September, 1588, in which he is described as Thomas Ilderton of Ilderton, gentleman, it is stated that he died seised of a tower, or capital messuage, with other buildings in Ilderton; of lands there called demayne lands, and of other lands and messuages in Ilderton and Roisden. He died in London on the 1st May, 1586, and William Ilderton his brother and heir was aged 40 years at the time of the taking of the inquisition. 66

William Ilderton was succeeded, or followed, by John Ilderton, who died about 1643, an aged man, from whom all the later generations, as may be seen in the accompanying pedigrees, are descended. His descendant in the fifth generation, Thomas Ilderton of Ilderton (born 1692, died 1762), married into the Brandling family, and his sons not only succeeded to a large proportion of the valuable corn tithes of the parishes of Lesbury, Alnwick, and Shilbottle, but inherited some of the business ability of their mother's family. The old tower at Ilderton having become uninhabitable, one or more of the brothers rented from the Greys of Howick the fine farm of Hawkhill which occu-

pied a central position for making the utmost of their corn tithes, for if the farmer of the land could not be induced to purchase the tenth sheaf and the tenth stook, the tithe-owner was entitled, and in this case ready, to cart the tithe corn on to his own land.

At Hawkhill, Mr. Ilderton erected a machine for threshing corn, worked by horses. Apparently of his own invention, it attracted great attention in his day and was subsequently improved by Sir Francis Kinloch of Gilmerton, bart.<sup>67</sup>

Thomas Ilderton, the eldest and the last survivor of the brothers, died at Alnwick on the 25th October, 1789, leaving Ilderton and Rosedon to Robert Ilderton of Westoe, near South Shields, formerly a solicitor at Hexham. He must not have shown to his predecessor's widow<sup>68</sup> the deference she expected and required, for she caused to be cut on her husband's tomb at Ilderton, 'He was the last in a direct line of the family of Ilderton of Ilderton and the inheritor of all their virtues.'





One of the unmarried daughters of Robert Delaval of Cowpen being seised of the corn tithes of Rosedon, gave one moiety to her sister Alice, wife of Ralph Hebburn of Hebburn, and the other moiety to her sister Barbara, wife of Sir William Carleton of Carleton, near Penrith, knight.

Alice Hebburn devised her moiety to her two daughters Mary and Alice, of whom the survivor, as 'Mrs. Alice Hebburn of London, sp.,' by will gave her moiety to her brothers Robert and Arthur Hebburn, who were parties to the articles of agreement of 8th Sept., 1736, mentioned in the text.

Dame Barbara Carleton, having outlived her husband, by will gave her moiety to her son [Robert], who died leaving Mary Carleton, his only daughter and heiress, party to the articles of agreement of 8th Sept., 1736.

Mary Carleton, spinster, being seised of the other moiety, enter into articles of agreement, 8 Sept., 1736, for the sale of the same to Robert Ilderton of Newcastle, gent., for 225l. *Ibid*.

I give to my friend and kinsman, Charles Ilderton of Newcastle, attorney-at-law, my estates at Ilderton, Longhaugh, Rosedon, Flint-hill, Newmoor-house, my houses and granary in Newcastle in a street called Plumber Chare; also my interest in the corn tithes of Shilbottle, Hawkhill, Bilton, and Denwick and in the tithe of wool and lamb of Ilderton and Longhaugh. He executor. Pr. at Durham, 2nd April, 1792.

Yesterday sennight, deservedly lamented, Mr. Cuthbert Ilderton at his mother's house in Percy Street. Newcastle Courant, 27th Nov., 1790.

#### ADDENDA.

Isabel, wife of Thomas Ilderton of Ilderton, named on p. 113 supra, must have been a widow when he married her. She is mentioned on the will, circa 1585, of her daughter, the wife of Robert Lamb of Newcastle, merchant. Cf. Welford Newcastle and Gateshead, III, 33.

The Parish Registers of Alnham, Rothbury and Wooler contain notices of persons bearing the name who probably sprang from seventeenth and early eighteenth century cadets of the family of Ilderton.
