IV.--NOTICES ON THE FAMILY OF SPEARMAN.

[Read on 24th September, 1924.]

Although the family of Spearman of Preston in the parish of Tynemouth, afterwards of Eachwick in the parish of Heddon on the Wall, ended in the direct line in Ralph Spearman of Eachwick, the antiquary, who died in 1823 it was continued, at least for a time, by branches settled in the county of Durham at Thornley and Old Acres both of which lines produced some notable men.

John Spearman of the city of Durham, attorney and under-sheriff of the county palatine for some eight and twenty years, was baptized at Tynemouth on the 16th January, 1645/6, as son of Robert Spearman of Preston. Described as a sound and judicious lawyer and antiquary, he left a collection of MSS. some part of which is preserved in Bp. Cosin's Library at Durham, and another portion was in the possession of Mr. Robert Surtees, the He was author of the well known, and still historian. much sought after Enquiry into the Ancient and Present State of the County Palatine of Durham, a work completed and published in 1729 by his son Gilbert Spearman. Having purchased Thornley, in the parish of Kelloe, in 1678, he designed to be buried in the Thornley porch of the church, but, apparently, his wish was disregarded for the Register of Burials of Durham Cathedral has the following: "1703 September 22 Mr. John Spearman Under Sheriff " buried.

The first of the following notices, which are printed from a MS. in the handwriting of the late Rev. James Raine, canon residentiary and chancellor of York, is taken from John Spearman's account book and gives details of the cost of his eldest son's education. ¹ John Spearman fourth but eldest surviving son of John Spearman, the under sheriff, was born at Durham on the 21st March, 1671/2, and, a week later, was baptized either in the Cathedral or in St. Mary-le-Bow for the ceremony was entered in both registers. After being at school in London and at Barnet he was entered at University College, Oxford, matriculating 12th June, 1689. In the following year he was entered at the Middle Temple. He succeeded to his father's estates at Thornley and Hetton, and dying at the latter place he was buried 23rd March, 1724/5, at Houghton-le-Spring. He left issue.

²" Mr. Cuthbert " may with much probability be identified with John Cuthbert, serjeant at law, Recorder of Newcantle, who 21st July, 1690, took out a licence to marry Dorothy daughter of John Spearman the under sheriff.

Mr. Spearman would be glad to be favord with an answer. He says it w^{d} be some pleasure to him to know what relations he has in your part of the world. From an old fam^y paper penes Rad Spearman de Eachwich esq.

I do not conceive ye above brief acc^t of ye descent from Spearman of Lillishall and through that family from Aspramonte &c. to be totally groundless. The name of Aspramonte stands on ye list (true or false) called Battle Abbey Roll, ye 6th in Order, amongst William's attendants, and ye Count D'Aspramont, and several of ye family appear in ye last *Royal* army list of France. The name is said to have been changed to *Spearman* from some exploit performed during the Crusades. A very ancient iron ring said to have been worn by a crusader was preserved in ye family but accidentally lost no long time since. The arms, tho' never till lately enrolled in ye Heralds office bear evidently an allusion to ye name and motto 3 spear points—dum spiro spero and I am inclined to suppose them from this and the simplicity of the bearing, ancient.

¹⁰ Philip Spearman, eighth son and eventually heir of Edward Spearman of Preston, was baptized at Tynemouth, 31st March, 1685. He was residing at Shortflatt, 25th August, 1703, when he took out a licence to marry Jane Burfield, the bondsman being James Burfield, jun., of Shortflatt, gent. The marriage took place at Bolam the following day. The bride's father, James Burfield, resided successively at Newsham, at Seghill, at Shortflatt, and, perhaps, at Wallsend. Another of his daughters, Margaret, born at Newsham was baptized at Earsdon, 28th February, 1670/1, was married 3rd June, 1690, at Ponteland, to John Jacques, or as the name is spelled in the Register, Jakes. Philip Spearman settled at Birtley in the county of Durham and was buried at Chester-le-Street, 30th April, 1718.

¹² John Spearman of Preston and of Newcastle, seventh son of Edward Spearman of Preston, was baptized at Tynemouth, 9th January, 1682/3, and was buried there, 2nd September, 1702.

¹⁵ This statement seems to be the only known evidence of the existence of these ladies and of their respective marriages.

¹⁶ Concerning the Middletons of South Shields, Mr. H. M. Wood has furnished the following information. George Middleton of South Shields, barber surgeon, on the 24th October, 1666, took out a licence to marry Jane Milburn. They were married at South Shields the same year. Although she is described in the marriage bond as a spinster and although proof is lacking it is possible that she was a widow and that her maiden name was Spearman. The above named George Middleton was buried at South Shields, 2nd December, 1682, leaving a son of the same name baptized at South Shields 28th June, 1669. He also was a surgeon, and married 25th December, 1700, Deborah, widow of Anthony Atkinson, and daughter of ——— Trewhit by whom he had issue a son George Middleton III, baptized at South Shields, 10th October, 1701, admitted to Grays Inn 11th September, 1721, as son and heir of George Middleton deceased.

 17 Mr. Henry Burfield was rated in 1663 for lands in the parish of Wallsend at £50 per annum. Hodgson, Northumberland, 111, i, 254. He was buried at Wallsend, 15th July, 1677.

¹⁹ Matthew Bonner was son of Michael Bonner of Newcastle by his first wife Magdalen Taylor whom he married at Tynemouth, 18th January, 1635/6. He was baptized 13th March, 1638/9, at St. Andrew's, Newcastle, educated at Berwick School, and at Magdalen College, Cambridge, where he matriculated 4th April, 1654; B.A., 1657/8; M.A., 1661. He was vicar of Warkworth 1667-1679, vicar of Hartburn 1676-1679. One of these names was rector of Simonburn, 1666.

Magdalen wife of Michael Bonner was buried 7th February, 1646/7, at St. Nicholas, Newcastle. The widower married secondly 3rd June, 1647, at All Saints, Elizabeth Johnson. The statement in the text corrects the pedigree of the family of Bonner in the *History of the Family of Carr*, which ignores Michael Bonner's first marriage.

Timothy Bonner the draper was a younger brother of the above named Michael Bonner.

²⁰ Ambrose son of Richard Hamlet of Shields was baptized 12th April, 1629, at Tynemouth, and was buried there 31st May, 1678.

²¹ Elizabeth Atkinson was evidently widow of John Atkinson of Cleadon, whose daughter Margaret was married 16th November, 1620, at Tynemouth, to Thomas Spearman of Preston. A woman of those names was buried at Tynemouth, 16th May, 1629, and another of the same names on the 22nd November, 1635.

²³ James Cordie of Tynemouth and Dorothy Spearman of Preston were married 16th October, 1663, at Tynemouth. She was widow of Robert Spearman of Preston and daughter of John Pattison of Hedworth. *Cf.* Surtees *Durham*, vol. ii, p. 81.

²⁸ Thomas Horner of Glass-houses, 18th March, 1661, purchased lands in Tynemouth from John B—— and conveyed the same 6th January, 1662, to his daughter Ann Spearman. Robt. Spearman of Old Acres, will pr. at York.
