## IX.—YOUNG OF ETHERDACRE.

[Read on 25th March, 1925.]

The desire to prove descent from distinguished ancestors has notoriously produced some of the errors in the pedigrees accepted at the heralds' visitations, but many more seem to be due to mere carelessness. In August, 1666, at Dugdale's visitation, Christopher Young of Newcastle, doctor of physic, registered a pedigree which is both unassuming and erratic. He misdated the death of his father and there is reason to suspect that he misstated the parentage of his mother; one of his aunts he omitted and the other he married to a man who was not her husband; finally he bewildered posterity by describing as Christopher Young, his great-grandfather, the praepositus, whose name was Robert. His uncle William Young and his aunt Anne Reed could have corrected some of his mistakes, but evidently he did not take the trouble to ask for their assistance. Doubtless he imposed upon himself a sterner standard of accuracy in his professional work of diagnosis and prescription.

Search has proved the existence of more evidence bearing on the family than might have been expected considering its modest position, and it is possible to set out the pedigree tolerably fully without appeal to the authority of the uncritical doctor.

ROBERT YOUNG obtained with Anne his wife, in consequence of her petition to the Queen (3), a lease for 21 years, by letters patent dated 29 March, 1568, of the tithes of Wylam, of a fishery in the Tyne, of the manor of Etherdacre and of 4 burgages in Fishergate and New Elvett, city of Durham (4); complainant with his wife in the Court of Exchequer, October, 1583 (5); obtained a fresh lease for 21 years, by letters patent dated 21

February, 1593/4, of all the above premises (6); buried 9 January, 1606/7 (a); will dated 2 January 1605/6, proved at Durham before 25 March, 1607 (7).

Married before 23 December, 1567 (3) Anne daughter of Thomas Carey (3), who in December, 1537, being then a sewer of the chamber, was appointed constable of Prudhoe castle by King Henry VIII, in place of Sir Thomas Percy lately attainted (1), and became marshal of Berwick before 4 April, 1554 (2); she was buried 25 August, 1593 as "Ms Yonge generosa wyffe of Robt Yong of Ederdakers" (a).

CHRISTOPHER YOUNG, devisee of his father 2 January, 1605/6 (7); though by letters patent dated 11 February,

1606/7 the King granted the lands held by the Youngs, together with property in eight other counties, to Simon Wiseman and Richard Moore of London gentlemen (8), it was found that Etherdacre was held of the King as of his manor of East Greenwich in socage, 27 September, 1617 (9); will dated 27 November, 1623, proved at Durham 1623 (11); buried 29 November, 1623 (a).

Married Jane ...., an executor of her husband's will; to her was committed tuition of her sons William and Christopher (11); perhaps identical with "Jennett Young de Ederakers" who was buried 16 June, 1645 (a).

## APPENDIX.

The pedigree set out above accepts, from the pedigree of 1666 no detail which cannot be proved from independent evidence. A few details remain to be considered.

- I.—The wife of the *praepositus* was described in 1666 as "... dau. of ... Carye, a Mayd of Honour to Qu. Elizabeth." It is known now that Thomas Cary, her father, at one time served in the royal household. Her appointment as a maid of honour is therefore at least credible, the more so if, as is not unlikely, she was nearly related to the Queen's first cousin, Henry (Carey) lord Hunsdon, who twice intervened in the affairs of the Young family. It will be noticed however that, if she had ever been a maid of honour, she did not think it discreet to mention the fact in her petition to the Queen.
- II.—Christopher Young who died in 1623 is said to have married Jane, dau. of . . . Reed of . . . The name Jane is correct (11), and there is no definite reason for suspecting the surname. As however both a sister and a daughter of Christopher Young married a Reed, there may have been confusion in a carelessly drawn pedigree.

III.—Dr. Young described Jane his mother as "dau. of Edward Johnson a mercht. in Newcastle-upon-Tine."

A good deal can be said in support of a thesis that she was

daughter of John Johnson and half-sister of Edward Johnson.

Her husband Robert Young, alderman, mentions in his will his "cosens" Mr. Robert Shafto, alderman, and Mrs. Anne Clavering (12). The two last named were brother and sister, and their aunt Elizabeth Shafto had issue by her husband John Johnson (Surtees, Durham, iii, 294).

The registers of All Saints, Newcastle, give-

1623 July 22—Admon of the goods of John Johnson of the chapelry of All Saints, Newcastle, granted to Jane Johnson widow, for the use of herself and of Edward, Robert and John Johnson, children of the intestate.

No record has been found of the baptisms of Robert Young's daughters Elizabeth and Margaret. As stated above his name first appears in the books of the Merchant Adventurers Company 20 Sept. 1635, when he is described as boothman. In the same year one Robert Young, described, perhaps incorrectly, as mercer, was admitted a freeman of Newcastle. It is uncertain where and how he was employed in the period 1620-1635. Between 26 Dec. 1621 and 13 June 1634 the registers of All Saints record the baptisms of John and Jane, and the baptisms and burials of Dorcas, Margaret and Mary, children of Robert Young, yeoman.
