York, together with the advowsons of the churches of these manors, and other things pertaining, held of the King *in capite*, to be had and held to whom he may give them, of the King and his heirs by customary services.²³

To have, of the chief lords, by the services due; paying to Dalton and heirs a rose yearly for other services. Dalton and heirs warrant. Witnesses: as of 117.

A.D. 1310: April 24. At Durham the Friday next after the Feast of St. George the Martyr A.D. "*millesimo trecentesimo decimo.*" Indenture witnessing that when John de Denum

recovered possession, by writ of novel disseisin, against Sir William Basset, knight, of a messuage, 100 acres of land, 12 acres of wood, and 30 acres of moor and pasture in Uffurton in the presence of Lambert de Trikyngham and companions on [the date as above], it was agreed John should not pursue execution of judgment of the writ before [a day fixed] on which if William or heirs should at the Monastery at Durham pay to John 110 marks of silver John would not make execution of judgment, but on the contrary would renounce his claim in the lands and would surrender all writings which he had of Sir Henry de Guldeford to the same Sir William with quit claim of all right to the said tenements. If Sir William or heirs make not satisfaction concerning the 110 marks, John should have the lands according to the form of recovery, it nevertheless being observed that if William or heirs pay to John 42 pounds of silver at the monastery of Durham in the feast of St. Michael Archangel in 1320 John should return and deliver to the said William the said tenements to be held for ever, otherwise they should remain to John for ever.

To have to Gilbert for life, paying yearly to Richard and heirs 25s. and a quarteriam of salt for all services, and doing for Richard and heirs the services due to the chief lord. Thomas shall keep tenement and land in as good state as he found them, and shall enclose the meadow of Peter near Thynforde when necessary. Patrick may hold, quit of all commons and estovers; but, if John's cattle enter these boundaries by reason of defect of enclosure they are not to be impounded, nor for any cause detained. Chirograph between (1) Richard [Kellawe] bishop of Durham and (2) Thomas du Boys, Lucia de Hessewell, William de Silkesworth, William de Bordone, and Ralph de Gretham: that these latter have granted to the bishop 24 acres of moor in Hessewell upon the Whiteside lying hard by the field of the same bishop [in] Shirburn. To have [etc.], to the bishop and successors in severalty all the year. Thomas, Lucia [etc.], and heirs warrant. And they have quit claimed for themselves and heirs to the bishop and his successors all the right they might have to right of common for their animals in lands or pastures of the same bishop in Shirburn and Shaldeford. And they have granted for themselves and heirs that the said bishop and his successors may hold their [the bishop's, etc.] lands and pastures aforesaid in severalty all the year for ever without the grantors' opposition or their heirs'. Furthermore, Geoffrey, prior of Durham, and Thomas de Goldesburgh, archdeacon of Durham, for themselves and successors, and Robert Page, William de Hessewell de Scotia for themselves and heirs have quit claimed to the bishop and his successors all right they might have to right of common for their animals in Shirburn and Shaldeford,

and in the aforesaid 24 acres of moor in Hessewell. For this donation and quit claim the bishop has quit claimed for himself and successors to Thomas, Lucia, William, William, and Ralph all the right he might have to right of common for his animals and those of his men of Shirburn and Shaldeford in lands or pastures in Hessewell, and he grants that Thomas, Lucia, [etc.], may have all their lands and pastures in the aforesaid vill of Hessewell in severalty all the year without his opposition or his successors'. And furthermore [in certain eventualities specified in the deed, it is agreed that these agreements and quit claims, as set forth above, shall be cancelled, and rights and claims shall remain as they were before the making of the present deed].
