VI.—A SECOND CALENDAR OF GREENWELL DEEDS.

[Read on 30th October, 1929.]

A calendar of the "Greenwell deeds" preserved in the Public Library of Newcastle upon Tyne formed the third volume of the present series of Archæologia Aeliana. This consisted, with a few exceptions, of local deeds. Dr. Greenwell's collection, however, contained a number of non-local deeds which, at the sale of his effects, were purchased by Mr. C. H. Hunter Blair; these form part I of the following calendar. The deeds are numbered consecutively throughout, the numbers within square brackets referring to the original numbers in Dr. Greenwell's books of transcripts from which (except numbers 44-47) this calendar has been made. The calendar is largely the work of our vice-president, Dr. F. W. Dendy, F.S.A. The deeds forming part I have been collated with the originals by our member, Mr. A. M. Oliver, M.A., whilst the notes are chiefly the work of Mr. C. H. Hunter Blair. It consists of three parts:

- I. Nos. 1-43, non-local deeds from the Greenwell collection.
- II. Nos. 44-47, four deeds belonging to Mr. Aylwin Raimes of Yarm.
- III. Nos. 48-84, deeds which were in Dr. Greenwell's collection and were transcribed by him, the originals of which cannot now be traced.¹

The reference (Durham Seals) is to the catalogue of seals in the treasury of the dean and chapter of Durham con-


