III.—CALENDAR OF DEEDS GIVEN TO THE SOCIETY BY LORD RAVENSWORTH.

INTRODUCTION.

The collection of deeds here calendared was given to the society by the present Lord Ravensworth through the agency of our members, Mr. W. W. Gibson and Mr. J. E. Stafford. They relate mainly to lands to the south-west of Gateshead, in and around Ravensworth, Eighton, Lamesley and Kibblesworth. There are eighty-two documents, varying in date from ante 1128 (no. 1) to 1698 (no. 82), providing wide divergences in form and handwriting, from the neat little quitclaim of Adam de Ravensworth, made in the first half of the thirteenth century (no. 9), to the cumbrous exemplification of a recovery, made at the end of the seventeenth (no. 82). The most interesting individual documents are perhaps the two earliest—the original grant by Ranulph Flambard to his nephew of Ravensworth, etc. (no. 1) (plate III) and Henry I's charter, confirming the grant (no. 2). But the real value of the collection is as a whole, for the evidence which it supplies concerning the descent of property in the area and about the families of the neighbourhood, many of whose members acted as witnesses to the transactions here recorded.

The deeds were placed in my care last April, and have been arranged and calendared during the summer of this year. When they were handed to me, the majority were

in two boxes, probably of seventeenth century origin, labelled No. 2 and No. 3:1 deeds in Box No. 2 were endorsed with nos. 1-31, and in Box No. 3 with nos. 1-36 (a single number describing, in several cases, a pair of indentures). Since the deeds outside the boxes were not numbered consecutively, it seemed best to re-number the whole collection. This has been done; but, so far as possible, the original order has not been disturbed, being roughly chronological. Each deed is now in a separate envelope, on the outside of which is indicated the new number and also the old. The new numbers correspond, of course, to those in the calendar which follows.

Many of the witnesses to the following deeds, especially in the earlier period, also occur in the Finchale documents, printed in 1837 by the Surtees Society; some of them in the volume of Northumberland and Durham Deeds. edited by a former member of this society;² for the identifications of both persons and places in the deeds, Surtees' History of the County of Durham has been invaluable. Finally, I should like to acknowledge the advice and help of Mr. S. C. Ratcliff on several problems arising out of this calendar.

THE CALENDAR³

I. [Before 1128.4] Grant by Ranulph, bishop of Durham, to Richard his nephew of Hectona, Raueneswrthe and Blaikestona, by these boundaries, pertaining to Hectona and Raueneswrthe, to wit, from Scadneslaue upon the east by the issue of the spring under Scadneslaue as it falls into Tame, by Tame to where Mereburne falls into Tame, by Mereburne to Aldrethesdene, by Aldrethesdene to Tame, by Tame to where Beccleiburne falls into Tame, by Beccleiburne to the river that falls from Felfordesfen, by Felfordesfen

to Auescheburne, by Aueskesburne to Blakesburne, by Blakesburne upon the east to where it falls into Tame, by Tame to where Choldene falls into Tame, by Choldene to Semer, and from Semer by the high road to Scadneslaue. To hold at service of half a knight.

Witnesses: Ranulph the archdeacon, Papamonus, Osbert, nephew of the bishop, Robert his brother, William, son of Ranulph, Urricus, Richard de Untedune, Payne, nephew of Ranulph.

Noted that the deed was read in court, 4 August 1716.

Seal, wrapt in wool and sewn in a linen bag, is now in small pieces and undecipherable; it was the seal illustrated, fig. 2 on plate IV, from an example in Durham Treasury, seal catalogue, no. 3110.

2. [1129.⁵] Charter of Henry I to Richard, nephew of Ranulph, bishop of Durham, granting to him the land of Ethun, Raueneswrda and Blechestona, as was granted by Ranulph in no. 1.

Witnesses: Roger, bishop of Salisbury, Nigel de Albin', Walter Espec, Geoffrey, son of Payne. At Portsmouth.

Noted that the deed was read in court, 4 August 1716.

Seal, fragment only of the fourth great seal of Henry remains attached to a strip cut off the parchment; fig. 1, plate IV, shows the complete obverse of this seal from an example in Durham Treasury catalogue, no. 3017.

- 3. Translation of nos. 1 and 2, probably made in 1716.
- 4. [Before 1290.] Grant by John de Kybbelesuurth' to William his son of a toft and 30 acres of land in the vill of Kybbelesuurth', lying between the land of Walter de Scrotevyll' on the east and west, at a yearly rent of one arrow to grantor and 3d. to the bishop of Durham; grantee to pay no multure.

Witnesses: sir John Marmeduk', Walter Scrotevyll', John de Byrteley, Gilbert [Gat]egange, John de Rauenisuurth'.

Seal, oval brown wax, 40×25 mm., a pelican in her piety feeding three young birds in a nest, beneath two birds pecking at a plant growing out of a vase. **\footnote{\text{X}}\ s'IOHANNIS DE KYBELSWOR. (No. 4, plate v.)

5. [II53-95.] Grant by Hugh, bishop of Durham, to Hugh Hauet and Philip his brother, sons of Ralph Nobil', of 20 acres of land between Yuestan and Merkesheued in the place called Croc, at a yearly rent of 12d.

Seal, which has been attached to a strip of parchment fastened through a slit in the document, is destroyed. For it see Durham seal catalogue no. 3114A and plate 48.

6. [Early 13th cent.] Quitclaim by Robert, son of Richard de Raueneswrthe to Geoffrey, son of Geoffrey, his nephew, of his right in the vills of Lamesleya, Hectona, Silkeswrthe, Hordene and Blaykestona, which belonged to Geoffrey, son of Richard, father of grantee; and of his right in the vill of Hameldona and in all other vills and lands in which Richard, his father, or Geoffrey, son of Richard, or Robert himself had any right. On account of this quitclaim Geoffrey has given to Robert 60 marks of silver and the whole vill of Raueneswrth' save waste retained in his own hand, Robert doing foreign service at a quarter of a knight's fee, with the foreign service of Hedleye.

Seal, greeny-brown wax, round, about 50 mm. in diameter, Robert, in civilian dress with flying skirts and high round hat, on horseback, galloping to the dexter a hawk upon his left hand. Legend destroyed. (Fig. 6, plate \mathbf{v} .)

7. The same as no. 6, except that 40 marks of silver is the consideration specified.

Seal the same as no. 6 but in light brown wax, a few letters of the legend are legible. The seal is covered loosely in a piece of linen. (Fig. 6, plate v.)

8. [As no. 6.] Agreement (indented in the form of a cyrograph) between sir Geoffrey, son of Geoffrey, and John, son of Adam de Raueniswrth', namely that Geoffrey has granted to John a place suitable for making a mill upon Tham' on the north of the vill of Lamesl', with right of way to the mill from the road of Lamesl'

towards Gatesheued, and has further granted a moiety of the issues of his mill of Lamesl'—the whole at a yearly rent of 3d. In return John has granted a moiety of the issues of his mill in Lamesl'.

With provisions that each shall maintain his mill and shall not let it to farm without assent of the other, and that each shall lose his part of the profits of the other's mill if he do not repair his own.

Seal destroyed.

9. [As no. 6.] Quitclaim by Adam de Raueneswrthe to Geoffrey, son of Geoffrey, of his right in the land held by Geoffrey, in exchange for (pro) the vill of Raueneswrthe, which Geoffrey has rendered to Adam.

Witnesses: Jordan Escoll', Roger Daudrer, Walter de Monasteriis, Reynald Basset, William de Latun, William de Lumel', William de Quicham, Robert de Yolton'.

Seal, sewn up in a linen cover, is in small fragments.

10. [Mid 13th cent.] Grant by Alexander de Redehou and Alice his wife to Geoffrey, son of Geoffrey, of the appurtenance (atachiamentum) of the pond of Geoffrey's mill of Lamesley upon their land of Kibleswrth, called Yerhau, at a yearly rent of 2s.

Witnesses: Robert de Yeland, William de Hossewell', William de Lumeley, Adam de Merlley, Matthew de Lumeley, Matthew his son, John de Kibleswrth, William de Birtlley, Geoffrey Ecoland, Henry de Lumeley.

The seal of Alexander which has been covered loosely in linen is now destroyed, that of Alice is in light brown wax, oval 30×22 mm., but is illegible.

11. Vigil of All Saints (31 Oct.) 1248. Ratification (indented in the form of a cyrograph) by Bertram, the prior, and the convent of Durham of the grant made by Nicholas, bishop of Durham, to Geoffrey, son of Geoffrey, of a close of his wood of Lameslegh'.

Witness: the prior's chaplain. At Durham.

The attached seal of prior Bertram has been wrapt in wool and sewn up in a fine linen bag; small fragments now only remain. The seal is no. 3431 in the catalogue of Durham seals, where it is illustrated on plate 64.

12. [Mid 13th cent.] Quitclaim and sale for 2 marks of silver by Avis, sometime daughter of Nicholas Mach, to sir Marmaduke of all that land in the field of Lameslei which Nicholas Mach her father held of sir Geoffrey, son of Geoffrey, father of Marmaduke.

Witnesses: sir John de Rumesey, then steward to sir Geoffrey, son of Geoffrey, John Gilet, sheriff, Thomas de Herington', William Basset, John de Bidich, Silvester de Dernington, Walter Pinchard.

Seal destroyed.

13. [1249-1256.] Grant by master William de Kilkenn', rector of the church of Chester by the assent of Walter, bishop of Durham, to sir Marmaduke, son of Geoffrey, of $5\frac{1}{2}$ acres of demesne lands of the church lying by (iuxta) Calkeburn' on the west in Lumel' at a yearly rent of 1d., in exchange for $5\frac{1}{2}$ acres lying on the north of Holden', which Marmaduke has granted of his demesne lands to the church.

Witnesses: Thomas de Herinton', William Basset, Adam de Bradel', Geoffrey Escouland, master Guy de Barnard Castle, Ralph de Cesterton', chaplain, Richard de Kilkenn', Simon de la Morton', Robert de Blockel'.

Small fragment of seal in green wax.

14. [Before 1280.] Quitclaim by Guy, son of Robert de Lamesley, to his lord, sir Marmaduke, son of Geoffrey, of his right in the vills of Lamesley and Horden.

Witnesses: sir W. de Mideltun, then steward of Durham, master R. de Bereuil', then sheriff of Durham, sir Robert de Neuil', sir G. Hansard, sir T. de Herigtun, sir W. Basset, sir R. de Yeland, Walter de Ludeuurth, Ranulph de Merley, Philip de Musteres, Ralph de Corneford'.

Seal, light brown wax, round, about 30 mm. diameter, a cross each limb ending in a fleur-de-lis. Legend destroyed.

15. [Late 13th cent.] Agreement (indented in the form of a cyrograph) between sir Marmaduke and Robert de Rasinsuurth' concerning the construction of a common mill in the vill of Lamisley on the lands of both parties (ubicunque magis expedit stagnum molendini fieri); expenses and profits to be shared equally.

Witnesses: William Basset, Richard de Yeland, Richard de Cruteuill', William de Byrteley, Robert de Hurpeth', John de Merley, Geoffrey de Kyblisuurth', Richard de Rasinsuurth', Gilbert de la Grene, John de Rasinsuurth', Richard de Trefford', Robert de

Lamisley.

Seal destroyed.

16. 10 Feb. 3rd year of the pontificate of Walter, bishop of Durham (1252). Licence from Walter, bishop of Durham, to Marmaduke, son of Geoffrey, to enclose and make a park of his wood, sometime called le leych' with the whole of Holdene and Byrewardes, paying 6d. yearly for the concession.

Witnesses: sir W. de Middelton', steward of the bishop, sir Robert, son of Meldred, sir Eudo de Punchardun', master Richard de Kirkeham, master Simon Guh', master Robert de Driffeld', sir P. de Well, sir William de Wyteby, chaplain, sir John Russell', sir Hugh Beyvin, sir Roger de Walteham, sir William de Hudleston', clerks. At Auclent, by the hand of master Thomas de Crauen', clerk.

Seal, in light brown wax, is wrapt in wool and sewn into a fine linen bag. It is much broken and only part of the *secretum* remains. It is the same seal as in catalogue of Durham seals, no. 3122, with the same *secretum* as on no. 3123; both are illustrated on plate 49 in that catalogue.

17. [Before 1290.] Grant by Robert Fychelinger, serviens, of Lamisley to sir John Fitz-Marmaduke⁶ of Horden of a toft, croft and 3 acres of land in the vill of Lamisley, lying between the land of John de Merley and of William le Nobill'.

Witnesses: sir Richard de Yeland', sir John de Farneacris, kts., Luke de Kibliswrth, John de Kibliswrth, Robert lord of Rainswrth, Robert, son of John de Rainswrth, Geoffrey de Rainswrth, John Gategang'.

Seal destroyed.

18. [Late 13th cent.] Quitclaim for a sum of money unspecified by Maud, daughter of Hathering', to sir John Fitz-Marmaduke of her land and right in the vill of Lamisley with lands etc. there.

Witnesses: Richard de Yeland, John de Kybliswrth', Alexander de Treford, Adam de Rasinwrth', clerk,

Seal, illegible fragment of small oval seal in light brown wax only remains.

19. Kalends of January (1 Jan.) 1288. Grant by Anthony, bishop of Durham, to sir John Fitz-Marmaduke of free warren in all the demesne lands of the manors of Lamesley and Raueneshelme within the royal liberty of Durham.

Witnesses: sir Brian, son of Alan, sir Robert de Hilton', sir Walter de Huntrecombe, sir Gwyschard de Charrom', sir Thomas de Herington', and sir Richard Knot, kts., master Nicholas de Well', archdeacon of Northumberland then chancellor of the bishop, John de Crawen', canon of Lichefeld, Adam de Driffeld', Adam de Aluerton', clericis nostris. At Auckeland'.

Seal, which has been attached by ribbon of brown silk, has now gone.

20. 4 June, 6th year of the pontificate of Richard, bishop of Durham (1223). Confirmation of Richard bishop of Durham, chancellor of the king, to Robert de Yeland' of all the land called Raueneshelm', to wit from Thame as the hedges of Lamesley stretch against the hill to the boundaries of Raueneswrth', and by those hedges of Raueneswrth' to the high-road (chiminus) between Raueneswrth' and Quicham, by that high-road to Blakeburn', falling to Thame, and thus by Thame climbing to the boundaries of Lamesley, as is contained in the charter of Geoffrey, son of Geoffrey, which the bishop has inspected.

With further grant of reasonable estover and common of pasture in the bishop's forest.

Witnesses: Roger Daudrer, Jordan Heyrun', Robert de Kokefeld', John de Pevton, Thomas son of Bernard, William Briton', Richard de Holmeside', Reynald Dalbelin, Thomas Bard', William Harpin', Adam de Merley, Robert de Langeley, Robert de Koggeshall', Geoffrey de Akeshel'. At Durham.

The seal, attached by woven cords of green and white silk, is that of Richard Marsh, bishop of Durham (1217-1226); only a fragment remains, but enough to show that it is the same seal and secretum as no. 3118 in catalogue of Durham seals, illustrated on plate 48 in that catalogue.

21. [1290-1299.] Grant by Richard de Yelande to John Fitz-Marmaduke of the manor of Raueneshelm.

Witnesses: sir Thomas de Herigton', sir John de Farnachers, Walter de Scrootuile, Alan de [S]likeburne, Alexander de Trefort, Robert de Raueneswrt.

Seal, round, 37 mm. diameter, brown wax, equestrian. Richard on horseback galloping to the sinister. He wears a loose flowing surcoat, a circular, visored helm with fan crest, brandishes a sword in his right hand and bears on his left arm a concave slightly triangular shield charged with two bars and in chief two molets.

Legend s' R DE EYNL (plate v, fig. 1). See catalogue of Durham seals, nos. 2724-2727.

22. [1290-1299.] Quitclaim by Richard de Yeland' to John Fitz-Marmaduke of the whole manor of Raueneshelm', which Richard held by lease for life of John, excepting a messuage and 35 acres.

Witnesses: sir Guischard de Charron', sir Robert de Hilton', sir William de Laton', sir Roger Bernard', sir John de Gildeford', sir John de Farnacres, kts., Walter de Scroteuill', John de Birteley, John de Oseworth', John de Rauenesworth', Walter de Wessington', William del Redehough', Thomas de Yolton'.

Seal, dark brown wax, oval, imperfect, 27×20 mm. diameter, an animal of indeterminate character. Legend s. . vi Huv.

23. [1290-1299.] Quitclaim by Richard de Yeland', kt., to John Fitz-Marmaduke of the manor of Raueneshelm'.

Witnesses: sir Gwyschard de Charun', sir Robert de Hylton', sir William de Laton', sir Roger Bernard', sir John de Gildeford, sir John de Farnakris, kts., Walter de Scruteuyl', John de Birteley, John de Osewurth', Walter de Wessington', Robert de Raueneswurth', John de Raueneswurth', William de Redhough', Thomas de Yolton'.

Seal, light brown wax, round, 27 mm. diameter, an eight rayed device. Legend s'RICARDI'DE'YHELAND. (Plate v, fig. 7.)

24. [1290-1299.] Quitclaim by Richard de Yeland' to John Fitz-Marmaduke of his land of Raueneshelm.

Witnesses: Wychard de Charun', Thomas de Herington', John de Farnakris, kts., Walter de Scruteuyl', John de Kilbeleswurth, John de Raueneswurthe, Robert de Raueneswurthe, Alexander de Treffod', Alan de Slykeburn'.

Seal destroyed, it has been wrapt up in a linen bag.

25. [1290-1299.] Quitclaim by John de Yeland and Mary his wife to John Fitz-Marmaduke of all their right in the lands etc. of Hedley.

Witnesses: sir Richard de Yeland', sir John de Farnakris, Walter de Scruteuil', John de Kilbleswurth', John de Raueneswurth', Alexander de Trefford', Robert de Hedley.

Two seals have been attached, both destroyed.

26. [Before 1311.] Quitclaim by Mariot, sometime wife of sir John de Yeland, kt., in her widowhood, to sir John Fitz-Marmaduke, kt., of her right in the manor of Raueneshelm', Hedley and Hamelden', which belonged to John de Yeland.

Witnesses: sir Robert de Lomeley', sir Walter de Wessington', sir Thomas de Whitemirche, kts., John de Birteley, John de Bydik', John de Osemirche, John de Alingscheles, Geoffrey the clerk.

Seal, light brown, very imperfect, a cross with the ends of the limbs broadened out. Legend **s' IOHANNIS

27. [Before 1281; probably c. 1269.] Grant (indented in the form of a cyrograph) by Robert, son of John de Rasinswrthe to his lord, sir John Fitz-Marmaduke, of a moiety of his mill upon Thame. To hold as freely as grantor or his father ever held it of grantee or his father. Grantee agrees not to make a mill on the north up to Blakeburne. Expenses of the mill to be equally divided, Robert rendering however 1d. yearly to John for the road to the mill. The mill to be moved, upon consent of both parties, to any more suitable place on their lands between the vill of Lamisl' and Blakeburne.

Seal, brown wax, round, 34 mm. diameter, a five leaved flower. Legend \(\frac{1}{2} \) [ROBERT] VS: FIL'-IOHANIS. (Plate V, fig. 2.)

28. Sunday in the feast of St. Laurence the Martyr (10 Aug.), 1315. Quitclaim by Roger, son and heir of sir John de Yeland', kt., to sir Richard, son of John Fitz-Marmaduke, kt., and Eleanor his wife and the heirs of Richard of his right in the manor of Rauenshelme.

Witnesses: sir Robert de Lumlay, sir John Warde, kts.; John de Lumlay, Richard de Barington', William de Silkesuurth', Roger de Esche, Walter de Toppecliue, clerk. At Durham.

Seal destroyed.

29. [1315.] Quitclaim by Alice, daughter of sir John de Yeland', kt., to sir Richard, son of John Fitz-Marmaduke, kt., and Eleanor his wife and the heirs of Richard of her right in the manor of Rauenshelme.

Witnesses: sir Robert de Lumlay, sir John Warde, kts., John de Lumlay, Richard de Barington', William de Silkesuurth', Roger de Esche, Walter de Toppecliue, clerk.

Seal destroyed.

30. [1290-1318.] Grant by Roger, son of Isolda de Lambesley, to Richard, son of John Fitz-Marmaduke, of a messuage, 5 acres and 1 rod of land in the vill of Lambesley, and of the remainder of 9 acres 1½ rods of land, held for life by Richard, son of Hugh de Heygton', of which grantor has the reversion after the death of Richard, son of Hugh.

Witnesses: John de Bydik', John de Aleynscheles, William de Merley, Richard de Scroteuyle, Robert de Rauenesworth', John de la Leye.

Seal, light brown, very imperfect, round, an indeterminate object. Legend s' . . . o' \cdot iso

- 31. Enrolments and memoranda as follows-
- (i) [Before 1290.] Lease by John Fitz-Marmaduke, lord of Horden', to John de Aleinsel' for his life of 2 tofts, called Kychyntoft and Campumtoft, and 32 acres in the vill of Eghton', at a yearly rent of 21s. 8d.

Witnesses: John de Byrtley, Walter de Scroteuill', John de Kybblysworth', Alexander de Treford.

- (ii) Morrow of the Circumcision 7 Edward II (2 Jan. 1313.) Fine made in the court of the bishop at Durham before Lambert de Trikyngham, Hugh de Louthre, Adam de Middelton', Thomas de Fissheburn' and William de Denum, between Richard, son of John Fitz-Marmaduke, and Eleanor his wife, pl., and William de Silkysworth', def., of the manor of Raueneshelm' and Lamesley. With successive remainders to John, son of Robert de Lomley, and to the right heirs of Richard.
- (iii) Note of descent—John Fitz-Marmaduke granted to John de Aleinschels for his life 2 tofts and 32 acres in Eghton', with reversion to Richard, son and heir of John Fitz-Marmaduke; the right descended to the said Richard, and to Mary, his sister and heir, wife of Robert de Lomley; from Mary to Robert de Lomley, her son and heir, and from him to Marmaduke, his son and heir.
- (iv) 26 Aug. 6th year of the pontificate of John, bishop of Durham (1389.) Writ precipe of John, bishop of Durham, to the sheriff of Durham, ordering him to command John de Kendale, clerk, to return to Ralph de Lomley, kt. (chivaler), 2 tofts and 32 acres in Eghton' (in which the same John has not entry except after the intrusion made by John Neweman after the death of John de Aleinschels, to whom the premises were leased for life, with reversion to Ralph de Lomley, by John Fitz-Marmaduke, kinsman of the said Ralph) or to be before Roger de Fulthorp', Ralph de Eure, William de Elmedon' and John de Preton'.

At Durham by the hand of William de Elmedon', chancellor of the bishop.

Letters Patent of Richard, bishop of Durham, licensing Henry Boynton', esq., and Isabel his wife, daughter and heir of Bertram Lomley, esq., deceased, tenant in chief of the bishop, (which Isabel is of full age) to enter without proof of age, inquisition or prosecution of livery upon the lands within the bishopric of Durham of which her father died seised, and which should descend to Isabel. With issues from the death of Bertram.

At Durham, by the hand of Ralph Both', clerk, the bishop's chancellor.

Great seal in chancery of bishop Richard Fox (1494-1501), light brown wax. Seal described in catalogue of Durham seals, no. 3164, and illustrated on plate 55.

72. 20 May 1st year of the pontificate of William bishop of Durham (1502.) Letters patent of William bishop of Durham, licensing Henry Boynton', kt., and Isabel his wife, daughter and heir of Bertram Lomley, late of Rauenshelme, esq., and of Margaret his wife, deceased, which Isabel is of full age, for a fine paid into the bishop's Chamber, to enter, without proof of Isabel's age or inquisition, upon lands, jurisdictions, advowsons etc. within the bishopric of Durham, of which Bertram, the father of Isabel, holding by knight service of Richard late bishop of Durham, Margaret his wife, or any of their ancestors died seised, and which should descend to Isabel.

Seal—the round chancery seal of bishop William Senhouse, in brown wax, is attached by a tag of parchment. It is of the usual two-faced type—Obverse the bishop in mass vestments with mitre and crosier seated on his throne, blessing, between Our Lady and St. Cuthbert. On the dexter is the shield of the see, on the sinister that of the bishop quarterly a popinjay in the first and fourth quarters. Reverse the bishop on horseback fully armed as lord palatine bearing his own shield of arms as on the obverse. The legend, on both sides, in black letter, reads (plate IV, figs. 3 and 4):—

Appointment of John Barbon' and John Sanderson to be Isabel's attornies to deliver seisin.

Grant by Isabel Boynton', widow, to Henry Gascon, kt., her son, Robert Bowes, esq., Ralph Gower, gentleman, and John Barker, chaplain, of a tenement in her lordship of Ravynshelm', now in the tenure of John Lowther, and another tenement there called Blakburn' miln' in the tenure of Henry Cokson', the two of yearly value 5l. 6s. 8d. To hold to the use of Isabel during her life, and after her death for a term of twenty-one years to their own use, finding during that term a chaplain to celebrate at the nearest altar to her place of burial and paying him yearly 8 marks out of the issues of the tenements; remainder to the heirs of Isabel. Appointment of William Snathe and John Barbon' to be Isabel's attornies to deliver possession.

77. 23 June 43 Eliz. (1601) Letters Patent of Elizabeth of pardon for the alienation, without royal licence, by Henry Jackman', esq., to Edward Browell', by writing of 3 July 40 Eliz. (1598), of half a water-mill, called le more mylne, and half of a close belonging to

it, in the fields of Kiblesworth', then in the tenure of Edward Browell', being within the manor of Beamish co. Durham, and held in chief of the queen; and grant that Browell' shall hold the premises. Consideration, 41s.

On dorse of this and nos. 78 and 79 it is noted that each is recorded on the Memoranda Roll, among the Recorda of Easter term, 15 James I (1618.) ex parte Lord Treasurer's Remembrancer.

Seal—imperfect impression of the second great seal (used 1586-1603) of queen Elizabeth. See no. 78 following.

78. I Dec. 45 Eliz. (1602.) Letters Patent of Elizabeth, licensing Edward Browell' to alienate to Thomas Cole the premises detailed in no. 77, now or late in the tenure of Edward Browell', and Cole to receive the premises. Consideration, 43s. 4d.

Second great seal of queen Elizabeth, used from 1586 to 1603, 150 mm. in diameter. See figs. 5 and 6, plate IV. The legend on both obverse and reverse reads—ELIZABETHA DEI GRACIA ANGLIE FRANCIE ET HIBERNIE REGINA FIDEI DEFENSOR.

79. I Dec. 5 James I (1607.) Letters Patent of James I, licensing Thomas Cole to alienate to William Scrutfeild, gentleman, the premises detailed in no. 77, now in the tenure of Thomas Cole, and Scrutfeild to receive the premises. Consideration, 33s. 4d.

Second great seal of James I, used 1605 to 1625. Imperfect.

William Scrutfeild offers proof of this and, after hearing the case, the court tells him, so far as concerns his entry to go without a day, saving his homage; the bishop of Durham to distrain Scrutfeild to do homage.

⁹ The contents of the entry (P.R.O., E. 368/565 m. 185) may be briefly indicated—23 May 15 James I, William Scrutfeild, by John Orme his attorney, appears and seeks hearing of the writ of 12 Feb. 13 James I to the bishop of Durham, whereby Thomas Cole was distrained to do homage for the half water-mill above, held in chief of the king, which Thomas had of Edward Browell, by licence of the king [sic] to alienate, as in part 6 Originalia Roll 45 Eliz. Roll 76. Scrutfeild states that he is vexed by the writ unjustly, because long before its issue Henry Jackman' was seized of the manor of Beamyshe, of which the premises are parcel, and by writing of 3 July 40 Eliz. granted them to Edward Browell, with patent (no. 77 above) pardoning the alienation; by writing of 19 Jan. 45 Eliz. Edward Browell granted them to Thomas Cole, with patent (no. 78 above) licensing the alienation, and fine levied in confirmation 15 Aug. 1 James 1 between Thomas Cole, pl., and Edward Browell and Jane his wife, def.; by indenture of 18 May 6 James I Thomas Cole, of Gateside, cordwainer, granted them to Scrutfeild, with patent (no. 79 above) licensing the alienation.

II Sept. 2I James I and 6th year of the pontificate of Richard, bishop of Durham (1623) Letters Patent of Richard, bishop of Durham, licensing Emanuel Scurfeild, son and heir of William Scurfeild, gentleman, of age at the time of his father's death, for a fine unspecified paid into the bishop's Hanaper, to enter without proof of age or livery upon lands, details of which appear in the inquisition taken before John Richardson the younger, esq., escheator of the County Palatine of Durham and Sadberg', after the death, on 14 Nov. 15 James I (1617), of William Scurfeild', as follows—the manor of Kiblesworth in the parish of Lamesley, and 5 messuages, 40 acres of land, 20 acres of meadow, 40 acres of pasture, 60 acres of moor, belonging to the same; the whole being of yearly value 51. and held of the bishop in chief.

Letters Patent of Richard, bishop of Durham, licensing Emanuel Skurfeild', gentleman, for a fine paid into the bishop's Hanaper, to alienate to Thomas Liddell, esq., and Richard Hedworth of Chester in le Streete, gentleman, holding to the use of Emanuel, the manor of Kiblesworth, a farm called Lawes farme in Kiblesworth, a little close of pasture called Whiteacres in Kiblesworth, a little close of meadow called East Gibbryding alias Leighes Gibbryding, a moiety of a water-mill, called Moore Milne and of a little close called Moore Milne close; and licensing Liddell and Hedworth to receive the premises.

82. 20 Feb. 11 William III (1698). Exemplification of a Recovery made before George Morland', esq., John Sedgwicke, esq.,

and their fellow justices itinerant in co. Durham and Sadberg at the Court of Pleas held at Durham 13 Jan. 10 William III (1698), by John Smith and Thomas Smith against Henry Smith, of 2 messuages, 20 acres land, 20 acres meadow, 20 acres pasture, and common of pasture for all beasts in Kibblesworth, Henry only having entry after the disseisin which Hugh Hunt unjustly made to John and Thomas within the past thirty years.

John and Thomas to recover seisin against Henry, Henry to recover a recompense of equal value from Robert Lawes, first vouchee, and Robert Lawes the like from Robert Pattison, common vouchee, in mercy.

There is granted to John and Thomas a writ of 10 Feb. 169§, returnable on 20 Feb. next, to Charles Mountagu, sheriff of co. Durham, commanding him that he cause them to have seisin, and this writ is executed.
