 Second son of Robert Chambers, an attorney of Newcastle. He was a banker in the town; alderman 1795; mayor 1795; resigned as alderman 1797; afterwards an ironmonger in London where he died 1806.

- 1790 CHARLES JOHN CLAVERING—sheriff.
Quarterly gold and gules, a bend sable—XII, 3.
Son of General Sir John Clavering, K.B.; admitted merchant on the recommendation of Sir Matthew White Ridley, governor, 4 Oct. 1790; was living at Widdrington castle in 1800 and afterwards at Ridlamhope; married Diana Adair; died 1838.
- 1791 SIR MATTHEW WHITE RIDLEY, BART.—mayor, as 1774—XI, 20.
- 1791 SHAFTO JOHN HEDLEY—sheriff.
Arms XI, 15.
Son of John Hedley, hostman, and his wife Deborah Shafto of Dunston; admitted to the Hostmen's company 14 Jan. 1796.
- 1792 JAMES RUDMAN—mayor, as 1772—XI, 19.
- 1792 MATTHEW PRINGLE—sheriff.
Shield blank.
Nothing has been found about this man.
- 1793 WILLIAM YIELDER—mayor, as 1773—XI, 21.
- 1793 HENRY JOHN HOUNSON—sheriff.
Shield blank.
Son of George Hounson of Trintington, Sussex; apprenticed to John Hedley, hostman, 26 April 1785; admission date not recorded.
- 1794 FRANCIS JOHNSON—mayor, as 1774.
Shield blank see IX, 9.
- 1794 ARCHIBALD REED—sheriff.
Gold on a chevron, between three sheaves gules, three fleurs de lis gold—XII, 4.
Younger son of Christopher Soulsby (afterwards Reed) of Chipchase and his wife Sarah daughter of Sir Francis Blake; admitted merchant by patrimony 9 Oct. 1798; married Mary Maister; alderman 1798; mayor six times between 1800 and 1831; died 13 Dec. 1842; buried in Jesmond cemetery; monument in St. Nicholas.
- 1795 RICHARD CHAMBERS—mayor, as 1786—XII, 2.

- 1795 ANTHONY HOOD—sheriff.
Blank shield.
The manuscript here gives Anthony Smith as sheriff in error. Anthony was son of John Hood, hostman; apprenticed to Simpson and Blackett; admitted hostman 29 Jan. 1782; councillor and one of the twenty-four 1795; alderman; mayor 1797 and 1807; J.P. and D.L. for Newcastle; lived at Singleton house and later Wallsend hall; married Elizabeth Snowdon; died 1810.
- 1796 WILLIAM CRAMLINGTON—mayor, as 1775—XI, 23.
- 1796 NICHOLAS HALL—sheriff.
Silver a fess engrailed between three eagles' heads sable.—XII, 5.
Son of Ralph Hall, merchant and boothman; admitted to the Merchants' company by patrimony 4 Oct. 1792; died 1803.
- 1797 ANTHONY HOOD—mayor, as 1795.
- 1797 THOMAS SMITH—sheriff.
Blank shield.
Second son of Thomas Smith of Togston and his wife Frances Cook; apprenticed c. 1770 to a roper in Newcastle; married Mary Pearson; lived at St. Lawrence; alderman; mayor 1803 and 1813; died 6 March 1836 aged 80; buried in St. Nicholas. The shield on his stone in St. George's porch bears azure on a mount vert a tower silver, on a chief gold three storks' heads rased gules.
- 1798 JOHN WALLIS—mayor, as 1781—XI, 27.
- 1798 WILLIAM WRIGHT—sheriff.
(Gold) on a chevron azure, between three hounds courant (sable), three slipped trefoils (silver).
The shield is left blank here but tricked in ink in 1823. Eldest son of John Wright, attorney, of Newcastle; born 1767; councillor 1798; married in 1806 Frances Magnay; lived at North Shields and in Saville Row, Newcastle; alderman and mayor 1823; municipal reformer; con-

tested mayoralty in 1832 against alderman Brandling, the official nominee who was elected. J.P. for Northumberland and D.L. in 1825; elected to the reformed town council in 1837 but resigned not being a burgess; died 10 Dec. 1847, buried in Tynmouth priory.

- 1799 ROBERT SHAFTO HEDLEY—mayor.
Son of Robt. Hedley, master mariner, and his wife Jane Shafto of Dunston; alderman.
- 1799 HENRY CRAMLINGTON—sheriff.
Arms as 1775—XI, 23.
Probably son of William (mayor 1787); was a rope-maker on the North Shore; alderman 1805 and magistrate in the same year; mayor 1805, 1815 and 1824; died at Birling, Warkworth, 22 May 1844.
- 1800 ARCHIBALD REED—mayor, as 1794—XII, 4.
- 1800 AUBONE SURTEES (the younger)—sheriff.
Arms as 1785—XI, 3.
- 1801 JOSEPH FORSTER—mayor, as 1787—XI, 13.
- 1801 MATTHEW HEDLEY—sheriff.
Arms as XI, 15.
Son of William Hedley of Newcastle, master mariner, and his wife Anne Dent; admitted to the Master Mariners company 8 Oct. 1782; master of Trinity House 1789; married Jane Charlton of Lee hall; died during his shrievalty in 1802. Isaac Cookson, the younger, had his office.
- 1802 THOMAS CLENNELL—mayor.
Azure a right arm vested proper, issuing from the sinister, grasping a truncheon gold—XII, 6.
Son of Thomas Fenwick of Earsdon; born 1766; took the name Clennell (1796) on succeeding to Harbottle after the death of Percival Clennell; admitted by patrimony to the Merchants' company 14 Nov. 1793; captain of Volunteers; chairman of Quarter Sessions; alderman; died at Harbottle 30 March 1848.

- 1802 DIXON BROWN—sheriff.
Shield blank.
Son of William Brown of Long Benton and of his wife Margaret Dixon; apprenticed to Anthony Hood, hostman, 9 Oct. 1792; admitted 30 Nov. 1799. His shield on the floor of St. George's chapel in St. Nicholas, is quarterly i and iv per bend gold and sable on a cross, between four spread eagles, four crosses crosslet all counter-coloured—Dixon, ii and iii sable on a bend doubly cotized, between two escallops silver three lions passant sable—Dixon (illustrated *Arch. Ael.*⁴ VIII, pl. XIII, fig. 6).
- 1803 THOMAS SMITH—mayor, as 1797—XII, 15.
- 1803 THOMAS COOKSON—sheriff.
Arms as 1779—XI, 26.
Younger son of Isaac, merchant (sheriff 1779); admitted merchant by patrimony 21 Jan. 1802; married Elizabeth Selby of Earle; lived at Hermitage, Durham.
- 1804 ROBERT CLAYTON—mayor, as 1777—X, 14.
- 1804 BENJAMIN SORSBIE—sheriff.
Arms X, 20.
Son of Malin Sorsbie of Newcastle, merchant; apprenticed to Jonathan Sorsbie, boothman, 5 Oct. 1792; admitted 9 Oct. 1801; alderman; mayor 1814, 1827.
- 1805 HENRY CRAMLINGTON—mayor, as 1799—XI, 23.
- 1805 NATHANIEL JOHN WINCH—sheriff.
Party per pale azure and gules, an escallop silver—XII, 7.
Son of Nathaniel Winch of Hampton, Middlesex, gent.; apprenticed to Robert Lisle, hostman, 4 Oct. 1787; admitted hostman 28 April 1796; alderman 1807, resigned 1808. He was a noted geologist and naturalist and a fellow of the Linnaean Society and one of the founders of the Botanical section of the Literary and Philosophical Society of Newcastle, and became first secretary of the Natural History Society of Northumberland as well as honorary curator. Died 5 May 1838.

- 1806 ARCHIBALD REED—mayor, as 1794—XII, 4.
- 1806 JOHN COOKSON—sheriff.
Arms as 1779—XI, 26.
Son of Isaac Cookson (sheriff 1779) and brother of Thomas (sheriff 1803); born 1773; admitted merchant by patrimony 21 Jan. 1802; lived at Whitehill, Durham; was a J.P. and D.L. for the county; died without issue.
- 1807 ANTHONY HOOD—mayor, as 1795.
- 1807 THOMAS BURDON—sheriff.
Azure three hautboys and three crosses crosslet gold—XII, 8.
Son of Richard Burdon of Shieldfield, gent.; born 1758; apprenticed to Matthew Bell, hostman 2 May 1776; married Jane Scott, sister of the earls of Stowell and Eldon; councillor 1796; sheriff until Christmas 1808 when he resigned; mayor 1810 and 1816; captain of volunteers in Newcastle; knighted by the Prince Regent at Carlton house 14 May 1817; died June 1826; buried at Gosforth.
- 1808 JOSEPH FORSTER—mayor, as 1787—XI, 13.
- 1808 THOMAS BURDON—sheriff, as 1807—XII, 8.
Resigned and Benjamin Sorsbie (sheriff 1804) took his place until Feb. 1808, when GEORGE SHADFORTH came of age and was then made sheriff.
Vert on a chevron, between three hour-glasses silver, three slipt trefoils vert—XII, 14.
He was son of Thomas Shadforth, merchant, boothman and hostman; admitted to the Merchants' company by patrimony 16 Nov. 1808; sheriff a second time 1824; mayor 1829.
- 1809 ISAAC COOKSON (the younger)—mayor—XI, 26.
Son of Isaac (sheriff 1779); born 1776; admitted merchant by patrimony 21 Jan. 1802; hostman 4 Jan. 1829; sheriff of Northumberland 1838; married Jane Cook of Togston.
- 1809 JOB JAMES BULMAN—sheriff.
Barry wavy gules and silver, on a chief gold three bulls' heads caboshed sable—XII, 9.
Son of Job Bulman who built Coxlodge hall, Gosforth, in 1796; he succeeded his father in 1818.

- 1810 THOMAS BURDON—mayor, as 1807—XII, 8.
- 1810 WILLIAM SMOULT TEMPLE—sheriff.
Shield blank.
Son of Simon Temple of South Shields and his wife Eleanor Smoult; born 31 Aug. 1786; married Mary Waldie of Yarm; educated at Kepier School; lived at Aislaby, Egglecliff.
- 1811 GEORGE FORSTER—mayor.
Arms as 1787—XI, 13.
A linen-draper in Wool Market; councillor 1802; alderman 1810; first mayor to wear the present official chain of office; mayor again 1820; died at his home in the Forth May 1836.
- 1811 THOMAS BURDON (the younger)—sheriff—XII, 8.
Son of Sir Thomas (mayor 1810); admitted to the Hostmen's company 17 Jan. 1811; died 1829.
- 1812 ROBERT CLAYTON—mayor, as 1777—X, 14.
- 1812 THOMAS ANDERSON—sheriff.
Blank shield.
- 1813 THOMAS SMITH—mayor, as 1797—XII, 15.
- 1813 THOMAS SMITH (the younger)—sheriff.
Arms as 1797.
Son of the mayor; died 15 Oct 1836; buried St. Nicholas.
- 1814 BENJAMIN SORSBIE—mayor, as 1804—X, 20.
- 1814 RICHARD BREWSTER—sheriff.
Blank shield.
Son of Richard Brewster, hostman, who was the son of rev. Richard Brewster of Heighington, Durham, clerk. Richard was apprenticed to John Hedley, hostman, and admitted to the Hostmen's company 19 July 1814.
- 1815 HENRY CRAMLINGTON—mayor, as 1799—XI, 23.
- 1815 RALPH NATERS—sheriff.
Blank shield.
Younger son of Joseph Naters of Sandyford, brewer; apprenticed to Edward Wilson, boothman, 20 Sept. 1802; admitted 26 Nov. 1811; wife was named Dorothy.

- 1816 SIR THOMAS BURDON, KT.—mayor, as 1807—XII, 8.
- 1816 THOMAS LOGGAN—sheriff.
Gold a lion passant sable in chief three piles sable—XII, 10.
Son of Thomas Loggan; apprenticed to Edward Mosley, hostman, 20 Sept. 1798; admitted hostman 4 Jan. 1805. An original member of the Society of Antiquaries and on its first council.
- 1817 ROBERT CLAYTON—mayor, as 1777—X, 14.
- 1817 WILLIAM CLAYTON—sheriff.
Arms X, 14.
Son of the mayor; admitted merchant by patrimony 7 Nov. 1817; died 1842.
- 1818 JOSEPH FORSTER—mayor, as 1787—XI, 13.
- 1818 HENRY CLAYTON—sheriff.
Arms X, 14.
Son of Robert (mayor 1817) and brother of William (sheriff 1817); admitted merchant by patrimony 31 Dec. 1818; died 1826.
- 1819 ARCHIBALD REED—mayor, as 1794.
Quarterly i and iv gold on a chevron between three sheaves gules three fleurs de lis gold—Reed, ii and iii gules on a saltire silver a rose gules—?Nevill—XII, 11.
- 1819 NICHOLAS NATERS—sheriff.
Blank shield.
Son of Joseph Naters of Sandyford, brewer; apprenticed to Thomas Robinson, boothman, 31 Dec. 1793; admitted merchant 9 Oct. 1804; brother of Ralph (sheriff 1815); died 1822.
- 1820 GEORGE FORSTER—mayor, as 1811—XI, 13.
- 1820 JOHN ANDERSON—sheriff.
Blank shield.
Son of Thomas Anderson and Eleanor Soulsby; born 1757; married Hannah King; Russia merchant; purchased Jesmond House; councillor c. 1826; died 1829.

- 1821 AUBONE SURTEES—mayor—XI, 3
Son of William Surtees; born 1777; educated Oxford; cornet in 11th Dragoons; married Frances Honeywood; died 1859.
- 1821 ALFRED HALL—sheriff.
Gold a chevron azure between three demi-lions rampant azure, on a chief gules three roses silver—XII, 12.
- 1822 ROBERT BELL—mayor.
Arms X, 4.
Son of Matthew Bell of Woolsington; born Feb. 1772; admitted merchant by patrimony 30 Oct. 1819; mayor again 1828; married Anna Childers and secondly Emma Cookson of Whitehill; died at Fenham 10 Jan. 1851.
- 1822 EDWARD JOHNSON—sheriff—IX, 9.
Son of Francis (mayor 1786); admitted to the Merchants' company by patrimony 1829.
- 1823 WILLIAM WRIGHT—mayor, as 1798.
- 1823 EDWARD JOHN JACKSON—sheriff.
Gold a chevron engrailed gules between three eagles' heads sable—XII, 13.
Son of Collingwood Forster Jackson, merchant; admitted by patrimony 4 Nov. 1823.
- 1824 HENRY CRAMLINGTON—mayor, as 1799—XI, 23.
- 1824 GEORGE SHADFORTH—sheriff, as 1808—XII, 14.
- 1825 GEORGE FORSTER—mayor, as 1811—XI, 13.
- 1825 JOHN LIONEL HOOD—sheriff.
Shield blank.
Son of Anthony (mayor 1797); born 21 Dec. 1799; admitted hostman 4 Jan. 1831; councillor 1825; mayor 1834-35, being the last mayor of the old corporation abolished by the Reform Act of 9 Sept. 1835; elected councillor for south St. Andrew's ward 1836; resigned 1837; died at Tunbridge Wells 5 Nov. 1847.
- 1826 ARCHIBALD REED—mayor, as 1794—XII, 11.
- 1826 ALFRED HALL—sheriff, as 1821—XII, 12

- 1827 BENJAMIN SORSBIE—mayor, as 1804—X, 20.
- 1827 EDWARD DALE—sheriff, as 1784—XII, 1.
- 1828 ROBERT BELL—mayor, as 1822—X, 4.
- 1828 JOHN BRANDLING—sheriff.
Gules a cross crosslet silver, an escallop silver in the dexter quarter—XII, 16.
Son of Charles Brandling of Gosforth; born July 1773; apprenticed to Aubone Surtees; admitted merchant 6 Nov. 1824; admitted hostman 1826; governor of that company 1832-34, 1836, 1846-47; mayor 1832; died 1847.
- 1829 GEORGE SHADFORTH—mayor, as 1808—XII, 14
- 1829 HENRY REED—sheriff.
Arms as 1794—XII, 4.
Probably younger son of Archibald Reed (mayor 1800); born 1794; died 1866.
- 1830-31 ARCHIBALD REED—mayor, as 1794—XII, 4.
- 1830 WILLIAM SMITH—sheriff.
Silver a lion's head rased sable between three annulets sable—XII, 15.
Younger son of Thomas Smith (sheriff 1797, for whom see arms upon memorial stone). He and his brother Thomas (sheriff 1813) established the shipbuilding firm of T. & W. Smith, shipbuilders and ropemakers. He married Margaret Werge, and lived at Gosforth House.
- 1831 WILLIAM AUBONE SURTEES—sheriff—XI, 3.
Son of Aubone Surtees (mayor 1821); admitted to the Merchants' company by patrimony 22 Nov. 1831; admitted hostman by patrimony 4 Jan. 1844.
- 1832 JOHN BRANDLING—mayor, as 1828—XII, 16.
- 1832 HENRY BELL—sheriff.
Arms—X, 4.
Son of Matthew Bell of Woolsington; admitted to Merchants' company by patrimony 9 Oct. 1833; died 1836.
- 1833 HENRY BELL—mayor, as 1832—X, 4.

- 1833 GEORGE CLAYTON ATKINSON—sheriff.
Blank shield.
Apprenticed to Nathaniel Clayton 11 June 1824; admitted to the Merchants' company 6 Jan. 1832. He was the eldest son of Matthew Atkinson of the Temple Sowerby family, Dorothy wife of Nathaniel Clayton being of the same family. Born 1808; married Sophia Hutton and secondly Elizabeth Carr; founder member of the Natural History Society and a member of the Society of Antiquaries; lived at West Denton and afterwards at Wylam Hall; died in his house in Windsor Terrace 14 April 1877.
- 1834-35 JOHN LIONEL HOOD—mayor, as 1825.
Blank shield.
- 1834-35 JOHN MILLER CHAPMAN—sheriff.
Per chevron silver and gules, a chevron counter-coloured. Of a Whitley and North Shields family; partner in banking firm of Chapman & Co., and in partnership with Robert Spence of North Shields; afterwards Newcastle manager of the Newcastle, Shields and Sunderland Jt. Stock Bank; councillor.
- 1836 CHARLES JOHN BIGGE—mayor (for unexpired part of year).
Ermine on a fess engrailed sable, between three martlets sable, three annulets gold—XII, 17.

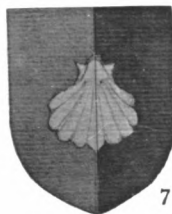
