VI.—MEMBERS OF PARLIAMENT FOR NORTHUMBERLAND AND NEWCASTLE UPON TYNE 1559-1831.

I.—NORTHUMBERLAND.

Paly or and gules.

This society, at the request of the Committee on the History of Parliament, prepared and published in volumes x-xiv, 4th ser. of Arch. Ael. a list, as complete as possible, of

the members for the county and boroughs of Northumberland from 1258 to 1588. The late Lord Wedgewood, chairman of the committee, upon the completion of that work, wrote thanking the society for having done it, saying also that "it competed for completeness and excellence with only three other counties in the whole country."

The war has caused a temporary stoppage of the committee's work, but, in 1940, the editor was asked if possible to continue the list to the parliament of the Reform Act of 1832. That task has now been completed in the following pages, for the county of Northumberland and the town and county of Newcastle upon Tyne. The members for Berwick upon Tweed and Morpeth yet remain to be published.

Sixty-four parliaments met during the period, the county being represented by sixty-one different men, the same man often serving in more than one parliament. Northumberland returned two members, or "knights of the shire" as the county members were called, to each parliament except to Cromwell's of 1654, to which three members were

assigned. The names of the "knights" for every parliament have been preserved except for that of 23 Jan. 1559. All have been identified except John Vaughan (1563) and Thomas Leighton (1572). The "knights of the shire" in earlier years were usually of knightly rank, but of those here recorded only twenty-five were of that degree, the others were esquires or bore a courtesy title before succeeding as peers to the Upper House.

The certificate by the sheriff of the county on the return of three members to Cromwell's parliament is printed in Arch. Ael., 1st ser., 1, 171. The writ of the Lord General orders the election of "three knights fit and discreet persons of the county," and the indenture certifies that "three knights girt with swords" have been freely chosen—they were, however, esquires and not of knightly rank (parliament 3 Sept. 1654).

Though such a large proportion of members were not knights, they were all, with some few exceptions, of the landed gentry class who as sheriffs, wardens of the marches, justices, commissioners or deputy lieutenants had taken a large share in the administration of the county. The few exceptions were men who, though not Northumbrians, had married local heiresses or held some important office in the county; of such were Sir Francis Russell (1572), Edward Talbot (1584), Sir Robert Carey (1597), Philip Bickerstaffe (1689) and Sir William Reade (1593). It was towards the end of the parliament of 18 Feb. 1661 that the House of Commons began to be divided into the two parties of modern times, namely the Tory or Court party and the Whigs or County party.

The king in the last years of this parliament built up "the new Tory party by the aid of wholesale bribery out of the public revenue and distribution of the spoils of office on lines of strict party tests" (England under the Stuarts, by G. M. Trevelyan, p. 379). All the members for North-umberland and its boroughs, except two of the Newcastle members, namely Sir John Marley and Sir William

Blackett, belonged to the Court party and were either placemen or pensioners (Arch. Ael., 1st ser., I, 173)—

Places. Northumberland Sir John Fenwick Northumberland Sir Ralph Delaval £,500. Newcastle Sir Francis Anderson Pensioner. Morpeth Sir George Downing Places. Berwick Dan Collingwood Place and £,300. Lord Dunblane Berwick Son of Lord Tréasurer.

The dates in capital letters in the margin of this list are those for which each parliament was summoned to meet, thus 22ND JAN. 1559 means the parliament summoned to meet at Westminster upon that day and so on for each succeeding parliament. All met at Westminster except the Anti-parliament of 1644 and that of 20th Jan. 1681, which met at Oxford.





The town was represented normally by two members; all their names are known except for the parliaments of 21 Oct. 1597 and 7 May 1659. Only one member was assigned to it for Cromwell's parliaments of 16 Dec.

1653 and 17 Sept. 1656, whilst no representative was called to the anti-parliament of 1644 as the members sent by the town to the Long Parliament were all supporters of the parliamentary party except Sir Henry Anderson, who had become a royalist but was at the time a prisoner in the Tower and later compounded for his estates. Newcastle upon Tyne, like other towns, except London, had no representation in the Little Parliament of 20 June 1653. The same man was often returned to more than one parliament. sometimes to several successive ones, so that only forty-six names represent the members for the sixty-four parliaments called during the period. These were, with few exceptions. members of the great company of Merchant Adventurers belonging to one or other of its three branches of Boothmen, Drapers and Mercers. Many also belonged to the Eastland Company which traded with the Baltic ports or to the Russian Company trading to Russia and beyond to the Caspian Sea. After 1600 some were also members of the Hostmen's Company whose dealings were in sea-coal and grindstones. They were the leading men in these influential merchant companies, and many served their turn as governors of both. Most of them also took a chief part in the government of the town, serving it as aldermen, sheriffs and mayors. It should be remembered that these wealthy merchants were not engaged in retail trade, as the names of the companies might now imply, they were often men of large capital who traded as merchants upon their own account, and ventured overseas with merchandise carried in their own ships. Towards the end of the period, some

members having purchased landed estates in the county, had ceased to be merchants except in so far as they became members of the company by right of patrimony; of such were the Liddells (1701), Ridleys (1747, 1774), Brandlings (1796) and Ellisons (1812). Two only were not closely connected with the town, Sir Arthur Haselrigg (1654) and Sir John Trevelyan (1774).


