King's hands for trespass, because the Burgesses of the same town elected their Mayor without special command of the King, from the feast of St. Michael at the end of the 21st. year beginning of the 22nd. until the 14th. December 22nd. year placed before the free men of the same town in the same town as contained in the memoranda 22nd. year.

588. The same renders account of £4 8s. 8d. for issues of two ovens in the same town for the same time. And of 3s. 4d. for stallage in the aforesaid town for the same time. And of 18d. for tronage there for the same time.
