

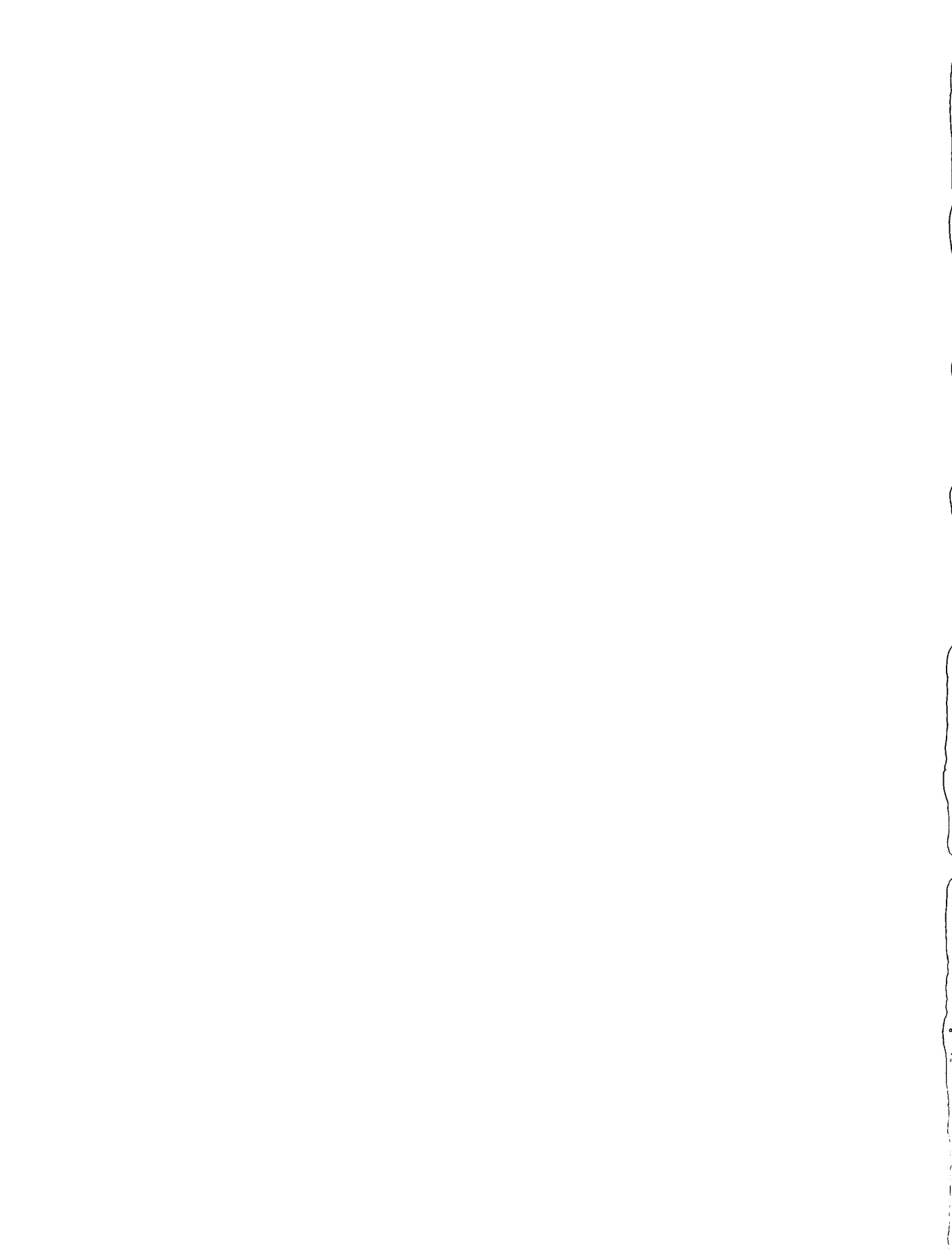

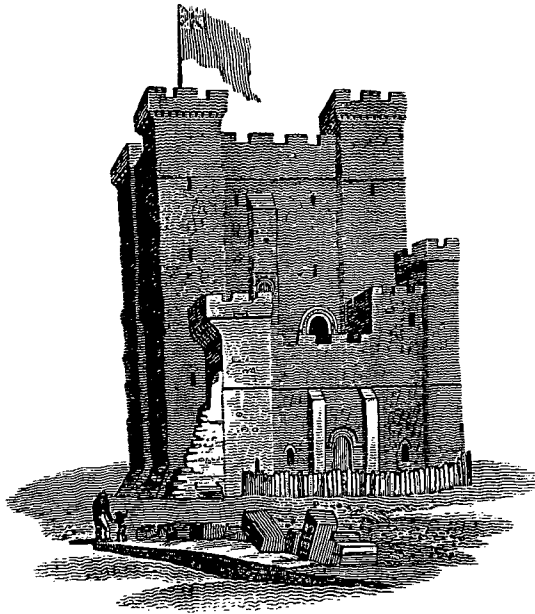

Notes for the guidance of authors

1. General

- 1.1. Authors should note that *Archaeologia Aeliana* is a refereed journal.
- 1.2. All papers should be sent to the Editor, *Archaeologia Aeliana*, at the Black Gate, Castle Garth, Newcastle upon Tyne, NE1 1RQ, before 15th January in the year of publication.
- 1.3. Papers may be submitted on disc, after consultation with the Editor, and must be accompanied by a hard copy typed on one side of A4 paper, double spaced, including the references, and with ample margins.
- 1.4. Typescripts must be complete in every particular; author's corrections, which are not printers' errors, and additions in proof will be charged to the author.
- 1.5. Authors receive one set of proofs.
- 1.6. Authors receive 25 free copies of their papers. More copies can be had at cost price if ordered at proof stage.
- 1.7. 100–150 word summary should be included.
- 1.8. For guidance in presentation authors are referred to the *MHRA Style Book* which may be obtained from W. S. Maney & Son Ltd, Hudson Road, Leeds LS9 7DL.

2. Text

- 2.1. Grid references, for the location of sites, should be included where appropriate.
- 2.2. Spelling. Follow the Concise Oxford Dictionary.
- 2.3. Quotations. Quotations should be enclosed in single-inverted commas; quotations within quotations should be placed in double-inverted commas. Omissions from quotations should be marked by three full points or stops; additions to a quotation should be enclosed in square brackets.
- 2.4. Numbers and dates. For precise measurements and quantities numerals should be used. Other numbers below 10 should be denoted by words. Financial amounts should be written £100 10s 6d or £100 50p. Dates should appear thus 22 March 1641.
- 2.5. Dimensions should be given thus: mm (millimetres), m (metres), km (kilometres), ha (hectares), g (grammes), kg (kilogrammes), followed if necessary by imperial equivalents in brackets.
- 2.6. Hyphens should be used where two words are used adjectivally, e.g. "iron-smelting site".
- 2.7. Italics should be used for the titles of books and periodicals, and for all words in a foreign language. All words to be in italics in the printed version should be underlined in the typescript.

3. References and notes including textual expansions

- 3.1. There will be NO footnotes.
- 3.2. There are two acceptable systems of references.

In system 1 consecutive numbers will appear in the text, and the relevant notes or appropriate references will be placed in a block at the end of the article. The full title or location should be given when the work is first cited, and abbreviated thereafter; the place of publication if not London; the date of the edition used. MS references should give the location, with abbreviation after the first mention, archive and document details. Examples:

For books: Robert Higham and Philip Barker, *Timber Castles* (1992), 68.

For articles: M. F. Downing, "Ewart Park and Estate, Northumberland", *AA*⁵, XXIII (1995), 270.

For manuscripts: NRO ZAN Bell 35/36.

In system 2 (Harvard) the reference is given in the main text thus (Manders 1994, 16), with a bibliography at the end of the article where books and articles are arranged alphabetically and listed in order of publication under each author. If more than one work is cited from the same author in the same year, the distinction should be made as follows:

Davies, 1958a M. Davies, *Wales in Maps* (1958).

Davies, 1958b M. Davies, "Common Lands in South-East Monmouthshire", *Trans. Cardiff Nat. Soc.*, 85 for 1955-6 (1958), 5-15.

4. Illustrations

- 4.1 Where questions of copyright are involved authors must obtain the necessary permission, supplying written permission to the editor where necessary and indicating the correct phrase by which the copyright should be acknowledged.
- 4.2. All illustrations should be sent at the same time as the text. Facilities may be arranged for the reception at an address in Newcastle of bulky drawings unsuitable for postage.
- 4.3. All the illustrations for each article, both line drawings and half-tones, should be numbered in pencil on the back in a **single sequence** as figures. The author's name should also be given.
- 4.4. The illustrations should be accompanied by a caption list which should also indicate the desired reduction and the optimum position in the text.
- 4.5. Line drawings should be no larger than 600 × 850 mm, and preferably of such proportion as will reduce to a finished size within the limits of 150 × 185 mm. For the sake of the reader final reduction to a natural scale of 1:50, 1:100 etc. is preferred.
- 4.6. Original line drawings are preferred; dyelines and photocopies should be avoided unless of very high quality.
- 4.7. For half-tones original prints on glossy paper are required, and of larger size than the final version.
- 4.8. All maps and plans should carry a north point, and a drawn linear scale in metres.
- 4.9. All illustrations will be returned to the author.

5. Proofs

- 5.1. Should be corrected in accordance with symbols of the British Standards Institution (BS 5261C:1976). There are adequate summaries of these symbols in *Whitaker's Almanack*, F. H. Collins, *Authors' and Printers' Dictionary* (OUP), *Writer's and Artists' Year Book*, R. A. Hewitt, *Style for Print* (Blandford Press), etc.
- 5.2. Proofs should be corrected and returned promptly.

PSAN—*Proceedings of the Society of Antiquaries of Newcastle*.

PSAS—*Proceedings of the Society of Antiquaries of Scotland*.
