


Figure 1. Site location. Scale 1:10,000

Summary

An archaeological watching brief carried out during the excavation of foundation trenches for an extension at Meadow House, West Barsham revealed no features, objects or deposits of archaeological significance.

1.0 Introduction




Figure 2. Site plan. Scale 1:200

(Figs 1 and 2)

An archaeological watching brief was undertaken during the excavation of foundation trenches for the construction of an extension to the east side of Meadow House, West Barsham, Norfolk. The survey area measured 10m x 6m (60 sq. m).

Fisher & Sons Ltd commissioned the work.

This archaeological watching brief was undertaken in accordance with a Brief issued by Norfolk Landscape Archaeology (ER/05/10/04). The Norfolk Museums and Archaeology Service currently hold the site archive, in accordance with the relevant policy on archiving standards.

The objective of this watching brief was to record any archaeological evidence of an earlier building that was revealed during groundworks. The Brief required that the works required constant monitoring by an approved archaeological contractor.

2.0 Observations

No archaeological features or deposits were recorded during the watching brief. The foundation trenches were excavated by mechanical excavator to a depth of 0.90m. Fragments of modern building material, glass and pottery sherds dating to the early 20th century were (although not retained) noted throughout a profile that consisted of mid to dark grey silty sands. This suggests dumping of soil to make up the ground level here had occurred relatively recently. Therefore, although nothing of archaeological significance was recorded, archaeological remains could lie deeply buried beneath this make-up material.

3.0 Conclusions

No features or deposits of archaeological significance were recorded during the watching brief. However, it is possible that archaeological remains may survive beneath the considerable depth of dumped material on the site
