

Summary

AOC Archaeology Groups was commissioned by Martin Reynolds to monitor the topsoil strip associated with the construction of a garage at No 1A Liberton Tower Lane, Edinburgh, as part of the planning condition on the development.

No archaeological features or finds were recovered and therefore no further archaeological works are recommended.

1 INTRODUCTION

1.1 **Background**

- 1.1.1 AOC Archaeology Group was commissioned by Mr Martin Reynolds to undertake an archaeological watching brief on the topsoil strip associated with the construction of a single garage at 1A Liberton Tower Lane, Edinburgh. The works were undertaken in order to satisfy a condition set by the City of Edinburgh Council who are advised on archaeological matters by the City of Edinburgh Council Archaeology Service (CECAS), Planning Ref: 11/01184/FUL.
- 1.1.2 The works were conducted according to the terms of a Written Scheme of Investigation approved by CECAS and in accordance with the principles set out in Scottish Planning Policy (Scottish Government 2010) and PAN 2/2011 Planning & Archaeology (Scottish Government 2011).

1.2 **Site Location**

1.2.1 The development area is located at 1A Liberton Tower Lane, Edinburgh and is centred on NGR: NT 26465 69599 (Figure 1). The area of development was bounded by existing properties to the north, west and east and a lawn with mature trees to the south.

1.3 Archaeological background


The development area lies within the grounds of Liberton Tower House, a Category A Listed Building dating to 1.3.1 the mid-15th century. The tower house is associated with various other estate buildings including outbuildings and stables. Due to the location of the development inside the grounds of this late medieval property, there remained the potential for uncovering significant medieval material.

2 **OBJECTIVES**

- 2.1 The objectives of the watching brief were:
 - i) to monitor any ground-breaking works associated with the construction of the garage to prevent the destruction of significant archaeological features prior to their recording;
 - given the discovery of significant archaeological material in quantity that would suffer an adverse impact from the development (ie, where preservation in situ would be impractical), the recording of all archaeological features by means of a mitigation strategy to be formulated with CECAS.

3 **METHODOLOGY**

All ground-breaking works were conducted using a 360° excavator with a bladed bucket. All excavation was 3.1 monitored by an experienced field archaeologist and all recording was carried out according to AOC Archaeology Group's standard practices.

4 **RESULTS**

- 4.1 The area monitored included a complete topsoil strip of the garage area to the west of the main house (see Figure 1).
- 4.2 An area measuring 8.20m by 5.80m was stripped with a thin topsoil depth of 0.15m throughout. This revealed made ground consisting of a gravel surface. Four trenches around the footprint of the building were also excavated to the maximum depth of 0.60m. This revealed a demolition rubble deposit, up to 0.40m in depth, consisting of mixture of modern brick, concrete fragments, gravel and stone. In the easternmost foundation trench, disused brown UPVC drain pipes were also encountered. The demolition rubble plausibly resulted from the demolition of the kennels, which used to stand on the site, and subsequent landscaping attempts associated with residential properties on the site. Beneath the demolition/made ground deposit natural clay at a depth in places of 0.40m, which was a possible redeposited natural (Plate 1).

5 **CONCLUSIONS**

5.1 No significant archaeological features or artefacts were revealed during the archaeological watching brief. No further archaeological works are considered necessary within the development area. This recommendation will require confirmation by CECAS.


