## SUMMARY

This report presents the results of an archaeological evaluation and subsequent excavation undertaken by AOC Archaeology Group prior to the construction of a new residential and commercial development at 102 St Leonard's Street, Edinburgh.

The initial evaluation showed that a large part of the site had been truncated by the previous modern development. The earliest buildings depicted along the street frontage had all been removed and the site had clearly been reduced to below the $18^{\text {th }}$ and $19^{\text {th }}$ century ground levels. However, the central portion of the development area showed potential for the survival of subterranean structures. Therefore, after discussions with the CEC Archaeology Service, an area of additional excavation was undertaken measuring 30 m by 20 m within this area.

The excavations revealed the surviving walls and floors of $19^{\text {th }}$ century warehouse cellars. The cellars were constructed on two levels with the 'Upper Level' consisting of sandstone walls with bitumen and wooden floors and the 'Lower Level' consisting of sandstone walls with sandstone flagstone flooring. In total, 23 rooms were identified, with ten linking corridors, a large stairwell, six light wells, five hearths or fireplaces and three external entrances.

Modern repairs and additions were visible throughout suggesting the buildings and rooms were altered and re-used, with some possibly blocked up and the floors removed for use elsewhere. With modern concrete used in the reparations it was not unusual that all of the material culture from the infilling deposits was modern in date.

## 1 INTRODUCTION

### 1.1 Project Background

1.1.1 An archaeological evaluation and subsequent excavation was required by GVA James Barr on behalf of their client prior to the development of a residential and commercial development at 102 St Leonard's Street, Edinburgh as part of a planning condition on the development (Planning Ref: 14/03643/FUL). The scope of the works was determined by the City of Edinburgh Council as advised on archaeological matters by the City of Edinburgh Council Archaeology Service (CECAS). The works were conducted according to the terms of a Written Scheme of Investigation (AOC 2015) and Addendum to the Written Scheme of Investigation (AOC 2016), approved on behalf of City of Edinburgh Council by CECAS and in accordance with Scottish Planning Policy (Scottish Government 2014) and PAN 2/2011 Planning And Archaeology (Scottish Government 2011).

### 1.2 Site Location

1.2.1 The site at 102 St Leonard's Street is located to the north-east of St Leonard's Street and was most recently occupied by the Homebase Store and its associated car park (Figure 1). The site is centred on NGR: NT 26597 72652 and is bounded to the south-east by St Leonard's Church, to the north-east by flats associated with Parkside Terrace and to the north-west by the flats associated with Parkside Street.

## 2 HISTORICAL BACKGROUND

2.1 Historic mapping evidence for the area is quite small scale prior to the mid-19 ${ }^{\text {th }}$ century. However, early maps do give an idea of the layout of the city and the development area from the late $17^{\text {th }}$ century onwards. Although quite schematic, Adair's 1682 map shows there to be no expansion of the city southwards within the vicinity of the Dalkeith Road at this time (Figure 2). Some development appears to be edging southwards, although the Dalkeith Road here looks to be relatively less-defined in comparison with its neighbour to the west (what is now Clerk Street and Minto Street). Into the $18^{\text {th }}$ century, there is some expansion of this main road towards Dalkeith as it becomes more well-used. For example, in Roy's Military Map of Scotland (ca. $1747-55)$ there are some buildings noted along the side of this road to the north of the development area, although in the site itself, there appears only to be cultivated land (Figure 3). Historic sources have identified the Castle O'Clouts pub as having been established in 1724 by William Hunter, a tailor burgess of Edinburgh (Internet Source 1 \& 3; Harris 1996; Chambers 1825). Chambers notes in a footnote of his book 'Traditions of Edinburgh' '... a goodly house of three storeys upon the Dalkeith Road, near the city, which was built about sixty years ago by one Hunter, a tailor... sneeringly denominated the Castle o' Clouts.' (quoted in Internet Source 3). Apparently '...Hunter was so proud of his achievement that he aimed at perpetuating it by having his likeness carved in stone on the back of his house. This memorial existed at the beginning of the present $\left[19^{\text {th }}\right]$ century, but whether it is still there the writer cannot say.' (ibid). Hence if this information has been correctly sourced, then Roy's map must be too small scale to show the pub.
2.2 Laurie's maps of 1766 and 1786 respectively are a little larger in scale and do depict buildings within the development area, one of which may be the Castle O'Clouts (Figures $4 \& 5$ ). In the 20 year gap between the maps there has been some additional development, including tenement buildings to the north of the site. The Gibbet Toll is also marked, and was used for executions. Although not recorded on the earlier maps, this site is thought to have origins going back to the late $16^{\text {th }}$ century. It was positioned at the corner of Dalkeith Road and Holyrood Park Road, between what are now the Scottish Widows building and the Royal Commonwealth Pool, to the south of the development area.

The earliest cartographic evidence for the development area and its environs in detail comes with the publication of John Ainslie's 1804 map (Figure 6). Here, the north-east/south-west angled boundary that marks the future position of Parkside Place can be seen bounding the north of 'Mrs Innes's Land'. The map then clearly shows a number of buildings on the north-east side of St Leonards Street, behind which is a large area of landscaped garden with a cross pathway. 13 years later, in Robert Kirkwood's 1817 map, there appears no change in the layout of the site, although Mrs Innes's Land is now annotated as belonging to 'Mr Bell' (Figure 7).

2.4 By the 1830s, Kay's map (1836) identifies that the streets have become more formalised. Unfortunately only the northern part of the development area can be seen in this town plan, although Parkside Place has been established as has Henry Street (the north-east/south-west street to the west of the development area) (Figure 8). The tenements that comprise Nos 2-24 \& 66-72 Parkside Place, 79A - 92 St Leonards Street and 94 St Leonards Street (now demolished) have also been established, as has a much larger expanse of buildings centred around the newly formed Henry Street to the east of this (also now demolished). Although not annotated on this map, it is thought that around 1838, the Castle O'Clouts pub got its present name, previously being referred to as Huntershell (Harris 1996). A much clearer picture of the area can then be seen in Lancefield's 1851 map (Figure 9). The tenements around Parkside Place are shown, as are those at Henry Street. In the south corner of the development area is the Castle O'Clouts pub, behind which is a range of two large buildings, possibly warehouses or storehouses. There is a house depicted to the north-west of the pub, which is a north-west/south-east orientated block with a wing to the north-east side. It is set in its own grounds.

2.5 The detailed Town Plan Ordnance Survey map of 1852 shows a much clearer and more accurate picture of the development area and its environs in the mid- $19^{\text {th }}$ century (Figure 10 ). The Castle $\mathrm{O}^{\prime}$ Clouts pub is depicted to the south of the site with a pend to its north-western side. This leads through a small yard to a range of buildings. The buildings to the rear of this are shown as a large warehouse to the south-east side and another to its north-west. There is a large stairway on the south-east side of the latter. Henry Place backs onto the rear of these buildings. The house can also be seen in much closer detail here with its own discreet gardens and a boundary wall, with some ancillary buildings to its north-east.

2.6 By the late 1870 s there has been significant industrial expansion in the area, especially to the north and east of the site, as is depicted in the Town Plan of 1877 (Figure 11). The major expansions include the Parkside Brewery to the north-east of the development area and the St Leonards Station and Coal Depot. The Castle O'Clouts pub is still annotated, with its pend and additional buildings. However, the warehouses to the northwest of this have been expanded with another building constructed between the two that are depicted on the 1852 map. To the north-east side of Henry Place, a number of other - possibly industrial - units have been built, set within their own discreet boundary wall.
2.7 The later $19^{\text {th }}$ century also saw further expansion of the area, as depicted in the 1894 Ordnance Survey map (Figure 12). St Leonard's Church has been established to the south-east of the development area and was constructed in 1880 for the congregation in Newington. There had also been major development to the south-east of this, with the establishment of Nelson's Parkside Printing Works and a large row of tenements between these Works and St Leonard's Church. Within the development area, little has changed since the 1870s, apart from some additional buildings to the north-west of the pub complex. The house also appears to now be connected to the warehouse buildings behind. The buildings to the rear of the development area (to
the north-east) are also as depicted in the 1877 map, and one of the larger buildings is now annotated as a smithy.

2.8 The 1948 Ordnance Survey map shows the development of the site up until the mid-20 ${ }^{\text {th }}$ century (Figure 13). Both the large industrial sites of the Brewery and the Printing Works, together with the railway, are still shown in operation, and the area is heavily built up with tenements at Parkside Street and Parkside Terrace. The development area itself, however, looks little changed from the earlier late $19^{\text {th }}$ century map. Archive
photographs of the site from the 1960s depict the Castle O'Clouts pub and adjacent buildings (Internet Source 1 \& 2; Figure 14). The pub is depicted at ground floor level of a four-storey building with an upper gable front to the centre two bays rising above the eaves of the sharply pitched slate roof with chimneys at each gable. Adjacent and abutting the building is another four-storey tenement of a different phase with a chimney to the front.
2.9 The 1976 Ordnance Survey map shows that the buildings to the front (south-west) of the site adjacent to the road - including the Castle O'Clouts pub and the adjacent house - have been demolished by this time; the Castle O'Clouts was demolished in 1969 (Internet Source 3). The Parkside Brewery has also been taken down and the railway is disused. The demolition of all the previous buildings within the development area made way for the present Homebase and its associated car park.

## 3 OBJECTIVES

3.1 The objectives of the archaeological evaluation were:
i) to determine and assess the character, extent, condition, quality, date and significance of any buried archaeological remains within the proposed development area through evaluation trenching;
ii) to advise and implement an appropriate form of mitigation, such as excavation, post-excavation analyses and publication, given the infeasibility of preserving the archaeological material in situ, should significant archaeological remains be encountered.
3.2 The objectives of the archaeological excavation were:
i) To expose the surviving archaeology within the development footprint through the application of a controlled strip around the marked area, recording all significant archaeological features within the area;
ii) To liaise with CECAS and the client in order to mitigate against possible damage to the archaeology if it cannot be preserved in-situ.

## 4 METHODOLOGY

4.1 The evaluation phase of works consisted of seven trenches excavated using a 30 tonne tracked excavator utilising a bladed ditching bucket operating under the constant supervision of an experienced field archaeologist. Each trench was recorded using AOC pro forma trench record sheets and any potential features investigated further to assess their character and date.
4.3 Due to the findings of the significant archaeology in a discreet area during the evaluation, a 30 m by 20 m excavation area was opened up, after discussions with the client and CECAS. The excavation area was stripped of overburden by a 30 tonne and 13 tonne excavator utilising a bladed ditching bucket and/or a narrow toothed bucket where required. All machine excavation was conducted under the constant supervision of an experienced field archaeologist. All features and structures revealed were then cleaned by hand before being recorded by digital photography, surveyed in detail and then a written record produced using AOC pro forma context sheets.

## 5 RESULTS

### 5.1 Introduction

5.1.1 All archaeological works were conducted between the $3^{\text {rd }}$ February 2016 and the $15^{\text {th }}$ February 2016. Weather conditions were generally fair throughout the course of the work and archaeological visibility was good.

### 5.2 Evaluation

5.2.1 A total of seven trenches were excavated throughout the development area (Figure 15). The trenches largely showed that the site contained 0.3 m to 0.7 m of modern hardcore [001] throughout, used for levelling the site for the modern floor slab. This deposit directly overlay a pink boulder clay (natural) in Trenches 1, 2 and 6. Trenches 4, 5 and 7, however, revealed that layer [001] overlay a significantly deeper modern made ground up to 1 m in depth. Trench 4 also revealed parts of the former Henry Street road with some areas of cobbled surface still surviving the modern drainage to the north-east end of the trench.
5.2.2 Trench 3, positioned to the south-east of Henry Street revealed a bitumen and wooden floor surface [301], with some sandstone flagstone [306] bounded by a north-east/south-west-aligned sandstone wall [302] (Plate 1). To the immediate N of this wall was a cellar area with wall [305] in the W edge of the trench, with another NW-SE aligned wall [304] at the northern end of the trench that had been excavated into the natural subsoil. Due to these findings an excavation around these features was required.

### 5.3 Excavation

5.3.1 The total area excavated was a 30 m by 20 m area that revealed two subterranean floor levels related to the early $19^{\text {th }}$ century and later buildings that occupied the central part of the site (Figure 16; Plates $2 \& 3$ ). The features, walls and floors of the buildings were covered in a made ground deposit [002] consisting of redeposited clay and demolition rubble that underlay the hardcore [001] related to the previous building level. Due to the differing nature of the buildings the site was split into two areas: 'Upper Level' and 'Lower Level'.

## Upper Level

5.3.2 The Upper Level contained seven rooms that were contained by outer walls [044] and [007] to the north-east and south-west respectively (Figure 16). The south-east edge had been truncated by the previous development, and the north-west edge was bounded by wall [038], that also formed the south-east wall of the Lower Level. The total size of the remains of this level measured 15 m by 11 m with the walls surviving to 0.4 m in height in some places, constructed into the natural clay subsoil.
5.3.3 The three main walls [007], [038] and [044] were all of sandstone construction and keyed into each other, measuring 0.65 m to 0.75 m wide. Along the south-west edge and aligned north-west/south-east, parallel to [007], another slightly narrower sandstone wall [003] was revealed containing entrance [005]. The gap between walls [003] and [007] formed a long corridor (Corridor 1, [004]) that was contained at the northwest end by wall [046]. The corridor measured 12 m long by 1.15 m wide and was floored by large, squared flagstones [006] (Plate 4). This corridor was accessed from outside the building via doorway [005] which in turn led into Corridor 2 [020], via doorway [030], which was also floored with similar flagstones [014]. This corridor was formed by sandstone wall [016] to the north-west and brick wall [013] to the south-east and would most likely have allowed access to Room 1 [019] to the south-east and Room 3 [023] to the north-east (Plate 5). Corridor 2, Room 1 and Room 3 had all been truncated to the north-east and south-east by the previous construction on the site.
5.3.4 Room 1 was bounded by outer wall [007] to the south-west and internal wall [013] to the north-west and contained a hearth or fireplace [015] in the western corner consisting of a large rectangular flagstone with a smaller trapezoidal flagstone at the back (Plate 6). There were also two recesses in wall [007] within this room. The room was floored by bitumen and timber surfaces [010] and [012] with a possible partition wall [011] between. Room 3 was floored with large, squared flagstones [024] that were truncated to the northeast and south-east (Plate 7). Narrow brick walls [025] and [027] divided Room 3 from Room 2 [021] to the south-west and Room 4 [028] to the north-west.
5.3.5 Access to these rooms was not obvious as there was no clear entrance from Corridor 2 or Corridor 1 . It is assumed that access must have been from Corridor 1 through a doorway in wall [007] that was later truncated by a modern drain [018]. Room 2 was bounded by walls [007] to the south-west, [016] to the south-east, [025] to the north-east and [031] to the north-west and measured 3.3 m by 3.4 m (Plate 8 ). It also contained a hearth or fireplace [017] that was similar in construction to [015] and was set within wall [016] that divided the room from Corridor 2 . This room was also floored by a bitumen and timber surface [022], and contained a recess within the north-west wall [007].
5.3.6 Doorway [026] allowed access from Room 2 into the L-shaped Room 4 to the north-east that functioned as a short corridor linking Room 2 and Room 5 [032], via doorway [036]. It also appeared to function as a storage space or utility room that contained a fragmented sandstone base [055] set within a repaired cement and flagstone floor [029] that showed signs of having large iron objects placed upon it (see Plate 7). This room was bounded by sandstone wall [040] to the north-west, [039] to the north-east, brick wall [027] to the south-east and sandstone wall [037]/ brick wall [025] to the south-west. It measured 3.4 m by 2.1 m and 4.1 m by 1.5 m .
5.3.7 Room 5 was the largest room set in the western corner of the Upper Level, bounded by walls [007] to the south-west, [038] to the north-west, [037] to the north-east, and [031] to the south-east, measuring 5.3 m by

4 m (Plate 9). Like Rooms 1 and 2 it was floored by bitumen and timber surface [033] and contained a hearth or fireplace [035] set within wall [038]. This room also contained one recess within north-west wall [007] that contained a square flagstone block [034] with ceramic pipes next to it that had truncated the original wall line indicating a later addition.
5.3.8 To the north-east of wall [037] from Room 5 and to the north-west of wall [040] from Room 4 there was a small room or cupboard (Room 6 [041]) that measured 2 m by 1.8 m . This small space no longer retained its floor but was bounded by [038] to the north-west and accessed through doorway [052], set within the northeast wall [039]. This wall also formed the south-west wall of a probable corridor (Corridor 3 [042]) that was floored with large flagstones [043] (Plate 10). The south-east end of this corridor was truncated, as was the probable north-east boundary wall that would have separated it from Room 7 [053]. This room contained no floor surface or other boundary wall other than the main outer wall [044] to the north-east.

## Lower Level

5.3.9 Due to the increased depth at which this level was constructed, there was greater survival of the walls, which were up to 1 m high in places, with plaster still adhering to the faces prior to removal of the made ground within the rooms. This level was bounded by Walls [038] and [051] to the south-east, Wall [049] to the southwest, Wall [094] to the north-west and Wall [067] to the north-east (Figure 16; see Plate 3). Walls [049], [094] and [067] were all sandstone walls measuring between 0.55 m to 0.7 m in width and were keyed into each other with the south-east ends of [049] and [067] abutting walls [051] and [038] respectively.
5.3.10 Access to this level was gained from three different locations. Firstly, an external corridor (Corridor 4 [050]) located outside the southern corner of the Lower Level would have provided access to rooms along the south-west edge. This corridor was formed by Walls [046] to the north-east, [047] to the south-west, [008] to the south-east, and [051] to the north-west. It measured 5.5 m by 1.53 m and no longer contained a floor surface. Doorway and stairs [048] were set within wall [051] to allow access from external Corridor 4 into internal Corridor 5 [056], but this was later blocked up with brick (Plate 11).
5.3.11 Corridor 5 was floored with large squared flagstone floor [064] and measured 7.2 m by 1 m and was bounded by wall [054] to the north-east for most of its length with the far north-west end forming a small narrow space defined by Wall [117] and abutment [115] to the south-west, Wall [118] and abutment [116] to the north-east, and end Wall [123] to the north-west. To the south-west of the corridor there were four narrow rectangular rooms - Room 8 [057], Room 9 [058], Room 22 [102] and Room 21 [103] - backing onto main Wall [049] and each measuring approximately 2.25 m in length and 1.15 m wide (Plate 12). Walls [059], [066] and [096] divided the rooms and each one was floored with irregularly-shaped and sized sandstone flagstone floors [060], [063], [098] and [100] respectively. Before the corridor reached the narrow end point there is a doorway [122] to the north-east that led into the central area of the Lower Level and Room 11 [083].
5.3.12 Room 11 contained light well [045] in the southern corner consisting of a large stone lintel placed between walls [007] and [051] (Plate 13). The stone lintel and the bay area below have been rendered in concrete in more recent times. Other evidence of modern repairs and re-use within this room is the removal of the floor [081], which only survives as two truncated flagstones abutting wall [038] in the eastern corner, and the presence of a concrete strap at the face of the base of Wall [054] . The north-east edge of the room appears to continue into Room 10 [082], although wall remnants [080] and [076] may have formed a now demolished north-east division. To the north-west edge of the room, the boundary wall is a curving sandstone wall that forms the outer edge of stairwell [071]. The other side of the stairwell is within Room 13 [085] that joins Room 11 in its western corner.
5.3.13 This is where the second access point to the Lower level would have been, via the central spiral stairwell [071] (Plate 14). The stairwell consists of curving sandstone outer wall [072] and inner sandstone and brick wall [073] that contained a rubble core [075]. The large stone steps [074] were laid upon this rubble core and the internal faces of the two walls, with only one step surviving intact. A large supporting wall [078] (now
mainly demolished) is present at the south-west end of the stairwell. The stairwell would have measured 1 m wide internally and led from an upper floor level into the north-east edge of Hallway/Room 13 [085].
5.3.14 Room 13 was floored with large squared flagstones [077] and bounded by walls [079] to the north-east, stairwell [071] to the south-east, wall [120] to the north-west, and the north-west end of Room 11 and Corridor 10 [157] to the south-west (Plate 15). It measured 4.27 m by 3.96 m and would have acted as a hallway allowing access to all areas around the edges of the building via the other corridors and rooms. Within wall [120], which divides Room 13 and Room 18 [106], a direct access route through doorway [121] had been blocked with a sandstone wall, requiring a route through Corridor 10, and Corridor 6 [112] to access the room.
5.3.15 Corridor 10 was accessed via doorway/threshold [158] and formed by Walls [119] to the south-east and [118] to the south-west. It measured 3.7 m by 1.1 m and was floored with large squared flagstones [160] and joined to Corridor 6 [112] via doorway/threshold [159] to the north-west. Another Corridor leading from Room 13 is Corridor 7 [113], entered through doorway [135] between the north-east end of wall [120] and the southwest end of wall [155] (Plate 16). This corridor was formed by wall [128] to the south and wall [134] to the north-east and appeared to have been used latterly as a service corridor with ceramic pipes set into brick work [164] within a truncation of Wall [094] at the north-west end, and other pipes visible running under the made ground that constitutes the floor of the corridor, the original floor most likely having been removed.
5.3.16 From Corridor 7 it is possible to access Corridor 9 [137] through doorway [136], which was floored with large squared flagstones [138] and measured 2.35 m by 0.95 m from doorway [136] to doorway/threshold [139]. This corridor allowed access to Room 17 [107] to the north-west and Room 16 [108] to the north-east via doorways [140] and [139] respectively. Room 17 was a narrow rectangular room, similar to Rooms 8, 9, 22, and 21 and was also floored with irregular sandstone flagstones [141] that have been mainly replaced by concrete. The room measured 3.23 m by 1.47 m , and is bounded by Wall [134] to the south-west and Wall [142] to the north-east. Room 16 in contrast was a large square room in the northern corner of the building bounded by Walls [094] and [067] to the north-east and north-west, and Walls [155] and [142] to the southeast and south-west (Plate 17). It measured 3.55 m by 4.26 m and is floored with large, squared flagstones [143] and would have been lit by two windows, [091] on the north-west wall and [090] in the north-east wall. Both were of similar construction to window [045], with [091] having been similarly blocked by a concrete slab. Window [090] did not appear to have been blocked although only the window base lintel survives. Also within Room 16 was a small structure [144] in the eastern corner consisting of two sandstone blocks sitting either side of a small gap ( 1.32 m by 0.44 m ) that could be interpreted as a small cupboard space or the supports for an unknown feature.
5.3.17 Within Wall [155] to the south-east of Room 16 there was access to Corridor 8 [114] through doorway [145]. This corridor divides Room 23 [111] to the north-east from Room 12 [084], Room 14 [110] and Room 15 [109] to the south-west. It also led into Room 10 [082] at its south-east end and was floored with large squared flagstones [152], measuring 3.97 m by 1 m (Plate 18). Room 23 to the north-east of Corridor 8 was accessed through doorway [153] within wall [154] that also forms the south-west boundary to the room. The other walls forming the room are [155] to the north-west, [068] to the SE and [067] to the north-east, the room dimensions measuring 3.6 m by 2.51 m . No floor surface survived within Room 23 although it would have been lit by window [089] which had survived intact and unblocked. The window was outside the main wall [067] and consisted of a rectangular space formed by thin sandstone walls consisting of rough-edged sandstone blocks and floored by small, square sandstone flagstones that sat approximately 0.05 m below the window sill/lintel. The base of the well measured 1.15 m by 0.46 m , with a small hole within the corner of four of the flagstones in the floor to the south-east of centre that would have allowed for drainage of water within the well (Plate 19).
5.3.18 Across to the south-west of Corridor 8 , the three rooms in this area are of varying sizes truncated by a large modern emplacement [148] (see Plate 18). The least truncated of the rooms is Room 12 to the south-east end of the corridor that is accessed via doorway [162] and contained an irregular flagstone floor surface
[069], measuring 1.7 m by 1 m . To the north-west - and divided by truncated wall [156] - is Room 14 that had some irregular flagstones [150] surviving but have been removed to the south-west end of the room. This room measured 1.7 m by 0.74 m and was accessed via doorway/threshold [151]. At the north-west end of the corridor, and divided from Room 14 by brick partition wall [149], was Room 15 that had little of its floor intact and was mainly filled with the modern concreted mass [148]. It would originally have measured 1.7 m by 1.48 m and was accessed via threshold [146].
5.3.19 Corridor 8 then led into Room 10 [082], through doorway [086] at the south-east end which was bounded by walls [038] to the south-east, [067] to the north-east, [068] to the north-west and [076]/[080] to the southwest, measuring 5.4 m by 2.9 m . The south-west edge of the room may have been a small cupboard space between walls [070] and [076]/[080] although truncation of the room below floor level makes this interpretation difficult. Within the room there is a blocked window [088] that was similar to windows [045] and [091]. There was also a fireplace [087] with a truncated hearth set within wall [038] (Plate 20). The hearth measured 0.7 m by 0.35 m and set between two upright sandstone slabs. The hearth stone was set on top of two courses of roughly laid brick and mortar.
5.3.20 The final and most recently constructed access to the Lower Level would have been via staircase [095] set within the north-west end of wall [049] (Plate 21). This staircase was constructed through Wall [049] with brick used to repair the truncation and the seven steps that survived made from poured concrete. The stairs were 0.98 m wide and descended steeply from a height of 1.17 m over a length of 1.4 m . The steps entered into Room 20 [104] which contained a small remnant of flagstone floor [161] and was latterly used as a storage area containing stacks of ceramic tiles and slates (Plate 22). The room was a broad L-shape bounded by walls [123]/[097] to the south-east, [049] to the south-west, [094] to the north-west, and [124] to the north-east and measured 5.58 m by 3.38 m (Plate 23). It contained an intact window [093], set within wall [094] that was similar in size to window [089]. The construction of the window differed as the back wall had angled sandstone flagstones as the wall face and a ceramic tile drain in the base of it (Plate 24). Room 20 would formerly have been accessed via Corridor 6 through doorway [131] which is formed by the south-east end of wall [124] and wall [123]. This corridor was floored with large squared flagstones [130] and led into Rooms 19 [105] and 18 [106], as well as stairwell [071] within Room 13.
5.3.21 Room 19 was a narrow rectangular room formed by wall [094] to the north-west, [124] to the south-west, and [126] to the north-east, measuring 2.94 m by 1.47 m (Plate 25). It was accessed via doorway [133] at the south-east end of Walls [124] and [126] and was floored by irregular sandstone flagstones [125]. Room 18 was another large square-shaped space measuring 4.18 m by 3.38 m and formed by wall [120] to the SE, [094] to the NW, [126] to the SW and [128] to the NE (Plate 26). The room is accessed through doorway [132] between the south-east end of Wall [126] and Wall [120], and was floored by large squared flagstones [127] that had been truncated by concrete in the north-west half of the room.
5.3.22 This room contained window [092], which was set within wall [094], that was similar in size and construction to [093]. It also contained a fireplace [129] within Wall [128] that measured 0.72 m by 0.26 m with the same upright slabs on either side of the hearth as fireplace [087].

## 6 DISCUSSION

6.1 The archaeological evaluation and excavations completed at 102 St Leonard's Street have shown that the majority of the earliest buildings on the site - the Castle O'Clouts pub and the house in the western corner have been entirely removed by the later Homebase construction on the site. Furthermore, the north-east edge of the development site has also been heavily truncated by the later construction works, with no evidence of Henry Place or the buildings beyond it.
6.2 The only building remains that have survived are those that formed cellars or sunken floors of the large warehouse structures depicted to the south-west of Henry Place. Looking at the cartographic evidence these buildings may have been constructed some time between Kirkwood's 1817 map (Figure 7) and Kay’s 1836 map (Figure 8), but are not shown in detail until the Ordnance Survey of 1852 (Figure 18). At this point it appears that only the Lower Level building had been constructed as the Upper Level is depicted as a blank space between the Lower Level and a building that no longer exists to the south-east edge of the site. This is in contrast to Lancefield's 1851 map that depicts a row of joined buildings along the south-west edge of Henry Place. Lancefield's depiction is also evidenced by the excavation results as the Lower Level walls [067] and [049] clearly abuts the Upper Level Wall [038] implying that the Upper Level was constructed first.
6.3 The Ordnance Survey map shows the Lower Level set back from Henry Street with six windows revealed in the excavations along the north-west and north-east walls clearly marked on the map. The map also depicts a doorway in the north-west wall that would have been at a higher level than the surviving remains. Corridor 4 is also shown as an external corridor accessed via a set of stairs that were also at a higher level and did not survive. The light well in this corridor is not depicted and neither is Corridor 1 along the south-west edge of the Upper Level. It is not until the 1893 Ordnance Survey that this corridor forms part of the buildings, indicating it is a much later addition (Figure 12).
6.4 From the results of the excavation it is clear that these warehouses continued to be used into the late $20^{\text {th }}$ century, evidenced by the concrete steps [095], the stacks of terracotta tiles and slates within Room 20, the amount of modern rubbish that filled the base of the light wells, and the presence of modern concrete floors patching some of the room surfaces. Furthermore, it appears that parts of the warehouse Lower Level may have been shut off with windows being blocked and floor surfaces being removed. The concrete straps at the base of the walls within Room 11 may also indicate the structure was becoming unsafe and in need of structural repairs.
6.5 From the size of the rooms and the elements within them it can be suggested that the Upper Level was used more for office space with the wooden floors and hearths in each room. In the Lower Level, the lack of windows along the south-west edge suggests this was the main storage area with access via Corridor 4. The other areas were more readily accessed via the central stairwell with Room 10 and Room 18 more likely to be office spaces with fireplaces and the larger rooms (Room 23, 16 and 11) being work spaces.

## 7 CONCLUSION AND RECOMENDATIONS

7.1 The archaeological excavations revealed the limited survival of the subterranean sections of the $19^{\text {th }}$ Century warehouses within the development area, and have shown that the ealriest structures depicted on the site did not survive the late $20^{\text {th }}$ century development.
7.2 The evaluation and excavations provided a safeguard for all archaeological remains on the site, which have now been excavated and recorded prior to their complete removal or truncation by the upcoming development.
7.3 It is not recommended that any further post-excavation works are conducted. This recommendation will require approval of the CEC Archaeology Service who advise the CEC on archaeological planning matters.

| MAIN (NARRATIVE) DESCRIPTION: <br> (May include information from other fields) | AOC Archaeology Group was commissioned to undertake an archaeological evaluation and subsequent excavation undertaken by AOC Archaeology Group prior to the construction of a new residential and commercial development at 102 St Leonard's Street, Edinburgh. <br> The initial evaluation showed that a large part of the site had been truncated by the previous modern development. The earliest buildings depicted along the street frontage had all been removed and the site had clearly been reduced to below the $18^{\text {th }}$ and $19^{\text {th }}$ century ground levels. However, the central portion of the development area showed potential for the survival of subterranean structures. Therefore, after discussions with the CEC Archaeology Service, an area of additional excavation was undertaken measuring 30 m by 20 m within this area. <br> The excavations revealed the surviving walls and floors of $19^{\text {th }}$ century warehouse cellars. The cellars were constructed on two levels with the 'Upper Area' consisting of sandstone walls with bitumen and wooden floors and the 'Lower Area' consisting of sandstone walls with sandstone flagstone flooring. In total, 23 rooms were identified, with ten linking corridors, a large stairwell, six light wells, five hearths or fireplaces and three external entrances. <br> Modern repairs and additions were visible throughout suggesting the buildings and rooms were altered and re-used, with some possibly blocked up and the floors removed for use elsewhere. With modern concrete used in the reparations it was not unusual that all of the material culture from the infilling deposits was modern in date. |
