# An Archaeological Evaluation on land adjacent to Headlands, Warton Lane, Austrey, Warwickshire.

### **Gavin Speed**

#### Summary

University of Leicester Archaeological Services (ULAS) carried out an archaeological evaluation by trial trenching on land adjacent to Headlands, Warton Lane, Austrey, Warwickshire (SK 29170 06759) in January 2015. The work was undertaken as part of a planning application for a proposed residential development.

The evaluation revealed no archaeological finds or features.

The site archive will be held by Warwickshire County Council, under accession no. WM T/1406.

#### 1. Introduction

University of Leicester Archaeological Services (ULAS) carried out an archaeological evaluation by trial trenching on land adjacent to Headlands, Warton Lane, Austrey, Warwickshire (SK 29170 06759) in January 2015. The work was undertaken as part of an application for planning permission for a proposed residential development (planning application PAP/2014/0301 and PAP/2014/0302, Figs.2-3).

The proposed development site is likely to have been within the area of medieval settlement at Austrey, and there is evidence for earthworks visible north-west of the two application areas (Stocks 2014 advice letter). Warwickshire County Council as archaeological advisors to the planning authority have requested an archaeological field evaluation to identify and record any archaeological remains of significance (Score 2015). The work was required to assess the nature, extent, date and significance of any archaeological deposits which might be present in order to determine the potential impact of the proposed development upon them.

In accordance with National Planning Policy Framework (NPPF) Section 12 *Conserving and Enhancing the Historic Environment* this document forms the report for an archaeological evaluation, with an assessment of the potential impact on buried archaeological remains from groundworks associated with future development.

#### 2. Site Description, Topography and Geology




Figure 1 Site location plan

The site is located in the north-west outskirts of the village, in three fields to the east and south of a property known as 'Headlands' on the north side of Warton Lane, Austrey, Warwickshire (Fig. 1; NGR SK 29170 06759).

The Ordnance Survey Geological Survey of Great Britain shows that the underlying geology consists of Tarporley siltstone and mudstone overlain with clay, silt and sand alluvium. The proposed development area lies within arable fields at a height of *c*.77.1m OD.




Figure 2: Proposed development plan of 'site1', plan provided by client




Figure 3: Proposed development plan of 'site2', plan provided by client

#### 3. Historical and Archaeological Background

An HER assessment and map survey has been undertaken for the area. The detailed list of all the data is presented in the Appendix. The Warwickshire Historic Environment Record (HER) shows that the proposed development lies in an area of archaeological potential. The development site contains no battlefields, world heritage sites / parks, scheduled monuments, or listed buildings.




Figure 4: HER monuments, events, listed buildings, and areas of ridge and furrow earthworks, data from Warwickshire Historic Environment Record

There are 15 listed buildings within a 1km radius, all within the village (Table 3, Fig. 4), notably close to the development site are the Bishops farmhouse (early to mid-16th century) and the Manor House (late 17th / early 18th century). Two HER monuments are listed, one being Bishops Farm (MWA7555), and the other a watching brief at 2 The Green. In addition a sketch of the earthworks was made in the area behind the church (EWA7006), and a negative watching brief was undertaken at White Cottage, Church Lane (EWA9165).

The village has Anglo-Saxon origins, and the Domesday survey of 1086 indicates a populous and valuable village. It has three entries:

Burton Abbey holds 2 1/2 hides, land for 2 ploughs. In lordship1, 6 villagers and 4 smallholders with 2 ploughs. Value before 1066, 40s, now 30s. Nigel holds 2 1/2 hides, land for 2 ploughs, 7 villagers and 3 smallholders have 2 ploughs. The value us 20s. Nigel of Aubigny holds Austrey from the king. 5 1/2 hides and 1 virgate of land. Land for 10 ploughs. In lodrships 2, 12 villagers with a priest and 8 smallholders have 5 ploughs. Meadow 1 furlong long and another wide. The value was £6, now £3. 8 thanes held it freely before 1066 (Morris 1976).




Figure 5: Landscape characterisation map (red line indicates 1km search area above and detailed view below)

The proposed development site lies within the possible extent of the area of medieval settlement at Austrey (MWA 9490). It does, however, lay well outside of the historic core of the village (HWA1532). Immediately to the west of Headlands, modern satellite imagery (such as Google or Bing) shows earthworks, possibly small paddocks /enclosures (see also

Figure 4) (MWA12507). Ridge and furrow earthworks are clearly visible immediately to the north of Headlands. The historic Landscape characterisation shows the site as small paddocks and closes next to Austrey village. Ridge and furrow in this area suggest they were once medieval open fields. Around the outskirts of the village are a mixture of large irregular fields and small generally rectilinear fields (Fig. 4).

Map regression indicates no development in historic times with potentially good survival of any earlier deposits. The earliest map of the area is the Tithe map of 1840 (Fig.6). It shows a dispersed village with settlement possibly focused in two areas, one south around the church, and the other close to the development site around Manor House. There are earthworks between these two areas (MWA19305) that could indicate shrunken settlement.




Figure 7: Detail from the 1885 Ordnance Survey map. Development areas highlighted (courtesy of Warwickshire Records Office)




Figure 8: Detail from the 1903 Ordnance Survey map. Development areas highlighted (courtesy of Warwickshire Records Office)

Empty plots on the 1885 map also indicate shrunken settlement. The fields for which the development is proposed are unchanged from the 1840 map (Fig. 6) throughout the various Ordnance Survey map editions. The 1885 map (Fig. 7) shows the property preceding Headlands as 'Manor House'. A pond in the east field which also appears in subsequent editions up to 1995, was backfilled around 12 years ago (Mr Ensor pers. comm.). The name 'Manor House' switches to a property to the north-east in the 1903 edition (Fig. 8). The 1957 map (Fig. 10) shows the Manor House as a 'ruin'. The south-east corner of the east field has been reduced in size slightly from earlier maps. A pumping station and electric substation has been added to the north of the southern field. The 1972 map (Fig. 11) shows significant infilling of plots with residential developments to the south. The property of

Headlands is shown on the 1995 map (Fig.12) edition, along with further new residential housing directly to the south of the development site.




Figure 9: Detail from the 1924 Ordnance Survey map. Development areas highlighted (courtesy of Warwickshire Records Office)




Figure 10: Detail from the 1957 Ordnance Survey map. Development areas highlighted (courtesy of Warwickshire Records Office)




Figure 11: Detail from the 1972 Ordnance Survey map. Development areas highlighted (courtesy of Warwickshire Records Office)




Figure 12: Detail from the 1995 Ordnance Survey map. Development areas highlighted (courtesy of Warwickshire Records Office)

#### 4. Aims and Objectives

The broad aims of the archaeological evaluation trenches were:

- To determine, as far as is reasonably possible, the location, extent, date, character, condition, significance and quality of any surviving archaeological remains on the site.
- To establish the nature and extent of any existing disturbance and intrusion to subsurface deposits and, where the data allows, assess the degree of archaeological survival of buried deposits of archaeological significance.
- To enable the clients to establish a schedule for archaeological risks.
- To allow the client to make an informed decision on the planning application as advised by Warwickshire County Council.

The detailed objectives of the archaeological evaluation trenches were:

- Insofar as possible within methodological constraints, to explain any temporal, spatial or functional relationships between the structures/remains identified, and any relationships between these and the archaeological and historic elements of the wider landscape.
- Where the data allows, identify the research implications of the site with reference to the regional research agenda and recent work in Warwickshire.

The initial assessment suggested that archaeological work would be able to contribute towards several research objectives derived from *The Archaeology of the West Midlands: A Framework for Research* (Watt 2011).

#### 5. Methodology

Prior to any machining of trial trenches, general photographs of the site areas were taken. The trenches were excavated using a mechanical excavator equipped with a 0.9m wide toothless ditching bucket. The topsoil and overlying layers were removed under full archaeological supervision until either the top of archaeological deposits or the natural undisturbed substratum was reached. Trenches were examined for archaeological deposits or finds by hand cleaning. The trenches were tied into the Ordnance Survey National Grid and then were backfilled and leveled at the end of the evaluation.

The work followed the approved design specification (Score 2015) and adhered to the Chartered Institute for Archaeologists (CIfA) *Code of Conduct* (2012) and adhered to their *Standard and Guidance for Archaeological Field Evaluations* (2010).

#### 6. Results




Figure 13: Trench plan

Eight trenches were excavated, six in two fields immediately to the north-east of 'Headlands', and a further two in a field to the south (Fig. 13). Six of the trenches were approximately 20m in length, and two others were 15m long. In all trenches no archaeological finds or features were identified. The trenches are detailed below in Table 1 and a selection of trenches are shown in figures 14-17.

The topsoil varied between 0.15m and 0.35m deep overlying orange-brown sandy clay substrata. No archaeological features were identified. Field drains were seen in trenches 7 and 8. The trenches in the southern field also contained significant depths of subsoil perhaps due to ploughing.
