

## Archaeological watching brief

Headland Archaeology (UK) Ltd was commissioned by Wilson Marshall to undertake a Watching Brief on a development at Pepperwood Cottage, Wheatlands, Edinburgh. The work was undertaken in response to a planning condition placed on the development by the City of Edinburgh Council Archaeology Service (CECAS) and comprised archaeological monitoring of groundworks during the construction of a new access road and garage. The site was considered to have high archaeological potential because of the presence of two cropmarks in the field to the west and other significant prehistoric activity recorded in the area.

The monitoring recorded three furrows, orientated north to west across the site, spaced 3-4m apart. These are likely to relate to medieval or later agriculture, although no finds were recovered from the furrows to date them.

#### 1. INTRODUCTION

Headland Archaeology (UK) Ltd was commissioned by Wilson Marshall to undertake a Watching Brief on a development at Pepperwood Cottage, Wheatlands, Edinburgh (Illus 1; NT 1433 7495). The work was undertaken in response to a planning condition placed on the development by the City of Edinburgh Council Archaeology Service (CECAS) and comprised archaeological monitoring of groundworks during the construction of a new access road and garage.

#### 1.1 Project Background

The development covers an area to the north-west of the existing Pepperwood Cottage and is currently grassland. The site is located to the east of the village of Kirkliston in the River Almond Valley and north of Edinburgh Airport. This area of the valley has been extensively occupied since the Neolithic period, with significant prehistoric activity identified near Carlowrie and therefore the site was considered to have a high archaeological potential.

There are two cropmarks in the fields to the west of the site, suggesting prehistoric occupation in the immediate vicinity of Pepperwood Cottage, indicating the potential for the discovery of prehistoric remains in the area.


#### 2. OBJECTIVES

The objectives of the work were to record any archaeological remains threatened by the proposed development and to report on the results of the work.

#### METHODOLOGY

A JCB 3CX with back actor and equipped with a flat bladed ditching bucket was used to remove turf and topsoil down to the top of the natural subsoil under archaeological supervision. An area 7m by 7m was stripped for the garage and subsequently the 4m wide access road was stripped.





#### 4. RECORDING

All recording was according to IfA standards and guidance. All contexts were given unique numbers and all recording was undertaken on pro-forma record cards.

Features were added to the overall site plan using hand drawn plans and sections of individual features were drawn at 1:10. The site has been related to the National Grid.

Colour transparency and digital photographs were taken and recorded in a photographic register. Record shots of archaeological contexts included a metric scale. A full photographic register can be found in Appendix 1. A summary report has been prepared for submission to Discovery and Excavation in Scotland (DES) a copy of which is found in Appendix 2 and the work has also been recorded on the OASIS database (headland1-105570).

#### 5. RESULTS

Topsoil [001] 0.4m in depth was removed directly onto natural clay subsoil [004]. The watching brief recorded three furrows orientated north to south across the garage and access road areas (Illus 2). These were 3–4m apart and very shallow; a section excavated through one of the furrows [003] was 0.09m in depth and was filled with mid brown silty clay [002], Illus 3 & 4. No finds were

recovered from the furrows. No other features were recorded.

#### CONCLUSION

The spacing of the furrows found during the watching brief suggests they are likely to relate to medieval or later agriculture. Trial trenching by Headland Archaeology in advance of the construction of the new Forth Road Crossing recorded numerous furrows across fields to the west and north of Kirkliston (e.g. Humble 2011, Jones 2011), demonstrating the ubiquity of these features in the local landscape.
