

ARCHAEOLOGICAL GROUND MONITORING AT GRANGE COURT, LEOMINSTER, HEREFORDSHIRE

Headland Archaeology was commissioned by Herefordshire County Council to undertake archaeological ground monitoring at Grange Court in Leominster, Herefordshire as a condition of planning approval ref. DCNC2009/0435/CD. Apart from a pond and modern well, the archaeological watching brief did not reveal any other evidence of archaeology around the building

INTRODUCTION

Planning permission for development of the house and gardens at Grange Court, Leominster was granted by Herefordshire Council on 07/08/2009. The applicant was Mr B Williams of Herefordshire Council, through agents ST Walker and Duckham of Worcester. On the advice of Herefordshire Archaeology, a pre-commencement archaeological planning condition (Condition 9) was attached to the planning permission, in order to secure a suitable programme of archaeological work in relation to the development. Such conditions are in line with the guidance given in *Planning Policy Guidance Archaeology and Planning 1990* (PPG 16), and are in accordance with the (Herefordshire) Unitary Development Plan, Policy ARCH6.

The presumed sensitivity of the site led to an archaeological field evaluation being undertaken in January 2009, in order to inform the planning application. The results of this evaluation are contained in An Archaeological Field Evaluation at Grange Court, Pinsley Road, Leominster, Herefordshire Mercian Archaeology PJ234 Feb 2009.

The objective of this stage of archaeological work was to record any remains of archaeological significance encountered during the course of the development, produce a report and deposit the archive with a local repository.

1.1 Location

Leominster is located at the junction of the A49 Hereford to Shrewsbury road and the A44, which links Leominster with Worcester. The Shropshire market town of Ludlow is some 18 kilometres to the north, the city of Hereford around 20 kilometres to the south. The town occupies the higher ground in the area of land defined by the confluence of the Rivers Lugg and Arrow.

Grange Court is on the eastern side of the town, around 300 metres to the south of the Priory Church of St Peter and St Paul (the site of Leominster Priory). The site is approached via Pinsley Lane, which runs from Etnam Street at the south, to Church Street to the northwest.

1.2 Background and history

Leominster is a historic market town, designated as an 'Archaeologically Important Urban Area' in the Herefordshire Unitary Development Plan. The core of Leominster, within which the site is situated, is regarded as having high potential for the recovery of historic artifact assemblages and for the detailed study and recording of historic structures (CMHTS, 1996).

The site is in a particularly sensitive location archaeologically, being within the ancient Saxon precinct of Leominster Priory. Because of the sensitivity of the site an archaeological field evaluation was undertaken in January 2009, in order to inform the planning application:

'The results of the archaeological work demonstrated that there were limited archaeological features within the evaluated area. A single shallow gully was seen in Trench 2, with a more substantial ditch feature identified in Trench 3. The fills of these features contained no artefacts and so remain undated. The likelihood is that the features are medieval and represent drainage features in a formerly wet area that was cultivated, probably during the medieval period. It appears that when the Grange Court building



was erected on the site in the mid-19th century, the gardens were also laid out resulting in areas of landscaping and terracing, with earth moved about the site.'
(Mercian Archaeology, 2009).

2. METHOD

The scope of the work encompassed archaeological monitoring of:


- · excavation for the slabs of the south and east wings,
- test pits, underpinning and footings for the northern extension of Grange Court,
- the rebuild of the outbuildings abutting the stable block,
- drainage works in the northeast and southeast quadrants of the site,

- excavation of a circular wall foundation for landscaping,
- excavation of trenches through the areas where soakaways are to be sited.

Due to a lack of finds of any archaeological significance over a period of two weeks whilst monitoring service trenches it was agreed with Julian Cotton (Archaeological advisor for the planning authorities) that other areas likely to be affected by the proposed developments be evaluated with 3 trenches.

2.1 Recording

All recording was carried out to IfA Standards and Guidance. All contexts were given unique numbers and recorded on pro forma cards and a context register. Photography was undertaken using 35mm slide and black and white film. A 7.2mp camera was used for illustrative purposes.

2.2 Samples and artefacts

No contexts worth sampling were uncovered during the course of the watching brief and no stratified small finds were observed/retained.

RESULTS

Observations made during the course of the project were consistent with the evaluation report from 2009 (Mercia Archaeology). The underlying drift geology is at *c*.500–700mm, below a cultivation subsoil of between 200

and 400mm thickness, underlying topsoil and general detritus *c*.200–400mm deep. The exceptions to this is the area of the stable yard which had little topsoil, but instead revealing make-up deposits for a sequence of yard surfaces.

No continuations of the ditch and gully reported by Mercian Archaeology have been found, but the demolition deposits noted in their Trench 2 were seen in the drainage and landscaping of the northwest corner of the garden area. A well was recorded during excavations for the south wing, and a probable clay-lined pond feature nearby in associated drainage works.

CONCLUSION

The results of the archaeological work revealed few archaeological features, limited to the probable pond and a well observed in the drainage and foundation trenches for the proposed south wing. The features did not contain stratified archaeological finds and it is therefore not possible to ascribe dates.
