Archaeological Monitoring

Headland Archaeology (UK) Ltd undertook archaeological monitoring of groundworks associated with the conversion of a barn and the associated outbuildings at Grange Farm, Bickenhill, Solihull, Warwickshire, in response to a condition placed on a planning consent (Planning Ref: 2013/571/FUL). The archaeological monitoring revealed stratigraphy comprising brick, stone and concrete floor surfaces which overlay foundation deposits which overlay the natural geological deposit within the structures; and topsoil over the natural externally. A modern pit and two postholes were additionally recorded. No archaeological remains or finds of interest were found.

1 INTRODUCTION

Dr Jugjit Singh Sanghera (the client) has been granted planning consent (2013/571/FUL) by Solihull Metropolitan Borough Council for the conversion of the existing two barns and attached outbuilding into two residential dwellings at Grange Farm, Bickenhill, Solihull, SP 1874 8239; henceforth referred to as the Development Area (DA) (Illus 1).

Due to the archaeological potential of the DA, a condition was attached to the planning permission which required the implementation of a programme of archaeological investigation. Warwickshire County Council's Planning Archaeologist (WCPA) prepared a brief detailing the archaeological investigation required, that involved a programme of monitoring to be undertaken during the development works (WCPA 2014). This work was requested in accordance with government guidance as set out in National Planning Policy Framework (NPPF) (2012).

The client commissioned Headland Archaeology to prepare a Written Scheme of Investigation (WSI) for the monitoring (Headland Archaeology 2014), undertake the site works, and prepare a report (this document) on the results. The WSI was approved by the WCPA prior to commencement of the project.

2 SITE LOCATION AND DESCRIPTION

The DA lies to the northeast of Solihull, approximately 1 kilometre to the southeast of Birmingham airport, within the village of Bickenhill. It is centered on SP 1881 8224 and is bounded by St Peter's Lane to the north and Church Lane to the east. The village of Bickenhill is roughly triangular and includes a single parish church and village green.

The land on which the DA sits is at 110mOD. The current use of the DA is two barns and an outbuilding surrounded by arable fields, see Illus 2 and 3.

The geology of the area is described as mudstone of the Mercia Group. No superficial deposits are recorded in the area (British Geological Survey – Accessed 28/08/2014).

3 ARCHAEOLOGICAL BACKGROUND

As stated in the WSI (Headland Archaeology 2014) The DA is located in an area of high archaeological potential within the core of the medieval village of Bickenhill.

No evidence for any prehistoric or Roman features has been uncovered in the vicinity of the DA, although the Fosse Way (the Roman road linking Exeter to Lincoln) was *c*. 2.5km to the east.

The DA is positioned close to, or possibly within, the medieval settlement of Bickenhill. Bickenhill is an old Anglo Saxon settlement, originally named Bichehelle (Bica's Hill) and Bickenhill manor was held by Edward the Confessor. Domesday records the value of the parish to its lord, Thorkil/Turchil of Warwick, at £1/5s in 1086 (http://domesdaymap.co.uk/ accessed 28/08/2014). The parish, part of the Coleshill hundred, is mentioned twice in the Domesday record, as *Bickenhill* and *Middle Bickenhill*. A total population for the two settlements is estimated at 19 households which, between them, land for 3-5 plough teams, 3 acres of meadow and 88 furlongs of forested land (ibid).

Earlier archaeological evaluation has been undertaken in the vicinity of the DA. For example, a trial-trench evaluation on Church Lane to the north east of the DA uncovered a pit and linear feature, both of which were undated (BUFAU 2006). However, there are no records of previous archaeological works which satisfactorily demonstrate the extent or scale of preservation of the medieval settlement.

Grange Farm, including the barns themselves are shown in broadly the same way on all maps since the 1888 OS. It was therefore possible that remains associated with the 19th century occupation (boundary features, rubbish pits, etc) could have been uncovered in the DA. The farmhouse is Grade II listed, although the barns are not

designated in their own right.

4 AIMS & OBJECTIVES

The WSI (Headland Archaeology 2014) states that the purpose of the investigation was to record and enhance understanding of the significance of heritage assets before they are lost (NPPF para 141). This was to be achieved by determining and understanding the nature, function and character of any remains on the site, in their cultural and environmental setting.

The local and regional research contexts are provided by The Archaeology of the West Midlands: An Archaeological Resource Assessment and Research Agenda (Watt 2011); Exploring Our Past (English Heritage 1991), and English Heritage Archaeology Division Research Agenda (English Heritage 1997).

Specifically the aims of the investigation included:

- Establishing the location, extent, nature and date of any archaeological features or deposits that may be present.
- Establishing the integrity and state of preservation of any archaeological features or deposits that may be present.
- Securing where appropriate, the assessment, analysis, conservation, and long-term storage of any artefactual / ecofactual material recovered from the site.

5 METHODOLOGY

5.1 Site works

Archaeological monitoring was undertaken on the 1st, 2nd, 3rd, 8th, 9th and 21st of June 2015. This observed the excavation of the footings and the ground levelling to the construction foundation level in the barn and outbuildings. Also the external excavation of drainage trenches entering the barn.

Monitoring was carried out in accordance with the WSI (Headland Archaeology 2014). This involved continuous archaeological observation, investigation and recording during all groundworks.

5.2 Recording

All recording was in accordance with the code of practice of the Chartered Institute for Archaeologists (CIfA). The trenches and contexts were given unique numbers. All recording was undertaken on pro forma record cards that conform to accepted archaeological standards. All stratigraphic relationships were recorded.

An overall site plan at an appropriate scale and relative to the National Grid was compiled. The site plan was accurately tied in to the National Grid and a scale version is shown in Illus 4.

A digital photographic record was taken and a metric scale was clearly visible in record photographs.

5.3 Reporting and Archives

The results of the works are presented below. A summary report has been prepared for submission to the OASIS database (headland4-223401).

There resultant archive will be deposited at Warwickshire Museum. All archive preparation will be undertaken in accordance with guidelines published by the CIfA on behalf of the Archaeological Archives Forum (July 2007).

6 RESULTS

The technical detail of contextual information can be found in the Appendix 1. The following is designed to interpret that technical detail and attempt to categorise its significance. Context numbers for deposits are expressed in parenthesis, i.e. (001).

The stratigraphy predominantly comprised brick floors [001], [007], [009], [010], [011], stone floors [003], [004], and concrete floors (002), (005), (006), (008) floors. These ranged between 0.08m-0.25m in thickness. All floor levels can be dated to the late 19th century and the 20th century see Illus 5.

Brick floor [001] see Illus 6, was an even regular coursed floor bonded with a lime based mortar, it was the original floor at the northeastern end of Barn A Room 1 later cut by [021] to form the foundation for the concrete floor (002). Bricks from [001] were incorporated into the foundation deposit (020) for floor (002). Barn A Room 2 comprised five different floor surfaces; stone floor [003] see Illus 7, made up of irregular sized stones with some regularity in coursing but no overall pattern; this floor was re-laid at a later date. A replacement floor was added where the doorway is situated on the northeastern wall of the room, brick floor [007] comprised regular coursing bonded with mortar; stone floor [004] believed to be the original floor was made up of irregular sized stones however coursed in an even and regular pattern, it was repaired over time with more regular stones. The southwest end of the room was later replaced with a concrete floor (005) and a concrete pad (006) was also added to the eastern corner of the room. Barn B Room 2 was made up of two brick floors, [010] see Illus 8, was the original floor with an even, regular course bonded by sand, it covered 60% of the room; 40% of the room was covered by brick floor [009], the bricks appear to match [010] suggesting it was laid at the same time or later then [010]. [011] see Illus 9, was a regular coursed brick floor comprising the associated outbuilding floor.

Barn B Room 1 consisted concrete floor [008] with a pit in the centre of it. The pit [044] (see Illus 10) measured 3.8m x 0.9m x 1.25m, and was located opposite the entrance in the northwest wall [015] and a filled in doorway in the southeast wall [015]. Two sheets of concrete measuring 2.6m x 0.01m x 1.95m formed the northeast and southwest edges of the pit, whist the southeast and northwest edges were not bordered. The

purpose of pit [044] is unknown, the rectangular shape and positioning between two doorways could suggest it was either for agricultural use or functioned as a garage pit enabling mechanics to work underneath vehicles. As it is modern it is therefore considered to have no archaeological significance.

Two postholes [049] and [051], relating to a dividing wall in the largest room of Barn B were investigated and recorded. Both were square in shape filled with a single context which comprised modern backfill. These postholes were positioned along the divide between floors [009] and [010], metal fixtures that once formed part of the divide were visible on the northeast and southwest facing interiors of wall [015].

The stratigraphy denotes the floor levels c.0.1m-0.5m thick; over a brown-red and brown-orange sandy-clay natural (100). Monitoring of the external drainage trench showed a stratigraphy of topsoil (101); over the natural (100).

No archaeological deposits or remains were noted during the excavation of the drainage trenches entering Barn A, see Illus 11.

6.1 Conclusion

The archaeological remains at the DA consisted 19th century floors which have subsequently been removed. No archaeological remains were found beneath the floor levels and foundations deposits.












ILLUS 4 Overall site plan
