#### **SUMMARY**

An archaeological watching brief undertaken on the construction of the KeyMed Distribution Centre, Temple Farm Industrial Estate, Southend-on-Sea has found no archaeological features or finds and few signs of modern disturbance. The absence of evidence suggests that the area of the KeyMed development has never been settled, or that all archaeological remains within that area have previously been removed and destroyed.

#### 1.0 INTRODUCTION

1.1 This report contains the results of an archaeological watching brief on the construction of the KeyMed Distribution Centre, Journeyman's Way, Southend-on-Sea, Essex (Fig. 1). The watching brief followed a written scheme of investigation (ECC FAU 2004) and was carried out by Essex County Council Field Archaeology Unit on behalf of PRC Group. The work was monitored by Southend Borough Council.

#### 2.0 BACKGROUND

2.1 The development covers approximately 0.5ha of derelict land and is part of the Temple Farm Industrial Estate, south-east of Southend Airport (Fig. 1). The ground is flat and low lying, and lies close to the estuary of the River Roach.

2.2 The geology of the site comprises brownish orange silt clay with no natural inclusions (brickearth) below c. 0.2m of brickearth-derived topsoil.

2.3 The site lies within an area of known archaeological potential. Prehistoric, Roman and Saxon remains have been uncovered within the west half of the industrial estate during the last 30 years or so, including an Iron Age coin hoard, a Roman cremation burial, and a Saxon sunken-floored building. A more detailed account of the archaeological background can be found in the desk based assessment, which was produced for the site prior to the watching brief (Heppell 2004).

#### 3.0 AIMS AND OBJECTIVES

3.1 The general aim of the watching brief was to assess and record archaeological deposits and features.

3.2 The specific aim of the watching brief was to look for further evidence for Iron Age, Roman and Saxon settlement, to obtain more information about the general context of these previous discoveries.

#### 4.0 METHOD

- 4.0 The watching brief monitored the excavation of approximately sixty foundation pits, ranging in size from 1.8m x 1.8m, to 3.2m x 3.2m (Fig. 1).
- 4.1 The foundation pits were dug by the developer using a mechanical excavator with a toothless bucket. The total area covered by the foundation pits was *c*. 400 square metres, or *c*. 8% of the total development.
- 4.2 The watching brief was carried out in accordance with the by-laws and guidelines of the Institute of Field Archaeologists. Essex County Council Field Archaeology Unit uses its own well-established set of procedures to record archaeological deposits and features (ECC FAU 2002). The total number of site visits was four.

#### 5.0 FIELDWORK RESULTS

5.1 No archaeological finds, features or deposits were identified. There was little evidence for modern disturbance, except for a narrow strip along the east side of the development area.

#### 6.0 CONCLUSIONS

6.1 The absence of archaeological features and finds possibly indicate that the archaeological remains found in previous years do not extend into the east half of the industrial estate. However, it is also possible that no archaeological remains are present because the original groundworks/site preparation undertaken for the Temple Farm industrial estate has destroyed and removed them. Either way, the current development has had a negligible impact on the archaeological resource of the area.


