### Summary

#### Mount Cottage, Hare Street, Buntingford

#### Synopsis:

In response to a condition on the planning permission for the construction of a new conservatory at Mount Cottage Hare Street, Buntingford, Herts, the Heritage Network was commissioned by Classic Window and Conservatory Co Ltd to undertake the archaeological monitoring of the development groundworks.

The monitoring of the groundworks revealed no archaeological features, deposits, or artefacts. Terracing in the garden and patio area to the rear of the house appears to have removed the original stratigraphy.

### 1. Introduction

1.1 This report has been prepared at the request of *Classic Window and Conservatory Co Ltd*, as part of the archaeological monitoring and recording of development works at Mount Cottage, Hare Street, Buntingford, Hertfordshire.

**1.2** The investigation wass a requirement of the planning consent granted by East Herts District Council (EHDC), under the provisions set out in Planning Policy Guidance Note No.16 (PPG16) on Archaeology and Planning (DoE 1990), for the construction of a rear conservatory (ref. 3/06/1964/FP). The extent of the work was defined in a *Design Brief for Archaeological Monitoring and Recording* prepared by the County Historic Environment Unit (CHEU) of Hertfordshire County Council acting as archaeological advisers to the EHDC (ref.AT15/12/2006). A full specification of the work was contained in the Heritage Network's approved *Project Design*, dated January 2007.

1.3 Mount Cottage is located in the historic core of Hare Street centred on grid reference TL 38995 29580. On the basis of the known archaeology on and in the vicinity of the present site, the CHEU advised that archaeological monitoring of the groundworks associated with the development should be undertaken, and the recording and appropriate investigation of any observed archaeological remains before the development proceeded.

1.4 The aim of the investigation has been to identify and record any archaeological features and deposits which might have been uncovered; and to retrieve artefactual and ecofactual elements to allow the date, character, and significance of the site to be assessed in accordance with current regional research agenda (Brown and Glazebrook, 2000), subject to the limitations of reasonable safety and practicality.

1.5 The present report describes the findings of the monitoring programme and is intended, together with the deposition of the site archive with Hertford Museum, Hertford, to complete the requirements of the planning condition.

### 2. Fieldwork

#### SITE TOPOGRAPHY

2.1 The ground across the study area appears to have been terraced into the hillside which rises on the western side of Hare Street. The new conservatory is located on part of the former garden patio on level ground at approximately 95mOD.

2.2 The drift geology belongs to the Melford Association (5710), and consists of deep well drained fine loamy or coarse loamy over clayey and fine loamy soils (SSEW, 1983). This was characterised on the site as firm, olive brown (2.5Y 4/4), clay with occasional chalk fragments.

#### *METHODOLOGY*

2.3 The timetable for the fieldwork followed the client's groundwork schedule. A number of site visits were made to supervise the reduction of the site and excavation of drainage trenches.

2.4 The machining was undertaken using a mini digger fitted with a toothless ditching bucket or toothed bucket, as required.

2.5 All work was carried out in accordance with the approved *Project Design*, current health and safety legislation, and both IFA and ALGAO standards.

#### MONITORING AND RECORDING

#### Site stratigraphy

2.6 The stratigraphy was consistent across the site and consisted of a layer of modern concrete slabs forming the existing patio over a layer of soft, yellowish brown (10YR 5/8) sand, imported to provide a base for the patio. Beneath this was the underlying natural geology of firm, olive brown, clay with occasional chalk fragments.

#### Ground reduction

2.7 The ground level was reduced by approximately 0.3m across the footprint of the new building. This removed the existing patio, levelling aggregate, and approximately 0.1m of natural clay.

2.8 No archaeological features, deposits or artefacts were revealed during this stage of the groundworks.

#### Footings trenches

2.9 A single 'L' shaped footings trench was excavated along the exterior wall of the new conservatory. The footing measured approximately 0.45m wide by 0.6m deep.

2.10 No archaeological features, deposits, or artefacts were revealed during this stage of the groundworks.

#### Drainage trenches

2.11 A single drainage trench was excavated for the new conservatory. It did not breach the levelling layer for the existing patio and did not impact on the underlying natural geology.

### 3. Discussion

**3.1** The site lies within *Area of Archaeological Significance 330* (AAS330), defined as the historic core of the settlement of Hare Street. Mount Cottage is situated on the western side of the B1368, which forms part of an old coaching route from London to Cambridge. A possible Bronze Age barrow (NMR 540769), 1.2km to the south-east, coupled with the discovery of a Late Bronze Age axe in the same area, demonstrates prehistoric activity in the vicinity of the site. Chance finds of Romano-British pottery from Little Hormead approximately 1km to the south-east have also been recorded.

3.2 The monitoring of the groundworks associated with the construction of the new conservatory revealed no archaeological features, deposits, or artefacts.

3.3 Mount Cottage appears to be constructed on land terraced into the hillside which rises steeply on the western side of the B1368. The terracing may have been undertaken during the construction of an extension to the western elevation of the house during the second half of the  $20^{\text{th}}$  century. No evidence of stratigraphy predating this period was observed, suggesting that the terracing was extensive enough to remove any earlier archaeological deposits which may have been present.

#### **Confidence Rating**

3.4 During the course of the fieldwork, the conditions were generally good for the identification of potential features and deposits, and for their investigation.

3.5 There are no circumstances which would lead to a confidence rating for the work which was less than High.






