Abstract

An archaeological watching brief was maintained during mechanical and manual groundworks for a new extension at Reigate Primary School, Bell Street, Reigate, Surrey. No significant archaeological deposits were recorded, although residual flintwork and medieval material was recovered from the overburden.

1.0 INTRODUCTION

1.1 Site Background

1.1.1 Archaeology South-East (ASE), a division of the Centre for Applied Archaeology (CAA), Institute of Archaeology (IoA), University College London (UCL) was commissioned by J S Surveying Associates Limited to undertake an archaeological watching brief during groundworks for development work at Reigate Primary School, Bell Street, Reigate, Surrey (Figure 1). The site is centred on NGR 525286 150041.

1.2 Topography and Geology

- 1.2.1 The school lies to the south of the main commercial centre of the town of Reigate, to the west of Bell Street (the A217), immediately to the north of the site of the town's Augustinian Priory (Figure 2). The monitored area within the site complex lies to the west of the school's 'inner courtyard', adjacent to a boiler room and staircase (Figure 3).
- 1.2.2 According to current data available from the British Geological Survey, the underlying bedrock is the Folkestone Formation of sandstone. There is no recorded superficial geology (BGS 2013).

1.3 Planning Background

1.3.1 Planning consent for the conversion of an ancillary flat to provide classroom space, demolition of an external stair block and erection of new stair block has been granted by Reigate and Banstead Borough Council (Ref: P/12/01658/F), subject to a number of conditions. Following consultation between Reigate and Banstead Borough Council and Surrey County Council (Reigate and Banstead Borough Council's advisers on archaeological issues), a condition (no. 4) was attached to the permission which stated that:

'No development shall take place until the applicant has secured the implementation of a programme of archaeological work in accordance with a Written Scheme of Investigation which has been submitted by the applicant and approved by the Planning Authority."

REASON: To ensure that the archaeological potential of the site is properly recognised and addressed having regard to Policies Pc8 of the Reigate and Banstead Borough Local Plan 2005.'

1.3.2 In accordance with this a *Written Scheme of Investigation* (WSI) was prepared by ASE (ASE 2013) and submitted to Reigate and Banstead Borough Council and to the Surrey County Council Archaeologist for approval prior to commencement of the work. The WSI outlined the methodology to be used in the field, in this case a watching brief, and in the reporting and archiving of the results (*ibid*.).

1.4 Aims and Objectives

1.4.1 The aims stated in the Written Scheme of Investigation (ibid.) were to:

'identify and record any archaeological remains uncovered during excavations associated with the new extension.

More specifically the aims of the investigation are:

To identify and record any evidence associated with the medieval priory and its post-Dissolution secular use.'

1.5 Scope of Report

1.5.1 The current report provides the results of the archaeological monitoring at the site carried out in September and October 2013. The on-site monitoring was undertaken by Giles Dawkes and Simon Stevens (Senior Archaeologists) and by Pip Stephenson (Archaeologist). The project was managed by Neil Griffin (Project Manager) and by Dan Swift (Post-Excavation Manager).

2.0 ARCHAEOLOGICAL BACKGROUND

2.1 Introduction

- 2.1.1 The Surrey County Council's (SCC) Historic Environment Record (HER) was consulted and a large number of entries within a 1km radius of the site were identified during the preparation of the WSI (*ibid.*). A table of entries is included as Appendix 1, and plotted on Figure 2. Listed buildings have been excluded. A summary by period is presented below.
- 2.1.2 The site lies within a Conservation Area, an Area of High Archaeological Potential and a Registered Park and Garden (Figure 1). The surviving historic structure of Reigate Priory to the south is designated as both a Grade I Listed Building (with elements dating back to the 13th century) and a Scheduled Monument, the boundary of which lies some 50m south of the site.

2.2 Prehistoric

- 2.2.1 Evidence of prehistoric activity in Reigate, and across the Weald is sparse. Some Mesolithic finds have been excavated in the town and finds from all the prehistoric periods have been found in surrounding areas. Environmental evidence suggests that the wider landscape of the Weald was wooded during this period and little evidence remains for Palaeolithic inhabitation of the area. The majority of finds recovered from the Weald are of Mesolithic date and suggest temporary, seasonal occupation possibly associated with hunter gatherer activity. Neolithic flint has also been discovered at the same sites as that of earlier Mesolithic material suggesting possible continuation of similar activities in similar locations.
- 2.2.2 The discovery of Neolithic polished stone axes and pollen evidence suggests woodland clearance with the beginnings of agriculture exploitation. This is continued into the Bronze Age with evidence of agriculture and hunter gathering activities occurring side by side.
- 2.2.3 A potential Bronze Age site on Park Hill, Reigate Park, c. 900m south of the site, was investigated by Oxford Archaeology in 2008, who undertook a detailed magnetometer survey where finds had previously been found (HER No. 14944). The OA survey identified a small number of anomalies that may be of archaeological origin; predominantly linear cut features possibly relating to enclosure boundaries, or in the case of the curvilinear features, structures such as roundhouses. A small number of broadly contemporary artefacts have been found within 1km of the site in addition to a Bronze Age pit in Bell Street.
- 2.2.4 The Iron Age is barely represented in the archaeological record of Reigate and comprises two coins, the precise find spot of one (a gold Gaulish coin) is not recorded.

2.3 Romano-British

2.3.1 Evidence for the Romano-British period in Surrey is confined to large settlements and villa sites and the route systems that link them. Specifically in Reigate, there is no evidence for a Roman Settlement within the parish

although a small quantity of Roman tile and pottery is recorded as being found at The Old Vicarage and a Roman pendant has been found within Priory Park.

2.4 Anglo-Saxon

- 2.4.1 There is little evidence from Reigate for activity during the Anglo-Saxon period, with the exception of the occasional find. The place name *Cherchefelle*, the name under which Reigate is first recorded in the Domesday Survey of 1086, means 'open space by the hill or barrow'. It has been suggested that the parish consisted of several isolated hamlets, with a church, St Mary Magdalene, east of the medieval centre. A solitary burial associated with a 7th century glass vessel is recorded at The Old Vicarage whilst Saxo-Norman structural remains are recorded at sites in Bell Street, High Street and West Street.
- 2.4.2 In the wider area, the Weald was largely covered by the great forest of Andredeswald. There is limited archaeological evidence for settlement in this period. It has been suggested that the lack of Anglo-Saxon sites in the Weald may be due to an inability to detect them. The majority of known Anglo-Saxon sites in this area are cemetery sites in places such as Leatherhead and Croydon.

2.5 Medieval and Post-Medieval

- 2.5.1 The name Reigate is not recorded in the Domesday Book, although it is believed that Cherchefelle was located there at that time. The manor was granted to William de Warenne when he was created Earl of Surrey in 1090. It was probably Warenne that started work on the castle, and by the late 12th- early 13th-century it had a bailey, becoming one of the main feudal castles of Surrey. It was around this time, in the late 12th century that the planned new town of Reigate, with characteristic long burgage plots was laid out by the lords of the castle, beneath the walls of their fortress.
- 2.5.2 The sixth Earl of Surrey, another William de Warenne, and his wife Isabel founded the Augustinian Priory at Reigate around 1240. Following the Act of Dissolution the Priory land and buildings were granted to Lord William Howard in 1541 whose niece, Catherine Howard, was Henry's VIII's fifth wife. Lord Howard set about demolishing a greater part of the buildings, including the monastic church, and transformed what remained into a mansion for his own use. This house was in turn almost entirely rebuilt or re-fronted in 1779. The estate passed through private hands until 1948 when it was acquired by Reigate Borough Council.
- 2.5.3 During the medieval period one main street, the High Street, ran east to west, south of the raised ground on which the castle stood, and north of the opposite ridge on the lower part of which was the priory. Bell Lane ran from the south to the eastern corner of High Street. Nutley Lane, now Pilgrim's way, ran north from the western end of High Street, up the hill, to join the old main road east and west on the chalk downs. The High Street retains its name and position; eastward it is continued as Church Street, westward as West Street. Bell Lane, High Street, and Nutley Lane, now the London road, were north and south lines, equally dominated by the castle.

2.5.4 The church of the original *Cherchefelle* stood south-eastward of the castle, on a sandy knoll not unlike that on which the castle stands. Apart from medieval remains at the Old Vicarage site excavated in the mid-1980s, there is no published evidence for medieval settlement outside of the current town centre. The town was granted a market before 1276. It had three medieval chapels, though little is known of their history.

2.5.5 Results of fieldwork to the south, east and west of the site have recently been summarised (Poulton 2012). Excavations *c*.50m to the south of the current site, immediately adjacent to the upstanding buildings of the school revealed masonry and burials associated with the Priory's main cloister (*ibid*. Figure 7). However, a reconstruction of the groundplan of the Priory buildings suggests the current work lies some distance to the north of the cloistral buildings (*ibid*. Figure 10). The current site lies adjacent to an extension to the main school buildings dating from 1895 (information from 'Heritage Statement' supplied by the client in support of the planning application).

3.0 ARCHAEOLOGICAL METHODOLOGY

- 3.1 A watching brief was maintained during all intrusive groundworks associated with the redevelopment work, namely the mechanical and manual excavation of foundations for the extension. This encompassed an area approximately 26.3m² (Figure 3). Monitoring visits were undertaken in September and October 2013.
- 3.2 All work was carried out in accordance with the WSI (ASE 2013) and the IfA standards and guidelines (2008)
- 3.3 All encountered archaeological deposits, features and finds were recorded to accepted professional standards using standard Archaeology South-East context record forms. Deposit colours were recorded by visual inspection and not by reference to a Munsell Colour chart.
- 3.4 A photographic record of the work was kept and forms part of the site archive which is currently held by Archaeology South-East at the offices in Portslade, and will be offered to a suitable local museum in due course, although at present Reigate Priory Museum is closed. 4.0 RESULTS

4.1 Monitoring of mechanical and manual excavations within the footprint of the extension revealed a deep but straightforward stratigraphic sequence. The entire area appears to have been heavily disturbed in the recent past resulting in deposits of made ground, which directly overlay the sandy clay natural. A total of seven contexts were recorded and these are tabulated below.

- 4.2 The natural (recorded as 1/004] and [2/004]) comprised sandy clay and was located approximately 1.40m below ground level. This was directly below a 0.50m thick deposit of brownish grey sandy silt made ground ([1/003] and [2/003]). This was overlain by 0.25-0.30m of mid-greyish brown sandy silt made ground ([1/002] and [2/002]) which contained modern debris as well as residual flintwork and medieval material. The sequence was sealed by 0.60m of dark brown silty topsoil [1/001].
- 4.3 No archaeological features or deposits were recorded.

5.0 THE FINDS

5.1 Introduction

5.1.1 A small assemblage of finds was recovered during the watching brief at Priory School, Reigate. An overview is shown in Table 3 below:

5.2 The Post-Roman Pottery by Luke Barber

5.2.1 The archaeological work recovered just two pieces of post-Roman pottery from the site. Context [1/002] produced a relatively large (17g) unabraded fragment from an Earlswood jug decorated with external white slip under a green glaze. A date between 1225 and 1300 is probable for this vessel. Context [2/002] produced a 5g, unabraded sherd from an 18th- century Chinese porcelain plate decorated with circumferential blue lines.

5.3 The Ceramic Building Material by Trista Clifford

- 5.3.1 A total of eleven fragments of roofing tile weighing 586g were recovered from two contexts. The fragments were examined microscopically at x20 and five different fabrics identified (Table 4).
- 5.3.2 Thickness varied between 10mm-16mm with a mode average of 12mm. Only one fragment from [2/002] exhibited a probable (circular?) peg hole. One piece from [1/002] appears to have been reused in some way, having a worn, 'polished' upper surface.
- 5.3.3 A date range of *c*.1250-1500 is probable for the assemblage as a whole. Large quantities of roof tile were recovered during previous excavations nearby (e.g. Jones 2012) of broadly the same date range, however comparison of fabric types was not possible due to a lack of published fabric descriptions.

5.4 The Glass by Elke Raemen

5.4.1 A single wine bottle base fragment was recovered from [1/002]. The piece is of mid 18th- to mid 19th-century date.

5.5 The Clay Tobacco Pipe by Elke Raemen

5.5.1 Context [1/001] contained a clay tobacco pipe (CTP) stem fragment. The piece is unmarked and undecorated and dates to c. 1660-1750.

5.6 Flintwork by Karine Le Hégarat

5.6.1 A single piece of struck flint weighing 13g was recovered during the watching brief at the site. The flake recovered from made ground context [1/002] displays heavy post depositional edge damage. It is made from a dark brown flint and is otherwise undiagnostic.

5.7 Overview

5.7.1 Finds recovered from Reigate Priory School include pottery, ceramic building material (CBM), clay tobacco pipe (CTP), glass and flintwork. Although artefacts provide dating evidence, the assemblage is too small to be of further potential and none of the artefacts are of intrinsic interest. The group is recommended for discard.

6.0 DISCUSSION AND CONCLUSIONS

- 6.1 No significant archaeological deposits were encountered during the monitoring of the groundworks. There was clear evidence of substantial earthmoving in the area in the recent past, probably associated with other building work at the site. This has led to considerable mixing of deposits, resulting in the wide date range of artefacts recovered from the overburden.
- 6.2 Unfortunately, the results of this archaeological works did not provide any further information about the character of the Augustinian Priory site, either during the medieval heyday or after the dissolution.






