Approximately 144m north-east of the site a find spot yielded an Iron Age ceramic jug (HER 29543). Additionally, 150m north of the site is the location of one of the Savage Engineering Works factories, in use from the 1870s (HER 13622).

1 INTRODUCTION

- 1.1 In September 2017 Archaeological Solutions Ltd (AS) carried out an archaeological monitoring and recording on land south of 16 North End Yard King's Lynn (NGR TF 6197 2063; Figs. 1 2). The monitoring and recording was commissioned in advance of a proposed residential development. It was carried out in fulfilment of a condition attached to planning approval for the construction of four dwellings (King's Lynn & West Norfolk Borough Council Ref. 14/01111/F).
- 1.2 The project was carried out in accordance with a generic brief issued by Norfolk County Council Historic Environment Service, and a specification compiled by AS (dated 23rd October 2014). It followed the procedures outlined in the Institute of Field Archaeologists' *Code of Conduct, Standard and Guidance for Archaeological Watching Brief* (2014). It also adhered to the

relevant sections of *Standards for Field Archaeology in the East of England* (Gurney 2003).

- 1.3 The principal objectives of the monitoring and recording were:
- To ensure the archaeological excavation and monitoring of all aspects of the development programme likely to affect buried archaeological remains.
- To secure the adequate recording of any archaeological remains revealed by the development programme.
- To secure the full analysis and interpretation of the site archive and the appropriate publication of the project results, if required.
- To secure the analysis, long term conservation and storage of the project archive.

Planning Policy Context

- 1.4 The National Planning Policy Framework (NPPF 2012) states that those parts of the historic environment that have significance because of their historic, archaeological, architectural or artistic interest are heritage assets. The NPPF aims to deliver sustainable development by ensuring that policies and decisions that concern the historic environment recognise that heritage assets are a non-renewable resource, take account of the wider social, cultural, economic and environmental benefits of heritage conservation, and recognise that intelligently managed change may sometimes be necessary if heritage assets are to be maintained for the long term. The NPPF requires applications to describe the significance of any heritage asset, including its setting that may be affected in proportion to the asset's importance and the potential impact of the proposal.
- 1.5 The NPPF aims to conserve England's heritage assets in a manner appropriate to their significance, with substantial harm to designated heritage assets (i.e. listed buildings, scheduled monuments) only permitted in exceptional circumstances when the public benefit of a proposal outweighs the conservation of the asset. The effect of proposals on non-designated heritage assets must be balanced against the scale of loss and significance of the asset, but non-designated heritage assets of demonstrably equivalent significance may be considered subject to the same policies as those that are designated. The NPPF states that opportunities to capture evidence from the historic environment, to record and advance the understanding of heritage assets and to make this publicly available is a requirement of development management. This opportunity should be taken in a manner proportionate to the significance of a heritage asset and to impact of the proposal, particularly where a heritage asset is to be lost.

2 DESCRIPTION OF THE SITE

2.1 The site is situated towards the north of central King's Lynn, on the northern side of John Kennedy Road, with Bentinck Dock c.300m to the

north-west. King's Lynn railway station is located *c*.660m south-east of the site. The A17 is found *c*.2.38 km south of the site, traveling roughly north-west/south-east, whilst the A149 is found some *c*.3.4km east of the site, traveling north-east/south west.

3 TOPOGRAPHY, GEOLOGY AND SOILS

3.1 The site is *c*.530m east of the channelised River Great Ouse, which flows into The Wash *c*.8.5km to the north. King's Lynn lies at approximately 5m AOD on the boundary between fenland in the west and low rolling chalk hills in the east. The soils of the area are unsurveyed, but the solid geology comprises the Ampthill and Kimmeridge clay formations.

4 ARCHAEOLOGICAL AND HISTORICAL BACKGROUND

- The earliest evidence for significant settlement within the immediate vicinity of the site is attributed to the Anglo-Saxon period, with scattered finds of pottery (HER 25906), and evidence for sea defences constructed during this period (HER 5486). However, it is not until the 12th century that a substantial occupation of the area takes place, when Herbert de Losinga founded St. Margaret's Church, and established a market in the area between the Purfleet and Millfleet. Later, in the mid 12th century, Bishop Turbe brought an expansion of the town north of the Purfleet with the construction of the Church of St. Nicholas and saw to the establishment of a second market in the town. By this point, King's Lynn had become a significant regional trading centre necessitating an upgrade of the town's existing sea defences and the construction of the town walls in the 13th/15th centuries (HER 5486). The success of the town attracted a number of religious houses, including the Dominican Friary in the 13th century (HER 1176), and later the Augustinian Friary in the 15th century (HER 1025). The prosperity of King's Lynn continued throughout the Middle Ages, and by the 18th century, along with Yarmouth, was one of the dominant grain handling ports in the country. By the 19th century however, sea trade had declined with both the Napoleonic wars and the construction of the railway, and the focus of the town shifted inland away from the river towards the railway and local industries such as the Savage Works, producing agricultural machinery in factories on Tower Street and London Road; with engineering and machinery production becoming the dominant local industry.
- 4.2 A number of important archaeological features are known within the immediate vicinity of the site, including the remains of a medieval bridge, identified c.60m south of the site (HER 40068), and in 2006 an archaeological evaluation c.75m south-east of the site identified remains of a medieval structure (HER 49124). Medieval stone mortar fragments have been recovered, along with post-medieval pottery sherds c.110m south-west of the site (HER 1151). Approximately 144m north-east of the site a find spot yielded an Iron Age ceramic jug (HER 29543). Additionally, 150m north of the

site is the location of one of the Savage Engineering Works factories, in use from the 1870s (HER 13622).

5 METHODOLOGY

- 5.1 The ground reduction and excavation of the foundation trenches associated with the construction of the dwellings was undertaken under close archaeological observation (Fig.2).
- 5.2 Exposed sections were cleaned and examined for archaeological features. Deposits were recorded using *pro forma* recording sheets, drawn to scale and photographed as appropriate. Open trenches and excavated spoil were manually/ visually searched and scanned by metal detector to enhance the recovery of archaeological finds.

Description: The remnants of a brick wall were visible and it truncated L1001 and L1002. M1004 was constructed using red frogged bricks, 220 x 110 x 70mm, and bonded with a pale yellow sandy mortar.

Excepting the brick wall no archaeological features or finds were present.

7 CONFIDENCE RATING

7.1 Within the parameters of the investigation it is not felt that any factors restricted the identification of archaeological features or finds.





Fig. 1 Site location plan


