# 3-13 SILVER STREET, ENFIELD EN1 3EF AN ARCHAEOLOGICAL EVALUATION

#### SUMMARY

In October 2010 Archaeological Solutions (AS) carried an archaeological evaluation at Nos. 3-13 Silver Street, Enfield, London (NGR TQ 32900 96610). The evaluation was funded by Elisabeth Homes UK Ltd and commissioned by Roy Welling Associates in compliance with a planning condition attached to planning permission for the construction of a new part-4 and part-5 storey building containing commercial units and 14 dwellings.

The site is located within the historic core of the town, within Enfield Town Archaeological Priority Zone. It had a potential for prehistoric, medieval and post-medieval archaeological remains.

*In the event the evaluation revealed remains of a*  $19^{th}$  *-*  $20^{th}$  *century basement and a wall.* 

### 1 INTRODUCTION

1.1 In October 2010 Archaeological Solutions (AS) carried an archaeological evaluation at Nos. 3-13 Silver Street, Enfield, London (NGR TQ 32900 96610; Figs. 1 & 2). The evaluation was funded by Elisabeth Homes UK Ltd and commissioned by Roy Welling Associates in compliance with a planning condition attached to planning permission for the construction of a new part-4 and part-5 storey building containing commercial units and 14 dwellings (London Borough of Enfield Planning Ref. TP/08/1733).

1.2 The evaluation was undertaken in accordance with an advice from English Heritage Greater London Archaeological Advisory Service (EH GLAAS) and a written scheme of investigation (specification) prepared by AS (dated 19/08/2010) and approved by EH GLAAS. The project adhered to EH GLAAS *Archaeological Guidance Papers* (AGPs, revised 1998), in particular *AGP No 3; Standards and Practices in Archaeological Fieldwork in London* and *No 5: Evaluations*. The project also conformed to the Institute for Archaeologists (IfA) *Code of Conduct* and *Standard and Guidance for Archaeological Field Evaluations* (revised 2001).

1.3 The evaluation aimed to determine the location, extent, date, character, condition, significance and quality of any surviving archaeological remains liable to be threatened by the proposed development. In particular, it aimed to establish the presence or absence of any remains relating to the prehistoric and medieval occupation. It was also important to understand the level of truncation on the site.

## Planning policy context

1.4 PPG16 (1990), the national Planning Policy Guidance Note which applies to archaeology and PPG15 (1994), the national Planning Policy Guidance Note which applies to conservation of the historic environment (by protecting the character and appearance of Conservation Areas and protecting listed buildings (of architectural or historical interest) from demolition and unsympathetic change and safeguarding their settings as far as is possible) have been replaced by Planning Policy Statement 5 (2010), the national Planning Policy Statement that applies to the historic environment

1.5 PPS5 states that those parts of the historic environment that have significance because of their historic, archaeological, architectural or artistic interest are heritage assets. The Planning Policy Statement aims to deliver sustainable development by ensuring that policies and decisions that concern the historic environment recognise that heritage assets are a non-renewable resource, take account of the wider social, cultural, economic and environmental benefits of heritage conservation, and recognise that intelligently managed change may sometimes be necessary if heritage assets are to be maintained for the long term. It aims to conserve England's heritage assets in a manner appropriate to their significance. It states that opportunities to capture evidence from the historic environment and to contribute to our knowledge and understanding of our past, and to make this publicly available, should be taken, particularly where a heritage asset is to be lost.

# 2 DESCRIPTION OF THE SITE

2.1 The site is located within the historic core of Enfield, close to the junction of Church Street/South Street and London Road/Silver Street (Fig. 1). It faces west on to Silver Street and east on to local road which leads from St Andrews Road to Churchbury Lane and provides rear access to the properties fronting Silver Street. The site comprises rectangular plot not occupied by any standing structures and until recently was used as a car park.

# 3 TOPOGRAPHY, GEOLOGY AND SOILS

3.1 Enfield lies on a gradual slope down to the River Lea which flows c.5km to the east of the site. The latter comprises relatively flat land at approximately 32m AOD. The New River, a man-made construction of the early 17<sup>th</sup> century, flows to the immediate east of the site parallel to Silver Street. Several other tributaries of the river Lea flow through the parish.

3.2 The solid geology of the environs is clay of Eocene Thames Group overlay by brickearth of Enfield Silt Formation, close to the edge of an outcrop of Taplow Gravels *c*. 40m to the west (British Geological Survey 1978). The site lies within urbanised area and the soil in the area remain unsurveyed; however, the soils to the north are of the Windsor association, described as

clayey soils mostly with brown subsoils over clay (Soil Survey of England and Wales 1983).

## 4 ARCHAEOLOGICAL AND HISTORICAL BACKGROUND

#### Prehistoric

4.1 A Palaeolithic flake (GLHER 80585) and handaxe (GLHER 380575) have been recorded nearby, and it is reported that a prehistoric arrowhead was found in 1836 (GLHER 82363). Further afield, an oval camp in Hadley Wood is believed to represent prehistoric settlement.

4.2 Excavations in 2005 off London Road, *c*. 100m south of the site, found multi-period remains including ditches containing lithic implements and charred grain (GLHER 98132). These finds were dated to the Mesolithic, or perhaps the early Neolithic era. The presence of cut ditches as well as charred grain may suggest the area was not simply a temporary camp or flint 'workshop'.

#### Romano-British

4.3 No Roman remains are recorded from the immediate vicinity with the exception of residual sherds of Roman pottery within medieval features found during excavations in 2005 off London Road (Section 4.2). Roman settlement remains were located much further south and south east, although Ermine Street to the east remains the main north-south route through the parish (Baker & Pugh 1976).

4.4 A Roman stone coffin was allegedly found but broken soon after its discovery at No.18, Wellington Road, *c*. 750m south-east of the site (GLHER 2817). Evidence of substantial Roman occupation was found at Lincoln Road to the north-east of the site during excavations in the 1970s, with material dating to the  $1^{st} - 4^{th}$  centuries. More recently, further evidence of Roman activity was recorded during the 1990s, particularly in the Leighton Road area *c*. 1.3km the south-east of the site.

### Medieval

4.5 Enfield is recorded in the Domesday Book of 1086 as *Enfelde*, held by Geoffrey de Mandeville. The place name derives from the word clearing or *feld*, most of the parish at this time having been covered in woodland. Settlement was concentrated along the main north-south routes through the parish; Ermine Street to the east and the slightly less important route further to the west that included Silver Street and Baker Street (Baker & Pugh 1976).

4.6 Medieval activity around the site is represented by the medieval church and market to the west (GLHER 222090, 81538, 80700). Medieval activity was also recorded during the 2005 evaluation off London Road, some 100m from the site. A market and fairs were granted in 1303 and houses overlooked the green to the south of the church by 1364. In the 15<sup>th</sup> and 16<sup>th</sup> centuries the area was settled by rich maltmen and by 1632 a market-place had been established. From the 16<sup>th</sup> century families were attracted to Enfield by its accessibility to London and large houses were built, although many of the large 16<sup>th</sup> and 17<sup>th</sup> century houses have since been demolished. It was a fashionable place of residence into the 18<sup>th</sup> century and noted for the handsome houses in Enfield Town and the roads to the north (Baker & Pugh 1976). This is reflected in the many listed buildings around the site along Silver Street, Chase Side and Gentleman's Row (GLHER).

### Post-medieval & modern

4.7 Enfield saw much suburban development after the introduction of the railway in 1840. A station was opened at Enfield Town in 1849, prompting the development of Enfield New Town (Raleigh Road, Essex Road, Sydney Road and Cecil Road). Further development followed around Lancaster Road to the north in the 1870s, Windmill Hill to the west in the 1870's-80s, and on the Willow Estate to the east in the 1930s (Area History 7, 1989). Enfield joined Edmonton in 1965 to form the London Borough of Enfield (Baker & Pugh 1976).

## 5 METHODOLOGY

5.1 Two trenches were excavated using a mechanical 180° excavator fitted with a toothless ditching bucket (Fig. 2). The location of Trench 1 was modified to avoid a modern drainage channel running across the site. Trench 2 was located close to the street frontage, as advised by EH GLAAS.

5.2 Tarmac and undifferentiated overburden were mechanically excavated under close archaeological supervision. Exposed surfaces were cleaned by hand and examined for archaeological features. Deposits were recorded using *pro forma* recording sheets, drawn to scale, and photographed as appropriate. Excavated spoil was searched for finds and the trenches were scanned by a metal detector.

*Description:* No archaeological remains or finds were revealed. Trench 1 contained a modern drainage inspection chamber with service pipes.

*Description:* The remains of what were probably a basement and a wall were present within the trench.

M1008 was a wall (0.48 x 0.60m) present in the southern end of the trench (DP 8). It was heavily truncated and was recorded in the eastern section of the trench. The wall was constructed of red and some yellow bricks (0.225 x 0.105 x 0.065m) bonded with creamy mortar. The wall was likely of  $19^{th}$  – early  $20^{th}$  century date.

M1009 (5.50 x 1.25 x 0.90m+) was likely a basement wall associated with a building located on the street frontage (DP 7). The basement was rectangular in plan and was roughly parallel to Silver Street. M1009 was constructed of just red bricks (0.225 x 0.105 x 0.063m) bonded with creamy, slightly yellowish mortar and covered with white paint. The basement was backfilled with L1010, a fairly recent, loose, deposit of CBM rubble and debris. The basement may have been of late  $19^{th}$  – early  $20^{th}$  century date.

## 7 CONFIDENCE RATING

7.1 It is not felt that any factors inhibited the recognition of archaeological features or finds.

## 8 DEPOSIT MODEL

8.1 The site was commonly overlain by modern Tarmac L1000, a dark, blackish grey, compact deposit (0.12 - 0.16m thick). It overlay layers containing large amounts of compact CBM rubble (L1001 and L1004), probably levelling layers. The most substantial deposit encountered during the evaluation was L1002, a thick (0.50 - 0.85m) layer of light to mid brown, friable, clayey silt with gravel and occasional CBM fragments.

8.2 The natural geology was present at 0.80 – 1.15m below the existing ground level and comprised a reddish dark yellow, loose, sandy gravel.

### 9 DISCUSSION

9.1 The site had a potential for archaeological remains, in particular for prehistoric, medieval and post-medieval archaeology. Mesolithic/Neolithic remains have been found in the vicinity of the site, and medieval and post-medieval remains associated with the historic core of Enfield within which the site is located were anticipated.

9.2 In the event the only archaeological features revealed were relatively late building remains of  $19^{th}$  – early  $20^{th}$  century origin. The site was subject to a degree of modern truncation including numerous drains, sewerage and power lines, however earlier deposits were intact indicating surprisingly limited previous development of the site.

### 10 DEPOSITION OF THE ARCHIVE

10.1 Archive records, with an inventory, will be deposited with any donated finds from the site at London Archaeological Archives and Resource Centre (LAARC). The archive will be quantified, ordered, indexed, cross-referenced and checked for internal consistency.












Archaeological Solutions Ltd Fig. 2 Detailed site location plan Scale 1:1000 at A4
