#### Introduction

This report documents the results of an archaeological watching brief carried out at High Beeches, Gatton Bottom, Reigate, Surrey RH2 0TU (Fig. 1). The project was commissioned by Mr Joshua Glynn of Ascot Design Ltd, Berkshire House, 39-51 High Street, Ascot, Berkshire SL5 7HY on behalf of Mr Wang Liu, High Beeches, Gatton Bottom, Reigate, Surrey RH2 0TU.

Planning permission (18/01995/F), has been granted by the Borough of Reigate and Banstead for the construction of a new house following demolition of the existing structure. Due to the potential disturbance of below ground archaeological remains by these works, the consent is subject to condition 7 relating to garden archaeology and an archaeological watching brief is to be maintained during the relevant period of the groundworks. This is in accordance with the Department for Communities and Local Government's *National Planning Policy Framework* (NPPF 2012) and the Council's policies on archaeology. The field investigation was carried out to a specification approved by Mr Nick Truckle, Archaeological Officer for Surrey County Council, advisers to the District on matters relating to archaeology. The fieldwork was undertaken by Andy Taylor and Jon Tierney on 22nd and 23rd January 2021 and the site code is GBE 18/96.

The archive is presently held at Thames Valley Archaeological Services, Reading and will be deposited with an appropriate local repository in due course.

#### Location, topography and geology

The site is located beyond the north-western extent of the village of Gatton, approximately 4km north of Reigate and south of the M25 within the Surrey Hills Area of Outstanding Natural Beauty and Grade II registered Lower Gatton Park. It comprises a rectangular parcel of land covering an area of *c*. 1.9ha previously occupied by a detached dwelling and long drive. The site is bounded by Tower Wood to the north, south and west and a playing field to the east. The underlying geology is recorded as Lower Chalk (BGS 1978). The site lies at the top of a hill at approximately 150m above Ordnance Datum, sloping down on all sides to the just *c*. 130m above Ordnance Datum in the north (the access from Gatton Bottom) and south extremes of the site.

#### Archaeological background

The archaeological potential of the site has been highlighted in a desk-based assessment (Baljkas 2018). In summary, this potential stems from its location within the Grade II registered park. Whilst construction of the replacement building is not considered to have any significant archaeological implications, there is a possibility of encountering of old garden features associated with earlier phases of the parks use.

Gatton Park and Pleasure Grounds was purchased in 1751 by Sir James Colebrooke from William Newland. Sir George Colebrooke inherited the site from his brother in 1761 and it was he who commissioned Capability Brown between 1762-8 and again at times in the 1770s, to improve the park.

#### **Objectives and methodology**

The purpose of the watching brief was to excavate and record any archaeological deposits including garden features affected by the groundworks. This would involve the monitoring of areas of intrusive groundworks and the excavation of foundation and service trenches. Any other deeply invasive groundworks would be monitored as necessary.

#### Results

The groundworks monitored comprised two components: creation of an access road and removal of the existing building.

#### The access road (Pl. 4)

The access road involved only superficial removal of turf/overburden and no deposits of archaeological or garden interest were revealed.

#### The demolition zone and ground reduction area (Figs 3 and 4; Pls 1-3)

The area covering the floor plan for the replacement building was stripped of overburden and demolition debris initially to expose the top of the natural geology (Fig. 3, Pl. 3). The stratigraphy observed typically consisted of 0.6m of 20th-century made ground (chalk, clay and brick rubble) overlying natural chalk with flint nodules geology. This revealed no deposits of archaeological or garden archaeology interest but some areas of disturbance and remnant footings from the previous structure were noted.

The stripped area was eventually levelled with the natural geology being reduced to a depth of up to c. 1.50m (Pls 1 and 2).

#### Finds

All finds encountered were modern and of no archaeological interest.

#### Conclusion

Despite some potential for archaeological remains, in particular garden features relating to the original historic

park, to be present on this site, and despite an area strip exposing the natural geology, no deposits nor finds of

any archaeological interest were observed during the course of the watching brief.






