Planning application 13/01453/FUL for a single-storey extension over an existing flat-roofed extension on the west side of 97A High Street, Bedford, and a two-storey extension with porch on the east side, was submitted to Bedford Borough Council in July 2013.

As the proposed development lies within an area of archaeological sensitivity, the Historic Environment Team (HET) of Bedford Borough Council recommended that a condition was attached to any planning consent requiring the implementation of an archaeological mitigation scheme.

The application was subsequently granted planning permission in September 2013 with an archaeological condition attached – Condition 6.

The Bedford Borough Historic Environment Record (HER) shows that the development site is located in an area of archaeological interest, within the core of the Saxon burh and medieval town at Bedford (BBHER 10530).

However, no features of archaeological significance were revealed during the groundworks.

Features visible along the north side of the trench appeared to be post-medieval in date and may be the remains of rubbish pits. However, they were not revealed to a sufficient extent to accurately determine their form or function.

The alignment of the previous building foundations and the recent excavations made interpretation of the partially visible deposits problematic. However, the presence of subsoil in places, above the relatively undisturbed gravel terrace, suggests that if archaeological features were present in the immediate vicinity, they could be relatively well preserved.

#### 1 INTRODUCTION

#### 1.1 Project Background

Planning application 13/01453/FUL for a single-storey extension over an existing flat-roofed extension on the west side of 97A High Street, Bedford, and a two-storey extension with porch on the east side, was submitted to Bedford Borough Council in July 2013.

As the proposed development lies within an area of archaeological sensitivity, the Historic Environment Team (HET) of Bedford Borough Council recommended that a condition was attached to any planning consent requiring the implementation of an archaeological mitigation scheme. This advice was in accordance with *National Planning Policy Framework – Section 12: Conserving and enhancing the historic environment*<sup>1</sup>.

The application was subsequently granted planning permission in September 2013 with an archaeological condition attached – Condition 6.

The HET issued a brief detailing the requirements of the archaeological mitigation scheme at the site (BBC 2013), which was to comprise observation of construction groundworks and the investigation, recording, analysis and publication of any revealed archaeological remains.

# 1.2 Site Location and Description

The development site is located within a block of properties on the east side of the High Street between Mill Street to the south, Lurke Street to the north, and Howard Street to the east (NGR 505064 249938).

Number 97A is located at the rear of property number 97 which fronts onto the High Street. It is bounded to the north and east by a car park and to the south by the garden of the adjacent property.

The site lies at approximately 31m OD and the underlying drift geology is typically sands and gravels of the Stoke Goldington Member (Second Terrace) of the Ouse Valley Formation.

#### 1.3 Archaeological Background

The Bedford Borough Historic Environment Record (HER) shows that the development site is located in an area of archaeological interest, within the core of the Saxon *burh* and medieval town at Bedford (BBHER 10530).

Numerous small-scale archaeological investigations undertaken in the first half of the 20th century in the High Street, Silver Street, and St Peter's Street have identified evidence of occupation in the area from the Saxon period onwards (BBHER300 etc.).

Various subsequent ground investigations undertaken from the 1980s onwards all within *c*. 50–150m of the development site have confirmed the potential of the area to contain features and artefacts of Saxon and medieval date (BBHERs 14378, 14819, 16099, 16107 etc.).

#### 1.4 Project Objectives

The objective of the archaeological fieldwork was to monitor and supervise all groundworks associated with the construction of the new dwelling that had the potential to reveal archaeological remains, and to investigate, characterise and record any archaeological deposits encountered within them.

The opportunities to address research themes identified in the local and regional research frameworks (Medlycott 2011, Oake *et al* 2007) during the project were limited due to the nature of the development groundworks. However, the specific research aims were:

- Identifying the nature of Saxon/medieval and later occupation of the area:
- Clarifying the chronology of Saxon/medieval and later occupation of the area:
- Identifying Saxon/medieval and later industrial/manufacturing activities in the area.



#### 2 METHODOLOGY

Archaeological observation of the groundworks took place between 24th and 27th June 2014. Groundworks monitored included excavation of the foundations of the dwelling and a reduction in level to the construction area.

Deposits encountered were investigated and recorded in accordance with Albion's *Procedures Manual*. Spoil heaps were checked on a regular basis for artefacts recovery.

# 3 RESULTS AND CONCLUSIONS

# 3.1 Description of Groundworks

Groundworks comprised a foundation trench for the new dwelling and ground reduction within the new building footprint (see Figure 2). The ground within the building footprint was reduced by 0.5m; this was not sufficiently deep to expose archaeological deposits. The foundation trench was 0.5m wide and reached a depth of c.1.1m exposing the underlying terrace geology.

#### 3.2 Overburden and Undisturbed Geological Deposits

Topsoil (100) consisted of a dark brown-grey sandy garden soil c. 0.25m thick. Underlying this, the remains of previous foundations (101) were visible up to a depth of c.1m in places. Where undisturbed by foundations, subsoil (102), up to 0.40m thick and consisting of mid brown silty sand, was present.

The underlying geology (103) was a loose mid orange sandy gravel. It was present at a depth of c.1m.

#### 3.3 Post-medieval Disturbance

Excavation of the foundation trench revealed previous brick and concrete foundations on almost exactly the same alignment. They are likely to represent the remains of outhouses associated with 97 High Street and are probably Victorian in date. They were almost entirely removed to make way for the new foundations.

The north side of the foundation trench revealed a dark grey silty deposit containing occasional brick rubble (105). The Victorian foundations on this side of the site appeared to be cut into this deposit. This may represent the remains of earlier post-medieval rubbish pitting as the deposit appears to be contained within a number of features [104] partially visible along the northern foundation trench (Figure 2).



#### 4 CONCLUSIONS

No features of archaeological significance were revealed during the groundworks.

Features visible along the north side of the trench appeared to be postmedieval in date and may be the remains of rubbish pits. However, they were not revealed to a sufficient extent to accurately determine their form or function.

The alignment of the previous building foundations and the recent excavations made interpretation of the partially visible deposits problematic. However, the depth of overburden and the presence of subsoil in places suggest that, if archaeological features were present in the immediate vicinity, they could be relatively well preserved.










Figure 1: Site location plan
