Summary

This report presents the results of an archaeological watching brief carried out by MOLA at 64 Murray Road. The site lies approximately a kilometre east of the centre of Wimbledon Village, and 300m south-east of Rushmore Pond. The report was commissioned from MOLA by C Aitken (Builders) Ltd on behalf of the client Jon Steer and his agent Holden Harper.

In accordance with the Written Scheme of Investigation (MOLA 2013) a watching brief was carried out on the site between 19th and 21st May 2014.

Natural strata in the form of banded gravels and sands was recorded in the east of the site at 53.77 mOD. This was overlaid by a 20th-century deposit, probably associated with the most recent buildings construction. This in turn was overlaid by a garden soil from the latter half of the 20th-century.

1 Introduction

1.1 Site background




Fig 1 Site location

- 1.1.1 An archaeological watching brief was carried out by MOLA at 64 Murray Road, Wimbledon, London SW19 4PE ('the site') between 19th and 21st May 2014 (see Fig 1). This document is the Report on that work.
- 1.1.2 Further to the condition on Planning Consent a *Written Scheme of Investigation* was prepared by MOLA (MOLA 2013).

1.2 Planning background

- 1.2.1 The legislative and planning framework in which the watching brief took place was fully set out in the *Written Scheme of Investigation* which formed the project design for the watching brief (see Section 1.2, MOLA 2013). To summarise here:
- 1.2.2 The watching brief was carried out to fulfil a condition attached to the Planning Consent given by Merton Local Authority (Consent reference 13/P0618; Condition Number 22.

1.3 Scope of the watching brief

- 1.3.1 An archaeological watching brief is normally a limited fieldwork exercise. It is not the same as full excavation, though individual features may be fully excavated.




Fig 2 64 Murray Road basement footprint

- 1.3.2 The watching brief was limited to the footprint of the proposed new basement (See Fig 2).
- 1.3.3 The watching brief was carried out within the terms of the relevant Standard for watching brief specified by the Institute for Archaeologists (IFA, 2008).
- 1.3.4 All work has been undertaken within the research priorities established in the Museum of London's *A research framework for London Archaeology*, 2002.
- 1.3.5 All work was undertaken within research aims and objectives established in the *Written Scheme of Investigation* for the watching brief (Section 2)

2 Topographical and historical background

2.1 Topography

2.1.1 The topography drops off significantly to the south and east of the site, into the valley created by the River Wandle, near the centre of Wimbledon Village. The site is located near the top of the northern side

of this valley. Natural strata in the immediate area consists of banded coarse gravels and sands.

2.2 Archaeology

2.2.1 The potential archaeological interest on the site is for prehistoric activity, and the proximity of the site to the medieval village at Wimbledon Common. Wimbledon Lodge or Murray House of 1797 was located to the south on The Ridgeway.

3 The watching brief

3.1 Field methodology

- 3.1.1 The /turf and basement slab was broken out and cleared by contractors prior to MOLA supervision. The basement area was entirely excavated by machine (initially by 20 tonner, then 2) by the contractors, and monitored by a member of staff from MOLA. Due to restrictions caused by the steel supports, the northern most end was excavated first, down to 2.5m below ground level, with clearance continuing south. The lowest deposits were then removed by the smaller 2 tonne machine.
- 3.1.2 Archaeological excavation of features was carried out in accordance with the *Written Scheme of Investigation* (MOLA 2013).
- 3.1.3 The building's outline and archaeological features were plotted on plans provided by the client using an 'offset methodology' and subsequently tied to the OS grid by MOLA Geomatics.

3.2 Recording methodology

3.2.1 A written and drawn record of all archaeological deposits encountered was carried out in accordance with the *Written Scheme of Investigation* (MOLA 2013).






Fig 3 North-east facing section (see fig 2 for location)

4.1.1 Fine grey orange gravelly sand was recorded at 53.15m OD, overlaid by sandy gravels at a maximum height of 53.82m OD in the western corner of the site (Fig 3). This natural strata sloped significantly down from the west to east. A dark grey brown sandy silt 0.3m thick at 54.07m OD sealed these deposits with inclusions of ceramic building material and charcoal. This deposit is likely mid-20th-century in date as a single piece of tin foil was retrieved from the section. This was overlain at 54.07 mOD by a mid brown silty sand, probably a reasonably recent garden soil horizon (perhaps contemporary with the most recent buildings construction ie c1970). Made ground sealed these deposits to 54.57m OD.

5.1.1 No significant archaeological remains survived in the location of 64 Murray Road

- 6.1.3 In view of the very limited potential of the material (Sections 5) and the limited significance of the data (Section 5.1) it is suggested that no further publication is required.
