AN ARCHAEOLOGICAL WATCHING BRIEF DURING GROUNDWORKS ON LAND AT SOMERBY HOUSE FARM 8 CHURCH LANE, SOMERBY LEICESTERSHIRE SEPTEMBER – OCTOBER 2012

Abstract

An archaeological watching brief was undertaken by Northamptonshire Archaeology during groundworks associated with the construction of a new extension on land at Somerby House Farm, 8 Church Lane, Somerby, Leicestershire. Modern deposits were recorded throughout the investigation area. No archaeological deposits or artefacts were present

1 INTRODUCTION


An archaeological watching brief was undertaken between September and October 2012 during groundworks for a new extension on land at Somerby House Farm, 8 Church Lane, Somerby, Leicestershire, (NGR SK 7787 1047: Figs 1, 2 and 3). The work was undertaken by Northamptonshire Archaeology on behalf of Ross Thain & Co Ltd acting on behalf of their clients Mr and Mrs S Scrivens following a request for an archaeological watching brief by the Senior Planning Archaeologist, Leicestershire County Council in a brief for archaeological attendance issued on the 9 March 2011 (LCC 2011). The work was carried out following the procedural document MoRPHE issued by English Heritage (EH 2006) and the appropriate national standards and guidelines, as recommended by the Institute for Archaeologists (IfA 2008).

2 BACKGROUND

2.1 Location and topography

The investigation area is located on the west side of Somerby House Farm within the village of Somerby approximately 11km to the west of Oakham. It is bounded to the east by Church Lane and Manor Lane to the west and is located on relatively level ground at an approximate height of 180m aOD.

The underlying geology has been mapped by the British Geological Survey of Great Britain as comprising Lias Group mudstone, siltston, limestone and sandstone overlain by glacial till (BGS Geoindex <u>http://www.bgs.ac.uk/geoindex</u>).

2.2 Historical background

The investigation area lies within the village of Somerby in an area of archaeological interest. The village is mentioned in the Domesday Book of 1086AD where it is recorded as *Sumerdeberie*.

Close by to the east is located the parish church of All Saints, a Grade I listed Building (English Heritage Ref: 189895), the earliest parts of which date from the 12th century, with later additions and subsequent restorations between 1714 and 1865. Somerby House a Grade II Listed Building (Ref: 189894) lies further to the east.

Somerby House Farm is a Grade II Listed Building (189875) dating from the early 18th century with later additions in the 19th and 20th centuries. The investigation area lies on the west side of the farmhouse, lying mostly within the footprint of a former stable/garage recently demolished.

Previous archaeological work recorded as having been carried out within the site has comprised a building recording survey of outbuildings undertaken as part of the current application (Bassir 2012).

3 OBJECTIVES AND METHODOLOGY

The aims of the programme of archaeological observation were to:

- Observe the groundworks undertaken for the new extension and to record all archaeological deposits uncovered;
- Determine the date, character, state of preservation and depth of any archaeological deposits observed and to retrieve all datable artefacts;
- Create a permanent archive and record of the archaeological information collected during the course of the fieldwork and analysis.

The fieldwork comprised visits to the site during the excavation of foundation trenches for the new extension. The groundworks were carried out using a 360° mini excavator fitted with a combination of toothed and toothless buckets. The investigation area lies within the footprint of a former stable/garage now demolished, lying adjacent to the main farmhouse.

A photographic record in both black and white negative and colour slide was kept, with supplementary photographs in digital format. The written record used Northamptonshire Archaeology pro-forma sheets. The watching brief was carried out in accordance with the *Standards and Guidance for an archaeological watching brief* (IfA 2008).

4 THE RECORDED EVIDENCE

The foundation trenches measured 0.70m wide and were excavated to a maximum depth of 2.0m. (Figs 2 and 5).

The natural substratum was encountered at a depth of approximately 0.30m below present ground level and comprised orange-brown fragmented ironstone. This was overlain by modern overburden comprising crushed fragments of modern ceramic building material and concrete within a matrix of grey-brown sandy loam up to 0.30m thick.

In the eastern half of the foundation trench and adjacent to the western gable end of the house, a modern water tank, of red-brick construction bonded with a grey Portland cement was exposed (Figs 2 and 6) along with a number of modern service runs.

No archaeological deposits or artefacts were present.

6 CONCLUSIONS

A truncated natural substratum was recorded throughout the investigation area. Modern ceramic building material was present associated with the former stable/garage building which had stood upon the site in recent times.

Tha lack of any artefactual evidence would suggest that no significant archaeological deposits are present in close proximity of the investigation area.

The watching brief was carried out in favourable circumstances and the results are considered to be reliable.
