Introduction

- 1. This Data Structure Report has been prepared for William Waugh & Sons (Builders) Ltd, on behalf of their client, in support of the demolition of an existing extension and the erection of a new larger extension at 32 Main Street, New Abbey, Dumfries and Galloway. The existing grounds are located within the old precinct boundaries of Sweetheart Abbey, Dumfries and Galloway (Canmore ID: 65454). The archaeological works were designed to mitigate any adverse impact on the archaeological remains within their development area.
- 2. The new extension works are located within the scheduled area of the precinct of Sweetheart Abbey, protected under the terms of Ancient Monuments and Archaeological Areas Act 1979. Any disruptive works in this area are subject to Scheduled Monument Consent issued by Historic Scotland on behalf of Scottish ministers (AMH/90293/1/1 dated January 2013).
- 3. Rathmell Archaeology has been appointed by William Waugh & Sons (Builders) Ltd to undertake the development and implementation of archaeological mitigation works in compliance with Condition 2 of the above noted Scheduled Monument Consent.
- 4. The Data Structure Report is structured to meet the advice of Historic Scotland who are the trustees of Sweetheart Abbey. Rathmell Archaeology Limited was appointed by William Waugh & Sons (Builders) Ltd to undertake the development and implementation of archaeological works during the development.

Archaeological and Historical Background




Figure 1a: 6 Inch 1st Edition Ordnance Survey: Kirkcudbrightshire, Sheet 34, Surveyed 1850, Published 1854.

5. The site at 32 Main Street, New Abbey sits on the northern side of the main road through New Abbey village. The earliest depiction of this road is in 1797 (Ainslie, 1797). The course of the road suggests that it was originally a route which serviced the abbey whilst also servicing the mill (Canmore ID: 68555) to the west of the abbey. The progression towards the current layout of the area may be seen on the superseded Ordnance Surveys (Figure 1a and 1b). The present road may then, overly previous roadways, surfaces and features which may be contemporary to those structures.

Sweetheart Abbey

- 6. Sweetheart Abbey and its precinct are a Scheduled Monument (Index No. 90293) protected under the terms of the Ancient Monuments and Archaeological Areas Act 1979. The scheduled area comprises the precinct and remains of the Cistercian Abbey of Sweetheart, or New Abbey, founded as a daughter house of Dundrennan Abbey by Devorgilla Balliol in 1273. The scheduled area is based on the area of the abbey precinct and is defined mainly by the precinct walls.
- 7. Sweetheart Abbey was built at the behest of Lady Devorgilla Balliol of Galloway to commemorate her husband John who died in 1268. In 1289 her body was laid to rest before the high altar and her husband's embalmed heart was placed aside her remains. The monks of the abbey subsequently chose the name *Dulce Cor* or 'Sweetheart' for the abbey in her memory, to create a 'shrine to human and divine love' (Richardson, 1938, 2).
- 8. King John Balliol of Scotland was the son of Lady Devorgilla and John Balliol. In 1296 he was 'stripped of his regalia' by the English King, Edward I. King John Balliol, stripped of his fur-surcoat, one of the symbols of his wealth and station was thenceforth known as 'Toom Tabard'. In the same year, John, the first abbot of Sweetheart Abbey, paid allegiance to the Edward I of England and the abbey was thereby used as a waypoint for future military incursions into Scotland.
- 9. The wars with England eventually impoverished the abbey and by 1352 many of the abbey buildings were in a ruinous condition. The Balliols had made forfeiture to England leaving the abbey without a patron. However, David II returned from captivity in England in 1352 and found a new patron: Archibald Douglas, known as Archibald the Grim from his infamous ferocity in fighting the English. He made two grants to the abbey in 1381

and in 1385 which aided the renovation of the abbey precinct.

- 10. During the Reformation in 1561 the monks of the abbey were protected by the local magnate, Lord Maxwell. In 1560, Maxwell was ordered to destroy the abbey buildings by the Lords of Congregation. Lord Maxwell refused and the Maxwells continued to support the tenants of the abbey until 1587. The Annexation Act resulted in the abbey coming under Crown property and the tenants were evicted as a result, many going into exile abroad.
- 11. The last Abbot of Sweetheart, Abbot Gilbert Broun returned to the abbey in 1603 after his initial displacement. He was arrested and imprisoned before being released again. In 1608 he returned once again to the abbey and was eventually allowed to reside at Sweetheart due to his ailing health, but without the official powers of an Abbot. He was determined to preach the Catholic faith and was thus eventually removed in 1608 after a raid on his lodgings revealed a stash of Catholic paraphernalia. He was released again and went to France into exile, where he eventually died in 1612.
- 12. Sweetheart Abbey was well preserved up to this point and may have continued further had it not been the loss of the denizens of the abbey itself who maintained the fabric of many of the buildings, which are now largely inexistent. Once secularised the abbey became a perfect source of stone for the growing village. In 1779 a group of concerned villagers decided to intervene, having witnessed the rapid despoliation of the abbey stonework. Their actions contributed to the well-preserved remains of the church that exist today.
- 13. A new church was erected in 1731 against the south wall of the nave and was eventually demolished in 1877. In 1928 the ruin was entrusted into state care.
- 14. There is no definitive typical layout for what would be present to the south of the main abbey buildings within this type of precinct, and therefore what may have stood in the area that is to be affected by the development remains uncertain. There are however a number of possibilities based on the types of activity and structures which would have originally comprised part of an abbey estate. These could include structures relating to industrial activities, such as granaries, woolhouses or brewhouses, as well as the possibility of uncovering earlier roadways, drains and surfaces which would have surrounded such structures. Thanks to the actions of Lord Maxwell and subsequent trustees, the abbey structures may survive quite well to this day.
- 15. The precinct itself has the potential to contain evidence relating to the outer claustral ranges and the domestic and store buildings essential to the life of the monastic community. The well-preserved precinct wall stands up to 2m high around all but the southern sides where the precinct may have been delineated by a ditch or by the mill lade. Aerial photographs have shown structures to exist in the southern portion of the precinct land which may relate to the abbeys drainage system.
- 16. The location of the ground works may lie in what used to be the open abbey grounds, which would suggest that any pre-existing archaeology may survive at this location where the ground has remained relatively undisturbed, even during the medieval period. There remains, then, a possibility of encountering features of a pre-historic date at this location.




Figure 2: Site plan showing location of ground works

Project Works

- 17. The grounds of 32 Main Street, New Abbey, excluding the present residential house, are located within the old precinct of Sweetheart Abbey and therefore comprise a Scheduled Ancient Monument. The archaeological potential of the ground remains quite high with its proximity to the present abbey structures. Archaeological monitoring was carried out from the 12th August 2013 to 14th August and on the 15th of November 2013
- 18. The proposed ground works at 32 Main Street, New Abbey comprise an area of 11.78m² metres along the western elevation of the existing residential house and an area of 6.6m² extending south from the new extension footprint. The works running south from the new foundations are the emplacement of a new oil tank and one inclusive trench for the new oil line and water pipe that will service the house (Figure 2).
- 19. All works were conducted and undertaken according to the terms of the Written Scheme of Investigation (Rees 2013) and complied with Code of Conduct Historic Scotland Policy Statements and the Dumfries and Galloway Council Archaeology Service's Standard Conditions, the Institute for Archaeologists' Standards and Policy Statements.

Findings

- 20. The majority of the work was carried out between 12th and the 14th of August 2013. The previous extension was reduced to ground level before digging commenced. The foundations trench for the new extension was completed using a mini-digger with a flatedged 700mm wide bucket and had dimensions of 700mm by 1.6m by 4.5m by 6m by 3.7m in plan view and was 450mm deep (Figure 2). The trench formed an outline of the footprint of the new extension leaving an island of material in-situ at the centre which measured 2.25m by 4.8m by 450mm deep. The first and last metre of the trench was dug by hand: along the northern elevation of the house against the brick founds and along the western elevation where the water drainage pipe was to be replaced. Along the northern extents of this trench the foot paving [002] was partially removed leaving sandy foundations (006) 100mm thick, above garden topsoil (003). The natural gravel subsoil (005) was encountered at a depth of 450mm along the trench under this (003) topsoil.
- 21. The foundations of the previous extension [007] were pecked out and removed along the western leg of the outline trench; to a depth of 450mm also reaching subsoil (005) (Figure 3b). The trench skirted the southern extents of foot paving [004], which had also been partially removed prior to monitored works. Surface [004] measured 3.5m by 3.5m by 200-250mm deep (including dry cement and foundation stones).
- 22. A second trench was hand-dug over the existing drainage pipe to expose it for renewal. This trench measured 6 metres long from the southern leg of the outline trench, by 250-500mm wide by 250-300mm deep, running north beyond the outline trench, into a box trench in [004] which formed a new manhole. The manhole was hand-dug and was situated within [004] foot paved area measuring 500mm by 500mm by 450mm deep cutting through (003) and reaching to (005) subsoil at 450mm.
- 23. Running south of the outline foundation trench over the present driveway (001), a trench for a new oil line and the new water pipe (replacing a copper pipe) was dug (Figure 3a). It was completed using a mini-digger using a flat-edged bucket and measured 220mm wide by 450-500mm deep by approximately 35m long. The gravel (001) was removed, followed by the topsoil (003) down to subsoil (005) at 450mm depth.
- 24. The oil tank base was emplaced in the front garden (Figure 4b) (southern side of site), using a 700mm wide flat-edged bucket and measured 2.4m by 2.6m by 200-300mm deep. The garden was overgrown and the initial deposits were humic topsoil (003), 100mm thick over (001) gravel at a thickness of 100mm. The subsequent topsoil (003) was removed to an average depth of 100mm. The overgrowth then, concealed modern surfacing of this area and the topsoil (003) was reduced to about 100mm below gravel (001).
- 25. The tank base was connected to the oil line and water trench (Figure 4a) with a 220mm

by 250mm by 2 metre long trench through the garden into the driveway. This was made through humic layers encountering (001) gravels and again only removed 100-200mm of the (003) topsoil deposit, deepening until it met the water trench at 450mm in the driveway.

- 26. Topsoil (003) comprised homogenous dark grey and black humic silt found at a consistent thickness of 420-450mm across the site. (003) contained modern glass, white glazed ceramic, occasional fragments of red brick and some animal bone <001>. The animal bone is likely of modern provenance, possibly the remains of a domestic pet burial.
- 27. The extension of the trench for the new water pipe was completed on the 15th of November 2013. This involved the excavation of a trench from the end of the driveway out onto the pavement of Main Street and then along the pavement to connect with the existing water main. This involved digging an L-shaped trench approximately 5m from the driveway to the centre of the pavement and then 4.5m along the pavement to the existing water main (Figure 5a). The trench was typically no more than 400mm wide and 700mm deep. A deeper section, 900mm, was excavated in the centre of the pavement while trying to locate the existing water main. The sediments encountered during this work, (101), (102), (103) and (104), were all modern deposits or the upper layer of natural subsoil.

Discussion

- 28. During monitoring no significant archaeological deposits or features were recorded. The lack of any significant archaeology is most likely due to the site having been heavily disturbed from the construction of the existing residential house in the 1960s and the surrounding works such as the driveway, the boundary wall and the modern road surface.
- 29. The only anthropic material recorded on site was there as a result of the modern (late 20th or 21st century) use of the area. A small fragment of animal bone was recovered <001>. However this bone was recovered from a disturbed and therefore unsecure context, this coupled with the condition of the bone suggests that it is of 20th century origin.

Recommendations

- 30. No significant archaeological deposits were uncovered and no anthropic material was recovered other than that which relates to the modern (late 20th or 21st century) use of the site. As all ground breaking works relating to this development have been completed Rathmell Archaeology Ltd therefore recommend that no further archaeological monitoring works are required on site in relation to this development.
- 31. It should be noted, however, that outside the footprint of the new extension the archaeological potential of the area has not been tested. The importance of Sweetheart Abbey and the surrounding area supports the possibility for older historic remains to survive in the surrounding grounds and along the course of the main street (Figure 5b).
- 32. The appropriateness and acceptability of our recommendations rest with Historic Scotland and Dumfries and Galloway Council Archaeology Service.

Conclusion

- 33. A programme of archaeological monitoring was carried out on behalf of William Waugh & Sons (Builders) Ltd, on behalf of their client, in support of the demolition of an existing extension and the erection of a new larger extension at 32 Main Street, New Abbey, in proximity to Sweetheart Abbey, Dumfries and Galloway. The works were designed to mitigate the impact on the archaeological remains within their development area and occurred from the 12th August until 14th August and on the 15th of November 2013.
- 34. No archaeologically significant deposits were uncovered during the course of this work and no anthropic material was recovered other than that which related to the modern (late 20th or 21st century) use of the site. Within the footprint of the extension and related services there is no significant archaeological potential however giving the historical importance of Sweetheart Abbey and surrounding grounds there is still a significant potential for uncovering significant archaeological material in the surrounding area.
