## Introduction

- 1. This Data Structure Report has been prepared for Mr R Niklasson in support of the construction of a new house at Swanston Road, Edinburgh (NGR: NT 23959 68258). The archaeological works were designed to mitigate the impact on any archaeological remains within the development area.
- 2. The works have been granted conditioned Planning Consent by City of Edinburgh Council (18/03101/FUL). The City of Edinburgh Council Archaeology Service, which advises City of Edinburgh Council on archaeological matters, provided guidance on the structure of archaeological works appropriate on this site. Rathmell Archaeology Ltd has been appointed by Mr R Niklasson to undertake the development and implementation of the archaeological mitigation works.
- 3. The Written Scheme of Investigation (Krischer 2019) provided the detail of the works (archaeological monitoring, exclusion, excavation, post-excavation analyses and publication) for the mitigation pertaining to groundbreaking within the development area and hence the direct physical impact on buried sediments.

### Historical and Archaeological Background




Figure 1a: Ordnance survey 1<sup>st</sup> edition (1855) with the development area shown in red

- 4. The development area is located between 4 and 12 Swanston Road, Edinburgh. The plot lies to the west of Swanston Road (centred on: NT 23959 668258, see Figure 3). The development area was in use as a garden until recently for a neighbouring house. The historical mapping shows very little change in the development area from the 18<sup>th</sup> century onwards. It is depicted as open countryside on Roy's *Military Survey of Scotland* (1747-52). Swanston Road and Oxgangs Road are both shown on the 1<sup>st</sup> edition Ordnance Survey (Figure 1a), where the development area is depicted as agricultural fields. There is little change in the development area within the 2<sup>nd</sup> edition Ordnance Survey of 1944, which depicts a number of houses around the intersection of Swanston Road and Oxgangs Road, including the house which currently lies adjacent to the development area to the north.
- 5. No known archaeological sites are located within the development area and no previous archaeological works have been conducted within the area.

### Project Works

- 6. The programme of works comprised the archaeological monitoring of groundbreaking works within ground to the south of 4 Swanston Road, Edinburgh (Figure 3).
- 7. The groundbreaking works consisted of topsoil stripping across the site of the house plot, including part of the driveway, to reveal the underlying natural subsoil in order to clear the area of any archaeological features prior to further development works taking place. The eastern portion of the driveway was only taken down to the required maximum working depth which did not reach subsoil. The works were undertaken using a 360° tracked excavator with a smooth ditching bucket and took place on the 1<sup>st</sup> April 2019.
- 8. Prior to attending the site, upstanding vegetation along the northern half of the eastern edge had been cleared to ground level. This was to allow access for the machine to enter the site from Swanston Road.
- 9. In compliance with the Written Scheme of Investigation (Krischer 2019) any potential archaeological features were investigated and recorded. All works were conducted in accordance with the Chartered Institute for Archaeologists' Standards and Policy Statements and Code of Conduct and Historic Environment Scotland Policy Statements.




Figure 1b: Ordnance Survey 2<sup>nd</sup> edition (1885) with the development area shown in red

#### Findings




Figure 3: Plan showing monitored area

- 10. The area sat within an enclosed grassed area just to the south of 4 Swanston Road, Edinburgh (Figure 3). The area had been previously used as a garden and was bounded by a mixture of timber fencing and hedgerows (Figure 2a).
- 11. The stripped area consisted of both the area of the house plot and also the driveway which will run in from Swanston Road to the east (Figure 3). The area of the house plot measured approximately 15.4m east-west by 12.6m north-south (Figure 4a). Directly adjacent to the east, the area for the driveway measured approximately 7m east-west by 5.2m north-south (Figure 4b). The stripped area stopped roughly 3m to the west of the pavement along Swanston Road where the driveway will be built up to meet the back edge of the pavement. This 3m section was not covered by turf as it comprised the area of upstanding vegetation (previously cleared) and also a 1m wide strip of concrete which bounded the eastern edge of the development area.
- 12. Prior to excavation, the entire area was covered by turf with underlying topsoil (001). (001) comprised a moderately compacted dark brown clayey silt with frequent rootlets and small stone inclusions. It contained occasional fragments of modern glass and 19<sup>th</sup>/20<sup>th</sup> century white glazed pottery sherds. The topsoil measured up to 500mm thick (Figure 2b).
- 13. The works removed (001) to reveal natural subsoil (002) across the entire area of the house plot and the western 2m of the driveway. This consisted of a firmly compacted mid- brownish orange sandy clay with frequent gravel inclusions (Figure 4a). The eastern portion of the driveway stopped within topsoil (001) and does not require to be taken any deeper.
- 14. No archaeological features were present, and the only finds noted were the occasional 19<sup>th</sup>/20<sup>th</sup> century artefacts throughout topsoil (001).

#### Discussion

- 15. No archaeological features were uncovered during the course of the monitoring works. The ground was revealed to have a simple stratigraphy of topsoil directly overlying natural subsoil, with no features visible cut into the upper surface of the subsoil.
- 16. The only artefacts noted were occasional fragments of modern glass and white glazed pottery visible within the topsoil. Looking at the available mapping from the 19<sup>th</sup> and early 20<sup>th</sup> century, this ground appears to have sat at the corner of a large agricultural field, although the use of the ground for this purpose has left behind little in terms of archaeological evidence. The presence of modern artefacts in the topsoil likely reflects the growing expansion of housing and settlements within the surrounding area throughout this period and into the latter half of the 20<sup>th</sup> century.
- 17. We know from historical accounts that prehistoric burials have been found within the surrounding area further to the east, and we also know of the presence of a standing stone in the area Caiy Stane which is protected as a Scheduled Monument (SM1155). The lack of archaeological features within this ground might imply that this activity did not extend this far west, but it is quite possible that this we are looking at too small a sample area to have caught what might still be present elsewhere in the vicinity.

#### Recommendations

- 18. No significant archaeological remains were located within the development area.
- 19. On balance, given the lack of significant archaeological material recovered in the course of the monitoring works, we consider that the development works will not compromise any significant archaeological strata. Rathmell Archaeology Ltd recommends that no further archaeological works be undertaken with regards to this development and the planning condition be purged.
- 20. The appropriateness and acceptability of our recommendations rest with City of Edinburgh Council and their advisors, the City of Edinburgh Council Archaeology Service.
