## Introduction

- 1. This Data Structure Report has been prepared for T & N Gilmartin (Contractors) Ltd in respect to the progressive renewal of road and pavements in Market Street, St Andrews. The archaeological works were designed to mitigate the impact on the archaeological remains within their development area to the agreement of Fife Council. Rathmell Archaeology Limited was appointed by T & N Gilmartin (Contractors) Ltd to undertake the development and implementation of archaeological mitigation works for the progressive renewal of road and pavements in Market Street.
- 2. The Fife Council Archaeology Service who advises Fife Council on archaeological matters had requested an archaeological watching brief be undertaken to manage the potential impact on archaeological remains. They provided guidance on the structure of archaeological works required on this site during development works. A Written Scheme of Investigation (Rees 2010) provided the detail of the works (monitoring, exclusion, excavation, post-excavation analyses and publication) for the mitigation pertaining to ground breaking within the defined archaeologically sensitive areas and hence the direct physical impact on buried sediments.
- 3. This Data Structure Report provides an overview of all archaeological works undertaken in response to this development work. Archaeological monitoring was carried out intermittently according to the needs of the client. According to the terms of the Written Scheme of Investigation all ground breaking works were monitoring; all works complied with the Fife Council Archaeology Service Standard Conditions, the Institute for Archaeologists' Standards and Policy Statements and Code of Conduct and Historic Scotland Policy Statements.

#### Archaeological and Historical Background

- 4. St Andrews has an origin as a religious centre from at least the tenth century as a Culdee community known as Kilrimont. A Culdee was an ascetic monastic community first appearing in Ireland then subsequently in Scotland in the Medieval Period. From the twelfth century Scotlish and Irish Culdees were brought under canonical rule, meaning they became more regulated in the Roman Church's pattern.
- 5. The burgh, a formalisation of the existing settlement, was established by Bishop Robert in the early twelfth century. Interpretations of the development of the burgh differ. One case argues that it originally focused on North and South Street with Market Street being a subsequent infill within the backlands of these two streets. The other case proposes a tighter area as the early burgh focused on Castle Street and some of North Street. Regardless of the sequence, Market Street is an element of the medieval street morphology and the location of the Market Cross.




Figure 1: Detail from John Geddy's Map (circa 1580)

- 6. The earliest map of St Andrews (circa 1580, John Geddy) (Figure 1) shows the burgh as a well formed grid with the focus on the Cathedral to the east. Market Street is represented with regular street frontage on both north and south sides. Within Market Street is an area cited in historical documents as the location of the burgh's tolbooth (also referred to as the Townhouse). This was believed to have had three phases of building, ranging from twelfth century to nineteenth century. The first reference of this structure occurs in 1144 which indicates a position in the vicinity of the market cross (Simpson & Stevenson 1981, 9).
- 7. Subsequent maps (John Geddy c1580) (Figure 1); (Ordnance Survey 1854) (Figure 3) depict the Tolbooth structure in the area to the north-east of Logies Lane; all three phases appear to have been built roughly on top of one another. Mapping subsequent to 1854 fails to depict the building, indicating its removal prior to the end of the nineteenth century; the building was reported to have been removed in 1862, as it had become an encumbrance to the street. An arrangement of red cobblestones in the area was thought to represent the locations of the walls of the Tolbooth.




Figure 2: Detail from Roy's Military Survey of Scotland (1747-55)

- 8. The first detailed post-medieval plan of St Andrews is from 1747-55 (General Roy's Military Survey of Scotland) (Figure 2); it depicts is as a coherent large burgh with




Figure 3: Detail from 1<sup>st</sup> edition Ordnance Survey (1854)

Market Street clearly visible with continuing street frontages on both sides of the road. By the 1st edition Ordnance Survey (1854) (Figure 3) this rigid streetscape within Market Street is shown to have been fully retained and has been maintained since.

9. The archaeological potential of the Market Street in general has not been tested, although excavations in the late nineteenth century (NMRS: NO51NW 29) located two Bronze Age cinerary urns from deposits beneath Market Street. This illustrates well the potential not only for medieval archaeological features related to the foundation and development of the burgh, but also precursor prehistoric activity.

#### Geology

- 10. St Andrews is located in the east coast of Fife, on raised ground between the sea cliffs to the North and the valley of the Kinness Burn to the South. The parent material for soil throughout the medieval burgh is a sand and gravel deposit up to 3m thick. This formed as beach sediment during raised sea levels in the late-glacial period and it occurs along most of the Fife coast. To the north, the sand and gravel overlies clay and solid rock.
- 11. It is believed as much as 0.5m of sandy loam topsoil may have been present prior to the development of medieval St Andrews, and is typically encountered at least 0.5m below the ground surface. This sandy clay material is derived from the natural sand and gravel deposits in the area.

### St Andrews 'Garden Soil'/'Occupation' Deposits

- 12. Above this natural sandy clay deposit, deep deposits of homogenous materials have been revealed during previous excavations. Excavations at the Byre Theatre (Carter 2007, 87) revealed dark grey/brown sandy loam deposits which contained a number of materials identified with human activity (shell, bone, pottery, slag, coal and charcoal, plaster). There are two theories as to the origin of these deposits.
- 13. The 'Occupation deposit' model suggests that it is the result of abundant occupational medieval activity; this includes a combination of previous horticultural activities located within the back gardens of domiciles associated with previous citizens of the town and debris build up (ibid, 91). The impressive layout and facing street frontage of Market St was preceded by arrangements of cultivated backland material in the twelfth and thirteenth centuries. However it remains to be demonstrated that this was the reason for the development of the deep soils.
- 14. Previous to the 'occupation Model' was the 'imported garden soil model' explanation which suggests the deposits consist of material imported from outside the Burgh to provide soils for horticulture (ibid, 87). Lack of disturbance of underlying deposits and the great depth and homogeneity of the soil are cited as evidence in support of this interpretation. The widespread occurrence of the deep soil in the burgh is interpreted as evidence for a major change in land use. Property divisions were abandoned, developments of backlands ended, and the land was turned over to cultivation. This sequence is explained as the product of the decline in the fortunes of St Andrews after the reformation.

# Project Works

15. The programme of works was carried out in the form of archaeological monitoring of all ground breaking works as described in the Written Scheme of Investigation (Rees 2010) and agreed with the Fife Council Archaeology Service. Archaeological monitoring allowed the removal of existing paving/cobblestones and ground reduction for the refurbishment of existing services and the resurfacing of the Road and pavement. The progress of work was frequently limited by the need to retain vehicular access through Market Street and limit the disturbance to shops. This resulted in the division of works into north and south areas of the street.

- 16. Archaeological monitoring work began on 22<sup>nd</sup> September 2010 and was carried out intermittently according to the needs of the client until 1<sup>st</sup> November 2011. At no point during the course of these works was archaeologically sterile drift geology reached over a sufficient area to demonstrate the absence of archaeological potential. However, it was often possible to determine that previous modern (nineteenth to present day) disturbance had removed any significant archaeological material from within the scope of these excavations. Any exposed features were investigated to determine their archaeological significance.
- 17. The ground breaking works for the public realm works included: installation of ducting for new services; removal of the existing paving and other surfaces; general reduction of the area as necessary; localised deeper reduction for new kerbs, tree pits etc; and excavations for the refurbishment of existing services, especially surface water drains. These works were carried out to various depths according to the needs of the project. Typically excavation work was carried out using a 360° mechanical excavator, a minidigger or by hand. Hand excavations were carried out when access was awkward or there was a high risk of impacting sensitive material.
- 18. Each phase of works was assigned a number, ordered chronologically, in order to maintain ease of reference. The numbers refer to a specific area within the Market Street works (e.g. Road 1, Road 2 etc). There are nine in total. These numbers were then grouped into sections A-D, organised by site location and archaeological significance.
- 19. The limit of works was restricted to the area between the Bell St junction and the Union St junction. The entirety of Market St is of highly interesting archaeological potential due to the location at the centre of the early medieval burgh, and the possibility of significant archaeology should be considered during any further works undertaken in this area. The works below were monitored at intervals matching those of the contractor.

# Findings: Section A, West End Market St




Figure 5: Plan of Road Works Phases

20. Section A includes Roads 4, 5, 6, and 7 and encompasses the area from the Bell Street junction to Logies Lane (see Figure 5). Works in Section A included the removal of the existing paving and reduction of the area below; reduction of the road; and installation of ducting for new services and the excavation of trenches for the installations of two manholes. Two manholes were excavated within Road 4 to provide subsequent access to the sewer mains (Manholes 2 and 3).

#### Manholes

- 21. Manhole 2 was located at the east end of Road 4 and measured 4m x 3.5m x 4m deep. Excavations through tarmac (003) revealed (009) (this was 0.2m–0.45m thickness from the top of the tarmac) black/brown/grey (mottled yellow) silty sand containing animal bone fragments, red brick and type 1 gravel. The main water pipe for Market Street was exposed running parallel to the sewer mains at the south, orientated WSW-ENE. A cast iron pipe (possibly a gas pipe) was exposed orientated NNW-SSE to the east. These services run the length of Market Street. Deposit (025) was exposed north of the services and was found at 0.5m below the top of the tarmac. This was dark brown/black sandy clay containing animal bone fragments, oyster and cockle shells and green glaze medieval pottery.
- 22. This sealed 0.3m thickness of natural orange sand (015) which was above 2.0m thickness of undisturbed natural grey clay subsoil (020). Below this was 0.2m thickness of (014), compacted, dark brown/black sandy clay natural subsoil. The section revealed a vertical service duct truncating (025), (015), (020) and (014). Excavation exposed yellow clay (016) as the lowest strata (0.4m deep as excavated). No archaeological features were found.

23. Manhole 3 was at the west end of Road 4 and measured 3m x 3m x 4m deep. Excavations through tarmac (003) revealed 0.2m thickness of (024), small to medium stones within a mid-dark brown clayey sand matrix with red brick fragments. The water and sewer mains were exposed again on the south side with a gas pipe orientated WSW-ENE in the centre. (025) continued at the north side to 0.3m thickness with 0.1m thickness of (015) below, followed by 1.2m thickness of (020). (025), (015) and (020) were truncated by the gas pipe. The lowest strata was bedrock (017) which was 0.3m thick. One possible archaeological feature was revealed within Manhole 3. A possible pit [027] was revealed in section truncated by the water mains and the gas pipe, cut into (025). This was filled with (028), firm mid-dark brown sandy clay containing occasional charcoal.

#### **Pavements**

- 24. The pavements in all areas were reduced by 0.45m depth. The kerb side was reduced to 0.5m depth to accommodate installation of drainage channels. The reduction area extended slightly out into the road in order to facilitate this. The paving slabs (001) were removed to expose bedding sand (002). Excavation on the kerb side through cobblestones (113) (and in some places, tarmac) revealed (002) and (009) below.
- 25. Service ducts were excavated to 0.55m deep within the pavement areas. The streetlight installations were located on the north and south pavements. An additional duct was excavated along the north pavements for the installation of electricity cables to provide power for stalls during the Lammas fair. The trenches revealed (009) with occasional areas of (006) exposed below.
- 26. The reduction of the pavements mainly revealed (009) with disturbance from the installation of services. The only features revealed during reduction within Section A were a number of tree-pits (004), exposed at the north side. These were oval in plan and contained modern pottery. No other archaeological features were found.

#### Road 4

- 27. Depths provided were measured from the top of the modern kerb on the north side, unless otherwise stated. Excavation through tarmac (003) revealed 0.2m thickness of (024) below. Deposits of possible windblown or Aeolian sand (006) were revealed in places below to a thickness ranging from 0.01-0.05m. (025) and (070) were located below at 0.3-0.45m depth from the top of the kerb which in turn sealed natural sand (015) found at a depth of 0.4m from the top of the kerb. (070) was mid-dark brown/purple sandy clay containing coal/charcoal, oyster and cockle shells, animal bone and medieval green glaze and white gritty ware pottery. (070) and (025) ranged in thickness from 0.1m-0.15m. Both of these deposits appear to be similar to the medieval deposit dubbed 'garden soil' found at the Byre Theatre. Excavation revealed these deposits to be heavily disturbed by recent service installations.
- 28. At the west end of Road 4 a shell midden [095] was found at 0.46m depth from the top of the southern kerb. This was 0.18m depth at the deepest point. The fill (094) consisted of very compacted cockle, periwinkle and limpet shells and charcoal in a matrix of redeposited (070) and (015). One sherd of white gritty ware was removed from the fill. Redeposited (070) and (015) sealed the feature, which was cut into (015). Services truncated it to the south and east. The presence of medieval pottery and the general lack of modern inclusions indicate this was the remains of a medieval shell midden.
- 29. Reduction of Road 4 revealed two deposits which possibly represent the remains of a medieval road surface, both located at the north side of Road 4. (093) was located north of (095), below (070) and consisted of abundant very compacted small to medium sandstone and stones and rare charcoal and shells within a mid-dark brown/purple sandy clay matrix. Modern services truncated this feature on all sides. 0.01-0.04m thickness of (006) appeared above this deposit, which lay immediately above (015). (091) was exposed approximately halfway along Road 4 at 0.45m depth below the top of the kerb. This was abundant very compacted, small to medium stone and sandstone pieces and medieval pottery with frequent charcoal, oyster and cockle shells and animal bone in a

mid-brown (mottled grey) silty sand matrix. The pottery was unglazed white gritty ware. It was sealed by (025) above and lay above (015). Modern services truncated this feature on the west and south sides. The feature peters out into (015) on the east side and runs under the limits of excavations to the north.

#### Road 5

30. Reduction through tarmac (003) revealed 0.1m-0.15m thickness of (024) below. (070) was revealed immediately below this at 0.15m depth from the top of the kerb on the south side. Areas of (015) were revealed sealed below this deposit. Excavation in this area revealed an abundance of modern gas, water and electricity services truncating (070). No archaeological features were found.

#### Road 6

31. Excavation through tarmac (003) and cobblestones (113) exposed bedding sand (002) to 0.25m thickness below. This was above 0.2m thickness of (007), compacted dark brown/black silty sand containing frequent oyster, mussel and cockle shells and animal bone. (015) was sealed below, visible in sporadic areas. Abundant services truncated this area, while no archaeological features were revealed.

#### Road 7

32. This was excavated through tarmac (003) and cobblestones (113) to reveal (002) and (024) to 0.2m-0.25m thickness. (070) was revealed below these deposits at 0.2m-0.25m thickness, above (015). Abundant modern services truncated (070) and no archaeological features were exposed.

#### BT Service Ducts

- 33. BT service ducts were excavated along the north side of Section A to 0.2m-0.4m depth from the top of the reduced ground level. The width ranged from 0.35-0.5m and the trench was orientated WSW-ENE. It was located 0.72m-0.9m from the northern edges of excavation. The trench revealed disturbance from a previous BT service at the NNW side.
- 34. The western trenching revealed (015) and areas of backfill and disturbance relating to services. The eastern trenching revealed (025) to 0.15m thickness above 0.3m thickness of (015). The base of the trench revealed (015) with areas of (020). Three old BT service boxes were excavated along the trench, revealing heavy disturbance alongside areas of natural clay (020) and bedrock (017). No archaeological features were found within the trenching.

# Findings: Section B - Central Section West (Tolbooth)

#### **Pavements**

35. These works were the same as those carried out during the reduction of the pavements in Section A (see above). The pavements were subject to areas of widening within Section B. Excavation revealed only (002) and (009) with areas of disturbance relating to installation of services. No archaeological features were found during these works.

#### Road 3

- 36. Depths provided were measured from the top of the modern kerb on the north side of the street unless otherwise stated. Monitoring works in this area revealed archaeological features and structures possibly relating to the Tolbooth structure.
- 37. Excavation through tarmac (003) and cobblestones (113) revealed (064) below to 0.3m thickness. This was loose, light-mid brown clayey sand containing frequent sandstone, rare shell (oyster and cockle) and charcoal and red brick inclusions. This deposit was found covering most of the area. A number of archaeological structures and deposits which appear to pertain to a building were revealed below this deposit.
- 38. Deposit (030), loose, blonde sandstone rubble (ranging from small fragments to large




Figure 8: Plan of Road 3

worked blocks) in a sand matrix, containing modern white-glaze pottery was exposed at 0.34m depth below the top of the kerb. It is possible this deposit was material from the demolition of the last phase of the Tolbooth structure (Figure 8 for location).

- 39. A similar deposit (050) was exposed at the east end of Road 3 at a depth of 0.2-0.25m below the top of the kerb to 0.1m maximum thickness. This consisted of compacted very pale yellow/white sand with occasional small-medium sandstone pieces and rare very small-small angular stone inclusions (Figure 8 for location). The full extent of (050) was unknown, as it was truncated by services and by modern backfill deposit (052) to the east. (052) was light brown/yellow (mottled yellow and grey) very compacted sandy clay with abundant yellow sandstone and small-medium angular stones and rare charcoal inclusions and was 0.3m thickness. (050) was also truncated by (077), very compacted, yellow/very light brown sand containing occasional shells, frequent blonde sandstone and very small-medium stones and stone flecks. This also looked to be a modern backfill deposit.
- 40. Excavation within Road 3 revealed three possible structures [032], [033] and [085]. [032] was found at 0.18m depth below the top of the kerb and appeared to be a foundation course of a sandstone structure. It measured 0.4m x 2.1m x 0.15m thickness and was orientated WSW-ENE (Figures 9 & 10). The majority of the stonework consisted of unshaped, undressed blonde sandstone, the average size of which was 0.22m x 0.4mx 0.15m thickness. The structure was one course high by one course wide. The stones were bonded with sandy clay mortar (054) which was grey and contained frequent stone flecks. Compacted orange sand (055) was revealed below. A void between the two stones at the east end indicated the end stone was not *in situ* but had been disturbed and re-deposited slightly east of where it lay previously. In addition, [032] was bordered to the east by (039), compacted, black, clayey silt with charcoal, oyster, limpet and periwinkle shells, animal bone and clay tobacco pipe fragments. This deposit ran below the most eastern stone of [032] to 0.15m thickness below the top of (032).
- 41. Structure [033] was exposed at 0.37m depth below the top of the kerb (Figure 10 & 11). This also appeared to be a foundation course of blonde sandstone. It measured 0.51m x 2.7m and was orientated NNW-SSE, with only one course remaining. This structure differs from [032] in that the stonework is much smaller (largest stone was 0.29m x 0.33m x 0.08m thickness) and the form is different. [033] consisted of a double-skin of worked and un-worked sandstone pieces with rubble infill. The stonework was bonded with (058), a mortar consisting of sand and stone flecks.
- 42. Structure [085] was exposed at 0.18m depth below the top of the kerb (Figure 12). It measured  $1.4 \text{m} \times 0.55 \text{m} \times 0.15 \text{m}$  thickness and was orientated NNW-SSE. This structure was one course high and wide, and was composed of unshaped and undressed blonde sandstone, the average stone size was  $0.33 \text{m} \times 0.35 \text{m} \times 0.14 \text{m}$  thickness. It was bonded with (086), compacted, green, silty clay material with occasional charcoal flecks and very small stones. This structure also looks to be the remains of the foundation course of a sandstone structure.
- 43. A shaped and dressed rectangular sandstone block [098] was found in situ within a heavily disturbed area at the east end of Road three (Figure 14). The stone measured  $0.39 \,\mathrm{m} \times 1.01 \,\mathrm{m} \times 0.4 \,\mathrm{m}$  thickness and was orientated WSW-ENE. A similar stone [099] was found disturbed and re-deposited to the south of [098], which looked likely to have formed part of the same structure at some point. [099] was found below a modern deposit (097).
- 44. Two deposits of stone slabs (040) and (041) were exposed to the east of [032] and [033]. (040) was found at 0.33m depth below the kerb and measured 2.4m NNW-SSE  $\times$  1.6m WSW-ENE. The stonework was flat and irregular in size, the largest of which was 0.67m  $\times$  0.52m  $\times$  0.05m thickness. This feature was truncated by a gas pipe along the centre and to the north by another service orientated NNW-SSE. Removal of the southeastern part of (040) revealed a second layer (068) below. These were similar in form, consisting of flat irregular size stones, the largest being 0.4m  $\times$  0.27m  $\times$  0.08m thickness. (040) and (068) were bonded by (067) which consisted of yellow sandy clay and frequent sandstone flecks. Deposit (069) was revealed to the east of (040) which

was an area of grey sand containing occasional charcoal flecks. It is possible this represented the location of further stonework.

- 45. The second area of slabs (041) was found east of (040). This stonework differed as the upper surfaces were slightly convex and rougher. This feature consisted of mostly unshaped stones. These were irregular with the largest being 1.0m x 0.45m x 0.08m thickness. (041) was truncated by modern deposit (047) to the NNW and ENE side, and by a gas pipe to the SSE. (047) was friable, light-mid brown/orange sandy clay containing frequent sandstone and small-medium stones. This was re-deposited modern material.
- 46. Structure [033] and deposit (040) were surrounded by (044), a later deposit added around the stones, acting as grout to keep them in place. This was firm, grey/mid-dark brown sandy clay with frequent sandstone, charcoal and occasional small-angular stones. Two medieval pottery sherds were found within this deposit, with an absence of modern material. (044) was truncated to the NNW by (047) and by the sewer mains to the SSE. It was further truncated to the SE by modern deposit (052).
- 47. Associated structures and deposits [032], [033], (040), (041) and [098] were found immediately above deposits which shared characteristics indicative of bedding material. A slot at the NNW side of [032] revealed 0.3m thickness of (036) below, which was very compacted, mid-brown (mottled pale yellow and white) sandy clay. It contained frequent charcoal, sandstone and small-medium stones and animal bone. One piece of medieval pottery was recovered from this deposit. (036) was also located SSW and NNW of this structure, but was truncated on the NNW side by the sewer mains. At the WSW side of [032] deposits (042) and (043) were exposed, stratigraphically below (036).
- 48. (042) was friable, dark-brown/grey (mottled black) sandy clay containing frequent charcoal and occasional coal, oyster and cockle shells and animal bone. (043) was found below (042) and was friable, mid-brown orange slightly clayey sand containing occasional very small-medium angular stones, frequent small-medium sandstone and rare charcoal inclusions. Both of these deposits were truncated to the NNW by the sewer mains and to the WSW by an area of disturbance resulting from the installation of manholes NNW of Logies Lane.
- 49. Deposit (045) was located below [033] to the WSW, which was very compacted yellow, slightly clayey sand with abundant blonde and red sandstone pieces and occasional sandstone flecks. The maximum thickness was 0.06m. It was truncated to the NNW on by (047) and to the WSW by a gas pipe.
- 50. Removal of [098] exposed a small rectangular area of orange sand below which looked to be either degraded sandstone. Below this was (100), compacted red and grey clay with flecks of charcoal and grey/white sandstone.
- 51. Below (068) and parts of (040) was (065), compacted, mid-dark brown sandy clay containing frequent charcoal, small-medium stones and sandstone and animal bone. Two sherds of medieval pottery were also removed from this context. (041) sat above (066), a very compacted mixture of mid-dark brown sandy silt and yellow compacted sand containing occasional charcoal flecks, frequent small-medium sandstone, small-medium stones and stone flecks. This was found at 0.35m below the top of the kerb.
- 52. The exception was deposit (066), which was found enclosing a rubble deposit (072). This was located ENE of (041), at 0.35m depth below the top of the kerb. It consisted of three large blonde sandstone blocks, the largest being 0.4m x 0.45m x 0.1m thickness. There was no mortar bonding and they were deposited in a haphazard fashion. Other similar deposits which look to have resulted from previous demolition in the area were also prevalent on site. Deposit (078) was exposed below (072), found at 0.37m depth below the top of the kerb and consisting of five irregular blonde sandstones pieces. Two showed signs of shaping and three retained an attached mortar deposit (079). A worked sandstone block (060) was located at the mid-eastern area of Road 3. This was found at 0.49m depth from the top of the cobblestones and sat within deposit (062), which was friable, light-mid brown sandy clay with frequent charcoal flecks, small-medium blonde and red sandstone and occasional small rounded and angular stones. (072), (060) and

(062) all appear to be deposits which resulted from the demolition of a sandstone building.

- 53. In addition, deposits (081) and (082) were found at the north-eastern end of Road 3 at 0.25m depth below the top of the kerb. This also appeared to have resulted from demolition and included sandstone (081) with deposit (082) above and between. (082) was mid-dark brown (mottled orange) sandy clay with abundant coal and charcoal, rare metal slag and frequent sandstone flecks inclusions. These deposits were sealed by (083), a compacted orange clay with black coal and charcoal inclusions. Deposit (052) was found above this. Removal of (081) and (082) exposed less than 0.04m thickness of (076) below, which looked to be natural beach gravel consisting of loose orange, yellow and white stone flecks, very small rounded stones and rolled shell fragments. This was also found near (078) and below (072) as well as under parts of (040). It was also found above modern deposit (097) which is likely to indicate the use of this natural material over a long period of time in St Andrews.
- 54. Structure [085] was exceptional as it did not sit above a bedding deposit, but sat immediately above a 'garden soil' deposit (Carter 2007, 91), (087). This was mid-dark brown/black sandy silt with moderate charcoal flecks, occasional sandstone pieces and small stone inclusions and rare shell fragments. Similar to this was (046), which was located below (045). (046) was very compacted mid-dark brown/purple sandy clay with frequent charcoal, blonde and red sandstone, oyster and cockle shells and animal bone. Frequent medieval pottery sherds were also retrieved from this context. This was found immediately below (045). Deposit (059) was similar to this and was located below (036).
- 55. Deposit (063) also appeared to be of the 'garden soil' nature and was friable, dark brown/black sandy clay with frequent sandstone, occasional oyster and cockle shells and abundant charcoal inclusions. This deposit was found at 0.49m depth below the top of the kerb on the south side, below (062). (084) was compacted mid-grey brown silty clay with frequent small stones, coal and charcoal, animal bone and degraded sandstone, also containing medieval pottery and located below (081) and (082). The dominant deposit of this nature exposed within Road 3 was (070), located below (043), (051), (065) and (078).
- 56. Deposits (046), (059), (063), (070), (084) and (087) are very similar, lacking modern material and including similar evidence of human interference. They appeared to be very similar to the 'garden soil' deposits found at the Byre Theatre excavations, and all seal natural undisturbed sand (015) below.
- 57. A number of modern deposits were also found during reduction of Road 3. Deposit (035) (Figures 9 & 10) was compacted black, clayey silt with frequent coal, coke and charcoal and slag and small sub-angular stones. This was revealed to be truncated by services on most sides. A slot at the NNW edge revealed 0.27m thickness; the upper 0.11m was black, below this it merged into light-mid brown sandy clay and sporadic black. It truncated (030), indicating a modern spread of burnt material.
- 58. (048) was a small pocket of modern material within (047); very compacted yellow, black and grey sandy clay with pockets of sand, frequent grey and blonde sandstone, charcoal and coal and occasional small-large flat and rounded stones. The area east of (041) and west of [085] looked to have been generally subject to modern disturbance. Within this area were a number of modern contexts; (071) was small area of loose, very dark brown/black silty clay with red brick and clay tobacco pipe fragments found at 0.2m depth below the kerb; (075) was friable, light-mid brown silty sand with occasional coal and charcoal, small-medium stones and sandstone and red brick. This was below (047), truncated (052) and was located SSE of a concrete deposit.
- 59. Deposit (102) was exposed in the south-east area of Road 3; this was loose, light-mid grey ashy sand with abundant slate, rare coal and occasional type 1. Modern glass was retrieved from this context, which looks to have resulted from service disturbance in the area.

#### Tree Pits

60. Monitoring of the excavation of two tree pits also took place within Road 3 works. These were located at the eastern end of the area. These measured 2.0m x 2.0m x 1.3m. Tree Pit 1 revealed only disturbance from service installations. Disturbed ground was found to 0.2m thickness below the top of the kerb with 0.35m thickness of (025) below. (015) was revealed in the Tree Pit 2. No archaeological features were found within either excavation.

#### BT Service Ducts

61. BT ducts were excavated on the north side of Section B orientated WSW-ENE and reduced to 0.2-0.4m depth from the top of the reduced ground level. The eastern trenching revealed abundant backfill from disturbance from services, truncated through (025) and (015). The western trenching was reduced through 0.15m-0.24m thickness of (084) above 0.15m thickness of natural sand (015). Part of a linear feature [088] was exposed at the base of the trench, orientated northwest-southeast. It measured 0.76m-0.97m x 0.38m NNW-SSE as visible; the north and south edges were obscured by limits of excavation. It was filled with (089), friable, light-mid brown silty sand with occasional sandstone flecks and occasional small sub-angular stones, exposed to 0.11m thickness. It was sealed by (084) and cut into natural sand (015). It is possible this feature represents a small section of a ditch. No other archaeological features were found during excavation of this trenching.

# Findings: Section C – Central Section East

62. This area includes Roads 2, 8 and 9 and encompassed the area from the east of Road 3 to the west of Road 1 (see Figure 5). Works in Section C included the removal of the existing paving and reduction of the area below; reduction of the road; and installation of ducting for new services and the excavation of trenches for the installations of two manholes.

#### **Pavements**

63. The works were the same as those carried out during the reduction of the pavements in Section A and B (see above). Excavation revealed only (002) and (009) with areas of disturbance relating to installation of services. No archaeological features were found during these works.

#### Road 2

- 64. Supplied depths are measured from the top of the northern kerb unless otherwise stated. On the north side, excavation through cobblestones (113) exposed bedding sand (002) and (009) below to 0.3m thickness. Below this (006) was found at 0.45m depth below top of kerb. An electrical cable service duct was excavated at the south of the fountain, to 0.3m depth from the top of the reduced ground level. This revealed (006) with sporadic areas of medieval deposit (007). A second duct was excavated orientated NNW-SSE at the WSW side of the fountain. This revealed a combination of backfill from a previous service, and (006) to 0.2m depth from the top of the reduced ground level.
- 65. South of this, in the area NNW of Church Street, excavation through cobblestones (113) revealed 0.2m thickness of bedding sand (002) and disturbed deposit (009). Below this (006) was found at 0.45m depth below the top of the kerb and was truncated by several services. (021) was found above (006) which appeared to be a spread of mortar consisting of abundant stones, stone flecks and shell fragments in a sand matrix. This was sub-linear in plan; the WSW end looped to form a circle. Sporadic areas of (022) were exposed below (006), which was compacted dark brown/black clayey sand containing abundant shells, stone flecks and small-medium stones. This deposit is similar to the 'garden soil' deposit found at the Byre Theatre excavations.
- 66. The NNW end of Church Street was excavated through tarmac (003) and cobblestones (113) to expose heavy disturbance below. A pipe trench was excavated to a depth of

0.3m from the top of the modern kerb, which exposed (029) in the base of this trench. This was orientated WSW-ENE and consisted of three blonde sandstone pieces two of which were mortar bonded, and one worked into a rectangular block. The most eastern stone looks to have been disturbed and re-deposited.

## BT Ducts/Trenching

67. A BT service duct was excavated at the north side Road 2, orientated WSW-ENE, to 0.2-0.4m depth from the top of the reduced ground level. The SSE facing section revealed only backfill from the previous BT service. The SSE end of the trenching revealed disturbance from services. The remainder exposed (006) to a thickness of 0.25m above 0.05-0.1m thickness of (007). The excavation of a BT box was monitored south of the Cross Keys Hotel, which revealed no archaeological features. An additional trench was excavated orientated WSW-ENE adjacent to the BT box to search for possible underlying services. This revealed (007) with (111) below, which was mid-brown clayey sand. Below this was (112), compacted orange/yellow undisturbed natural sand.

#### Road 8

- 68. The required reduction depth in this area was 0.52m below the top of modern ground level. Depths given have been measured from the top of the modern kerb on the south side unless otherwise stated. This area was excavated through cobblestones (113) to reveal (002) and (009) below found at 0.2m depth below the top of the kerb. In the southern area of Road eight, 0.1-0.2m thickness of (006) was exposed below, while in the northern side (070) was dominant. Both deposits were heavily truncated by services.
- 69. Excavation revealed (103) cut into this deposit, located at the SSW limit of Road eight and found at 0.51m depth below the top of the kerb. This was a two pronged linear feature in plan, orientated WSW-ENE and measuring 0.09m thickness at the deepest point. The deposit consisted of loose, grey (mottled yellow), small-large blonde sandstone, flat angular stones and abundant lime mortar (shell and stone flecks) within a clayey sand matrix. The original full extent is unknown as it was truncated to the WSW and SSE sides by modern services and concrete. It is possible this is the remains of another demolition deposit which has survived due to natural undulations in the ground.
- 70. Within Road 8 was a square arrangement of cobblestones which were thought to depict an area of historical or archaeological interest. This was located at the east end of Road 8. Excavation of this area revealed a possible tree-pit. Bedding deposit (105) was immediately below the cobblestones, which was loose, orange brown beach gravel in a sand matrix. This sat on [106] which was found at 0.2m depth below the top of the kerb, cut into (006). This was filled with (104), compacted dark brown/purple silty sand containing frequent blonde sandstone pieces and occasional coal, shell and bone fragments which looked to be re-deposited (070). A slot excavated through this (104) retrieved modern glass and modern white-glaze pottery.
- 71. The excavation of a large trench (Manhole 4) for the installation of a pump for the fountain was monitored at the south side of Road 8. This measured 3.5m x 4m x 3.5m deep from the top of the reduced ground level. This exposed 0.1m thickness of (006) above 0.25m thickness of (025). Below this was 0.3m thickness of (015) above yellow/brown natural clay subsoil (016) above yellow sandstone bedrock (017).
- 72. Further works for service trenching were also excavated within Road 8. Three service ducts were excavated, which were 0.2-0.25m wide and of varying length and orientation. Trench 1 was excavated NNW-SSE along the WSW limit of Road 8 (this connects with the duct excavated in Road 2). This revealed only backfill deposits from a previous service in the area. Trench 2 was located west of the manhole orientated NNW-SSE and running into the pavement on the south side. This revealed 0.1-0.2m thickness of (006) above 0.2m thickness of (025). Trench 3 was orientated north-south from the north side of the manhole towards the fountain and exposed 0.1m-0.2m thickness of (006) above 0.5m thickness of (025).

#### Road 9

- 73. Reduction in this area was 0.52m depth below modern ground level. Depths given were measured from the top of the kerb on the south side unless otherwise stated. Excavation though cobblestones (113) and tarmac (003) revealed bedding sand (002). Below this was 0.1m-0.2m thickness of (006). A square arrangement of cobblestones similar to that in Road 8 was located in this area. This was at the west side of Road 9. Excavation revealed a possible tree pit similar to the one found in Road 8.
- 74. A stone structure [108] was exposed at the west side of Road 9, below (006) (see Figure 15). It was sealed by (107), firm, yellow (mottled orange, grey and white) sandy clay containing abundant blonde sandstone, frequent small-medium stones and patches of redeposited clay (020). [108] was revealed to be a subterranean stone structure; six worked rectangular sandstone blocks capped this structure. These were arranged in a row (orientated WSW-ENE) and measured 0.32m-0.51m x 1.8m-2.0m x 0.22m thickness. The top of these blocks was found at 0.27m depth below the top of the kerb.
- 75. Removal of the capping stones revealed the interior of the rectangular structure. The internal elevations revealed uniform courses of stonework as the majority, consisting of worked blonde rectangular and square blocks. Areas of irregular, uneven sandstone were also revealed. The number of courses varied the highest being 11 courses. The base of the feature consisted of rough flat stone slabs found at 3.2m depth below the top of the stone capping. The NNW facing elevation revealed a structure which appeared to serve as a rubbish chute, located in the upper courses of the elevation. This consisted of flat, rectangular sandstone blocks that surrounded a V-shaped chute made of slate which looked to protrude from beneath 84 Market Street. The stonework was bonded with mortar (109), white (mottled grey and black) stone flecks, beach gravel and sand.
- 76. [108] was cut through deposit (110), which surrounded [108] to the SSE and WSW and was found at 0.22m depth below the top of the kerb. It was friable, mid-dark brown/purple sandy clay containing frequent charcoal, sandstone and shell fragments. Medieval green glaze pottery sherds and clay tobacco pipe fragments were retrieved from this context. This deposit looked to be re-deposited (070), likely to have been disturbed during the construction of [108]. It is possible that [108] was once a stone drain serving this area of Market St.
- 77. No other archaeological features were exposed within Road 9. The area was found to be very disturbed by services and recent works in the area.

# Findings: Section D – East End Market Street (Road One)

#### **Pavements**

78. The works were the same as those carried out during the reduction of the pavements in Sections A, B and C (see above). Excavation revealed only (002) and (009) with areas of disturbance relating to installation of services. The only features revealed during reduction within Section D were a number of Tree Pits (004), exposed at the north side. These were oval in plan and contained modern pottery. No other archaeological features were found.

#### Manholes

79. Manhole 1 was excavated at the east end of Road 1, in the centre of the road. This measured 3m x 3m x 3m deep from the top of the reduced ground level. Excavation revealed disturbance from services; the water mains was exposed running WSW-ENE in the centre, with the sewer mains 1.5m directly below. The trench was excavated through 0.4m thickness of (007) above 0.7m thickness of natural sand (015). Below this was 0.6m thickness of natural yellow/brown clay subsoil (016). Below this was yellow sandstone bedrock (017). Monitoring of a drainage trench leading to the manhole revealed only (002), (009) and disturbance from services.

#### Road 1

- 80. Depths given are measured from the top of the modern kerbs on the north and south sides. Excavation through cobblestones (113) revealed (002) and (009) to a thickness of 0.05m-0.14m. (006) was exposed to 0.18m-0.3m thickness below, which was truncated by a number of services. Deposit (007) was exposed to 0.4m thickness in sporadic areas below (006).
- 81. Approximately midway between the western and eastern limits of Road 1, an area of cobblestones (008) was exposed below (009) (see Figure 16). The remains of this cobbled surface consisted of unshaped, irregular stones. (008) was found at 0.21m depth below the top of the northern kerb, immediately above (006). Five stones were found arranged in a roughly circular shape, surrounding an area which had been filled in with smaller stones. It is possible this once supported an upright pole, although this is uncertain. A small copper pin was retrieved from this context.
- 82. At the west end of Road 1 a structure was exposed (see Figure 17), which was composed of contexts [010], (011) and (012). [010] consisted of three shaped sandstone blocks the largest of which was 0.52m x 0.35m x 0.26m thickness. The majority looked to be *in situ;* the second stone from the west looked to be slightly disturbed. The stones were arranged as a quarter-circle in plan but this was the result of truncation and disturbance in the area and it is likely it once formed a full circle. Reduction at the north side exposed 0.1m-0.2m thickness of a foundation below the stones, which consisted of two layers of paving slabs with small-medium sub-angular and sub-rounded stones in a re-deposited (015) matrix between. The foundation sits above (015).
- 83. A fourth stone was located to the south-east of [010]; this was roughly the same size and was shaped into a square block. This stone was located 0.1m higher depth than other stones, and sits above the fill of a service trench located to the east of [010]; it seems likely that this once formed part of [010]. North-east of this was deposit (011). This consisted of three flat irregular grey stone slabs the largest of which was  $0.6m \times 0.53m \times 0.04m$  thickness. These look similar to those within the rubble foundation of [010] and were also located above the fill of the service trench.
- 84. Located to the south of [010] was deposit (012), a conglomerate of small, sub-angular and sub-rounded sandstone pieces and yellow/brown mortar. This deposit sat above (015). This deposit abuts [010].
- 85. Structure [013] was a linear feature located abutting [010] and (012) to the west and was orientated NNW-SSE. The stonework consisted of angular and sub-angular stones, the largest of which was 0.3m x 0.26m x 0.16m thickness, with voids evident between some of the stones. The structure was one course high by one skin wide. This was over [010] on the west side, indicating a later structure. It was truncated to the NNW side by a modern BT box, and to the south side by the sewer mains. Contexts [010], (011), (012) and [013] were sealed by deposit (014). This was very compacted black/grey boulder clay containing no visible inclusions. It is possible this is re-deposited natural boulder clay, resulting from works in the adjacent sewer mains, which had truncated the southern half of the structure.

#### BT Ducts/Trenching

86. BT service duct was excavated at the north side Road 1, orientated WSW-ENE to 0.2-0.4m depth from the top of the reduced ground level. The SSE facing section revealed only backfill from the previous BT service. Trenching revealed abundant disturbance by services. The remainder exposed (006) to 0.2-0.25m thickness above 0.05-0.1m thickness of (007). Excavation revealed no archaeological features.

## Discussion

- 87. A large number of structural features and deposits were uncovered and recorded in the course of the monitoring works. These can be attributed to a number of different phases of activity. Although for some of them an interpretation has already been suggested, either from obvious characteristics or with reference to previous excavation works carried out in St Andrews, for all of the archaeological remains there is the need for further interpretation with reference to the historical record or a more detailed analysis of the material found on site. Key to the discussion of all of the structures and material recovered is the question of when it may be placed in the chronology of the site. It is possible the activities span a time period ranging from early medieval to recent activities in the area.
- 88. The exposed stratigraphy on site is consistent with naturally occurring beach deposits found along a coast line. The lower strata consisted of natural bedrock (017) which was found below natural deposits of clays, (016) and (020). No archaeological features were found at these depths. The deposit occurring above the natural clays appeared to be natural sand (015). This consistency of strata was followed throughout the site.
- 89. It is likely that the oldest archaeological feature found during these works was a short section of ditch [088] which lay at the base of the BT trench excavated within Road 3. This feature was found at a depth of around 0.75m below the top of the kerb on the northern side of Market St. The full extent of this deposit was unknown as edges were obscured by the limits of excavation of the BT trenches, but the likelihood is that this feature extends further. The lack of modern materials within the fill of this feature (089) coupled with the position sealed below a suspected medieval deposit (084) indicates this is the oldest archaeology found on site. It is possible this small area represents the cut of a larger field boundary or ditch. No other archaeological features were found at this depth, but it is possible more features exist at this level.

# 'Occupation'/'Imported Garden Soil' Deposits

- 90. During the course of these works it became increasingly apparent that the deposits located immediately above the natural sand (015) appeared to form a homogenous soil horizon along the length of Market Street. This homogenous soil horizon was subsequently overlain by a heterogeneous mix of other layers depending on the location within Market Street.
- 91. The homogenous soil horizon appears similar in form to those found at the excavations at the Byre Theatre, which are referred to as both 'Occupation' and 'Imported Garden Soil' deposits; the 'Occupation' deposits theory suggests these are the result of abundant occupational medieval activity, while the 'Imported Garden Soil' deposits model suggests they consist of imported horticultural material (Carter 2007, 87).
- 92. Excavations at the Byre Theatre describe these deposits as dark grey/brown sandy loams and brown sandy loams which contained a number of materials indicative of human interference (shell, bone, coal, plaster, slag and pottery). A number of deposits found within excavations on Market Street maintain this consistency of inclusions and form; (025), (070), (007), (087), (046) and (022). Given that the natural topsoil within St Andrews is believed to be a sandy loam it is likely that these deposits represent the disturbed remains of the natural topsoil with a build up of deposits above. This is likely a result of continual biological mixing in addition to human activity such as cultivation of land.
- 93. It seems most likely that deposits (025), (070), (007), (087), (046) and (022) represent 'Occupation' deposits as indicated by this model, rather than being the result of imported landscaping material such as the 'Imported Garden Soil' theory suggests (Carter 2007, 87). The consistent inclusions of human and animal debris within the deposits listed above (found throughout the entire thickness as excavated) would indicate high levels of disturbance inconsistent with the 'Imported Garden Soil' theory.
- 94. While excavations at the Byre Theatre site exposed two distinct layers of this type of

material, no such distinction could be made during the monitoring of works in Market Street. The location of these deposits (025), (070), (007), (087), (046) and (022) immediately above the natural sand (015) indicate an original ground surface which has built up over a long period of time (possibly beginning twelfth century). It is possible that features (091) and (093) located at the west end of Road 4 are representative of an original metalled road surface which no longer remains; this would have been a very compacted surface consisting of small-medium stones and general debris such as pottery and animal bone.

95. That accumulated deposits of general debris and waste (070) and (025) (two of our Occupation deposits) overlay the small metalled surfaces (091) and (093) may indicate progressive dumping in this area. However, the limited area of these features exposed leaves this interpretation highly subjective. It can be assumed that most of these sediments were deposited as a result of occupation in the medieval period. It can be assumed that any medieval archaeological features were once cut through deposits (025), (070), (007), (087), (046) and (022) but none were found; only structures were found during the course of these works.

#### The Tolbooth

- 96. The structures found within Road 3 are consistent with the known location of the Tolbooth buildings which are cited in historical and cartographic sources. Due to a general lack of any other structures in this area, it can be assumed that structures [032], [033], [085] [098] and [099] can be associated with the previous Tolbooth structures. Although it is clear that these structures were built on top of the original medieval ground surface (the 'Occupation' deposits listed in the text above), the assignment of these structures to individual phases of the Tolbooth buildings can not be assumed at this time.
- 97. Despite this, some of the structures found appear more similar than others. For example structures [032] and [085] appear consistent in that they both appear to be a foundation course of a sandstone buildings consisting mainly of unworked sandstone rubble pieces. [098] and [099] on the other hand, have been worked and dressed. Structure [033] differs again, in that the size of the stonework and the form of the structure itself differ from those listed above. Although [099] is re-deposited material, disturbed by recent works in the area, it looks to at one point have formed part of the same structure as [098]. It seems likely that [098] is the very truncated remains of part of the south wall of one of the phases of the Tolbooth; the location and orientation of this structure support this. Prior to recent works in the area, an arrangement of red cobblestones were thought to depict the outline of the Tolbooth building. [098] was found in a position below the south line of these red cobblestones.
- 98. It is likely that in addition to the structures listed above, a number of deposits can also be associated with the Tolbooth structures; the areas of slab stones (040), (041) and (068) are also likely to be contemporary with one of the phases of building of the Tolbooth. It is possible these areas of flat stone represent an internal floor surface of one of the Tolbooth buildings.
- 99. Deposits (030) and (050) may represent the demolition of the last phase of the Tolbooth. These deposits (particularly (030)) were found restricted to the area which is depicted within sources as the location of the Tolbooth. Inclusions of modern domestic material (such as modern white-glaze pottery) within (030) support this. The aforementioned depiction of the Tolbooth with the red cobblestones is roughly aligned with the limits of deposits (030) and (050). (030) and (050) were found only in areas which did not contain any remaining sandstone structures; this would seem to support the notion that these deposits result from demolition of structures similar to [032], [033], [085] [098] and [099].
- 100. Associated with these structures are deposits (036), (045) (065), (066) and (100), which were found immediately below structures [032], [033], [098] and deposits (040), (041) and (068). It is likely these were laid as a bedding or levelling deposit prior to the building of these structures. Their location immediately above the 'Occupation' deposits would support this, as it is likely that a more solid ground would have been required for

building.

101. It is possible the structures associated with the Tolbooth within Road 3 are contemporary with other structures found on site.

#### The Tron and Market Cross

- 102. The cobbled surface (008) which was located in the centre of Road 1 (Figure 16) was located in the approximate location of what appears to be the Public Weigh Beam (known as the Tron), which was depicted in this area on John Geddy's Map of St Andrews in 1580 (Figure 1). This image is of an upright with a crossbar which have objects hanging from each end. At the public Weigh Beam the weights and measures of the day were exhibited and used to assure fair play when commodities were being bought and sold (Lamont-Brown 1989, 62-63).
- 103. The small circular area within this cobbled surface is possibly representative of an upright vertical post which once stood in this position. If this was the case, it is possible that this area of cobblestones and post-hole was the location of the depicted 'Tron'. The placing of this feature within a formal cobbled surface may indicate that this composite feature could be in part later than the feature depicted within the 1580 map, but nonetheless is located in the same position.
- 104. In addition, the structure found at the west end of Road 1 could represent the remains of the Market Cross which once stood in this area (Figure 17). This feature consisted of an arc of sandstone blocks [010] enclosing a sandstone and mortar mass (012). It is possible that [010] represents the stone foundations of the Market Cross, while deposit (012) represents the core. This Market Cross is show in roughly this location within John Geddy's 1580 map.
- 105. It is known that a number of prominent members of society were publicly executed at the Market Cross; Paul Craw (a physician turned revolutionary) was burned at the stake in 1433; Sir Robert Spottiswoode (Lord President of the Council) and three other royalists were beheaded here in 1646; and Samuel Rutherford (Professor of Divinity) who was the author of a revolutionary book, *Lex Rex* in 1644, was burned here in 1660. The Market Cross was removed in 1768, but later royal proclamations were read from a temporary rostrum on the site (*ibid* 63).
- 106. The slight stone feature [013] that lay above [010] and [012], without truncating them, appears to be the remains of a dry-stone wall. As this structure post-dates the possible remains of the Market Cross [010] and (012) it is possible that this relates to the late eighteenth century temporary rostrum.

#### Modern Disturbance and Services

- 107. Despite the remains of potential medieval structures, it is clear from monitoring of these works that the upper 0.2m of material found within Market Street result from abundant recent disturbance and modern activity in the area. This has resulted in the destruction of any potential archaeology at these depths.
- 108. The archaeological remains found during these works have been heavily truncated by the installation of what appeared to be nineteenth century sewer and water mains, in addition to very modern gas, electricity and water pipes (although these tended to be found at a much higher depth). This is likely to be the result of the overall unusually high depths of the supposed medieval deposits found within Market Street; the medieval deposits and features have been unusually well preserved due to the overall nature and history of the town as an important historical burgh.

#### Recommendations

- 109. These monitoring works have exposed a range of features relating to the burgh's Tolbooth, Market Cross and Tron; each of these are critical structures in the management of a medieval burgh. While the volume of materials is modest, access to features relating to these structures is rare heightening their importance as a record of the medieval burgh.
- 110. Post-excavation works to analyse and report on the materials recovered from this programme of archaeological monitoring are recommended. This should encompass not only analytical work on sediments and artefacts but the publication of a short summary and findings in the Tayside and Fife Archaeological Journal.
- 111. Sampling of potential medieval deposits and deposits of significance was maintained throughout the course of these works, in order to gain dateable evidence which will reveal a definitive stratigraphic matrix for the site. This will also enable us to gain a better understanding of the burgh as a whole when compared to previous excavation works in the area.
- 112. No additional on-site works are recommended during the current phase of development, but it should be recognised that there remains a high potential for significant archaeology to survive at relatively shallow depths within Market Street.
- 113. The appropriateness and acceptability of all recommendations rests with Fife Council, and their archaeological advisers, the Fife Council Archaeology Service.

## Conclusion

- 114. Archaeological monitoring works were undertaken in respect to the development of St Andrews, Fife; these works were required by Fife Council and took place within Market Street. The core development comprised the reduction and repaving of the pavements area and main road. Additional works, such as the excavation of service ducts for the installation of street lighting and power sources; and the excavation of manholes and tree pits for landscaping purposes were also covered by the archaeological mitigation. The archaeological works were designed to mitigate the impact of this development on the area.
- 115. Archaeological monitoring of groundbreaking works ran from 22<sup>nd</sup> September 2010 until 1<sup>st</sup> November 2011. Several significant archaeological features were uncovered and recorded during the course of the development work. These features related to the use of Market Street as a main street of the burgh over long periods of time and included surviving elements of the Tolbooth, Market Cross and Tron. While it was possible to suggest a historical origin for some of the archaeological features exposed, the extent of investigation was necessarily constrained by the limits of excavation inherent within the works monitored.
