# **Summary**

This report presents the results of an archaeological test-pitting carried out by South West Archaeology Ltd. for the site of Fish Hoek, Dartmouth, South Hams, Devon. The site is located in an area of known archaeological potential given the significant medieval history of the town.

The test-pitting identified three features, all walls and reflecting the presence of a possible cellared structure against a former waterfront wall, all of which were superseded by a phase of land reclamation in the post-medieval period. The structure is undated, though the presence of machine-made bricks within one of the walls would indicate it has having at least been repaired in the late  $18^{th} - 19^{th}$  century.

Given the results of the archaeological test-pitting the archaeological potential for the site is considered low, with the site largely built on made-up ground possibly in the 18<sup>th</sup> century. It is recommended that **if** there is to be further archaeological investigations undertaken in relation to this site that these should focus on the area surrounding Fish Hoek, and establishing a more definitive date and functions for the identified structures.

### 1.1 PROJECT BACKGROUND

South West Archaeology Ltd. (SWARCH) was commissioned by O'Brien Developments Waterside Ltd (the Client) to undertake a desk-based assessment and archaeological test-pitting in advance of a planning application for proposed development of land at Fish Hoek and Waterside, Dartmouth, Devon. The test-pitting was carried out by P. Webb on 14<sup>th</sup> February 2018. This work was undertaken in accordance with a Project Design (Balmond 2018) drawn up in consultation with Stephen Reed of the Devon County Historic Environment Team (DCHET) and in line with best practice and CIfA guidelines.

# 1.2 TOPOGRAPHICAL AND GEOLOGICAL BACKGROUND




FIGURE 1: SITE LOCATION (THE SITE IS INDICATED).

The site is located approximately 600m south of the centre of Dartmouth, on the western bank of the River Dart. The site comprises a roughly rectangular plot of land to the rear of the properties of Fish Hoek and Waterside at the foot of a steep cliff, at a height of approximately 3m AOD (Figure 1). The soils of this area are the well drained fine loamy and fine silty soils of the Denbigh 1 Association (SSEW 1983); which overly the mudstone, siltstone and sandstone of the Dartmouth Group (BGS 2018).

#### 1.3 HISTORICAL & ARCHAEOLOGICAL BACKGROUND

The site lies in an area of archaeological potential, on the waterfront of the important medieval port of Dartmouth; the staging post for the European fleet during the Second Crusade (1147) and later for the wine, cloth, pilchard and cod trades. Opposite the site (west) is a row of Grade II listed residential buildings, of late 18<sup>th</sup> or early 19<sup>th</sup> century date. The Steppes House slipway, located to the north, is first recorded on the second edition Ordnance Survey mapping; the Devon HER recording a Second World War anti-aircraft battery to the front (east) of Fish Hoek. Further afield to the north is the SAM of the 16<sup>th</sup> century Bayards Cove Castle (SAM1014668); and to the south the 14<sup>th</sup> century Dartmouth Castle (SAM1014610) and Gallant's Bower Civil War defences (SAM1020166). Only limited archaeological work is recorded in this area.

# 1.4 METHODOLOGY

This work was undertaken in accordance with best practice. The desk-based assessment follows the guidance as outlined in: Standard and Guidance for Archaeological Desk-Based Assessment (CIfA 2014a) and Understanding Place: historic area assessments in a planning and development context (English Heritage 2012). The archaeological evaluation was conducted in accordance with a Written Scheme of Investigation (WSI) (Balmond 2018) drawn up in consultation with Stephen Reed (DCHET) and in line with best practice. Six test-pits, each 1m wide and between 2m and

4.50m in length, were opened by tracked machine to a depth of up to 2m or weathered natural using a toothless grading bucket. Exposed archaeological deposits were excavated by hand and in accordance with the WSI and CIfA guidelines.

The test-pitting was designed to establish the presence or absence, extent, depth, character and date of any *in situ* archaeological deposits within the site to inform any further planning decisions. The archaeological test-pitting took place on 14<sup>th</sup> February 2018.

#### 2.0 DESK-BASED ASSESSMENT

#### 2.1 DOCUMENTARY HISTORY

Dartmouth lies in the hundred of Coleridge and in the deanery of Totnes. The parish of Dartmouth was created from the historic ecclesiastical parishes of Townstall, St Petrocks and St Saviours; the waterfront area around Fish Hoek and Waterside within St. Petrocks, in the manor of South Town. Settlement at 'Dartmouth' is first recorded in 1049 (Watts 2010), though this originally referred to all the land beside the mouth of the river, the current town of Dartmouth not coming into being until the 13<sup>th</sup> century through the coalescence of the adjoining riverside settlements of Clifton and Hardness to either side of the now reclaimed Mill Pool (Hoskins 1978). In 1086 South Town, Stoke Fleming, St Petrocks and Townstall were all held by Walscin de Duaco; and following his rebellion against William II, Fitzstephen; subsequently passing through the families of Mohun, Carew, and Southcote; and latterly to John Seale, Esq., of Mount Boone, who also owned the manor of Townstall. The manor of South Town, behind St. Petrock's church, was residence of the Southcote family (Lysons 1822).

Following the amalgamation of settlements, the town of Dartmouth continued to grow, though the topography demanded that this was to the south, towards South Town; the suburb known as Southtown first being recorded in 1328, and in 1463 it was brought within the borough boundaries.

The importance of the sheltered deep water harbour is reflected in its use as a staging post for the launching of fleets to both the Second (1147) and Third (1190) Crusades. As a medieval port, Dartmouth was the fourth town in Devon, thriving on the export of cloth and import of wine from France and Spain; though from the 15<sup>th</sup> century the town started to decline. During the 16<sup>th</sup> and 17<sup>th</sup> centuries there was a revival in the town's fortunes through the development of the Newfoundland fishing trade and renewed growth of the cloth trade; resulting in the reclamation of land from the river. During this time the most prominent family in Dartmouth was that of Roope. In the 1550s the brothers Gilbert and Nicholas Roope were successively Mayor of Dartmouth and both represented Dartmouth in Parliament. In the later 16<sup>th</sup> century John Roope inherited their fortunes, including tidal mills and a house at Warfleet.

During the Civil War Dartmouth was first garrisoned by Parliamentarian forces, though after a month long siege in 1643 it fell to Royalist forces under Prince Maurice. The defences of the town were strengthened, including the construction of the forts at Gallant's Bower, Paradise Fort and Mount Flaggon overlooking the river; though the town was re-taken by Parliament under Sir Thomas Fairfax in 1646.

Following the collapse of the textile trade and the disappearance of the Newfoundland trade during the 18<sup>th</sup> century, Dartmouth once again fell into decline, and despite prospects for naval improvements in the 17<sup>th</sup> century and Atlantic shipping routes in the 19<sup>th</sup> century, neither occurred. Poor railway connections and the increased size of steamships meant that shipping lines were not encouraged to the area; and whilst the development of the coal bunkering trade at the end of the 19<sup>th</sup> century brought a brief revival, this was ended by conversion to oil fuels.

#### 2.2 CARTOGRAPHIC DEVELOPMENT

#### 2.2.1 EARLY CARTOGRAPHIC SOURCES

There are a number of early maps for Dartmouth, many including the harbour and detailing sailing conditions, but none of these depict the landscape around Dartmouth in any meaningful detail (see Figure 2); the first source to show the landscape in any detail is the 1804 Ordnance Survey surveyors draft map (Figure 3). This shows the site at the southern tip of the main settlement of Dartmouth, with limited development appearing to continue to the west of the road to Warfleet, and an unclear extent of development to the east of the road. The town is situated within a wider landscape depicted as being largely agricultural: small farmsteads surrounded by fields with gently-curving boundaries suggestive of earlier medieval strip-field origins.




FIGURE 4: EXTRACT FROM THE 1840 STOKE FLEMING TITHE MAP (SOURCE: THE GENEALOGIST) (THE APPROXIMATE LOCATION OF THE SITE IS INDICATED).

Whilst usually detailed cartographic sources, the parish of St. Petrox was tithe-free, though the 1840 Stoke Fleming tithe map (Figure 4) shows the wider landscape. It appears to confirm the impression of the curving boundaries of medieval strip fields divided through later enclosure suggested by the earlier Ordnance Survey map; but shows it in more detail and the straighter boundaries reflect a greater amount of later enclosure. The corresponding apportionment (Table 1) indicates that most of the field names were relatively prosaic, relating to land-use, nearby features, or the local topography; it also shows that the land to the immediate west of the site was owned by Sir John Henry Seale, with plots occupied by Thomas Tucker, John Lavers, Amos Peeke, and Richard Fox. The apportionment lists the land here as largely being garden with vegetable plots, including potato.

# 2.2.2 ORDNANCE SURVEY MAPS




FIGURE 6: EXTRACT FROM THE 1880S ORDNANCE SURVEY 1:500 TOWN MAP (NLS) (THE SITE IS INDICATED).

The 1873-88 1<sup>st</sup> edition Ordnance Survey map (Figure 5) is the first accessible map providing significant detail of the site itself. It shows that the buildings of both Fish Hoek and Waterside are already in existence, Fish Hoek with a glasshouse/conservatory to its southern façade. The 1880s town map (Figure 6) shows the site in much greater detail, including access to the well laid-out tree lined garden with well, seat and glasshouse via a winding terraced footpath.

By the early 20<sup>th</sup> century, the only discernible development of the site was the reduction in size of Waterfront and the removal of the glasshouse to the south of Fish Hoek. The surrounding area saw very little change, only limited development of the footprints of existing buildings, and small scale growth of the settlement being identifiable. It was not until the mid 20<sup>th</sup> century that development began to increase, and whilst to the south this remained on a small scale with individual plots infilling land along roadsides, to the west of Townstal it was more dramatic.




FIGURE 7: EXTRACT FROM THE 1888-1913 ORDNANCE SURVEY 2<sup>ND</sup> EDITION MAP (NLS) (THE SITE IS INDICATED).

#### 3.0 ARCHAEOLOGICAL BACKGROUND

#### 3.1.1 BASELINE DATA

The site is located to the south of the main historic core of Dartmouth, on the western bank of the River Dart, south of Bayards Cove Fort and opposite the western bank of Kingswear, all of which have historic origins. A limited amount of archaeological investigation has been carried out in the area: archaeological monitoring during works carried out at Evelyn Cottage and St Barnabus' Church, identifying structural remains associated with the post-medieval development of the town. The majority of the evidence for the archaeological background of the area is derived from documentary and upstanding remains, the Devon and Dartmoor HER identifying activity and settlement in the region dating from the Prehistoric through to the Post-medieval and modern periods (see below).

No archaeological investigations have been carried out on the proposal site itself, and the only monuments recorded adjacent to the site reflect World War II defences.




FIGURE 8: MAP OF NEARBY HERITAGE ASSETS (SOURCE: DEVON AND DARTMOOR HER) (CONTAINS OS DATA © CROWN COPYRIGHT AND DATABASE RIGHTS 2016) (THE LOCATION OF THE SITE IS INDICATED).

#### 3.1.2 Prehistoric and Romano-British 4000BC - AD43

There is limited evidence for Prehistoric, and no evidence for Romano-British activity in the area surrounding the proposal site. Only finds of a Mesolithic flint scatter recovered from the silts of the River Dart (MDV8528) indicate signs of activity; the scale of which (several hundred pieces), however, may indicate that this represents more substantial activity.

#### 3.1.3 Medieval AD1066 - AD1540

It is not until the medieval period that there is again evidence of activity, the surviving evidence of early settlement around Dartmouth and Kingswear suggested by the presence of chapels and churches (MDV28403; MDV8522), and more directly through the remains of medieval manor houses (MDV17598). By the 15<sup>th</sup> century trade routes resulted in further growth of the settlement, indicated by the presence of merchant's houses (MDV42293). The strategic importance of Dartmouth during a period of increasing political turmoil and threat from abroad during the late-medieval period can be seen alongside Dartmouth's growing status as a trading harbour and is reflected in the construction of substantial quay walls (MDV1197533) and an artillery blockhouse at Bayards Cove (MDV8525).

#### 3.1.4 POST-MEDIEVAL AND MODERN AD1540 - PRESENT

The increasing population during the post-medieval period resulted in further growth of the settlement, several of the buildings within the Conservation Area showing 17<sup>th</sup> century origins, including: Agincourt House (MDV23694), Bayards Restaurant (MDV43359), Harbour View (MDV74905) and along Newcomen Road (MDV1297097) and Sunderland Terrace (List1197583). However it is largely the 18<sup>th</sup> and 19<sup>th</sup> century growth of the town that is mostly in evidence, well preserved examples along the waterfront (MDV23634), Custom House (MDV23637), Port View House (MDV23640), and Sabine House (MDV23636).

This settlement and trade was carried out alongside continued development of agricultural systems, with large scale irrigation within catch meadows (MDV105212) associated with farmsteads such as at Lower Swannaton (MDV110893); alongside increasing industrial activity to the south identified through numerous limekilns (MDV49102, MDV49103, MDV74895, MDV74896), mills (MDV23746) and quarries (MDV110751).

The importance of Dartmouth as a port continued into the 20<sup>th</sup> century, its position on the south coast resulting in the town being targeted by bombing raids during World War II (MDV105210) and the provision of anti-aircraft batteries (MDV71833, MDV71834, MDV71848) and anti-tank obstacles (MDV55096).

#### 3.2 HISTORIC LANDSCAPE CHARACTERISATION

Much of the landscape surrounding Dartmouth, particularly on the higher ground, is characterised as *barton fields*, larger regular enclosures likely to have been laid out between the 15<sup>th</sup> and 18<sup>th</sup> centuries, some of the boundaries following earlier divisions, and distinct from the later generally straight-sided fields of later enclosure. As the land approaches the river, it has seen increasingly later post-medieval and modern enclosure until large areas of 19<sup>th</sup> century settlement are encountered along the riverside.

The county HLC represents a broad-brush approach to landscape analysis and it is clear in this instance that all of the land surrounding Fish Hoek and Waterside falls into the category of  $19^{th}$  century settlement.

# 4.0 RESULTS OF ARCHAEOLOGICAL TEST-PITTING

#### 4.1 Introduction




FIGURE 9: SITE PLAN SHOWING LOCATION OF THE TEST-PITS AND ARCHAEOLOGICAL FEATURES.

The archaeological test-pitting was carried out on  $14^{th}$  February 2018; and comprised the excavation of six test-pits (TP 01-06) measuring between 2m and 4.5m in length  $\times$  1m (Figure 9) wide by machine using a toothless grading bucket under archaeological supervision to a depth of up to 1.90m, this being the maximum safe depth. Test-pit 01 was excavated to a depth of 0.60m; test-pit 02 to 1.90m; test-pit 03 to 1.70m; test-pit 04 to 1.90m; test-pit 05 to 1.30m; and test-pit 06 to 1.90m.




FIGURE 10: TEST-PIT SECTIONS AND PLANS OF ARCHAEOLOGICAL FEATURES.

A total of three features were identified, all walls and all within Test-Pit 04 (Figure 10). What follows is a summary of each test-pit with finds noted where they occur; see Appendix 1 for detailed context descriptions; Appendix 2 for a full finds concordance; and Appendix 3 for a set of baseline photographs.

#### 4.2 DEPOSIT MODEL

The stratigraphy of the site was largely consistent across the whole area. A dark grey-brown silt-loam topsoil 0.12m-0.30m thick overlay dark grey-brown gritty silt-clay modern buried garden soil up to 0.35m thick. In the southern corner of the site (TP 01) this overlay a mid grey-brown soft clay-silt subsoil (102) up to 0.15m thick and the natural slate-stone bedrock (103). Elsewhere across the site the modern garden surface overlay a made-ground of loose angular slate-stone within dark brown-grey soft-friable clay silt 1.10m (TP 05) to 1.40+m thick (TP 03). The Natural was not encountered except within Test-Pits 01 and 05.

# 4.2.1 TEST-PIT 01

Test-Pit 01 was located towards the south-eastern corner on an approximate north-west to south-alignment. It measured 4.50m long and 0.60m deep, the depth to natural bedrock; the topsoil (100) was 0.18m thick; buried soil 0.25m thick; and the subsoil 0.15m thick. No finds were recovered from this trench.

A single modern water service pipe was identified within this test-pit, cut in from the topsoil.

#### 4.2.2 TEST-PIT 02

Test-Pit 02 was located in the south-eastern corner of the site on an approximate north-west to south-east alignment. It measured 4m long and 1.90m deep; the topsoil (200) was 0.12m thick; overlying buried soils (201), (202) 0.64m thick; and made-ground (203) 1.10+m thick. Natural bedrock was not reached within this test-pit. Finds recovered from this test-pit included 2x sherds of flower pot from the topsoil (200) and 2x fragments of post-medieval ridge tile from made-ground layer (203).

A modern water service pipe, continuing from that within Test-Pit 01; and a modern former garden surface were identified within this test-pit, sealing the older topsoil layer.

# 4.2.3 TEST-PIT 03

Test-Pit 03 was located centrally towards the eastern boundary of the site on an approximate east to west alignment. It measured 2.80m long and 1.70m deep; the topsoil (300) was c.0.30m thick; and the made-ground (301) 1.40+m thick. Natural bedrock was not reached in this test-pit. No finds were recovered from this trench, nor any features identified.

#### 4.2.4 TEST-PIT 04

Test-Pit 04 was located centrally along the eastern boundary of the site on an approximate east to west alignment. It measured 3.80m long and 1.90m deep. The topsoil (400) was up to 0.60m thick, having been heavily disturbed by tree roots; and the made-ground (402), (403) 1.40+m thick. Natural bedrock was not reached in this test-pit. Three walls, {404}, {405}, and {406} were identified within the test-pit.

Wall {404} was orientated north-west to south-east, measuring 1.05+m wide; wall {405} was orientated north-east to south-west, measuring 2.50m long from the southern end of {404}; and wall {406} orientated north-west to south-east, measuring 1.00+m long and 0.40m wide from the western end of {405}, though not surviving in good condition. All three walls measured 1.40+m high and were stone faced and constructed of coarsely dressed angular and sub-angular slate-stone up to 0.40m in size with a friable yellow lime mortar bond, wall {405} also containing occasional machine-made bricks. No finds were recovered from this trench.

# 4.2.5 TEST-PIT 05

Test-Pit 05 was located towards the north-eastern corner of the site on an approximate east to west alignment. It measured 2.50m long and 1.30m deep, the depth to natural bedrock; the topsoil (500) was c.0.20m thick; and the made-ground (501) 1.10m thick, directly overlying the natural slatestone bedrock.

No features were identified within the test-pit. A single small sherd of Chinese Porcelain from made-ground layer (501).

#### 4.2.6 TEST-PIT 06

Test-Pit 06 was located at the north-eastern corner of the site on an approximate east to west alignment. It measured 2.50m long and 1.90m deep; the topsoil (600) was *c*.0.20m thick and the made-ground (601) 1.70+m thick. Natural bedrock was not reached in this test-pit.

No features were identified within the test-pit. A single sherd of North Devon Gravel Free pottery and 2 butchered cow bones were recovered from made-ground deposit (601).

# 4.3 DISCUSSION

The test-pitting at Fish Hoek and Waterside identified a total of three features, all walls. The thickness and alignment of wall {404} suggests that it may have formed part of an earlier phase of waterfront wall, superseded by later land reclamation; walls {405} and {406} forming part of a structure built against/retaining this wall. The three walls are likely to form part of a single structure built extending inland from the waterfront, the depth perhaps indicating the possible presence of a cellar. The presence of machine-made bricks within wall {405} would suggest possible repairs to the wall during the post-medieval period; the infill within the walls being the same as the made-ground across the site indicating that it went out of use as a result of the land reclamation.

That the structure is not present on the historic mapping would indicate that it pre-dates the mid 19<sup>th</sup> century, though by how much is unclear.

# 5.0 CONCLUSION

The test-pitting at Fish Hoek and Waterside identified three features, all walls and reflecting the presence of a possible cellared structure against a former waterfront wall, all of which were superseded by a phase of land reclamation in the post-medieval period. The structure is undated, though the presence of machine-made bricks within one of the walls would indicate it has having at least been repaired in the late  $18^{th} - 19^{th}$  century.

Given the results of the archaeological test-pitting the archaeological potential for much of the site is low, and it is recommended that if there is to be further archaeological investigations undertaken in relation to this site they should focus on the area surrounding Fish Hoek.
