### 3. Annual Meeting.

The Annual Meeting of the Society was held at Reading University on April 25th, 1936, Mr. P. S. Spokes, B.Sc., M.A., Chairman of the Council, presiding. The Report and Statement of Accounts were approved and adopted. The Vice-Patrons and Vice-Presidents of the Society were re-elected. The following were elected Officers of the Society:-President, the Very Rev. W. R. Inge, D.D., K.C.V.O.; Hon. Secretary and Treasurer, Mr. H. T. Morley, F.R.Hist.S., F.S.A. (Scot.); Hon. Editor of the Society's Journal, Mr. E. W. Dormer, F.R. Hist.S., ; Hon. Librarian, Mr. F. M. Bunce. The retiring members of the Council were re-elected and to fill the vacancy caused by the election of Miss A. Baily as a Vice-President, Mr. H. Grayson, M.A., F.R.I.B.A., was elected a member of the Council. Owing to a family bereavement, Dr. R. E. Mortimer Wheeler, V.-P.S.A., was unable to deliver his lecture on "The Earliest Towns of England; Recent excavations," and, in consequence, an illustrated talk on "The Bayeux Tapestry" was given by Mr. H. T. Morley at short notice.

### 4. STATEMENT OF ACCOUNTS.

The Statement of Accounts for the year ended 31st December, 1936, accompanies this Report. It will be seen that including the Deposit Accounts there was a balance on the year's working of £197 8s. 9d. as against a balance at December, 1935, of £127 15s. 9d. It should be noted, however, that only one issue of the Journal was paid for in the year 1936. Owing to a delay in publication the Autumn, 1936, number was not issued until January, 1937. There was, therefore, a liability to the printers and block-makers, etc., of the sum of £86 17s. 2d. If this account had been paid in 1936 the balance as at December of that year would actually have been £110 11s. 7d.

### 7. SITE OF THE BISHOPS' MANOR PLACE, SONNING.

Your Council learn with satisfaction that Mr. Clement Williams, of Sonning, has purchased the site of the Manor Place of the Bishops of Sarum at Sonning, thus preventing the possibility of building upon an extensive scale on this historic spot.

### 9. Arborfield Old Church.

Mention was made in last year's Report of the ruinous condition of this Church. On October 24th, 1936, Messrs. C. B. Willcocks, E. T. Long and P. S. Spokes met members of the Standing Committee of the Arborfield parochial church council to consider the best steps to take for the preservation of the old church. It was resolved to endeavour to preserve the ruins and the Society offered support to the effort to be made to raise the sum needed.

### 10. ARCHITECTURAL PRIZE.

Mr. J. E. Gadsden was awarded a prize of 10/6 for a set of measured drawings of Lucas Hospital, Wokingham.
