He was the son of General Daniell Burr (d. 1828) H.E.I.C.S., by his second wife Mary (d. 1836), daughter and heir of James Davis, Esquire, of Chepstow. He was High Sheriff in 1851, M.P. for Hereford, 1837-1851, and married in 1839, Ann Margaretta (d. 1892; see No. 123 below), only daughter of Captain E. Scobell, R.N., by whom he had issue Higford (d. 1906; see No. 124 below), Edward and James-Scudamore. In 1848 he purchased the manor of Aldermaston out of the Court of Chancery and built the present house on a new site in 1851. On his death the estate passed to his eldest son, who in 1861 assumed the surname of Higford, and who sold it in 1893 to Charles Edward Keyser. [Land. Gent.; V.C.H. Berks, iii, 390; Trans. > Mr. C. E. Keyser stated that these eight shields had been removed from the east window and here reinserted. According to the pedigree (see p. 37), the order of Nos. 2-5 should be Forster, Popham, Delamare, Achard. Nos. 6-11 also appear incorrect in their present arrangement, which does not agree with the trick given in the Visitation of Berkshire in 1532. From the impaled arms, Nos. 12-14, this shield represents the marriage of Sir Humphrey Forster (d. 1556; see Nos. 29-31) with Elizabeth, daughter of Lord William Sandys of the Vine (d. 1542; see Nos. 32-34 above). The arms, Nos. 13 & 14, were brought in by the marriage of this Lord Sandys with Margery only daughter and heir of John Bray, niece and heir of Sir Reginald Bray. This Sir Humphrey (d. 1556) was an esquire to the body of Henry VIII and attended him at Boulogne, being knighted in 1534. If the marshalling of Nos. 15-22 is intended to represent the marriage of Sir Humphrey Forster (d. 1500) with Alice Popham, he could not have quartered Delamare and Achard, as his son Sir George Forster (d. 1533) acquired these through the marriage with Elizabeth Delamare. If, on the other hand, the arms Nos. 15-22 are intended for the quarterings of a later Forster (e.g. Sir Humphrey d. 1556), the marshalling is still incorrect, for the order, according to the pedigree, should be Forster, Harpden, Popham, St. Martin, Zouch, Milborne, Delamare, Achard. Nos. 26-28 represent the marriage of Sir Humphrey Forster (d. 1500) with Alice, daughter and coheir of Sir Stephen Popham. This Sir Humphrey was Sheriff of Berks and Oxon, 1476 and was buried in the church of St. Martin's in the Fields, London. Nos. 35-39 represent the marriage of Sir George Forster (d. 1533) with Elizabeth (d. 1526) daughter and heir of John Delamare. Sir George was made a Knight of the Bath in 1525 at the marriage of Prince Arthur, eldest son of Henry VII; he was Sheriff of Berks and Oxon in 1516. He died in 1533 and was buried with his wife under an alabaster altar tomb with effigies which still remains and now devoid of heraldry, in the north chapel of this church. In Nos. 40-43, the order appears incorrect and should be Forster, Popham, Delamare and Achard, as given in the Visitation. [Berks. Arch. Journ. xvii (1911) 9; Harl. Soc., Ivi, 8; G.E.C., Compl. Charles Edward Keyser (1847–1929) was the son of Charles Keyser (d. 1892; see No. 125 below) by his wife Margaret (see No. 126 below), younger daughter of Edward Blore, F.R.S. (see No. 67 below). He was educated at Eton and Trinity College, Cambridge, and in 1893 purchased the manor of Aldermaston from Higford Higford. He married Mary Emma (d. 1938), youngest daughter of Thomas Bagnal! (see No. 65 below) of Newberries, near Watford, by whom he had one son, Charles-Norman, and three daughters. For biographical notes see Berks. Arch. Journ. xxxiii (1920) 65–70. [V.C.H. Richard Congreve (d. 1782) of Congreve by his wife, Martha, daughter and heir of John Jones of Fynnant, Co. Montgomery. It is stated that this glass shield came from the Old Aldermaston Court and shews the effects of fire. It represents Sir Humphrey Forster (d. 1663), Sheriff of Berkshire 1619, who was created a baronet in 1620; in 1636 he rebuilt Aldermaston Court which remained until partially destroyed by fire in 1843. He supported the King in the Civil War and mortgaged his estates for £14,000 but eventually recovered Aldermaston and was succeeded by his grandson, Sir Humphrey (d.s.p. 1711). See pedigree on p. 37. He was the only son of Colonel Ralph Congreve, Commandant of the Gibraltar Garrison, who was the third son of John Congreve, Esquire of Congreve, Co. Stafford. He married (as her third husband), the Hon. Charlotte Stawell (d.s.p. 1762) daughter of William, 3rd Lord Stawell (d. 1742) of Somerton by his wife Elizabeth (d. 1748 and whose heir the Hon. Charlotte became), daughter and heir of William Pert. In the right of his wife he held the manor of Aldermaston from 1752 until his death s.p. in 1775. after which the estate passed to William Congreve (see No. 5p. 68 and 69 above. The arms of Fitzherbert (No. 77) represent the marriage of Richard Congreve (temp. Charles II) with Anne, daughter of Sir Thomas Fitzherbert of Norbury. Thomas Congreve (fl. 1614) of Stretton and Congreve, married the daughter and coheir of Roger Fowke (No. 76) of Gunston, Co. Stafford. [M.I.; Land. Gent.; Trans. Newbury Dist. Fld. He owned the quasimanor of Rushall. [Land. Gent.; V.C.H. Berks., iii, 397].

firstly Elizabeth, daughter of Robert Hawkes of Iver, Co. Bucks., by whom he had an only daughter Rawson (Rason); he married secondly Mabel, widow of Francis Waferor of London, and daughter of Richard Staverton Esquire of Warfield, Co. Berks., by whom he had a daughter Sarah. His second wife, Mabel, afterwards married Sir Read Stafford, Kt., who died s.p. Nicholas Williams was granted the manor of Burghfield, and the so-called manor of Amners Court in 1560 by Henry Lord Norreys of Rycote to whom it reverted through one of the coheirs of John Lord Williams of Thame. She was the second daughter of Lieut.-General Sir John Cameron, K.C.B. by his wife Amelia, eldest daughter of Henry Brock, Esquire of Guernsey; she married in 1822 the Rev. Henry Curtis Cherry, M.A., of Clare Hall, Cambridge, Rector of Burghfield for 37 years, and Domestic Chaplain to the Rt. Hon. Lord de Saumarez, third son of John Hector Cherry (d. 1803), member of the Council and sometime officiating Governor of Bombay, by his wife Catherine, daughter of William Stratton, Esquire. The Rev. Henry Curtis Cherry compiled a collection of MSS. in three volumes, arranged for publication in 1851, but never printed, entitled "Bercherienses Prosapiae"; the collection was acquired by the late Dr. William Page, F.S.A., Editor of the "Victoria History," and it passed on his death to the Library of the Institute for Historical Research, University of London. The pedigrees, some 400 in number, contain much information, some difficult to obtain elsewhere, including coats of arms; the work was the result of many years labour, and an expression of lasting gratitude and appreciation is due from all Berkshire genealogists to the indefatigable compiler. From the arms this effigy can be identified as representing Sir Richard Nevill (1400-1460) Earl of Salisbury, K.G., who was the second son of Ralph, 1st Earl of Westmorland (d. 1425) by his second wife Lady Joan Beaufort. His garter plate is to be seen in St. George's Chapel, Windsor. He married in 1424 Alice, suo jure Countess of Salisbury, only daughter and heir of Thomas Montacute (d. 1428), 4th Earl of Salisbury, by his first wife Eleanor, fourth daughter and coheir of Thomas Holand, 2nd Earl of Kent. On the death of his father-in-law in 1428, Sir Richard Neville was acknowledged as Earl of Salisbury jure uxoris; at the coronation of Henry VI he acted as Deputy Constable and in 1436 he was created a Knight of the Garter. The Duke of York, when Protector, made him Lord Chancellor; in 1459 he fought with the Yorkists at Blore Heath and at the battle of Wakefield in 1466 he was captured by the Lancastrians and beheaded. He was buried at Bisham. Co. Berks, where also was buried his wife with him, c. 1463. His "abilities were not of a high order, but he possessed great territorial and family influence. He never became popular like his son." It is to be noted that he placed the arms of the Salisbury earldom of his wife's ancestors in the place of honour and his paternal coat, differenced by the label of Beaufort for his maternal descent, in the 2nd and 3rd quarters. The arms of Monthermer were brought in by the marriage of John de Montacute (d. 1390), grand-father of Thomas Montacute (1388-1428), Earl of Salisbury, with Margaret (1329-1395), daughter and heir of Thomas Lord Monthermer (1301-1340). His eldest son and heir was Richard (born 1428, d.s.p.m. 1471) who married Anne, suo jure Countess of Warwick, and who was confirmed in 1449, and created in 1450, Earl of Warwick; he succeeded his father as Earl of Salisbury, and was killed at the battle of Barnet in 1471, being known as "The King-His effigy must have at one time been on a tomb which has now been destroyed; it is almost certain that the tomb was in the abbey church at Bisham, founded by William Montacute, Earl of Salisbury in 1337. Judging from the crespine head-dress the effigy of the woman, which here lies beside his, is a generation earlier in date. When and how they both came from Bisham to Burghfield is unknown. [G.E.C. He married thirdly before April 1669, Isabella (d.c. 1702), daughter of William Howard, Viscount Stafford (see Nos. 9 & 10 above; second son of Thomas Howard Earl of Arundel and Surrey, Earl Marshall)

by his wife Mary, sister and sole heir of Henry, last Lord Stafford who was the heir male of Prince Edward Stafford, Duke of Buckingham. He had no issue by his third wife. He held as a royal garrison his own house at Basing and was there besieged 1643-1645. From 1635 he held the manor of Englefield but it was sold after the fall of Basing, being restored to him after the Restoration, when he lived at Englefield House. 



Loftus Brightwell was the son of Samuel Brightwell (d. 1679; see No. 10 below) by his wife Susanna (d. 1712, aged 81; see No. 11 below) daughter of Joshua Loftus, and niece and heir of John Loftus of Luteiton, Co. Northants. He married Mary only surviving child of Henry Sayer, Esquire, of Hounslow, Co. Middlesex, and grand-daughter and coheir of Francis Style, Esquire of Little Missenden, Co. Bucks. The issue was Thomas (d. 1721; see No. 9 below), Susannah (d. 1739; see No. 9 below), Mary (mother of Christopher Griffith; see No. 7 below), Ann (d. 1740; see No. 9 below) and Elizabeth (d. 1765; see No. 9 below).

His grandfather Thomas Brightwell bought a share of the manor of Padworth in 1655 and appears to have settled it on Samuel (d. 1679); in 1738 three-fourths of the manor was settled on Christopher Griffith (d. 1776; see No. 7) who obtained the whole manor through his marriage with his cousin Anne Chicheley (d. 1758; see No. 13). On the death of Christopher Griffith in 1776 the estate passed to Matthew Chitty Darby (d. 1823; see No. 3 below). Reproductions of the portraits of Christopher Griffith (d. 1776) and his second wife Catherine St. Quintin (d. 1801) and of Mathew Chitty Darby Griffith (d. 1823) are given in Record of the parish of Padworth (1911), Ed. 

This shield probably represents Sir John St. John (d. 1648) who was the son of John St. John (d. 1594) of Lydiard Tregoze, Co. Wilts, by his wife Lucy, daughter and heir of Sir Walter Hungerford of Farley, Co. Wilts. He married firstly Anne, daughter of Sir Thomas Leighton of Feckenham, Co. Worcester, and secondly Margaret, widow of Sir Richard Grubham, Kt. By his first wife he had issue seven sons and three daughters. He was knighted at Whitehall on February 2, 1608, and was created a baronet, at the first institution of the order, on May 22, 1611. He had an estate at Battersea and Wandsworth. During the Civil War he was a Royalist and had three sons killed in the King's service. He was M.P. for Wiltshire 1624. His sister Anne married Sir George Ayliffe, Kt. of Grittenham, Co. Wilts., and was the mother of Ann (d. 1632; see No. 13 below), the first wife of Edward Hyde (1609-1674) afterwards 1st Earl of Clarendon. Ann (d. 1632), ds.p. of the smallpox at Reading some six months after their marriage. The arms of Grandison and Tregoze were brought in by the marriage of William Lord Grandison (d. 1335) with Sibyl younger daughter and coheir of Sir John Tregoz of Ewyas Harold, who were ancestors, through Patshall and Beauchamp. 

He was the son of Thomas Perkyns (d. 1524) by his wife Dorothy (d. 1550), daughter and heir of Edward More of Wichwood, Co. Hants. He married Elizabeth (d. 1581), daughter and coheir of Sir John Mompesson of Bathampton, Co. Wilts. He was succeeded in the manor of Ufton Robert (of which William Perkyns his greatgreat-grandfather was lord in 1428) by his nephew Francis (d. 1615; see No. 16 below), the son of his second brother William (d. 1558). For his will, see Hist. of Ufton Court, pp. 51-53, in which he gave instructions for the erection of his tomb in this church. This tomb was found defaced in 1666 by Ashmole who recorded the shields of Arms as he found them. A drawing of an attempted restoration of the tomb is given on p. 57 of the History of Ufton Court. The remains of the monument were thrown out of the church in 1860 but Dr. Fraser (see No. 4 above) "built them up again in some sort of fashion, as an arbour in his garden." As the result of the efforts of Mr. Fraser Cornish (son of the Rev. T. B. Cornish, rector in 1878), a subscription was raised and the canopy and two shields re-erected in the church. Nos. 1-2 represent Edward Boscawen 4th Viscount and 1st Earl of Falmouth (d. 1841), son and heir of George Evelyn Viscount Falmouth (d. 1808) by his wife Elizabeth Anne, daughter and heir of John Crewe of Bolesworth Castle, Co. Chester. He was born in 1787 and was M.P. for Truro, 1807-08, and was created Earl of Falmouth at the coronation of George IV. He married in 1810 Anne Frances (d. 1864) first daughter of Henry Bankes of Kingston House, Dorset, by whom he had issue an only son and heir George Henry (see No. 3) who was born at Woolhampton House in 1811. The latter was M.P. for West Cornwall, 1841, and High Steward of Wallingford in 1845; he died unmarried in 1852 and at his death the Earldom of Falmouth became extinct. [Compl.
