## The Berkshire Muniments of Corpus Christi College, Oxford.

THE muniments calendared here are those which were arranged by Brian Twyne and copied under his supervision shortly before he was appointed first Keeper of the Archives of the University in 1634. They include the deeds relating to purchases of estates for the endowment of the College by Richard Fox and other benefactors, together with such documents as were handed over in evidence of title: some few papers which were set aside by Twyne as irrelevant to his purpose, but contain matter of interest on other accounts, are included. There is a great deal of material subsequent to Twyne's day in the Lease-books, Court Rolls, Bailiffs' Accounts, and miscellaneous correspondence from which an economic history of the management of the estates, practically complete from the dates of their acquisition by the College, could be compiled: but this cannot be summarised here. The College has authorised the President and Librarian to grant permission for the examination of these documents to students who are engaged in researches for which they might be helpful.

The only deeds printed in full are those dated before 1350: there is nothing later in this section of the Archives except transfer deeds, which follow regular formulae; and for the local historian it is generally sufficient in such cases to have a list of the names occurring in them and any topographical information included. The order followed is Twyne's: this is not always chronologically correct, as he seems to have given out the bundles of deeds to his assistants for copying, and then numbered the deeds as they stood in the copies: sometimes a deed had got into the wrong bundle, and the fact was noted by him on the copy, but he did not alter the numbering or move the deed. Some stray deeds relating to property which was never in the possession of the College had also drifted in, and were copied in the transcripts—for instance, 2.ii.14

in the Berkshire volume.

The map of the Streatley and Arborfield properties reproduced is one of a set drawn for the College in 1606/7 by Langden: comparison with the Ordnance Survey map shows that it is closely accurate.

(In the calendar the scribes' spellings of proper names have been followed where they appeared interesting).

## WEST HENDRED.

The Manor of West Hendred, given by Nigel de Albeneyo to St. Albans Abbey in the reign of William I, transferred in the next century to the daughter Priory of Holy Trinity, Wallingford,

appropriated by Wolsey in 1525 to the endowment of Cardinal College, and on Wolsey's fall reverting to the Crown, was made over to C.C.C. by Henry VIII in 1535 in exchange for the manor of Molesey. It is still in the possession of the College, and the bounds are practically the same as in the days of the Conqueror.

The deeds handed over by the Crown (1.1.-24) were published in full in Oxoniensia V, pp. 50-77, and need not be calendared here. There remain three, one of which is extraneous, but relates

to the neighbourhood.

1.25. Indenture of exchange between the King and the President and Scholars of C.C.C. The College sell to the King their manor of Mulsey with its appurtenances, and the King sells to the College his manor of Westhenreth otherwise Lyttell Henreth and the parsonage of the church of Westhenreth with their appurtenances.

1.27. Grant from Thomas son of Hugh of Estgenge to John Ho Sho and wife Matilda of all rights in a quarter of an acre arable at Estgenge and a quarter of a messuage at its western end towards the village and a fifth of an acre in the village field between le Cherihcuneye and the mill formerly held by Herbert of Estgenge, inherited from his father Hugh, on payment of a rent of 6d. annually to Robert son of Hugh, in consideration of sum of Ios. Witnesses, Peter Boton, Thomas son of Robert, Gilbert de Fonte, John de Budeford, Stephen de le Perye. (? c. 1350).

The only documents concerning West Hendred classed by Twyne as rejectanea are a copy of part of (26), and a citation of John Souch, vicar, in 1461 described in Oxoniensia V, 51. In the Tower, among the Court Rolls, which he arranged but did not have copied, is a bundle, now marked B.b.1, containing parchment rolls from 1479 to 1482 and from 1508 to 1519, and paper drafts of the period between these dates: the former have the names of the Priors, the latter, except in two cases, no names. The following list gives details.

There are also among the Extranea two sheets of Antony Zouche's accounts for Wallingford Priory for the years 21/2 Edward iv and 2/3 Richard iii, containing respectively about 160 and 100 lines and giving details of receipts and expenses for years beginning at Midsummer.

## STREATLEY.

The Streatley property bought by John Claimond from Richard Piggott in 1512 and given to the College has a fairly clear history. The first deed of gift, from William de Mandeville to Simon his chamberlain, covers a good deal more acreage than that of Claimond's purchase, which amounted to 164 acres; but the recurrence of some names-Uppegrove, the Nuppegrove of Frewen's terrier, and Kaugles, Frewen's Caugyllys-shows a connexion. A definite series begins with the grant from Walter Golde to John de Cruce of Basildon (4): on Langden's map of 1606 the names of Gouldes field and Gouldes wood appear. de Cruce property passed to the Dents, also of Basildon: holdings derived from them by Walter Rodney and others (10) and by John Forest and others (12) were granted to William Hall of Hagborne, and by him to John Stafford and others, in 1445 (9). Thence they went to John Fawkes and others in 1462 (19), who transferred them next year to a group of which Henry Dogett was seemingly the active member (17). In 1500 John Viell and his wife sold the lands after the death of Henry Dogett to Robert Pigott, whose son Richard was the vendor to Claimond. This last sale included two acres meadow, which had a separate title, beginning with the grant of Nicholas de Molesford to John Osebern about 1290 (2). The property may be included in the grant of John de Mohun about 1350 (5), and, as it is subsequently called Porteresmede, is certainly that given by Agnes widow of Thomas Porter to her daughter Joan wife of Henry Clerk in 1402 (6). It passed back to William Porter in 1416 on the grant of John Brugge and his wife Joan (7): in 1460 it was held by John Fairfield (16), then, through Richard Quartermain and John Felowe, it joined the Dogett and Pigott estates in 1477 (21). The property was sold by the College in 1912.

In the calendar place-names which occur frequently are abbreviated to the capital letters. These are B—Basildon (Bastildene): G—Goring: H—Hagborne (Hakebourne); S—Streatley (Stretle). The references in the notes to G.C. are to "The Goring Charters"

William succeeded to the Earldom of Essex in 1166, went on crusade in 1177, returning the next year, and died in 1189. As the mill at Streatley had been given to the Priory of Goring by 1181, it seems possible that William's gift to his chamberlain was made on the occasion of his return from abroad. The seal is broken.



A blurred note on the back gives date in 8 Hen.?

This terrier represents the lands purchased by Claimond. The Frewens continued as tenants under the College for a considerable time: their last lease expired in 1583.
