Parish box. ERO – Debden. 1715 – Richard Chiswell leading bookseller & publisher and for nearly 100 years the Chiswells remained at Debden gradually acquiring the ancient manors and farms until Debden became, once again, a rich and prosperous estate of nearly 5000 acres.

Chiswell – Vincent through marriage Mrs Cely – Trevilian last member in 1882 sold to William Fuller Maitland of Stansted Mountfitchet Hall, Lord Strathcona & Mount Royal.

The house was demolished and portions of the estate finally dispersed in 1935.
